Redistricting To Be On Agenda

In conversations this week with County Judge Allen Moore, it has been learned that one of the items on the agenda for the upcoming meeting of the Upton County Commissioners Court on Thursday, December 19, is to be the question of possible redistricting of the Commissioner Precincts within the county. The Judge confirmed that a request by Commissioner Kenneth LaQuey had been made that this item be on the next agenda for the court and Judge Moore said

that he would post notice of the meeting on either Friday or Monday.

Redistricting of precincts is a procedure whereby precinct lines are redrawn thereby shifting certain voters from one precinct to another. Generally the purpose and aim of setting up the precincts within a county is to include within the precincts, as nearly as possible, voters with common interests — and, if possible, of approximate equal or near equal numbers.

The last time any changes were made in Upton County precinct lines was more than 20 years ago. Traditionally, these lines have been drawn in Upton County in such a way that McCamey and Rankin residents have been divided into four precincts, two each for the two towns, and extending out over the remainder of the county area so as to take in rural residents. Approximate figures—not official—presently indicate voter registration to be as follows: Precinct No. 1, 550; Precinct No. 2, 325; Precinct No. 3, 700; and Precinct No. 4, 750. Precincts 1 and 2 take in Rankin and Midkiff and the eastern part of the county while Precincts 3 and 4 include McCamey and the western part of Upton County.

Should the court decide to redraw the lines, and could agree upon their locations, any combination of voters into any one precinct could be made.

All Court meetings are open to the public and any who have an interest in the upcoming session are free to attend.

Minutes of Meeting Tell of Actions Taken at Monday's Council Session

With Mayor J. B. Pettit, Jr. and Aldermen Darrel Northcott, David J. Rose and Ruben Peterson present, the Rankin City Council held their regular December meeting last Monday at 7:30 p.m. Among actions taken were:

- The minutes of the November 19th special meeting were approved. The financial statement for the month of November showed an operating loss of \$718.90.

- A revision of the fire station contract with Abbott Builders of Midland was tabled pending completion of a new contract being prepared by the city attorney.

- It was generally agreed that Maggie Armendariez should be retained in the sanitation department of the city on an hourly basis consisting of 12 hours per week working on the trash truck and 12 hours per week spent picking up trash in the alleys which might hinder the performance of the trash truck.

- Carrol Daniel will continue receiving minimum water rate in lieu of a salary after January 1st for his services pertaining to checking on unaccounted for gas losses, until by-passes are installed and percentage of

loss is improved.

- Consideration of purchase of 25'x60' of property adjacent to City Hall on the North was tabled for further study.

- Regular annual Christmas bonuses were granted (included in budget as part of annual salaries) for all full time employees with one year or more of service.

- On recommendation from the Federal Housing Authority Board, J. L. Johnson was appointed to serve on the board, replacing E. Travis Bley.

- Bills were approved for payment and various items to appear on the January agenda were discussed and will include (1) consideration of increase in gas meter deposit; (2) consideration of increase in monthly trash hauling rates; (3) consider banning shooting in dump ground area; (4) set salaries; (5) set regular meeting date.

- Monday, Dec. 16th at 7:30 p.m. was tentatively set for a special called meeting for the purpose of finalizing contract for the fire station and purchase of property tabled in the regular meeting.

- With no further business at hand the meeting adjourned at 9:45 p.m.

J. L. Johnson New RHA Member

In actions taken by the City Council this week, J. L. Johnson was named as a new member of the Housing Authority of the City of Rankin. His appointment to the Board of Directors was made to fill a vacancy that occurred when Travis Bley, an original member of the Board and it's only chairman, moved to San Angelo.

This gives a board composed of Johnson, Dunn Lowery, Dean Nichols, Charlie Wheeler and Johnnie Hurst. J. B. Hutchens is secretary of the board.

One of the Board's first actions will be a meeting in the near future to select a new chair- (Continued to Page 5)

Commissioners Court Holds Regular December Meeting

The Upton County Commissioner's Court met Monday, December 9 for their regular session with all members of the court present with the exception of Commissioner Tommy Workman. Matters attended to were mostly of a routine nature.

Approval was given to various county officials' monthly reports and a motion was made and approved for the County to continue for the year 1975 to combine Officers' Salary Fund with the General County Fund.

Approval was given for the authorization of the County Judge to approve an application for a permit to Phillips Petroleum Company to construct a pipe line across certain county roads.

Approval was given to a letter of resignation by John Whaley, Justice of Peace in Precinct 3 in McCamey. The resignation is to become effective January 1, 1975. Whaley, who was to begin a new four-year term January 1, 1975, is moving from Upton County and the Court will appoint, after January 1, a replacement who will serve until the next election—or for two years. This is as long as the law allows the filling of an appointment to a public office.

This will not be a special election, but rather, will be held in connection with the regular Primary and General Elections of 1976. The winner of the office will serve a two-year term and then must run again in the 1978 elections.

Minutes of two previous meetings were approved and the Court recessed until 10:00 a.m. on Thursday, December 19.

Friday Services Held for Forrest Eggemeyer

Funeral services were held at 2:30 p.m., Friday, December 6, in the St. Lawrence Catholic Church for Forrest Eggemeyer. Burial was in the St. Lawrence Cemetery.

Eggemeyer, 53, and a long-time resident of the Midkiff area where he farmed, was dead on arrival at a Midland Hospital as a result of an accident on his farm Wednesday, December 4. He had stopped his cotton stripper to check its operation and his clothing was caught in the machinery and he was pulled into the stripper.

He was born October 8, 1921 at Rowena. He served in the U. S. Marines as a lieutenant during WW II in the Pacific. He was married to Mae Dell Braden in San Angelo February 18, 1947. He was a member of the St. Lawrence Catholic Church.

Survivors include his wife; two sons, Billy Eggemeyer, and Jimmy Eggemeyer, both of the home; a daughter Mrs. Sandy (Sheryl) Wilson of Lubbock; his mother, Mrs. Regina Eggeme-

yer of Midkiff; a sister, Mrs. W. C. Brown of Hillsboro; a brother, Bill Eggemeyer of Midkiff.

All three of his children are graduates of Rankin High School.

Rankin School District's Business Manager Appointed to Study Panel

In a letter from the office of Governor Dolph Briscoe, W. O. Adams, business manager for Rankin Independent School District, has been notified that he has been selected as one of twelve school business managers and twelve school superintendents from throughout Texas to serve on a special review panel. Purpose of the panel is to evaluate and review the finance program presently under study by the Governor's Office for Education and Research Development on funding Texas Public Schools.

Rankin Independent School District is one of six groups of exemplary districts, chosen earlier this year, for study of school financing methods. Presently, it is said that the program under consideration is based on the so-called "weighted pupil basis", a funding method presently in use by Florida schools.

It will be the duties of Adams and other members of the panel on which he will serve, to study all phases of the proposed financing plan, and to make a written report, giving their views and opinions on individual aspects as well as the overall planned undertaking.

Adams has served as business manager of Rankin Schools for the past thirteen years.

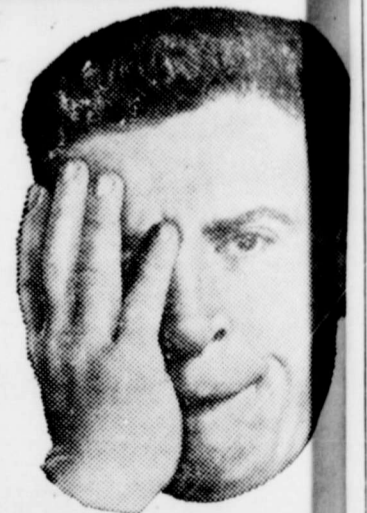
