## BRITISH PROPOSAL STRENGTHENS U. S. FIGHT ON LIQUOR

### MODIFICATION OF PLAN IS EXPECTED TO MEET WITH APPROVAL

WASHINGTON, Oct. 31. (AP)—British modifications of Secretary Hughes' proposal for a treaty agreement permitting search of foreign vessels for contraband liquor beyond the three-mile limit are expected to be acceptable to the Washington government since they place an even stronger weapon against rum runners in the hands of America's prohibition enforcement officials than this government originally had expected to be able to obtain. Under the modified plan as described in news dispatches from London search of British vessels for contraband liquor would be permitted for an indefinite distance off shore obviating the setting up of a twelve-mile zone suggested by the American government. The distance to which American enforcement officials would prosecute the search rights permitted would be governed by the circumstances in each case. In any event it is believed here that under the British plan "rum row" on the Atlantic coast would disappear as vessels laden with liquor intended for sale in the United States would have no one of safety anywhere off shore. The Hughes treaty proposal also was presumably this blanket method of dealing with the matter also will be proposed to other maritime nations in an effort to establish uniform conditions as to all flags for the greater convenience of the American enforcement flotilla. Hope is entertained here that treaties with all the powers concerned can be concluded without delay as a result of the British decision and be ready for ratification by the senate at the coming session of congress.

Dr. Fellich, a socialist, was named federal commissioner for Saxony after the socialist-communist government was formed by the Saxony diet yesterday.

### BUREAU BULLETIN PEARLS IN COST

FROM WELL TO TANK MAY RANGE FROM 20 TO 90 PER CENT.

### NUMBER OF FACTORS FIGURE IN THE COST

Detailed Information Given by Petroleum Engineer Department Interior.

WASHINGTON, D. C., Oct. 31.—The cost of lifting oil from the well to the stock tank may range from 20 to 90 per cent of the total cost of producing petroleum, states the department of the interior, following an investigation of the matter made by the bureau of mines, in which 57 groups of properties with a total of 447 producing wells were examined. The lifting cost frequently ranges from less than three cents per barrel at flowing wells producing several hundred barrels a day to more than \$2.00 a barrel at wells producing less than a fifth of a barrel per well per day. On the other hand the lifting cost per well per month may range from more than \$1000 at large flowing wells such as those recently developed in Oklahoma, Texas, Arkansas, and California, to less than \$10 at many of the wells pumped only a few hours a week, as in most of the oil fields of New York and Pennsylvania, where the average daily production per well per day is less than a quarter of a barrel.

Whether a well flows, whether it is pumped individually "on the beam," pumped as one of a group by a "power" or jack plant, operated by the air-lift system or by some other method, depends upon a number of factors such as the location of the well, quantity of oil, amount of sand, water and emulsion produced with the oil and depth from which the oil is produced. The combined influence of many factors, rather than any one factor, determines what production method should be used.

Conditions which influence operating costs and are peculiar to any property or oil field are: The depth of the well, the character of the sand, the amount and character of the oil present, the amount and pressure of the gas entering the well, the character and quantity of fuel available for development and operating requirements, topographical conditions, number of wells in the area, quantity and quality of water for development and operating purposes, living and climatic conditions, quantity and quality of timber available for field use, transportation facilities, probable life of the oil field, present stage of development and methods and equipment in use.

NEW YORK, Oct. 31.—Dissolution of the S. Lyvation Army on the ground that it is engaged unlawfully in the waste paper business was sought at a hearing held before Deputy Attorney General John J. Dwyer by commercial waste paper dealers. They charged that the S. Lyvation Army through cheap labor recruited from the ranks of unfortunates for whom it cares was overbidding them in buying waste paper and underbidding them in selling it.

### 25 Years Verdict Of Jury In Case Of Ollie Dollar

Confinement in the state penitentiary for a period of 25 years was the penalty assessed by a jury in the state district court Wednesday morning in the case against Ollie Dollar. The defendant had entered a plea of guilty to the charge of being a party to a conspiracy to defraud the state and was sentenced to the penitentiary for a term of 25 years. The jury also accepted the state introduced evidence to make out the charge.

### ATTORNEYS ARGUE CASE OF HOUSTON DEFENDANTS BEFORE SUPREME COURT

AUSTIN, Oct. 31.—Attorneys representing the defendants in the Houston case argued their case before the supreme court this morning. The attorneys argued that the state was in violation of a supreme court order suspending further proceedings until the case could be determined by the high court. Judge Harvey, who presides over the 10th judicial district, was represented by General J. F. Walters of Houston. Attorney W. L. Hill represented the Houston Exchange National bank, one of the defendants. O. M. Duclos, district clerk of Harris county, was present with his attorney, R. B. Walters. The state was represented by John C. Walt, first assistant attorney general, and W. W. Cayes, assistant attorney general.

### CONVENE ASSOCIATION OF COTTON MANUFACTURERS

BOSTON, Oct. 31.—The National Association of Cotton Manufacturers opened its semi-annual meeting today in connection with the textile exhibition in progress in Mechanics building. President Robert Amory presided. Secretary H. C. Moberg reported that the research department of the association had been actively cooperating with the federal bureau of standards in its work of dyeing and finishing of cotton. The industrial relations committee reported that it was working to help the members of the association to put the question of employing relations on a practical basis. The committee on rates and transportation urged that the members make clear to the railroad the necessity of prompt shipment of lint cotton from the south to northern mills and said that the railroads should be assisted by opening up additional water routes for cotton shipments.

### RUSSIAN COMMUNISTS IN SYMPATHY WITH REVOLUTION

MOSCOW, Oct. 31.—Leo Kamenef, speaking at a communist meeting yesterday, said it was difficult to foresee victory for the German revolution, but that on the other hand there was no reason for pessimism. The communist party of Russia, he said, sides wholeheartedly with the German revolution and is trying to help it, planning to call on all revolutionaries to follow the example of the Germans. "Over the head of Berlin," Kamenef declared, "we greet the workers-peasants' government in Saxony."

### REACH SETTLEMENT OVER CONSULATE CONTROVERSY

LONDON, Oct. 31.—A settlement of the controversy over the American consulate at New Castle-on-Tyne has been reached between Foreign Secretary Curzon and American Ambassador Harvey as reported by Mr. Herby. The consulate will be reopened within a fortnight.

**LEADER OF GREEK REVOLT  
IS CONDEMNED TO DEATH**  
LONDON, Oct. 31.—A Greek court martial at Salonika has condemned to death Major Sakelertou, who took a leading part in the recent military insurrection, says a central news dispatch from Athens. Three captains were sentenced to long terms of imprisonment. Several other revolutionaries were fined small sums and 17 were acquitted. The arrest of General Moutouras resulted in the capture of the chief of the rebels, it is stated by the minister.

### PETROLEUM COKE POWERFUL HEATING PRODUCT MADE HERE

The first car load of petroleum coke, a lighter, heavier, product in this section of the country, was shipped from the refinery of the Texoma Oil and Refining Company to Children Tuesday morning to O. Smith, local freight and passenger agent of the Fort Worth and Denver railroad.

J. E. Joyce, petroleum engineer of the Texoma company, explained that petroleum coke is a by-product of the pressure or cracking plant of the refinery. The coke is a deposit of free carbon that is taken from the inside of the gasoline refineries when the plant is shut down and cleaned out. The product is formed in the refining of gasoline from fuel oil. The coke is a by-product of the cracking process, which has recently been installed in the refinery. By extreme heat and pressure gasoline is refined from fuel oil, which hitherto was not known to contain gasoline. The petroleum coke is found inside the cracking plant. It is a dark, granular material, which is moved every week when the plant is cleaned out.

According to Mr. Joyce, petroleum coke greatly resembles coal coke except that the petroleum coke is much blacker. It burns easily and makes a much hotter fire than either coal or coal coke. Mr. Joyce said. Petroleum coke contains 14,000 British thermal units per pound. Coal coke has 14,000 British thermal units per pound and coal has only 11,000 British thermal units to the pound. Although not similar in appearance, petroleum coke is somewhat similar to carbon black in burning qualities. Mr. Joyce explained. Carbon black, another recent product from the refinery, is a natural gas with incomplete combustion, but the carbon black resembles graphite or soot in appearance.

### LAKE WICHITA NOW AT HIGHEST POINT FOR SEVERAL YEARS

Wet weather and the poor condition of the roads from the diversion dam to the railway station at Dundee have interrupted the moving of the pumps, motors and other machinery used in pumping water from the diversion dam to Lake Wichita to replenish the city supply. F. N. Lawton, manager of the city water department, said Wednesday. One of the two 10,000-gallon pumps, the motors and a portion of the other machinery used have been loaded on the car at Dundee and the remainder of the equipment will be taken down and loaded as soon as the condition of the roads will permit.

The two pumps of 10,000-gallon daily capacity were operated steadily for 30 days and eliminated any danger of a shortage of city water supply, until the lack of water was relieved by rains. Mr. Lawton said. Water in Lake Wichita is now up to the spillway and affords a supply which will furnish the city with water for two years. It is expected that the lake is at the highest point it has been in several years. Water from Lake Kemp is expected to start flowing into the city lake in February and indications are that Lake Wichita will never fall to the low water mark recorded during the past summer.

### EXPRESS CONFIDENCE IN U. S. TRANSPORTATION ACT

WASHINGTON, Oct. 31.—Confidence in the "fundamental principles underlying the transportation act" was expressed in a resolution adopted today by the Investment Bankers' Association on recommendation of its committee on railroad securities.

### EL PASO MAN DIES OF SELF INFLICTED WOUNDS; SHOOTS WIFE AND SISTER

EL PASO, TEXAS, Oct. 31.—Albert Davie, 42, died at a hospital today from self-inflicted gun shot wounds while his wife, Helen, and her sister, Miss Mary Reagan, are possibly fatally wounded. He was shot after a quarrel last night over financial matters and jealousy.

### WILL TAKE RECESS TEAPOT DOME CASE BEGINNING FRIDAY

WASHINGTON, Oct. 31.—After hearing further evidence regarding the leasing of naval oil reserves in Wyoming and California the senate public lands committee announced today that its public inquiry into the subject would be adjourned indefinitely on Friday because of out of town engagements of committee members.

Additional hearings may be held later, however, as the investigation has broadened considerably in scope since it originally began in response to a separate resolution relating to the leasing of the Teapot Dome. Wyoming reserve. Much evidence already has been heard in regard to a lease for reserves one and two in California, given the Delaney interests and some of the committee members have indicated a desire to develop that subject still further before a report is made to the senate.

HONOLULU, Oct. 31.—Eleven members of the crew of the sailing vessel Iahra were placed in jail today on charges of mutiny. The men were arrested at the request of Captain Boisset of the vessel who charged them with mutiny and with attempting to poison him.

MEXICO CITY, Oct. 31.—One hundred and eighty generals belonging to the first reserve will be dropped from the rolls November 10 when the army review board files its report, according to a semi-official announcement made here today.

### Lachman Shows Here Next Week 'One Big Family'

How would you like to be a member of a family of over 250 people and be shown in daily contact with them all every day for a period of say 15 weeks?

Well, that is what you would be if you "trouped" with the Lachman Exposition shows and stood the test for the full season. One great big family is just what it is. When the show is over one week from next Tuesday night, the band will parade the midway, playing "Home, Sweet Home," and "Auld Lang Syne" and the "goodbyes" and "leavings" will begin and there will be many "damp eyes" as the family breaks up for the winter period, but there will be joy in the thoughts of the reunion in the spring.

I helped select Miss Brent for the picture in which she appeared with my husband; I am always looking over chorus girls and women for him."

CHICAGO, Oct. 31. (AP)—The budget system is the only possible way to eliminate extravagance at Washington, Brig. General Charles G. "If the public realized just what it would mean to abolish the budget public support would be opposed to any effort to kill the budget system during the coming session of congress," General Dawes said.

### Most Touching of Offers of Help Is From American

PARIS, Oct. 31. (AP)—Princess Louise of Battenberg in an interview in Lektain said she had many kindly offers of help at the time of the death of her consort, Count Matichich, but that the most touching was from an American.

"The day after the count died," the princess said, "an American woman came here to my house. She was so insistent that I let her in. 'Madame,' she said, 'I have received a telegram from America about you. There is a man over there who does not wish his name known, but who has planned the death of your wife. He telegraphed instructions to his bankers and I bring you his offer. He wants you to put flowers for him on Count Matichich's tomb and hopes that the rest of the sum will help you during the first days of your mourning.'"

"Well, it kept me for eight days. And it is because of gifts and presents that I still have a foot over my head and that Matichich was not borne in a pauper's hearse to a pauper's grave."

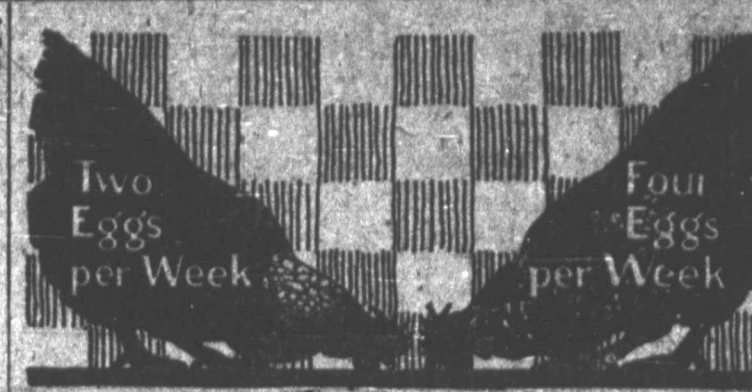

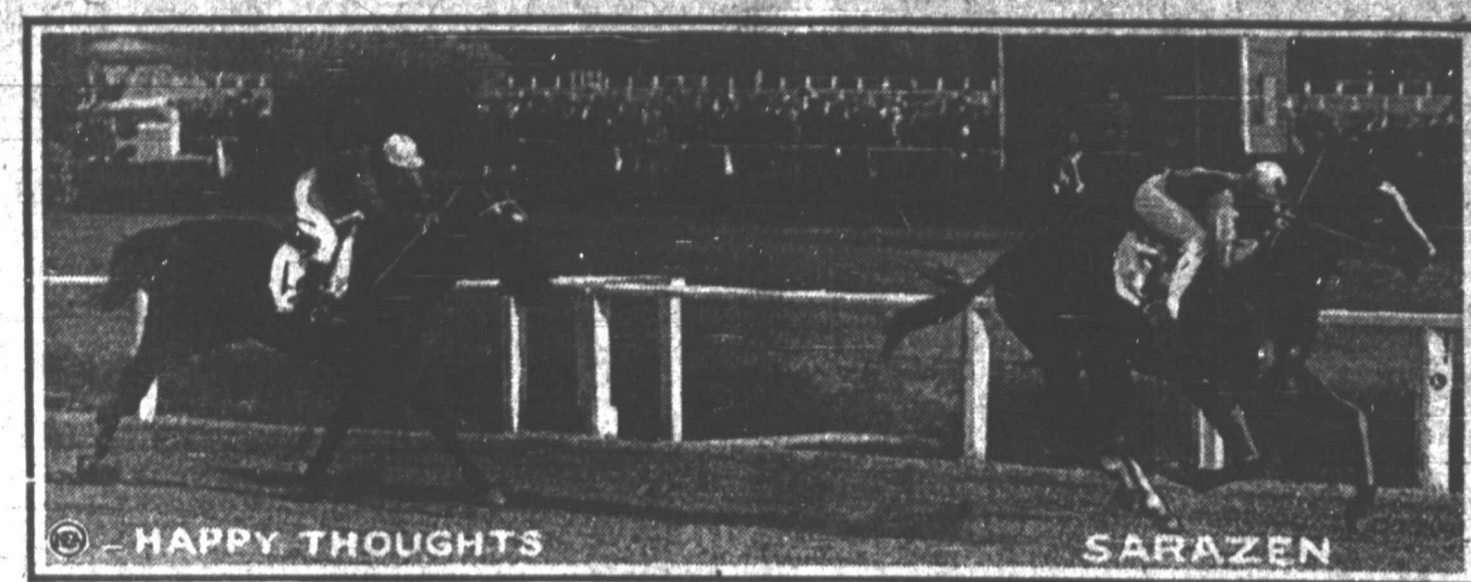

## Greatly Increased Purchasing Power On Part of Cotton Farmer Feature In Review of Business

DALLAS, Oct. 30.—Greatly increased purchasing power on the part of the cotton farmer is noted as the outstanding feature in the review of business and industrial conditions for the month ending October 15 in the Eleventh Federal Reserve Bank district. The report of the Dallas Federal Reserve Bank states the developments affecting the cotton farmer have overshadowed all others in the month.

"Bank deposits have increased heavily," the report says. "Loans have been liquidated at a rapid rate, collections on bank credit have been the best in several years, and the circulation media have risen to the highest point reached in more than two years. Federal reserves, bank loans between September 1 and October 15 reflected a net decline of \$52,106,553.31, and federal reserve notes in circulation stood at \$22,355 on the latter date. Charges to depositors' accounts increased 21 per cent in September, as compared to the previous month, and were only three per cent less than those of September, 1922. The federal reserve bank's well as many member banks has turned to the open market as a medium for the investment of its idle funds.

"The large returns from cotton and the high wages paid the laborer for gathering the crop have been further reflected in local business demand for merchandise at both wholesale and retail. Department stores noted for September a 15 per cent increase in excess of August sales, and four of the reporting lines of wholesale trade

showed substantially larger volumes of business than for the previous month. Despite the heavy consumer demand, merchants show no general departure from the policy of limiting commitments to well defined needs. It is significant to note that this policy continues to receive the encouragement of the wholesalers themselves, who are no doubt influenced to some degree by the current statistics on commercial failures, which continue comparatively heavy.

"Lumber mill orders at the district's pine mills were above normal production in September for the first time since January of this year. The September construction program, as evidenced by the building permit valuation at the larger cities, was well maintained.

"City production in the district reached an almost record-breaking volume during September in the face of a steadily declining market. This, together with the price competition among the major refining companies, has resulted in gasoline being sold at an exceptionally low level.

"The recent heavy rainfall in this district has been helpful to the livestock industry, and to some extent to agriculture. Abundant stock water and pasturage have been assured for winter range, and this improvement in physical conditions, coming at a time when the financial situation of the cattle man is being fortified by the functioning of the federal intermediate credit bank, will accelerate the recovery of the livestock industry."

Lord Kingsborough's "Antiquities of Mexico," Very Rare Work, Given University of Texas By Wichitan

One of the greatest acquisitions of literature ever presented to the library of the University of Texas was made several days ago by a public spirited citizen of Wichita Falls, who expended time and money in procuring the work of a famous writer for the library.

Lord Kingsborough's "Antiquities of Mexico" in nine volumes, which was published in London between 1815 and 1816, was presented to the library by the Wichita Falls resident who conducted a search of the United States and the literature centers of Europe in his determined effort to gain possession of a complete set of the work for the University of Texas library.

Considerable investigation was made by the Wichita Falls citizen by communication with some of the largest second hand book dealers in the United States, the congressional library at Washington and three large dealers in London. From all reports obtained the volumes purchased for the library constituted the only set for sale in the United States.

In his grateful acknowledgment of the receipt of the work, R. W. Winkler, librarian of the University of Texas says:

"It is not often that so pleasant a duty falls on a librarian as was laid upon me by your generosity. Lord Kingsborough's 'Antiquities of Mexico' (9 volumes) which arrived in good condition. It is one of the two copies now in Texas, I believe. It is a work that has been wanted for many years at the University of the faculty of this university and it fits exactly in the very good collection of the 'Garcia' collection in this library, and is appreciated like something that has been wanted for a long time. In my estimation, there is only one other work whose acquisition would produce as much genuine pleasure as that occasioned by this gift. I refer to Audubon's 'Birds of America'."

On behalf of the board of regents and the patrons of this library, I thank you for the generous contribution to the library of the University of Texas.

While the library at the State University has received a notable growth, provision has been made for a "special" appropriation for the purchase of books. It is almost all notable editions have been acquired with special funds, derived from gifts or special appropriations, because the ordinary budget of the library only takes care of the regular increase and is not adequate to enable the library to purchase rare, special collections or libraries devoted to special subjects, according to Mr. Winkler.

"Antiquities of Mexico" comprises fac-similes of ancient Mexican paintings and engravings preserved in the royal libraries of Paris, Berlin, and Dresden and in the imperial library in Vienna, in the Vatican library in the Vatican museum at Rome, in the library of the Institute of Bologna, and in the Bodleian library in Oxford. The work also contains monuments of New Spain by M. Dupak with their respective scales of measurement and their original names in Spanish. Volumes VIII and IX were not published until 17 years after the others.

The story of this magnificent work is interesting and pathetic and the facts concerning the author are set forth in his own original introduction. The author, who was a man of letters, was employed by the British government in Mexico and after his return to make drawings of them on stone.
