





Budget bill goes to conference committee

AUSTIN-The Texas House of Representatives on April 17 refused to accept Senate amendments to House Bill 1, the proposed state budget for 2008-

Differences in the House and Senate versions of the \$150 billion budget will have to be worked out in a 10-member conference committee.

Speaker Tom Craddick, R-Midland, named the five House appointees to the conference committee: Reps. Warren Chisum R-Pampa; Ryan Guillen, D-San Diego; Sylvester Turner, D-Houston; Dan Gattis, R-Georgetown; and Lois Kolkhorst, R-Brenham.

Four floor motions to instruct conferees to go into the negotiations with certain nonnegotiable points were voted down by the full House. Chisum thanked members for voting down the motions, saying he thought it better to proceed "without tipping your hand."

Senate members had not been named to the conference panel as of press time for this column.

The Legislative Budget Board's pie chart of the Senate version shows education getting 36.6 percent of the budget, health and human services getting 31.6 percent, and the remaining onethird of the budget going to all other functions, including, for example, business and economic development, property tax relief and public safety and criminal

House approves handgun bill

The House passed HB 991 by Patrick Rose, D-Dripping Springs, legislation that would make the names of concealed handgun license holders confidential.

Current law allows a requestor to give the Department of Public Safety another person's name and find out if that person holds a Texas concealed handgun license.

Advocates of the legislation say it's nobody's business who has a license. Opponents say it's a matter of personal safety to be able to find out who might be carrying a concealed handgun.

The measure now moves to the Senate for consideration.

If HB 991 becomes law, concealed handgun licenses will be the only confidential stateissued licenses.

Senate amends loan program

The Senate on April 18 passed legislation amending the forgiveness part of the Texas B-On-Time Loan Program.

SB 1496 by Sen. Judith Zaffirini, D-Laredo, would allow students who graduate within five years from an eligible four-year institution with at least a 2.5 grade point average to have 50 percent of their education loan forgiven.

In 2003, Zaffirini's SB 4 created the B-On-Time Loan Program, providing Texas students with a zero-interest higher education loan. Under the program, students are required to graduate with a 3.0 GPA within four years for a four-year degree or within five years for a five-year degree to have 100 percent of their loans forgiven.

Senate passes redistricting bill

Legislation by Sen. Jeff Wentworth, R-San Antonio, ould require congressional redistricting to be determined by a bipartisan panel appointed by the House, Senate and governor's

The Senate passed SB 1068 by Wentworth on April 16, and it has moved to the House for further nsideration.

Until the recent, mid-decade redistricting, lines were redrawn

every 10 years. Supporters of the bill say if the redistricting task is in the hands of a special commission, it would free up the Legislature to work on other important law-making. Opponents say moving district boundaries is a job the full House and full Senate should keep.

House passes record votes bill

The House approved House Joint Resolution 19, authored by Rep. Dan Branch, R-Dallas, requiring each legislator's final votes on legislation to be recorded and available for public view on the Internet.

The measure has moved to the Senate for consideration. If it passes, Texans will have the opportunity on Nov. 7 to cast a yes or no vote on HJR 19, along with other proposed amendments to the state constitution.

Flags fly at half staff for V-Tech

Gov. Rick Perry directed that flags be flown at half-staff to honor the lives of the victims of the April 16 shootings at Virginia Tech. The governor's directive was effective April 17 through sunset on April 22.

Attorney General Offers Tips to Avoid Travel Scams

Spring break and summer vacation are just around the corner, and many travel agencies will offer vacation packages or travel specials. Before committing to a vacation promotion or travel offer, take the following simple precautions to help ensure you enjoy your vacation without losing your hard earned money to a travel scam.

Ask for the offer in writing. Timeshare resorts, travel clubs and other companies often provide vacation certificates or coupons to customers who agree to attend a marketing presentation describing the company's various products and services.

A typical vacation certificate may arrive unsolicited by mail, fax or e-mail, or you may receive a telephone call informing you that you have been "selected" to receive a "free vacation." The offer may include airfare and hotel accommodations. All you have to do, they say, is participate in the company's sales seminar.

Ask for the offer's details in writing, including cancellation

and refund policies. Contact our least 90 days before the desired office or your local Better Business Bureau to check the reliability of any company offering a travel bargain, especially businesses offering a timeshare resort or other vacation deal in exchange for attending a sales presentation. Read the fine print. Once you

receive the travel offer in writing, take the time to read the fine print and pay special attention to asterisks or footnotes. Often, these are indicators of restrictions, including limitations on the length of your stay or prohibitions on certain days or times of departure. Fine print may detail additional charges that you are responsible for, such as transportation fees and taxes.

In 2006, our Consumer Protection Division won a \$64 million verdict against a travel company that misled the public about so called "free vacations." Investigators discovered that the company failed to provide information about a variety of fees, deposits, airline and hotel taxes and other costs linked to their offers.

The company also tightly restricted the dates on which these trips could be taken. The "free" vacation offers were only valid for one year, and consumers had to submit reservation requests at

departure dates. The company disclosed none of these restrictions until after the presentations and consumers had signed up.

Do not offer to pay a company without thoroughly reviewing the travel offer and understanding its limitations.

reservations Confirm independently. Another complaint associated with "free" or low-cost vacations is that promises for "five star hotels' often result in small, cramped rooms with bad food and questionable facilities. When travelers complain to the travel promoter, the promoter "finds" an "upgrade," usually at a much higher price, and leaves the travelers responsible for the added expense.

Check reservations and availability on your own. Request brochures directly from the hotel and find out what features are included in the price. The promoter may rave about a hotel's beautiful golf course, but that does not mean a round of golf is included in the package.

Ask the vacation promoter whether you can make your own travel arrangements if the designated hotel is booked. Smart travelers compare rates with those available through other travel

agencies. Remember that Internet specials on airfare or hotel accommodations do not

special requests, such as a room that allows pets. Protect your identity. Do not provide credit card information over the phone or Internet unless you initiated the call or communication. Make travel arrangements only with

guarantee that you will receive

businesses you trust. Two years ago, our office took legal action against an operation that heavily promoted sweepstakes drawings for vacations and other prizes as a way to obtain consumers' personal information. The perpetrators then sold the personal information to a third party business without consumers' permission. Be careful not to give out confidential information for a travel promotion if you don't know how it will be used.

Secure your passport early. Finally, remember that U.S. citizens are now required to have a valid passport to exit and reenter the United States, even for travel to Mexico and Canada. Consult a trusted travel agent to get passport information and updates, along with timely advice on all your travel needs.

Building flexibility into your beef system

At the recent Southwest Beef Symposium in Amarillo my colleague, Dr. Ron Gill, discussed ways to make a cow-calf operation more flexible. Briefly summarized from Proceedings they are: http:// spectre.nmsu.edu/dept/docs/

1. Stocking rate-for cow-calf operations, stocking at no more than 75% of normal forage production potential. Otherwise, in poor years you must reduce numbers or buy feed.

2. Enterprise selection/ diversification-by utilizing any excess forage with stock cows or yearlings. In doing so, you should exercise good biosecurity to protect the base cow herd.


3. Genetics of the cow herdto fit your conditions. This generally means British-base cows, with needed levels of Bos

indicus influence when dictated by the environment. Calf genetics can be tailored for particular markets through choice of sire breeds, and individuals within

Counter cyclical management-especially by selling cows when everybody is dying to get in the business and being able to buy cows when nobody else is. This uses the cattle cycle to your advantage, although it seems to be getting harder to predict cycles than was once true.

5. Outside investment opportunities-in other segments of the industry. If they're 'stealing your calves" then keep them, maybe even to the rail so you get what your cattle are "really worth." If you think packers are going to get more than "their share," consider buying their stock.

6.Emergency reservesespecially of cash. Don't spend money just to save on taxes. When times are good, don't make "investments" in things like equipment you "really need" or for a vacation you "really deserve." Proper stocking yields forage reserves that can be used or marketed.

Authorized by a 2004 law to use private collection agencies to help collect overdue taxes, the IRS finally launched the program by turning over 12,500 cases to three agencies this past September. The Service expects to have sent 40,000 cases for private collection by the end of this year.

Though safeguards have been put in place to protect taxpayers, the IRS is warning taxpayers to be alert to possible scams as con artists may try to use this new program to extract money from unsuspecting Be suspicious of letters, telephone calls, and e-mails that pretend to be official IRS collection efforts.

Here's what the IRS says you need to know about the program. •All taxpayers whose cases will be turned over to a private debt collection agency will know they are in the program before they are contacted by a private collector.

•The IRS will notify taxpayers by letter that they are in the program. The letter will contain the name of the collection agency given their account.

•Taxpayers will receive a second letter, this one from the collection agency, informing them that they will be contacted soon

•When paying a collection agency the taxes owed, taxpayers should make checks out to the U.S. Treasury, not to the collection agency or to any individual. The agency is to provide the appropriate IRS coupon and mailing address for the payment.

•Warning signs of a scam include threats to place liens or seize taxpayer property. The private collection agencies are authorized only to discuss payment schedules and to collect the debt.

•The taxpayer information the private agency will have is very limited. If an agency asks for personal or banking information, consider that a warning sign of a scam. The IRS never asks for taxpayer information such as PINs or account passwords, and they already have your social security number.

If in doubt about someone claiming to be from the IRS or working on behalf of the IRS, call the IRS's toll-free help line at 800-829-1040.


