Prison discussed at Council Meeting

Members of Sonora's Economic Development Committee were present at Tuesday's city council meeting to discuss their recent visit to a state prison facility in Scurry County. The facility which is located approximately 4 1/2 miles from Snyder has been a positive factor in the city's recent economic stability.

Lewis Allen, a member of the committee that traveled to Snyder, explained to the council that the city showed a 14% increase in the tax rate in 1989-90, above the pre-prison year of 1988. Allen also explained that the Scurry County Hospital was expecting to be closed within eleven months had the community not been chosen as a site for a state prison.

The state contracted with the Texas Tech Medical Center in Lubbock, which then contracted with the Scurry County Hospital. The hospital then received \$1200 per inmate per year, whether that inmate received any medical services through the hospital or not. Allen stated that the hospital administrator told them that the building of the facility saved their

hospital. "Their hospital went from a 1988 net operating loss of \$1.3 million to a 1990 hospital net income of \$477 thousand", said Allen.

Chamber of Commerce manager, Kathy Davis, who also traveled to Snyder stated that she believed that many people think the prisoners who go to prison, do not work, and are more or less on vacation. "They all work, they all have a job. On this site it was a factory...an office furniture factory, and we saw the finished product", said Davis. She explained that all of the inmates were working and that this also involved more civilian jobs.

Ms. Davis also stressed that the state requires grades 1-12 be taught in the prison, which employs from 25-30 teachers and a principal. "So the effort is to strive to rehabilitate and they will either have a job that they can do when

they get on the outside or they will have a G.E.D.", said Davis.

Snyder is in the process of applying for a second prison and would not release much information

about their incentive package since they consider Sonora as competition. The application for the existing prison facility in Snyder was made without the assistance of an outside consultant, which alleviates a great deal of the cost involved in the application process.

There was concern stressed during the meeting that Sonora might not be able to complete the application process by the January 15, 1992 deadline. However, if an option on available land was obtained and the paperwork completed, Sonora could at least make an attempt at obtaining one of the prison facilities from the state.

The next step for Sonora's Economic Development Committee will be to present the information to the county commissioners. However, the citizens of Sonora and Sutton County must openly show their support or disapproval for such a facility in order for the governing entities to act accordingly.


Excellent Turnout for Wildlife Field Day

The Wildlife Management Field Day conducted at the Texas A & M University Research Station at Sonora on October 8, 1991 was well attended with just under 200 persons present. People came from as far west as Alpine and as far east as Columbus. Edinburg and Hermleigh were also represented as people with a diverse interest turned out for the event which was sponsored by the Texas Agricultural Extension Service, the Texas Agricultural Experiment Station, the Texas Section-Society for Range Management and the Texas Wildlife Assn. Participants seemed especially interested in a talk given by Forrest Armke, ranch manager for the G. Rollie White Charitable Trust in Brady, as he talked about mixing sheep, goats, cattle, deer and hunters. Some very enlightening information was also presented with respect to competition for available forage within species and between species by Dr. Ken Risenhoover. Don Davis made an excellent presentation on management for wild turkeys and Dr. Dale Rollins gave some excellent facts on why more quail are not seen in the Hill Country.

The tour which included a look at some wildlife cool season food plots and some innovative techniques in deer proof fencing seemed to draw considerable interest. Wildlife and ranchers alike were impressed with the use of prescribed fire as a range improvement tool after hearing Dr. Butch Taylor's talk and having a chance to see the pasture which has been repeatedly burned at the station over the past seven years.

Dr. Fred Smeins gave an interesting view of the benefits and problem cedar poses to wildlife. This topic allowed the group to both speak and think about the consequences of legislation affecting endangered species in our area. Wildlife management has been a topic of growing interest to landowners and the general public alike. Dr. Charles DeYoung made an excellent presentation about why some managers fail.

The group enjoyed a dutch treat lunch catered by the Sutton County Steakhouse and refreshments provided by the Edwards Plateau Soil and Water Conservation District and the Upper Nueces-Frio Soil and Water Conservation District.

Fisher re-elected to S&WCD

Glen Fisher of Sonora was re-elected to the Edwards Plateau Soil and Water Conservation District board of directors on October 8, 1991. Fisher represents Zone 3 of the district.

The purpose of the Edwards Plateau SWCD is to promote sound soil and water conservation programs on agricultural lands within the district and to serve as a voice for farmers, ranchers, and local community entities on conservation matters.

The board of directors coordinates the conservation efforts of various local, state and federal agencies and other organizations and has authority to enter into working agreements with these governmental agencies and private concerns to carry out its purposes.

In Texas there are 211 soil and water conservation districts. Each is a legal subdivision of state government organized by local agricultural landowners with the assistance of the Texas State Soil and Water Conservation Board. Unlike most other legal subdivisions of state government, SWCDs do not have the powers of taxation or eminent domain. All conservation programs managed by the district are of a voluntary nature to the landowner or operator or other potential users of the SWCD's programs.

Broncos beat Kermit in District Opener

Sonora literally ran their way to a 25-14 victory over the Kermit Yellowjackets last Friday night. It was a district opener for both teams and Sonora once again was led by Adam Youngblood with his 186 yards and 3 touchdowns. Danny Mata joined in and rushed 116 yards on 10 carries.

Kermit came out in the 1st quarter and got things going early. Just 2 1/2 minutes into the 1st quarter, quarterback Brandon Heiser scored on a 39 yard run. Kermit then went for a 2 point conversion and got it.

Sonora came right back, marching down the field quickly, and with just over 7 minutes remaining in the 1st quarter, Youngblood took the ball and ran 7 yards for Sonora's first score. The 2 point conversion failed and Sonora trailed 8-6.

Sonora started the scoring off in the 2nd quarter with a 13 yard run by Youngblood. Again the Broncos failed on their attempt for 2. Sonora marched the ball down the field with relative ease on the next couple of possessions but their drives were halted by turnovers. The Broncos defense continued to play well as they limited the Yellowjackets to less than 200 yards total offense for the game. The half ended with Sonora leading 12-8.

Kermit came out in the 2nd half moving the ball down the field with 7:23 left in the 3rd quarter. Heiser took it in from 7 yards out. This time the Yellowjackets were stopped on the 2 point try and led 14-12.

Once again though,

Sonora marched down the field with some big runs by Youngblood and the Broncos moved the ball down to the Kermit 1 yard line. From there Youngblood took it into the end zone and the Broncos took the lead 18-14.

The 4th quarter was all Sonora as the Broncos defense was dominating and the offense, though not spectacular, was very effective. Quarterback Brian Paris finished off the scoring for the Broncos on a keeper from 16 yards out, midway through the 4th quarter. The extra point was good and Sonora went up 25-14.

Sonora is 5-1 on the season and 1-0 in district. This week the Broncos travel to Big Lake to take on the Owls in a key district game.

The annual lamb carcass show which is a part of the Sutton County Jr. Livestock Show has been scheduled for a new time. The show is normally held in January but has been moved to the fall in order to facilitate processing the lambs. The love lambs will be exhibited on Saturday, October 19, at 1:00 p.m. at the 4-H Center. Ten finewool and ten crossbred lambs will be selected for the final carcass judging which will be conducted on Tuesday evening, October 22, at 6:30 p.m. also at the 4-H Center. The public is invited to both sessions and the evening educational program will also offer 1 CEU of credit on your private pesticide applicator's license or

certificate in the area of label and labeling comprehension and 1 other CEU in the area of business ethics. This offers an excellent opportunity for you to come and learn about the latest in lean lamb production and pesticide safety. Dr. Dan Hale from the meats lab at Texas A & M will be here to give the program on carcass evaluation and Dr. Frank Craddock will be present to discuss feeding and breeding techniques to achieve lean lamb. All persons are invited to attend and educational programs conducted by the Texas Agricultural Extension Service serve people of all ages regardless of socioeconomic level, race, color, sex, religion, handicap or national origin.

Blood drive to be held Oct. 22

Sonora's next blood drive will be held from 3:00 p.m. to 8:00 p.m., Tuesday, October 22, 1991 at the Sutton County EMS Building, 211 E. 3rd. This is an opportunity for residents of Sonora to positively affect the lives of others. Giving blood is safe and easy, and takes only about 30 minutes.

"There is absolutely no risk of getting AIDS or any other diseases by giving blood. This is a statement of fact that is echoed by every medical, scientific and blood service agency in the nation," said Paula Kennemer, Community Relations Director of United Blood Services, the area's nonprofit community blood provider.

Only sterile, disposable equipment is used during the donation process. Everything, from the swabs to the blood bags to

the needles, is used just once and then disposed of. "There is simply no way to get any infectious diseases from giving blood," she said.

Before the blood donation, the donor is asked a series of medical questions to help assure the safety of both the donor and the patient who will receive the blood. In addition, the donor's pulse, temperature, blood pressure and iron level are checked.

Once the blood reaches the United Blood Services laboratory, several hours of tests are performed to further assure patient safety.

"Hospital patients' blood needs are increasing every year, and the only way to meet their needs is by healthy people regularly volunteering to donate blood," Kennemer concluded.

ASCS petitions to nominate to be mailed to members

Petitions to nominate persons to be placed on the election ballot for County ASCS Committee elections have been mailed to all known eligible voters for Sutton County. Under the present system, committee members are elected for a three year term. A person may serve three consecutive terms (nine years) before being ineligible for reelection. Cleve T. Jones III has served on the committee for three years and is eligible for another three year term. Other Committee Members are George Wallace and Charles Shannon Jr.



School Board Minutes

The Board of Trustees of the Sonora Independent School District met in regular session at 7:00 P.M. on Tuesday, October 8, 1991 in the Board Room of the Administration Building, 807 South Concho, Sonora, Texas.

Board members present were: Donald Patton, President; Jesse Bustamante; Jim Garrett; Gary Hardgrave; Becky Johnson; Gloria Lopez; Michael Smith and Charles Russell, Superintendent.

The meeting was called to order by President Patton and the invocation was given by Superintendent Charles Russell.

The minutes of September 10 and 12, 1991 were unanimously approved as written after a motion by Jim Garrett and a second by Becky Johnson.

There being no comments from visitors at this point, the President moved to the next item on the agenda.

Chief Appraiser Rex Ann Friess stated that the collection rate stood at 98 1/2 % of the current levy. She continued with general information concerning tax collection, including facts concerning county/education district tax collections. President Patton, on behalf of the Board, expressed his appreciation to Mrs. Friess for her continued commitment to the Sonora ISD.

The Superintendent presented a list of names of people who had agreed to serve as board members for the Tax Appraisal Board. After a general discussion, it was the consensus of the Board to allow one more month before selecting nominees and then to elect them at the December meeting.

The Superintendent reported on the October meeting of the Breakfast Club and he stated that enrollment is as follows: Primary-267, Intermediate-261, Junior High-244, High School-280, with a total of 1052.

The Superintendent concluded his remarks with a report on the newly formed Sick Leave Bank and commented that 93 employees had joined.

Mr. Russell informed the Board that current bills were higher for the month of October because of payments for items ordered for the beginning of school. After some discussion, current bills in the amount of \$261,937.69 were unanimously authorized for payment. Motion was made by Gloria Lopez and seconded by Gary Hardgrave.

President Patton welcomed Mrs. Claudia Dempsey, high school math teacher, to the meeting. She informed the Board about the TAAS Test which is being administered this week and the efforts for the past 6 weeks of teachers to prepare students for this test. She continued with information about the newly developed co-ordinated curriculum which is being used by high school math teachers and she gave detailed information about her work as the math support person for the Sonora ISD. At the conclusion of her remarks, the Board thanked her for her interesting and informative presentation.

After a motion from Gary Hardgrave and a second by Michael Smith, the Board unanimously approved the following early dismissal days: Thursday, October 31-Halloween; Tuesday, November 26-Thanksgiving; Friday, December 20-Christmas; Thursday, April 16-Easter; Friday, May 29-Last Day of School.

Maintenance Supervisor Wesley Henson was appointed asbestos Program Coordinator for the Sonora ISD after a motion by Jim Garrett and a second by Jesse Bustamante. The motion carried unanimously.

The Superintendent informed the Board that the job description for Sonora ISD teachers was outdated and that a new one had been written. He pointed out various changes in the job description and asked the Board to review it before formally approving it at the November meeting.

The Board unanimously voted to adopt the fund raiser procedure for the Sonora ISD as listed. Motion was made by Jim Garrett and seconded by Gary Hardgrave.

The first reading of Update 40 was held. The Board will adopt the new policies at the November meeting.

After some discussion, the Board unanimously approved the proposed Community/School Survey to be used for the formation of Organizational Goals for 1992-1993. Motion was made by Jesse Bustamante and seconded by Becky Johnson.

The Board unanimously voted to rescind previous policies EIA (LOCAL), Grading Policy, and FB (LOCAL), Equal Education Opportunities, and to approve the newer policies as presented. Motion was made by Gary Hardgrave and seconded by Gloria Lopez.

On motion of Jesse Bustamante and a second by Jim Garrett, the formal certification of the 1991 appraisal rolls by the Tax

Assessor/Collector was unanimously accepted by the Board of Trustees.

President Patton showed the Board various thank you notes that had been received from staff members and he suggested that the Board write letters to both the Athletic Director and the Band Director, expressing their support for the programs.

There being no further business to bring before the Board, the meeting was adjourned at 8:58 P.M. after a motion by Becky Johnson and a second by Jim Garrett.



TxDOT to begin project

San Angelo -- Flasher Equipment Company of San Antonio is scheduled to begin a project to place raised pavement markings on 350 miles of highways in District 7. Various sections of highways on Val Verde, Kinney, Real, Edwards, Sutton, Crockett, Menard, Runnels, Coke, Tom Green, Irion, and Glasscock counties will receive the new markings, according to Joe W. Lane, PE., of Sonora, the engineer in charge of the project for the Texas Department of Transportation (TxDOT).

The contractor will begin work Monday, October 14, in Glasscock County, and will move east and south as they complete a section. They estimate it will take 80 working days, including some Saturdays.

In the area where the crew is working, adequate warning signs, barricades, flaggers and other warning devices will be utilized to direct the travelling public. Motorists approaching the work area should slow down and watch for men and equipment. The crew will move down the road at a steady but slower pace than the public.

This \$203,895 project is one of many the department contracts with private firms to do state work. The following highway in Sutton County is included in the project: U.S. 277 from St. Ann's Street in Sonora to Edwards County Line.


Eighth Grade Hands Del Rio a Loss
