Ranchers Urged To Keep Watch For Screwworms

Livestock producers in the county are warned that the screwworm situation is potentially grave, especially now that rains have fallen on a large area of grazing land. Outbreaks in the state are well ahead of last year when over four hundred cases of screwworms were reported in the county.

County agent Pete W. Jacoby urges all ranchmen to use every means of curbing an outbreak by using preventive practices such as spraying and treating all wounds. It is also very important that any suspected cases be collected and sent to the Mission Lab for identification. Most of the cases so far this year have been in the Valley but a case of screwworms was confirmed last week in Pecos county and Crockett county could have a case turn up anytime now, warns the county agent.

"It is important that Mission be kept advised of any cases so sterile flies can be released immediately," Jacoby said. "Just a few unreported and untreated cases can get us in the same trouble as last year with a full-scale outbreak on our hands."

Beall Barbee, Wool Warehouse Operator, Dies

Funeral services for Beall Barbee, 55, owner of the Ozona Wool and Mohair Co., and Terrell County ranchman, were held at 3 p. m. Tuesday from the Ozona Methodist Church, with burial in Cedar Hill Cemetery under the direction of James Funeral Home.

Mr. Barbee died suddenly at his ranch in Terrell County Sunday afternoon. He and Mrs. Barbee had spent the day at the ranch doing various chores and were preparing to return to their home here. Mrs. Barbee was in the pickup waiting for him to hitch a trailer to the vehicle when she realized that some time had passed since she had heard any activity. Upon investigation, she found Mr. Barbee on the ground near the trailer. Unable to revive him, she rushed to the home of a neighbor, who went for help. Mr. Barbee apparently died of a heart attack.

Mr. Barbee was born June 10, 1913, in Sweetwater. He moved to San Angelo with his parents as a youth. He had lived in Ozona the past 22 years. He was married to Katherine Findham Sept. 13, 1941 in Big Spring. He was a long time member of the Methodist Church.

Mr. Barbee was the youngest wool buyer in the fraternity when he worked for Walter M. Marston Wool Co. in San Angelo. He started his career with Joe B. Blakney in that city.

He worked for Texas Wool and Mohair Co. and continued with that firm after its merger with Wool Grower's Central Storage Co. of San Angelo.

He was manager of Ranchers' Wool and Mohair Co. of Rankin and Ranchers' Wool and Mohair Co. of Ft. Stockton before moving to Ozona and purchasing the Ozona Wool and Mohair Co., which he owned and operated until the time of his death.

He served 3½ years with the U. S. Air Force and was on the CCC Wool appraisal committee following his discharge. (Continued on Last Page)

Dr. and Mrs. Randle Coker moved to Ozona this week from El Paso where Dr. Coker was employed by the U. S. Public Health Service. Dr. Coker will open his medical practice around May 1 in the offices formerly used by Dr. E. L. Dyer.

Mrs. Coker, who is a registered nurse, will assist her husband in the office.

Dr. Coker, 31, is a graduate of the University of Arkansas school of medicine. He took his internship and residency at Barnes Hospital in Saint Louis, Mo. He has been with the Public Health Service for three years. In El Paso he worked in a joint program with Mexico in the control and reporting of infectious diseases. He is a general practitioner.

Dr. Coker said he became interested in living in Ozona when he came here to help with the countywide polio and measles vaccination program some time ago. He and his wife, Ruby, prefer to live in a small town and they were both favorably impressed with the hospital facilities here.

Mrs. Coker, who has a master's degree in nursing from Washington University in St. Louis, taught pediatric nursing in an El Paso school of nursing prior to moving to Ozona.

early Friday morning severely damaged a communications tower located behind the G. H. Whitley home at 102 Ave. M, atop the hill in the Couch addition. A bolt of lightning scored a direct hit on the antenna, traveled down through the tower and hit the radio house located below, blowing fuses and breaker boxes and damaging equipment. The electricity then traveled along a telephone wire to the house where the remote control was located. Heat melted a ground wire and stopped the full force of the bolt. However, the remaining force traveled into the house through a water line, burning out an electric dryer and breaking a valve in a washing machine, flooding the kitchen with water.

The full extent of the damage was not known at mid-week. Telephones and electrical service in a two-block area were put out of commission for several hours after the lightning struck.

Showers fell intermittently Friday, but dreaching rains continued all night Friday and all day Saturday. The ground was so thoroughly soaked that a large tree in the yard of the P. C. Perner home fell over into the street.

Rainfall was general throughout the county with over five inches reported on the Charlie Black ranch northwest of town. The heaviest rainfall reports came from ranches along Howard Draw from the north to the mid-section of the county.

Directly north of town, the J. B. Parker ranch recorded a 4-inch fall. The E. B. Ingham ranch on the Pecos river in the extreme western part of the county reported a 5-inch fall.

In the eastern part of the county, the Demp Jones ranch received 2.5 inches of moisture during the two-day period. Reports of three inches were general directly south of town and the Geo. Montgomery ranch located in the extreme southern part of the county reported a half inch up to three inches, the heaviest fall reported on the northern sections.

The bountiful early spring rainfall promise the finest range conditions West Texas ranchmen have enjoyed in a number of years.

SIRHAN IN SPLENDOR

The Los Angeles County supervisor has been quoted as estimating the cost of the trial of Sirhan B. Sirhan as being more than \$858,000 to date. He said that the sum total will be in excess of a million dollars before the trial is finished. In recent months, we have been up to our elbows in circuses. The James Earl Ray trial and the Garrison-Shaw episode set some sort of record for bizarre court cases. They make the Scopes trial look like a small claims case.

It now appears that the astronomical expense of the Sirhan trial is not going to be the end. The California Medical Facility is in process of creating special living quarters for Sirhan in case he is found guilty and sentenced to life imprisonment.

Plans for the special cell appear to be curiously lavish. The quarters will consist of three units. One will be a kitchen - dining room. The others are a living room, a bedroom and a lavatory with shower. This seems to us generous and makes us wonder how the California taxpayer must feel about it. Unfortunately, the press release did not give the cost figures on the cell. It did not even detail what the furnishings would be.

We are not among those who believe that convicted murderers should live a bread-and-water existence. Prisons to today do not contain dungeons with chains and manacles or torture racks, but surely a line should be drawn between imprisonment, as a punishment for a capital offense, and a retirement suite. After all, if the assassin is convicted, he should receive appropriate punishment. A man is

ONE MORE INSTANCE

The nation's press almost daily carries examples of how judicial leniency continues to endanger public safety.

A recent story from Washington, D. C. points up once again just how grave the situation has become. Seventy six of the felonies which occurred there last year were committed by 45 persons already under indictment for armed robbery, but who were out on bail, pending trial.

Chief Inspector Sanford D. Garelik of New York City says: "It is self-defeating, to say the least, to have to arrest the same people over and over again. It seems as if our system of criminal justice is being perverted into a system of criminal injustice — injustice to a repeatedly victimized public."

There was a time when proof of guilt was enough, but in today's growingly complex society, the stress is on the "why" rather than on guilt or innocence. A good example is the trial of Sirhan B. Sirhan in Los Angeles. A good portion of the trial has centered on his past, rather than the act of murder which he readily admits. Testimony regarding his early years is receiving significantly more coverage than details of the actual planning and enactment of the assassination itself.

The Dover, Del., State News reported yet another instance of the perils of judicial restraint. On June 3, 1968 a man was arrested for indecent exposure. Bond was set at \$500. Two days later a young girl was kidnapped and attacked. The same man was arrested and charged with the crime, but some days later the young victim committed suicide. The case was not pressed. The victim had removed herself as a witness. Neither that case nor the indecent exposure case has ever been tried.

In February of this year, an 18-year-old girl was abducted at knife-point but managed to escape with minor injuries. The same man gave himself up to the police. He is now in jail for a six-month term. The sentence was not for any of the crimes mentioned. It is for probation violation. He was on probation for robbery of an old man in 1966.

Washington News Letter

Congressman O. C. Fisher

The Equal Employment Opportunity Commission (EEOC), a product of the burgeoning Big Government era, got into the news the other day when Senator Teddy Kennedy called Clifford Alexander, Jr., chairman of that agency, to report to a Senate committee on progress in forcing businessmen to hire, fire and promote employees in accordance with the commission's findings.

As the EEOC chairman told of his meddling in private business affairs, the venerable Everett Dirksen came unglued. He reminded the witness of mounting complaints against the agency's excesses and proceeded to insist that the harassment of private business must stop or "I'm going to the highest authority in this Government and get somebody fired."

This prompted Teddy to rebuke Dirksen, and dared him to try his hand at firing Alexander, a New York Negro.

Well, Kennedy was a bit too amateurish for his own good — and that of Alexander. For the next day it was announced President Nixon was removing EEOC's chairman from his exalted position.

EEOC, a scourge of American business, has authority to have employers hauled into court for failing to hire, fire or promote in accordance with the whims of the agency's functionaries. Created five years ago to run herd on businessmen and all private employers, the agency has prospered in terms of swollen rolls and mounting costs. Now staffed by 518, the agency's cost tag per year is \$8.7 million — and it is asking for twice that amount. This compulsory control over employment practices — along with its double-cousin, the Civil Rights Commission — irritate more people every day. The use of harassing tactics by both agencies is commonplace. Both should be abolished.

Recipe of the Week From Kitty's Kitchen

Greek Salad Platter

- 6 cooked medium potatoes diced
- 2 onions chopped
- 1/2 cup thinly sliced green onion
- 1/4 cup minced parsley
- 1/2 cup French dressing
- Lettuce leaves
- 1 bunch watercress, stems removed
- 2 tomatoes sliced in thin wedges
- 2 small cucumbers cut in finger pieces
- 1 small avocado sliced
- 3/4 cup blue cheese coarsely grated
- 1 small green pepper cut in rings
- 2 small cooked beets julienned
- Ripe olives
- French dressing
- 2 tbs. minced fresh oregano

Combine the first five ingredients. Line a large platter with the lettuce leaves and pile the potato salad mixture in the center. Tear remainder of lettuce and scatter it around the platter outside the salad. Sprinkle watercress over the whole platter. Arrange the tomato wedges around outside of platter with cucumber fingers between. Lay the avocado slices inside the tomato ring. Scatter the cheese over the entire platter and lay green pepper rings on top. Arrange little bundles of beets around potato salad and scatter olives all over top. Drizzle with French dressing and sprinkle with oregano.
