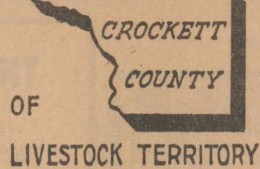

## Hospital 1971 Loss Placed At \$42,382

A down-to-earth analysis of Crockett County Hospital operating results for the year 1971 as prepared by County Auditor Dick Kirby shows the year's cash receipts at \$118,965.87 and cash expenditures for the year at \$197,567.25, a total cash outflow, or loss, of \$78,601.58. This loss figure, however, was tempered by Medicare payments for the years 1969-70 of \$36,219.00, leaving a net loss for the year 1971 of \$42,382.58.

These figures contradict an analysis of operating results presented to The Stockman last week by Hospital Administrator Sonny Kirklen and Board Chairman Joe Couch, based on figures contained in financial statements made by a San Angelo auditing firm of hospital operations for last year. The administrator's conclusion, as reported in last week's Stockman, was that the actual loss to the taxpayers was only \$11,755. This figure was arrived at by subtracting from the audit loss figures of \$40,055, a cash-on-hand item of \$12,351 and a deficit from the previous year of \$16,000 carried forward. This method of calculation overlooks the fact that the county had transferred into the hospital fund \$70,000 from the county's general fund, as shown in the County Auditor's report \$20,000 in the final month of

The audit as prepared by the San Angelo firm, on an accrual basis, was to meet Medicare requirements. The Stockman is glad to publish the detailed statement of finances to correct any misrepresentations that might have been contained in the report of last week.

## WTU To Sponsor Ozona Student To Science Course

West Texas Utilities Company will sponsor an outstanding student from Ozona High School to the 12th Texas Nuclear Science Symposium for High Schools to be held in Austin June 5-8, according to local manager Glenn Burns.

Held on the campus of the University of Texas at Austin, the four-day symposium is co-sponsored by the university and the Texas Atomic Energy Research Foundation. West Texas Utilities Company and nine other investor-owned electric utility companies in Texas compose the foundation. The foundation is supporting research at the university in seeking a future source of energy supply for generation of electric power by controlling nuclear fusion reactions.

A number of noted speakers from science, industry and education will address the delegates to the symposium. Two afternoons will be spent touring the science laboratories at the university.

The company also will sponsor a teacher to accompany the student. Both the student and teacher will be selected by the high school. Some 550 delegates from throughout Texas will attend.

## Armando Reina Announces For Commissioner

Armando Reina, 44, native of Crockett County, has announced his candidacy for the office of commissioner of Precinct 1, subject to the May 6, Democratic Primary.

Reina, son of Mr. and Mrs. Ignacio Reina of Ozona, attended Ozona schools and Sam Houston State University. He is a veteran of the U. S. Navy.

Mr. and Mrs. Reina have four children. All attended Ozona schools. Their son is attending school at Texas A & I.

In May, 1950, Reina started in business in Ozona as a photographer and recreation hall attendant. On June, 28, 1954 he photographed the Ozona flood and his picture made the front page of The Stockman. The picture was later used by the Army Corps of Engineers to sell Congress on the seven retention dams built around Ozona today.

Reina has been president of the U. P. O., P. T. A., Southside Lions Club, American G. I. Forum, treasurer of the American Legion and Our Lady of Perpetual Help Parish Credit Union. He has been active in all church organizations and was recently voted member of Parish Council.

In making his announcement, Reina said, "I was the rabble rouser who protested about our County Commissioners buying the land south of town to install a new dump ground. I was fighting pollution then. The dump ground was too close to my house."

## Commissioners Take First Step Toward Nursing Home Facility

First moves toward construction of a nursing home for Ozona was taken this week by the Crockett County Commissioners Court when the court met in special session with representatives of an Austin, Texas, architectural firm to begin preliminary planning.

John Chiles Allen, Austin independent architect, who was associated with the firm which planned the Crockett County Hospital, and his associate, John T. Warren of Austin, formerly with the State Health Department, were invited to assist the court in planning the facility.

## Over 100 Present For Annual CofC Banquet

Over 110 local and out-of-town guests were on hand for the annual Chamber of Commerce Banquet held here last Thursday night.

A. R. Rutherford, owner of Rutherford Motor Co., took over the reins of the presidency from C. O. Lefty Walker, outgoing president and director.

Rutherford said chamber efforts would be turned to easing the present housing shortage caused by so much pipeline activity in the area. He said there is no problem with workers who are in Ozona temporarily, but he said there will be permanent pipeline employees who will need homes and the beginning of Interstate 10 construction will create a need for housing. Tourism will be high on the list for the chamber also, Rutherford said.

## Precinct 1 Race Is Headliner In May 6 Primary

When the May 6 Democratic Primary rolls around, the Precinct 1 county commissioner's race will no doubt be the most hotly contested race for Ozona voters.

Incumbent Jesse Marley, 33, a rancher, is asking for another term, but is challenged by Bill Seahorn, 40, a rancher; Weldon Maness, 40, a service station operator, and Armando Reina, a pool hall operator.

Jack Williams, incumbent commissioner in Precinct 3, has filed for re-election and has one opponent, Ted Lewis, 58, local grocer.

Incumbent constable of Precinct 1 Gene Williams, 54, also a rancher is running unopposed.

On the district level, District Attorney Dixon Mahon, who has filed for re-election, is being opposed by Charles Prock of Fort Stockton. Mahon makes his home in Ozona.

Crockett County Democratic voters will also have an opportunity to cast ballots for U. S. Rep. O. C. Fisher of San Angelo, for the District 21 seat; State Sen. Pete Snelson of Midland, also running unopposed; and State Rep. Hillary Doran of Del Rio, an unopposed incumbent.

THAT'S THE WAY THE DOMINOES TUMBLE

The general scramble of nations to improve their relations with Communist China following President Nixon's revolutionary move to visit Peking is bringing more surprises. All those persons and groups who have been poohpoohing the domino theory of international events must be doing some serious headscratching.

On top of the demonstrated rage to live with the Chinese Communists in the United Nations, even to the point of expelling the Republic of China (the Nationalists), it is now believed that Eisaku Sato will resign as Premier of Japan this summer to permit the installation of a political leader more acceptable to Communist China.

Thailand, one of the best friends of the United States in Asia, and a country with a small but growing Communist problem, is also seeking some modus vivendi with the Chinese Reds. On the other hand, the Soviet Government has sent its Foreign Minister to Japan in an effort to counteract Tokyo's bent toward Peking.

The dominoes are tumbling, and the end is nowhere to be seen. From Singapore to North Korea and from Tokyo to Moscow the pieces in this deadly game of international politics are falling into new patterns.

Easter Seal Sale Opens Mon.

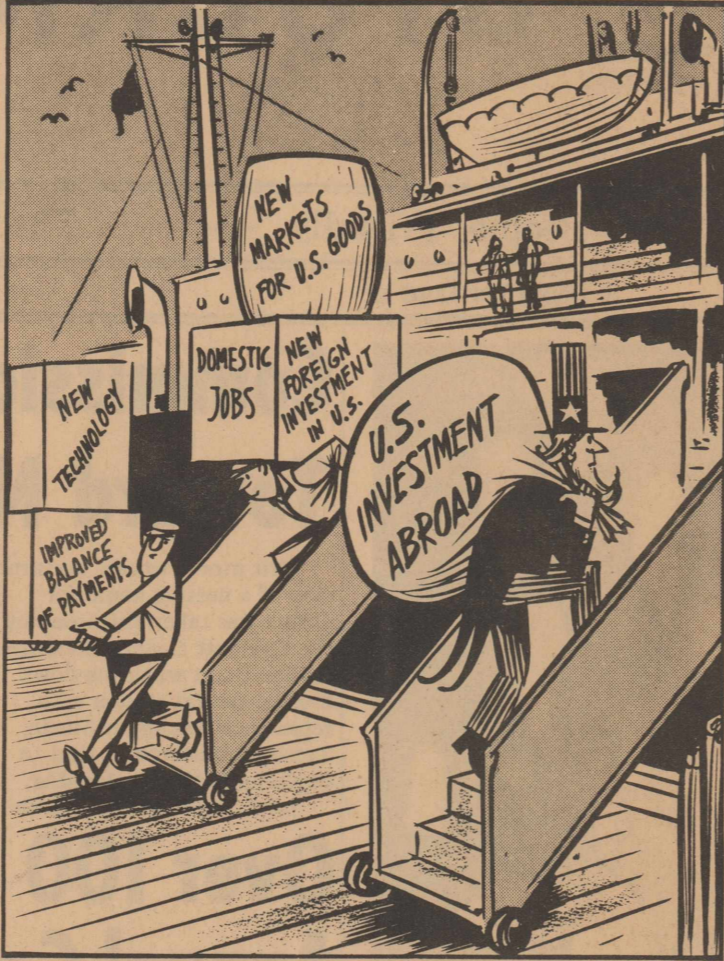

**Washington News Letter**  
By Congressman O. C. Fisher

Forced busing continues to be the Nation's top issue, according to opinion polls. In Richmond a federal judge (who sends his child to a private school) declared illegal the city's inner-city predominantly Negro schools and ordered massive cross-busing into suburbia, miles away, in order to get a better mixture. If such a monstrous action is upheld in the Richmond case, then it can happen throughout the land. Thousands of Richmond citizens, white and black were outraged, and managed to obtain a temporary stay order. The case now goes to the

Supreme Court. Many Texas communities are feeling the whiplash of compulsory busing orders. In Dallas, for example, a federal judge imposed a cross-busing scheme which was drafted by an outfit in Austin, known as Texas Educational Desegregation Technical Center (TEDTAC). The plan forces cross-busing for 10, 12 or 15 miles across the city. In the Congress a hearing is scheduled to begin March 1 on a resolution, of which I am a co-sponsor, to amend the Constitution by guaranteeing the right of every child, regardless of race, to attend its own neighborhood school. I will testify in support of this proposal. Much grave concern is being heard around here that Hanoi may now be induced to forego any temptation to engage in serious negotiations for a settlement of the war and release of

our POWs, pending outcome of the November election. It is reasoned the Commies may figure on getting a much better shake in dealing with a dovish president, should one of that commitment be elected. Some candidates favor a virtual sellout. Radio Station KNX of Los Angeles recently reported a well-dressed woman named Johnnie Blunt, sporting a new Lincoln Continental, has been trading food stamps for food at supermarkets. An investigation has been ordered. It smacks of the rankest form of welfare fraud. --0-- Mr. and Mrs. George Turner recently returned from a visit with her parents, Mr. and Mrs. Wm Keene, in Pecos. ### Tips For Gardeners

From the  
Ozona Garden Club

Mrs. Bailey Post

Beauty in a garden can be yours if you plan now. Fulfill your dreams with spring and summer beauty and celebrate the glory of the fall season. Each spring, fall-planted bulbs come into bloom to make a spectacular show. Also, plans now will bring a more colorful spring for many years if you plant peonies next September or October. To send in your order soon will assure you of a better selection and grade of peony roots.

These lovely garden perennials are known to have lived many years without being moved or almost forever they say. Don't expect blooms the first year, but once established, you can expect beautiful blooms each year, if properly planted and cared for.

For this area, select the early varieties that will bloom before summer heat begins. Flower types are double, Japanese, the enchanting singles, and tree peonies. The single peonies are not as popular in American gardens as they deserve to be. These simpler flowers withstand the stormiest weather, are lovely in the garden and wonderful for cutting (best done when buds are just opening). They are especially good in the southern areas where doubles may not open properly.

If you mounded your peonies in the fall for winter protection, remove excess before growth starts -- These buds will soon appear, and are very brittle and easily damaged. After buds are several inches high, make a circle 6 inches away from the crown and apply an annual top dressing (about a cup) of low-nitrogen, high phosphate and potassium fertilizer (a 5-10-10) to each plant. Dig it in lightly and give a thorough soaking if needed. Their fleshy tubers grow deep. Should your old peonies fail to bloom, they may be planted too deep. Only two inches or less of soil should be directly above the eyes or buds of the tubers.

Some varieties that do well in Ozona: Doubles - Tempest, dark red but glowing; Mons Jules Elie, early all-time great pink; Festiva Maxima, early white with red flecks; The Mighty Mo, early velvety red; John Harvard, early red hybrid; Henry Sass, early white; Ruth Clag, red. Japanese - Van Houte, red; Shaylor's Sunburst, white with yellow center; Nippon Beauty; Man O'War; Nippon Gold, light pink; Largo, deeper pink. Singles - Angelus, white; Man of war, red; Fortune Teller, red; Sea Shell, beautiful pink; Krinkled White; "Le Jour", fine white.

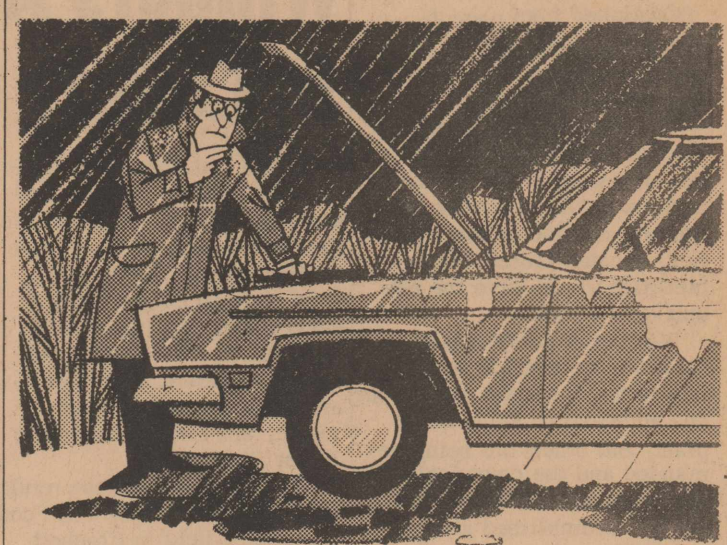

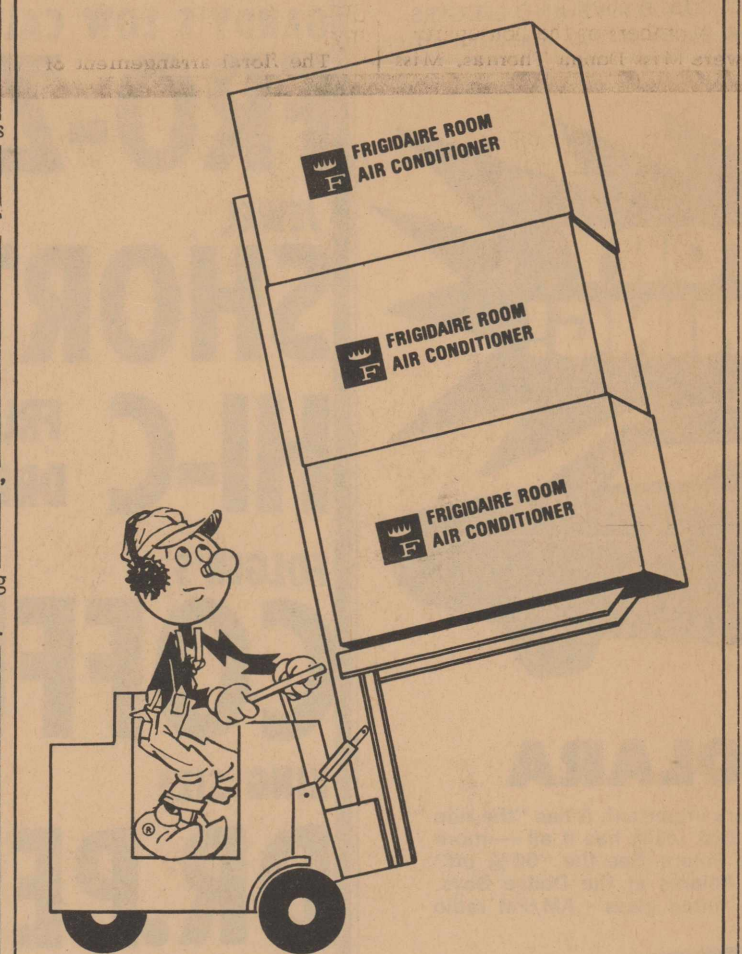

(Continued from page 1) will be large enough for two beds if necessary, thus providing a 40-bed facility.

The present hospital building can be expanded by addition of a wing to the north or to the west, but the west expansion was considered more practical because present kitchen facilities would serve the new unit conveniently.

Various requirements of Medicare have made it necessary to make certain alterations and additions to the hospital plant, but others are being demanded and the court feels that the necessary modernization can be accomplished along with the nursing home project if the voters approve the project when the bond issue is submitted at a later date. No cost estimates have been made pending completion of preliminary work by architects.

(continued from page one) the American taxpayer 100 billion dollars a year. Welfare may need reform but I don't go for that kind of stuff. Those in actual need should be helped but I don't believe that one cent of relief money should go to an able bodied man who won't work."

Bussing may not have much significance in this area, Mr. Fisher said, but in much of the country it is the number one issue. The courts have gone wild, the Congressman said, in expanding the Supreme Court's anti-discrimination stance. It is not a civil rights issue, it is purely a flair of arrogant power that the courts are exercising. He said that he is co-sponsor of a resolution calling for a constitutional amendment clearly outlawing busing for the sole purpose of mixing the races. Neither whites, blacks nor Mexican-Americans favor such disregard of their right to send their children to neighborhood schools, he said.

A ranking member of the Armed Services Committee, Congressman Fisher is concerned about the push of the "Disarmament Lobby" which is allowing the Russians to catch up with us in armaments and ultimately to surpass us.

"We can have peace but it will take vigorous action on the part of the people of this nation if we are to maintain our position of strength which is the only position you can successfully bargain from in this kind of world."

**Tower Seeks Delay of Ban On Predator Poison**

Austin, Texas -- Senator John Tower today requested Interior Secretary Rogers Morton to delay implementation of an executive order banning use of poisons for predator control on federal lands until a study of other possible means of control is completed.

Tower said he also had been in contact with officials of the U. S. Department of Agriculture on the problem, which he described as "most serious" for sheep and goat raisers in Texas and other parts of the nation.

The senior Texas senator suggested that the ban on predator control could be delayed at least until the livestock industry is given a review of the government's Cain Report on predator problems.

"There is some research now going on in the use of sterilants and chemical repellants, but nothing conclusive is yet known of their effectiveness," Tower pointed out.

Tower said some livestock raisers already are talking about a "population explosion" of coyotes in the western parts of the United States, and many fear that sheep losses may double within a year unless some form of predator control is practiced.

"Certainly I am interested in protecting our environment," Tower said he had told Secretary Morton, "but we must consider the effect such a restriction will have on the protection of sheep and goats from predators."

"Federal lands which have been leased for grazing will now be open to predators except for the protection of big game for trapping and hunting. Needless to say, these methods will fall short of offering the needed control."
