We finally hit on a plan. J.C. had his head kinda rolled off the side of the bench. His mouth was half open and he was snoring something fierce.

We got a dipper that didn't have much water left in it. Very little, in fact, and we dared each other to pour a little in his mouth. And we did!

I don't know whether you've ever seen very many people drown or not but he took that water in one big snore and near died. He came up from there fighting like a madman. EDITORIAL

To get things done takes a lot of perseverance and it looks like if Seminole gets an adequate supply of doctors and hospital facilities, we're just going to have to keep on keeping on. There's no doubt in my mind that we're going to get them. When I start thinking on a success story, I can't help but think about a little rat terrier dog we used to have. (It could have been a fox terrier and it could have been mixed with something else.) And for the life of me I can't remember what its name was. It could have been Cannonball, intoxicated or Spot. He was not much larger than your hand but he owned a success story that was unreal. He hated rattlesnakes. When he found a rattlesnake, he started with that patented high bark of his that not only bothered the snake, it bothered the other dogs and other animals on the farm, plus the people. Now, if you were a little dog and found a huge Diamondback rattler, what would you do? Go off and tell the bigger dogs? Go complain to the other animals? Rush to the master's house while the snake got safely away? Night or day, it made very little difference, when Cannonball found a rattler, he set up his pattern. He worked him away from the brush or a den and got him in a good open space and began to work. He hastened his steps. His bark got shriller and higher pitched. He went around and around the snake. He moved his 12 foot circle in a few inches at a time and made that snake watch him as he went round and round. He traveled that circle one time, two times, ten times, fifty times, one hundred times. No, a thousand times. How many steps? Maybe a million.

The snake watched for his opportunity. He struck out. Ah, he missed by one clean foot. Little Cannonball was in; he was out. He was round and he was about. He probably got tired, but no thought of giving up. He didn't eat. He didn't drink. The night wore on. He kept faking that snake. The hours wore on. Two hours, three hours, four hours. Five hours? The snake became weary, only to have the dog move in his circle a tiny bit more, which made the snake have to move its head more, to watch the complete circle. He struck again. He got closer, but like a flash, Cannonball only answered him with his rhythmic barking. Sometimes help was forthcoming and the master shot the snake. But then there were times when help was not available. The milk cows came by on their way to pasture and cast an admiring glance at the little dog and gave them plenty of room. Public Meeting

The County Judge and the County Commissioners have accepted an invitation from the Seminole Area Chamber of Commerce for a public meeting to discuss the problems related to attracting doctors to Seminole. Competition for general practitioner has reached the point that it requires a tangible effort on the part of any community to draw these sought after men.

The Chamber of Commerce feels we must evaluate what we need to offer; what we don't have to offer; what we need to acquire; and what we feel must be done.

The meeting will be at 8:00 p.m. in the District Court Room, second floor of the courthouse, Thursday, July 30, 1970. Everyone is urged to come; bring your questions and answers.

Seminole is not only faced with the loss of its hospital, but with the far reaching effect of such a loss to the community.

City Budget \$360,250.00

The City Council met Monday night and set a tentative budget of \$360,250.00. The hearing on the tentative budget will be held August 24, 1970. In the income department the sale of water is the largest item - \$90,000.00, with trash haul the next largest item - \$70,000.00, taxes \$70,000.00, sales tax \$55,000.00. The income, like the budget, is tentative and approximate.

Some of the larger items in city expense are salaries. The Sanitation Department salaries are estimated at \$67,000.00, Police \$42,000.00, Water and Sewer \$65,000.00, one new water well to the field, plus rework on existing wells \$20,000.00 and street lights and equipment \$12,000.00, along with other estimated expenses.

The Council also set a tax rate of \$1.15, the same as last year, with Ruby Frost, city secretary, pointing out the city's approximate evaluation of \$15,586,000.00.

New Hospital Estimates

The architect firm of Stiles, Roberts & Messersmith, in conjunction with the firm of O'Connell & Probst, has released a revision of the hospital survey made May 21, 1970 and revised July 27, 1970.

The alternate survey points out the cost of a new twenty bed hospital and clinic at Seagraves at a total of \$792,000.00. A new one in Seminole at a cost of \$1,219,500.00. Another route would be to remodel and make an addition to the present structure in Seminole at a cost of \$787,500.00, for a total of \$1,579,500.00 for a new hospital in Seagraves and the remodeling of the present structure and the addition in Seminole.

The architect firm recommended and broke it down as follows:

George W. Sultemeier has joined the technical staff of Texas Research Foundation as agronomist and pasture-rangeland specialist.

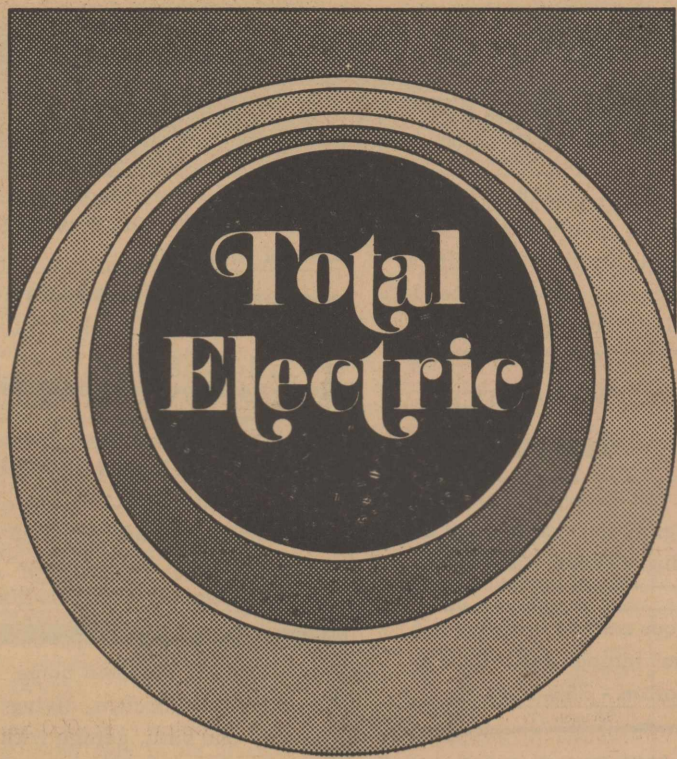

PUBLIC NOTICE

**Proposed CONSTITUTIONAL AMENDMENT
NUMBER ONE ON THE BALLOT (HJR30)
General Election Nov. 3, 1970**

BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:

Section 1. That Subsections (5), (6), (7), (8), (9), (11), (12), and (13), Section 1-a, Article V, Constitution of the State of Texas, be amended to read as follows:

"(5) The Commission may hold its meetings, hearings and other proceedings at such times and places as it shall determine but shall meet at Austin at least once each year. It shall annually select one of its members as Chairman. A quorum shall consist of five (5) members. Proceedings shall be by majority vote of those present, except that recommendations for retirement, censure, or removal of any person holding an office named in Paragraph A of Subsection (6) of this Section shall be by affirmative vote of at least five (5) members.

"(6) A. Any Justice or Judge of the Appellate Courts and District and Criminal District Courts, any County Judge, and any Judge of a County Court at Law, a Court of Domestic Relations, a Juvenile Court, a Probate Court, or a Corporation or Municipal Court, and any Justice of the Peace, and any Judge or presiding officer of any special court created by the Legislature as provided in Section 1, Article V, of this Constitution, may, subject to the other provisions hereof, be removed from office for willful or persistent conduct, which is clearly inconsistent with the proper performance of his said duties or casts public discredit upon the judiciary or administration of justice; or any person holding such office may be censured, in lieu of removal from office, under procedures provided for by the Legislature.

"B. Any person holding an office named in Paragraph A of this subsection who is eligible for retirement benefits under the laws of this state providing for judicial retirement may be involuntarily retired, and any person holding an office named in that paragraph who is not eligible for retirement benefits under such laws may be removed from office, for disability seriously interfering with the perform-

ance of his duties; which is, or is likely to become, permanent in nature.

"(7) The Commission shall keep itself informed as fully as may be of circumstances relating to the misconduct or disability of particular persons holding an office named in Paragraph A of Subsection (6) of this Section, receive complaints or reports, formal or informal, from any source in this behalf and make such preliminary investigations as it may determine. Its orders for the attendance or testimony of witnesses or for the production of documents at any hearing or investigation shall be enforceable by contempt proceedings in the District Court.

"(8) After such investigation as it deems necessary, the Commission may in its discretion issue a private reprimand, or if the Commission determines that the situation merits such action, it may order a hearing to be held before it concerning the removal, or retirement of a person holding an office named in Paragraph A of Subsection (6) of this Section, or it may in its discretion request the Supreme Court to appoint an active or retired District Judge or Justice of a Court of Civil Appeals as a Master to hear and take evidence in any such matter, and to report thereon to the Commission. If, after hearing, or after considering the record and report of a Master, the Commission finds good cause therefor, it shall issue an order of public censure or it shall recommend to the Supreme Court the removal, or retirement, as the case may be, of the person in question holding an office named in Paragraph A of Subsection (6) of this Section and shall thereupon file with the Clerk of the Supreme Court the entire record before the Commission.

"(9) The Supreme Court shall review the record of the proceedings on the law and facts and in its discretion may, for good cause shown, permit the introduction of additional evidence and shall order public censure, retirement or removal, as it finds just and proper, or wholly reject the

recommendation. Upon an order for involuntary retirement for disability or an order for removal, the office in question shall become vacant. The rights of an incumbent so retired to retirement benefits shall be the same as if his retirement had been voluntary."

"(11) The Supreme Court shall by rule provide for the procedure before the Commission, Masters and the Supreme Court. Such rule shall afford to any person holding an office named in Paragraph A of Subsection (6) of this Section, against whom a proceeding is instituted to cause his retirement or removal, due process of law for the procedure before the Commission, Masters and the Supreme Court in the same manner that any person whose property rights are in jeopardy in an adjudicatory proceeding is entitled to due process of law, regardless of whether or not the interest of the person holding an office named in Paragraph A of Subsection (6) of this Section in remaining in active status is considered to be a right or a privilege. Due process shall include the right to notice, counsel, hearing, confrontation of his accusers, and all such other incidents of due process as are ordinarily available in proceedings whether or not misfeasance is charged, upon proof of which a penalty may be imposed.

"(12) No person holding an office named in Paragraph A of Subsection (6) of this Section shall sit as a member of the Commission or Supreme Court in any proceeding involving his own retirement or removal.

"(13) This Section 1-a is alternative to and cumulative of, the methods of removal of persons holding an office named in Paragraph A of Subsection (6) of this Section provided elsewhere in this Constitution."

Sec. 2. The foregoing constitutional amendment shall be submitted to a vote of the qualified electors of this state at an election to be held on the first Tuesday after the first Monday in November, 1970, at which election the ballots shall be printed to provide for voting for or against the proposition: "The constitutional amendment relating to the removal, retirement, or censure of Justices, Judges, and Justices of Peace under prescribed circumstances."

**Texas
Peanut Producers Board**

A full Board Meeting of the Texas Peanut Producers Board was held in Fort Worth July 10, 1970 with all members present except one. The following action was taken:

To fund to the National Peanut Council our proportionate share of funds assessed Southwest growers for promotion and research on the national level. Promotional activities will also include some work abroad. Expense for this program is pro-rated between the three producing areas in the nation based on total tonnage marketed in each area. The Southwest's portion will be pro-rated by the same standard to the three grower organizations in this area - the Texas Peanut Producers Board, the Oklahoma Peanut Commission, and the Southwestern Peanut Growers' Association.

The Board voted to fund to the Texas Agricultural Extension Service \$1,000 to carry out an extension program at Stephenville on peanut disease control under the direction of Dr. Wendell Horne.

The Board also voted to fund the Texas Agricultural Experiment Station \$7,800 in support of continuing Aflatoxin research. U. S. D. A. funds expired in June, but it is believed more federal funds will be available soon to resume this work.

PUBLIC NOTICE

**Proposed CONSTITUTIONAL AMENDMENT
NUMBER TWO ON THE BALLOT (SJR10)
General Election Nov. 3, 1970**

BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:

Section 1. That Subsection (a), Section 20, Article XVI, Constitution of the State of Texas, be amended to read as follows:

"(a) The Legislature shall have the power to enact a Mixed Beverage Law regulating the sale of mixed alcoholic beverages on a local option election basis. The Legislature shall also have the power to regulate the manufacture, sale, possession and transportation of intoxicating liquors, including the power to establish a State Monopoly on the sale of distilled liquors.

"Should the Legislature enact any enabling laws in anticipation of this amendment, no such law shall be void by reason of its anticipatory nature."

Sec. 2. The foregoing constitutional amendment shall be submitted to a vote of the qualified electors of this state at an election to be held on November 3, 1970, at which election the ballots shall be printed to provide for voting for or against the proposition:

"Repeal of the prohibition against open saloons found in Section 20, Article XVI of the Constitution of the State of Texas."

Letters to the Editor

Dear Mr. Woods:

There is an emergency facing our community and it is imperative that we do something about it.

THE PROBLEM: The Memorial Hospital of Seminole, Texas will be closed August 31, 1970 unless another medical doctor or doctors are brought to Seminole. A part solution to the problem is for some group of our community to purchase the clinic now owned by Dr. H. D. Dow and Mrs. Hildy Koberg and use it in any way possible to entice doctors.

An explanation to the above, Dr. Dow states that he will no longer continue a hospital practice after August 31, 1970 without another physician on the medical staff. A hospital cannot operate in any capacity without a physician. Some hope Dr. Dow will change his mind. Dr. Dow is familiar with the work and pressure of working by himself, having done so six months last year. I feel he has agreed to work to the limit of his endurance.

The last Medicare inspector was aware of our circumstance and ask both Dr. Dow and myself to advise him immediately of our closure. We would in all probability lose our Medicare certification and, according to agency sources, be unable to participate in the future. Although only about 1/3 of our income is from Medicare and Medicaide. The Medicaide program is a sleeping giant and should involve another 1/3 of our income by 1975. Seminole needs to maintain a continous hospital program.

The hospital board has worked very diligently in trying to recruit doctors. It has now reached the point of what do we have to offer physicians? First of all there has been little doubt in the mind of any prospective doctor that he will be able to maintain a thriving practice here. At this point the prospects starts comparing what Seminole has to offer with the offers from other fruitful areas.

The pertinent question then is what do we have to offer besides the promise of a going practice? There are many intangible items; an excellent school system, a stable economy, and active churches. Yet, we need more; something tangible. The two doctors the hospital board is working with will consider moving to Seminole if the above clinic is purchased by someone who is willing to furnish free rent for one year. The alternate suggestion of providing clinic space in the hospital was considered but was refused. One of the reasons for opposition to putting the clinic in the hospital is that a minimum of seven beds that are needed during high occupancy would be eliminated.

In conclusion we have an emergency that must be alleviated in the next 33 days, the clinic should be obtained at the earliest possible moment, and we should seek other ways of making our medical environment more promising.

It would be futile to continue our exchange of views because you will not listen to me, and I have wasted too much of my life listening to apathetic conservatism espoused by people such as yourself.

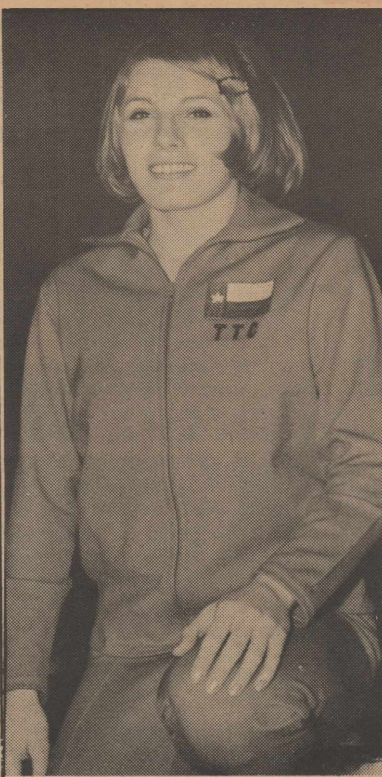
