

# SHEEP LOST TO COYOTES

A group of area ranchers and farmers gathered last Friday night at Jo's Restaurant to discuss the predatory control of coyotes in Gaines County. Gene Iparrea, who has 6000 sheep in the county at the present, said, "I have lost at least 53 head, actual count, to coyotes."

It was pointed out in the meeting of some twenty men that Gaines County now has 40,000 head of sheep with the group present owning above 30,000 head. To show that something had to be done it was pointed out that as many as 100 head a day were being lost to the coyotes, about half of them newborn lambs.

They formed the Gaines County Predatory Control Association with the following men as its officers: Jay Harris - president; Joe Foshee - vice president; George Sultemeier - secretary; and Luther Cope as their treasurer.

The new association claimed 21 members. \$1120 was donated at the meeting, showing their sincerity in having something done. They agreed on 10¢ per head for a fair figure for members to participate. Other interested persons without livestock gave strictly donations.

Ben Meith and Sultemeier will head up a group to encourage other interested farmers, ranchers and business people to join. Mr. H. D. Ellard, Department of Sports, Fish and Wildlife, was present, pointing out that conditions had grown much worse in the 73 counties over which he directs 35 government trappers. He pointed out that ten years ago there were two government trappers in the county. Today there's only one.

Mr. Sultemeier told the News "If we can guarantee \$250 per month the government will pay a like amount for Gaines County to have an extra trapper. Mr.

Floyd, the government trapper in the county now, is limited on what he can do because of his 1500 miles travel allowance for the month. This organization would like to help out on that, too."

Pete Flippo reported to the Gaines County News that following the snow he had observed a pack of coyotes following his cattle. The Seagraves paper reported a population increase of coyotes in the past few months.

## WIG DAVIS HURT \*\*\*\*\* Chamber Banquet Friday Night

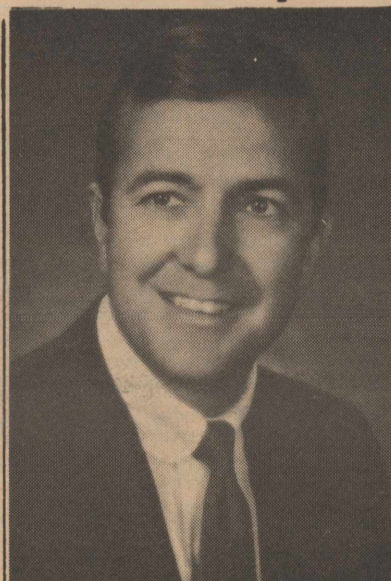


A 1969 Volkswagen driven by Billy Earl (Wig) Davis, 27.

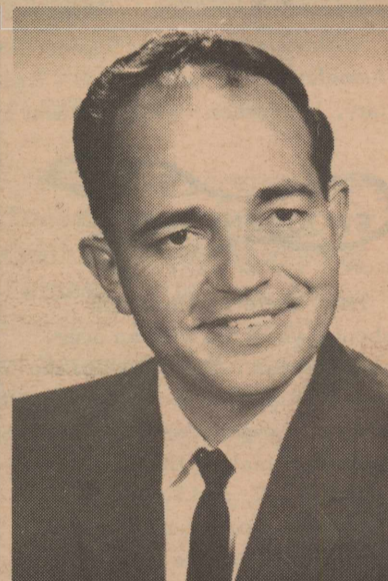
Billy Earl (Wig) Davis, 27, suffered a broken back and remains in a paralyzed condition from the waist down in a Lubbock hospital after an automobile mishap at 4 a. m. January 1. Davis was reported to have returned from Hobbs after carrying his girlfriend home from Seminole, apparently falling asleep 2.2 miles west of Seminole, striking a farm trailer and turning over three times. He was driving a 1969 Volkswagen and apparently crossed the center line, striking

a two axle farm trailer being pulled by a Chevrolet pickup driven by James Doughty of Gurdon, Arkansas. Two other passengers along with the driver of the pickup were unharmed.

Damage to the auto was estimated at \$2200. Davis, a graduate of Seminole High School, is the son of Mr. and Mrs. Carl Davis. He was recently released from the service and was coaching and teaching in New Deal, Texas.

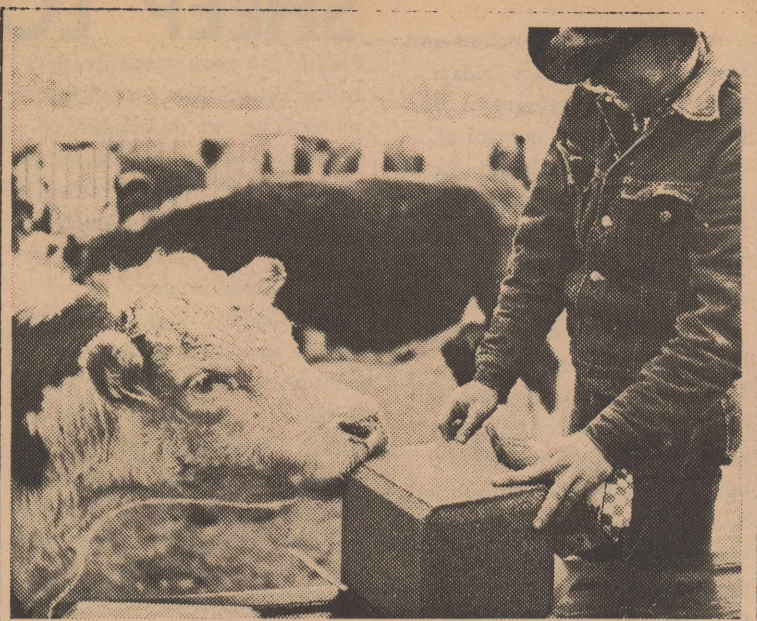

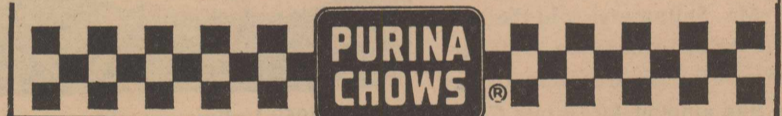

### LYNN GARRETT SUFFERS KNEE INJURY

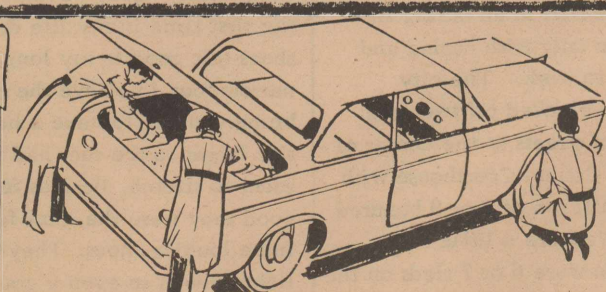

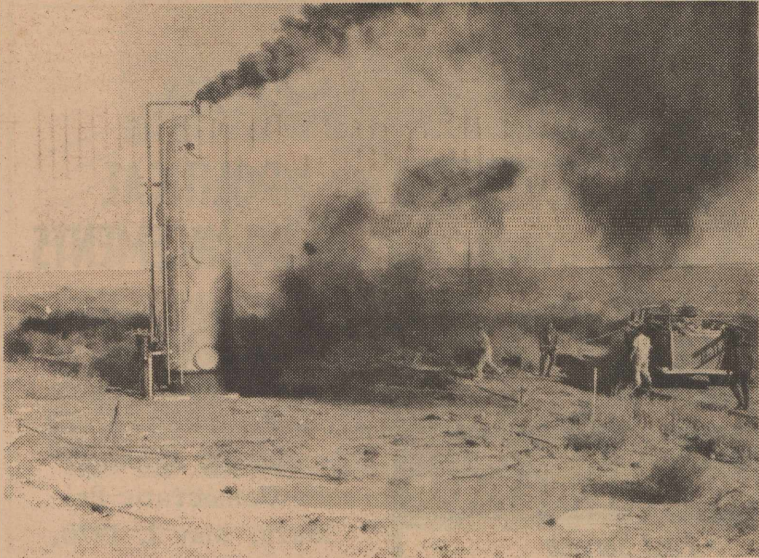

### Information From Social Security Office

BY DOROTHY FEAZELL

QUESTIONS ASKED BY CALLERS AT THE ODESSA SOCIAL SECURITY OFFICE AND THE CONTACT STATIONS IN GAINES COUNTY HAVE SHOWN ME THAT MANY ARE CONFUSED AS TO HOW SOCIAL SECURITY PAYMENTS ARE FIGURED.

SOME PERSONS THINK SOCIAL SECURITY PAYMENTS ARE BASED ON AN INDIVIDUAL'S HIGHEST THREE YEARS OF EARNINGS. ACTUALLY, THE FORMULA USED IN FIGURING A PERSON'S SOCIAL SECURITY PAYMENT DEPENDS ON HIS OR HER YEAR OF BIRTH.

FOR EXAMPLE, IN THE CASE OF A MALE RETIREE WHO WAS BORN IN 1904, SOCIAL SECURITY COUNTS THE YEARS FROM 1951 TO THE YEAR HE BECOMES 65 OR 18 YEARS. THE FIVE YEARS OF LOWEST EARNINGS ARE THEN DROPPED WHICH MEANS THAT 13 YEARS OF HIGHEST EARNINGS SINCE 1951 ARE USED IN FIGURING THE PAYMENT AMOUNT.

A SECOND METHOD COULD BE USED USING EARNINGS FROM 1937-1950, TOO IF IT WOULD GIVE A PERSON A HIGHER AVERAGE. FOR A FEMALE RETIREE, YEARS FROM 1951 TO AGE 62 ARE CONSIDERED. THE EXCLUSION OF FIVE YEARS OF LOWEST EARNINGS ALSO APPLIES TO THE FEMALE RETIREE.

OCCASIONALLY A PERSON INDICATES THAT HE THINKS SOCIAL SECURITY PAYMENTS ARE BASED ON NEED. ACTUALLY, THEY ARE BASED ON THE SOCIAL SECURITY LAW AND EARNINGS A PERSON HAS HAD DURING HIS WORKING YEARS. A PERSON WHO HAS ALWAYS HAD A GOOD SALARY CAN ANTICIPATE A LARGER PAYMENT AMOUNT THAN THE PERSON WHOSE SALARY WAS LESS. PAYMENT FORMULAS ARE A PART OF THE SOCIAL SECURITY LAW, AND PAYMENT AMOUNTS DERIVED FROM THESE FORMULAS ARE A PART OF THE SOCIAL SECURITY LAW, AND PAYMENT AMOUNTS DERIVED FROM THESE FORMULAS ARE GUARANTEED THE INDIVIDUAL REGARDLESS OF HIS NEEDS.

REGISTRATION SHOULD BE FASTER THIS YEAR. If a motorist goes to the county tax office or a substation, all he need take is the three part form -- the motor vehicle registration application -- that came in the mail. And the registration fee, of course.

If he should find a line, chances are it will be shorter and faster-moving than any he remembered from previous years.

All he needs do is to present the renewal application and pay the fee. The clerk will validate the application with the new license numbers and return part of the form as a receipt.

Another part of the form is retained for the county's records and the third is sent to the Motor Vehicle Division of the Texas Highway Department in Austin.

Should the vehicle owner decide to register his vehicle by mail, he sends the entire renewal application, the fee and an additional \$1 to his county tax officers. The \$1 additional charge is provided by statute to cover the cost of handling and postage.

The registration "season" begins at county tax offices and substations on February 1. The vehicle owner can register his vehicle in person until April 1.

If he wants his plates mailed to him, he must send in his application, the fee and the \$1 postage and handling charge to his county tax officer by March 1.

Easy-to-follow instructions are printed on the three-part form. The Highway Department asks that the owner leave the form intact and that he not separate the three parts.

The responsibility continues as he answers questions on these subjects abroad with the climax coming when he returns home to report in person through talks and lectures. Following a four week "home-stay" the ambassador will be allowed an informal trip of several weeks.

DEADLINE FOR COMPLETED APPLICATIONS IS FEBRUARY 5, 1970

**GENERAL REMINDERS ON QUALIFICATIONS OF APPLICANTS**

1. The applicant must be able to adapt to a variety of situations. The nature of the project requires adaptability, flexibility, intelligence, and a spirit of cooperation and responsibility as well as a sincere interest in international relations.
  2. Applications will be considered from anyone in the 18-30 age group.
  3. Only applications from single persons will be considered.
  4. At the completion of the program and after returning to Seminole, the ambassador will be available for speaking and personal appearances. In the case of college students this might mean remaining out of school during the fall semester. (Draft status of male students will be considered before enforcing this requirement.) Employed persons would have to submit a letter from employer agreeing to this arrangement of appearance availability.
  5. Applicants will have considerable say in the choice of country; about 48 countries are involved in the program. However, the Club will approve the country which the ambassador will visit.
  6. The applicant must agree to attend a two week language school, at the expense of the Club, if this is deemed necessary by the membership of the Club.
  7. The applicant must be a resident within the boundaries of the Seminole School district. In the case of college students, if your family still resides within the district, you will be considered a resident.
  8. Only complete application forms will be considered. This includes the general membership application as well as the registrar's form, the physician's report, personal description form, "Dear Family" letter, and three confidential reference sheets.
