Retired Teachers meet

The Coke County Retired Teachers met on Monday, September 12, 2015 at the First Baptist Church in Bronte for the first regular noon meeting. Following lunch, a meeting including minutes, treasurer's report, and committee reports was conducted.

Treasurer Janet Wommack reminded the group that the dues (\$35 TRTA and \$5 local) could

be arranged as a payroll deduction. Any retired school personnel who wish to add their names to support teacher and retired teacher interests in Austin and fund local projects may send dues to the treasurer at Box 365, Bronte, Tx. 76933.

A note and picture was received from the Robert Lee Sr. Class of 2015, thanking the CCRTA for a donation to Project Graduation. The note will be added to the CCRTA scrapbook.

President Kelso reported on the meeting with the San Angelo Retired Teacher Assn. to hear Tim Lee discuss teacher and retired teacher issues. A strong membership showing will be needed to denote support to those representatives and senators who will be voting positively on TRTA retirement and health care in the future. It is noted that teacher retirement is not an "entitlement." Teachers and retired teachers paid into TRA in lieu of Social Security throughout their careers which is comparable to paying into a 401 retirement savings account.

The President also announced that District XV President Lynn Granzin would be attending the October meeting on Monday,

October 19, 2015. A good turnout will indicate CCRTA's support of District XV concerns. Good food is guaranteed.
