Of Love and Warts

by James M. Decker Let's start with an honest admission: our communities have warts. Our streets could be better. We don't pick up trash as well as we should. It's a challenge to attract stable new jobs that pay well. Our local history has unsavory blemishes. And yet, if we're in a

community position of leadership - business owner, elected official, leader of an organization, etc. - we love the place as well. If we didn't have any love for it, we wouldn't invest our time and/or money in the place and its people. But beyond that investment, how well do we show that love?

A favorite podcast of mine is one called "Mountain and Prairie." It focuses on life and culture in the American West, with extensive discussions on conservation, agriculture, and the outdoors. A recent episode interviewed Christian Beckwith, an outdoors advocate from Jackson Hole, Wyoming. On preserving the outdoors and Western lifestyles, Mr. Beckwith said something particularly moving: "any time we try to encourage more people to fall in love with these places, we are in a better position as a result to protect them."

He then dropped this line, which hit me like a ton of bricks in the context of rural communities: "you're not going to fight for anything you don't

Perhaps most importantly, what does it say to our young people who are trying to decide their future path, and whether their hometown will have a place in their life or not? If the leaders don't appear to love the place, why should anyone else

love it? If we care about our rural places, we surely want to see them survive and thrive into the future. We know that goal takes more than just us. It requires inspiring others to invest in that goal. But first, we have to inspire them to love our place. In the words of Christian Beckwith, people will not fight for something that they don't love.

I leave you with this: if you love your place, show it. Don't just assume that your role in that place expresses your love to others. If you use more words on the warts than your love, think about how to change that. As a thought exercise, spend a few minutes writing down all the reasons you love the place. You'll be surprised how much love you do have. After you do, don't be afraid to show that love to others. You might inspire some others to love it and fight for it just as much as you do.

Judge Blair adjourned the meeting at 9:38 am.


Bronte City Council Meeting minutes told

Citizens of Coke County

The exchange of services between County and City is governed by law in the Texas Constitution, Article III Section 52, which prohibits one governmental entity from making a gift to another entity. From time to time, it is important for our elected officials to review exchanges to ensure all entities are within the law. It's my opinion that in the past, County Commissioners violated this law by maintaining the streets in the City of Bronte without "fair compensation" as required by our Constitution.

However, in the past three years, the Bronte City Council and the Coke County Commissioners Court have agreed upon a new Interlocal Agreement and set policies that have been adopted by both to address how Coke County can help Bronte with its municipal streets. I believe this new agreement helps ensure that Bronte and Coke County are now in legal compliance. Neighboring counties are also going through similar challenges, and are adapting new ways and in some cases, new fees to generate revenue for city street repairs.

For Bronte property owners, the portion of your property taxes that goes to Coke County covers a variety of services mandated by State law, including all the functions of the Courthouse (Judge, Clerk, Auditor, Tax Assessor, Treasurer, et al.) and the Sheriff's office. Additionally, part of your taxes covers the cost of non-mandated services like your park, Senior Citizens Center, and rural transportation. What they do not cover (legally) is the municipal streets in the City of

CVEC Scholarship

Established to provide financial assistance for qualified individuals seeking a college, trade school or university education.

Concho Valley Electric Cooperative offers four \$2,000 scholarships. Two scholarships are awarded to graduating high school seniors and two are awarded to other students of higher learning.

2018 Guidelines

- The applicant must be an active CVEC member whose primary residence is served by CVEC, OR be the dependent of a CVEC member whose primary residence is served by CVEC.
- The applicant will be chosen based on the following criteria: grades, leadership, community, school activities and essay.
- · Permissible use of funds include payment of tuition, fees required for books, supplies and/or equipment required for courses of instruction.
- The recipient must attend a recognized Texas institution of higher education, including certified trade schools, while pursuing a degree at any level.

Recipients

Recipients must obtain at least a 2.5 cumulative grade point average on a 4.0 scale and carry a minimum of 12 hours or be considered by the registrar to be a full-time student. One half of scholarship is awarded at the beginning of the Fall Semester and the remaining one half is awarded at the beginning of the Spring semester.

Note: If recipient's cumulative GPA falls below 2.5 or if the recipient fails to register as a fulltime student for the spring semester, recipient will be placed on probation for one semester. If probationary issues are not corrected within the following semester, the remaining scholarship funds allotted to that student (\$1,000) will be revoked. If the recipient fails to enroll or register for any course work during the spring semester the remaining scholarship funds allotted to that student (\$1,000) will be revoked.



What Should You Do With Your Tax Refund?

You may not get much of a thrill from filing your taxes, but the process becomes much more enjoyable if you're expecting a refund. So, if one is headed your way, what should you do with the money?

The answer depends somewhat on the size of the refund. For the 2017 tax year, the average refund was about \$2,760 - not a fortune, but big enough to make an impact in your life. Suppose, for example, that you invested this amount in a tax-deferred vehicle, such as a traditional IRA, and then did not add another penny to it for 30 years. At the end of that time, assuming a hypothetical 7 percent annual rate of return, you'd have slightly more than \$21,000 -not enough, by itself, to allow you to move to a Caribbean island, but still a nice addition to your retirement income. (You will need to pay taxes on your withdrawals eventually, unless the money was invested in a Roth IRA, in which

case withdrawals are tax-free, provided you meet certain conditions.)

Of course, you don't have to wait 30 years before you see any benefits from your tax refund. If you did decide to put a \$2,760 tax refund toward your IRA for 2018, you'd already have reached just over half the allowable contribution limit of \$5,500. (If you're 50 or older, the limit is \$6,500.) By getting such a strong head start on funding your IRA for the year, you'll give your money more time to grow. Also, if you're going to "max out" on your IRA, your large initial payment will enable you to put in smaller monthly amounts than you might need to contribute otherwise.

While using your refund to help fund your IRA is a good move, it's not the only one you can make. Here are a few other possibilities:

some time or another, most of us probably feel we're carrying too much debt. If you can use

your tax refund to help reduce your monthly debt payments, you'll improve your cash flow and possibly have more money available to invest for the future.

Build an emergency fund. If you needed a new furnace or major car repair, or faced any other large, unexpected expense, how would you pay for it? If you did not have the cash readily available, you might be forced to dip into your long-term investments. To help avoid this problem, you could create an emergency fund containing three to six months' worth of living expenses, with the money kept in a liquid, lowrisk account. Your tax refund could help build your emergency
