Council Member Brandi Brosh was absent, however a quorum confirmed.

The invocation was provided by Mayor Pro Tem Roger C. Alexander Jr. and the Pledge of Allegiance was recited by those in attendance.

Budget amendments available at Floyd C. Petitt required to be done within the appropriate fiscal year; because the deadline was missed, there will not be a final budget amendment for FY 2017-18.

Sanitation Fund Excess of Revenues Over Expenditures on the Statement of Revenue and Expenditures is in the amount -\$9,963.59. Trash Receipts are in the amount \$141,514.53 with Trash Service expense in the amount \$157,452.91. Citizens were receiving trash services but not being billed appropriately. Convenience Center expenses for roll-off containers have also been used more frequently. Citizens outside of city limits have been utilizing the Convenience Center at the citizens of Robert Lee's expense. Transfer of funds have not been done throughout FY 2016-17 or the beginning half of FY 2017-18; The transfer deposits will likely put Sanitation into the "black".

Council requests to see Statement of Revenue and Expenditures for full months. Current month is only partial due to council meeting in the middle of the month.

Water Department staff is looking into the 420,000 gallons of water loss, per the Monthly Billing Report, between Bronte and Robert Lee's meter.

The Happy Porch invoice in the amount \$252.00 is uniform t-shirts & sweatshirts for City Water Department staff.

Council Approval Report does not update the YTD Balance until invoices are posted to the account.

A motion was made by Mayor Pro Tem Roger C. Alexander Jr. to approve of Consent Agenda Item B; and was seconded by Council Member Janie Munoz. Vote 4-0; Motion carried

A motion carried from the September 10, 2018, City Council meeting to amend citizens' trash rates with a 25% increase from what Republic Services charges the City resulted in rates reduced policies from what was currently being charged.

A recent situation with a citizen made it clear that Ordinance #1110 (Nuisance Amendment) should be clarified and updated following current State law. There has been some confusion regarding responsibility of mowing the City's Easement, defined as rights to the use of others' property for limited purposes.

It was proposed to establish a records management program, and procedures consistent with the Local Government Records Act, designate a Management Officer and repeal Ordinance No. 1015 (previous record retention ordinance).

A motion was made by Mayor Pro Tem Roger C. Alexander Jr., 3yd (1xweek) - Current \$51.34, to approve of the Record Retention Ordinance; and was Del/Rem 96-Gallon Cart – seconded by Council Member Approved Ann Hedges. Vote 4-0; Motion carried

It was proposed to amend Ordinance No. 1199 (Water Rate), Section 2: Truck Water from \$0.20 per barrel to \$0.25 per barrel or \$5.95 per thousand gallons and to repeal all past Water Ordinances.

A motion was made by Council Member Janie Munoz to approve of amending the Water Ordinance with the bulk water rate increase; and was seconded Council Member Ricky Green. Vote 4-0 Motion carried

The City of Robert Lee received a letter dated September 14, 2018, from the Coke County Water Supply Corporation stating: enclosed you will find our full payment of \$7,609.73 for

If rates increase with the City of Bronte, CCWSC agrees to Capital Improvement - \$1.25 x increase the rates per thousand on their invoice. Council wants to continue to charge Improvement and water debt.

The Closet opens at Robert Lee ISD





Citizens request reconsideration of a Culligan Dispenser. No discussion was held and no action was taken at this time.

RLVFD sent a request for assistance however no discussion was held and no action was taken.

Previous Mayor Leroy Casey returned bond funds in the amount \$750,000 to the Texas Water Development Board on May 7, 2018. Mayor Casey did not correctly submit forms when returning the funds. An Outward Expression of Christmas

By James M. Decker Last week, I wrote about the seemingly inevitable stress, exhaustion, and annoyance of the Christmas season. encouraged each of us to focus on hope—the hope provided by the birth of Jesus Christ and the hope that we can find in our own lives. In his classic song "If Make It Through December," Merle Haggard has very few obvious reasons for hope, but he still has hope all the same. If he can find hope, in the context of that song, we too can find hope in our lives.

On my mind today is how we can actually express that hope that underlies Christmas. How can we end the cycle of holiday - exhaustion, annoyance? It shouldn't have to be inevitable. We shouldn't have to fight it. We shouldn't have to find reasons to take a step back and escape it. It's easy to blame "society"

commercialization of Christmas and encouraging obsession in pursuit of holiday perfection. But society is a "we," not a "they." Even if we are but a tiny fraction of society, we're still part of the society that creates and exacerbates those feelings in each of us. We can't and shouldn't wait on "them" to improve society, we must look for ways that "we" can improve society.

We can and should start in our own homes and communities. This goes even beyond my encouragement last week to worry less about trying to provide the perfect Christmas for friends, family, or community. For many in our communities, perfection in Christmas isn't even a consideration. For numerous reasons, folks are merely trying to survive Christmas.

Christmas is expensive. The cost of Christmas gifts, trees and ornaments, maybe even a few outside decorations and lights, is staggering. That's before we get to the cost of a Christmas dinner for a family. For families living from paycheck to paycheck, it's an impossible task that results in greater financial hardshipcredit card debt or high-interest short-term loans-or simply doing without.

However, struggling for survival Christmas crosses socioeconomic lines. It touches every demographic in our community. Many of our family, friends, and neighbors will face their first Christmas without a loved one, whether parent, spouse, sibling, child, or otherwise. Without that person, the holidays can go on, but they will never be the same. For others, it is not the first Christmas without a loved one, but the second, third, or tenth without them is still difficult. Some may have strained or distant relationships with family, so the concept of being "together" at Christmas simply doesn't exist.

Others are already struggling with depression and other mental health issues. The pressures associated with the holidays-

obligations for family, friends, work, church, and communitycan be completely overwhelming. There's a reason why mental health concerns become bigger during the holidays. Too many of our friends and family are not sure if they CAN make it through December. Do we even realize that?

Last year, I wrote about Stamford's Christmas Day Dinner. This year, for the 31st year, we'll serve fellowship and a full Christmas dinner to anyone and everyone who desires it. Some come out of need for a hot meal. Others come to avoid loneliness. Many simply desire the good community-wide fellowship. Last year, over 700 people were served with the simple mission that, no matter your lot in life, you shouldn't have to be alone on Christmas

With three weeks before Christmas, there are many opportunities for us to improve the Christmas season by changing our own piece of society. It doesn't require a large event serving a meal to your community. It may be as simple as taking an evening to spend time with an older neighbor. It might mean a quick trip to Walmart to purchase a toy for a local toy drive. It might be pressing a \$10 bill into the hand of a clearly-struggling mother doing her shopping at the store one day.

Whatever the case may be, I hope and pray that each of us will look across our community, at familiar faces and strangers, and find a way to make Christmas something happy, not merely a struggle for survival.

Improvement Project


