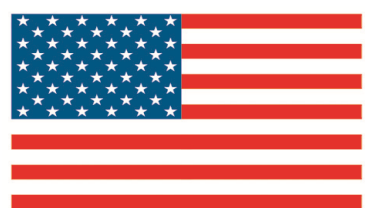

## A Moment in History Boydston Home

Some may remember the dilapidated Boydston home that sat to the northeast of the Benton viaduct. It was torn down in 1969 almost 88 years after it was built.

The Boydston home was one of the first homes built in Big Spring. The house was sold before the Benton viaduct was even built. Once Mr. Boydston died in 1930, it stood empty for over 39 years, void of laughter, family celebration and

happiness. J.B.D. (Benjamin) Boydston, listed as a Civil Engineer, arrived in Howard County in 1881 just as the tracks were

hunt for the killer is interrupted when an internal investigation in the police force uncovers what seems to be a crucial mistake in one of Rhyme's previous cases. He is removed from the case, and must investigate the Locksmith in secret to untangle the mysteries behind the psychotic killer before he can set his ultimate trap.

In *The Judge's List- The Whistler #2* (AUCD F GRI J) by John Grisham, Lacy Stoltz investigated a corrupt judge who was taking millions in bribes from a crime syndicate. She put the criminals away, but only after being attacked and nearly killed. Three years later, and approaching forty, she is tired of her work for the Florida Board on Judicial Conduct and ready for a change. Then she meets a mysterious woman who is so frightened she uses a number of aliases. Jeri Crosby's father was murdered twenty years earlier in a case that remains unsolved and that has grown stone cold. But Jeri has a suspect whom she has become obsessed with and has stalked for two decades. Along the way, she has discovered other victims. Suspicions are easy enough, but proof seems impossible. The man is brilliant, patient, and always one step

ahead of law enforcement. He is the most cunning of all serial killers. He knows forensics, police procedure, and most important: he knows the law. He is a judge, in Florida, under Lacy's jurisdiction. He has a list, with the names of his victims and targets, all unsuspecting people unlucky enough to have crossed his path and wronged him in some way. How can Lacy pursue him, without becoming the next name on his list?

Logan Tanner lives the exhilarating life of a professional gambler, taking risks with nerves of steel in *High Stakes* (AUCD F JOH I) by Iris Johansen. From casinos in Macau to Monte Carlo to Milan, he's racked up a fortune and become a living legend. But all the glitz and glamour hide a dark and violent past as an extractor, a world that comes rushing back to him when the beautiful and innocent Lara Balkon enters his life. Soon Logan is drawn into the conflict between two Russian mafia bosses over Lara, whose life now hangs in the balance. Logan has been offered something more valuable than money, information he desperately needs, in exchange for getting Lara out of Russia and to safety. Once together, Tanner discovers that Lara is a force to be reckoned with in her own right. Tanner's search for the truth leads them to the bright lights of Las Vegas, where the person

who was hunting Lara now lies in wait for them. As the stakes climb with each deadly confrontation, Logan and Lara are catapulted into a game against pure evil. The odds are stacked against them, but it's a game they know they must play even if it may cost them their lives.

The town of Paradise receives a tragic shock when the mayor is discovered dead, his body lying in a shallow grave on a property on the lake in Robert B. Parker's Stone's *Throw-Jesse Stone* series Bk 20 (AUCD F PAR R) by Mike Lupica. It's ostensibly suicide, but Jesse's has his doubts especially because the piece of land where the man was found is the subject of a contentious and dodgy land deal. Two powerful moguls are fighting over the right to buy and develop the prime piece of real estate, and one of them has brought in a hired gun, an old adversary of Jesse's: Wilson Cromartie, aka Crow. Meanwhile, the town council is debating if they want to sacrifice Paradise's stately character for the economic boost of a glitzy new development. Tempers are running hot, and as the deaths begin to mount, it's increasingly clear that the mayor may have been standing in the wrong person's way.

being laid for the T&P Railroad. He purchased a half section of land surrounding the property where he built his home and eventually sold all but 10 acres. Walter Roper purchased the eastern portion of Mr. Boydstuns land and this was later known as Roper's Grove, Parrish Park and then Cottonwood Park. It was in the low draw where Casey Campers is now located, and it stretched to the track area. Boydstun laid out and sub divided the land south of his home and named the streets with letters from his last name: Benton, Owen, Young, Donley, State, Temperance, and Union. He never named a street for the letter 'n' as his land had reached the city limit boundary.

Boydstun began building his home in the late fall and early winter of 1881-82. On February 12, 1882, the Boydstun family moved into their new two-story home. It faced Benton Street which, at the time was named Demming.

During an interview, several years ago, the Boydstuns granddaughter Florene Wilshire, described the home as a "showplace in it's day." "The yard was fenced with a decorative picket fence. A wire fence encircled the property to keep out stray cattle. She said "the lower floor had a living room and large guest bedroom located on the south side of the home. There was a door that opened out onto a large covered porch (on the south) where the family and company would gather to visit and the children would play under the shade of the large mesquite tree There was a cistern on the porch where one could draw a cool drink of water. On the north side of the home there was a large dining room where the family would gather for meals and happy times." Mrs. Wilshire added "Grandmother Boydstun was known for her good cooking. Aunt Nannie helped grandmother by keeping the biscuits hot and serving the delicious food to the guests. The kitchen was right off the dining room and had a large walk in pantry that was filled with shelves of canned vegetables, fruits, and meats." She continued "You would enter the home into a hallway

which circled the stairway that led to three bedrooms once upstairs. When you reached the upstairs landing, you could enter the bedroom to the north, south or the favorite bedroom which had a vaulted ceiling in it and was located at the back of the stairs. From the hallway upstairs, you could walk out onto the upper porch. Our most happiest times were spent on the front porch listening to grandfather teach us the old songs, which I still remember."

Florene's mother was Malinda Idelia (Delta) Boydstun. On July 6, 1904, Delta came down the stairway in her wedding dress as she married her beau, Edgar Dean Gillespie. Before that, in 1890, Boydstuns other daughter, Jennie married John W. Cook in the yard before many friends and family.

In November 1882, the First Christian Church was organized in the Boydstun home. They continued to have meetings there until a church home was built. Mr. Boydstun along with I.D. Eddins served the First Christian Church as the first Elders.

Mr. Boydstun was hired by the T&P Railroad as one of the first surveyors in Big Spring however, his original purpose was to establish an experimental agricultural farm. He planted numerous testing crops including the first cotton crop in Howard County. Boydstun had to consider the climate and the soil which convinced him that this would be good cotton country. In 1885, he broke out four acres of land and planted it in cotton. He was rewarded with two bales on the four acres. Since there was no gin, even thought of, he loaded the seed cotton in a box car and took it to Sweetwater to have it ginned. He sold his first bale of cotton in Sweetwater to cover his expenses but brought the second bale back to Big Spring in hopes of raising \$100 for the premium first bale. His hopes were dashed when he was unable to raise even a dime for his bale. "Cotton raising went on the shelf for about 15 more years." Joe Pickle Gettin Started. Boydstun fared better with his fruit and vegetable crops. He claimed to have a vine, (in 1883) that yielded 29 watermelons for which he sold for \$29. The following year, his 1 1/2 acre plot of melons returned him \$500 in revenue. Fresh fruits and vegetables were probably a welcome site for West Texas pioneers.

# Cowboys go camping in California, eyeing elusive playoff run

**DALLAS COWBOYS (12-6)**

**CAMP SITE:** Oxnard, California.

### LAST YEAR

The Cowboys won the NFC East for the third time in quarterback Dak Prescott's six seasons, but again failed to go deep in the playoffs, losing a home wild-card game to San Francisco. Dallas hasn't reached an NFC championship game since the 1995 season, when the storied franchise won its fifth Super Bowl. The offense was one of the best in the NFL before Prescott strained a calf, and was inconsistent at best the rest of the way. NFL Defensive Rookie of the Year Micah Parsons led a dramatic turnaround for a much-maligned unit.

T Tyler Smith (first-round pick), DE Sam Williams (second-round pick), free agent DE Dante Fowler, free agent WR James Washington.

### CAMP NEEDS

Prescott could use a healthy camp after a strained throwing shoulder sidelined him almost all of the preseason last year. He was coming off the gruesome broken ankle that ended his 2020 season in Week 5. There are several questions on the offensive line that need answers in camp. Topping the list is

left guard after Dallas let Connor Williams go in free agency. First-round pick Tyler Smith is a tackle, but could fill that spot to start his career. C Tyler Biadasz was inconsistent last year and shouldn't get too comfortable. LT Tyrone Smith hasn't been able to stay healthy in recent years, so the Cowboys will have to think about the lineup behind their eight-time Pro Bowler.

### KEY CAMP COMPETITIONS

Connor McGovern will be the player to watch alongside the rookie Smith at right guard. DE Sam Williams, Dallas' second-round pick, could challenge for a starting job opposite DeMarcus Lawrence, who returned on a reworked contract and will be important in trying to offset the loss of Gregory. The Cowboys thought Gregory would be back, but he made a late switch to Denver in free agency. Williams' primary competition could be Dorance Armstrong, who resigned in free agency. The pecking order behind new No. 1 receiver CeeDee Lamb will be a topic with Michael Gallup still recovering from a 2021 knee injury and unlikely to be ready until early in the season. LB Leighton Vander Esch, a 2018 first-round pick, is back on a one-year contract alongside Parsons. But the Cowboys are ready for a longer look at second-year player Jabril Cox, who missed most of last year with a knee injury.

### EXPECTATIONS

Owner Jerry Jones hired coach Mike McCarthy in 2020 because he thought the Super Bowl winner from Green Bay could end Dallas' long stretch without a deep playoff run. The pandemic year was a throwaway before the team cruised to the division title last year. The 23-17 loss to the 49ers ranks high on Jones' list of disappointments in the 33 years since he bought the Cowboys. If Dallas doesn't go deep in the postseason this time, McCarthy's job security will be a hot topic.

# Texans look to Mills at QB after trading Watson to Browns

### LAST YEAR

The Texans won just four games for the second straight season after winning the AFC South the previous two seasons, costing coach David Culley his job after just one year. With QB Deshaun Watson sitting out amid a trade request and multiple lawsuits from women alleging sexual harassment or assault, the Texans relied on Tyrod Taylor early before giving rookie Dayvion Miller a chance at quarterback. Ineffective play at quarterback paired with a defense that ranked near the bottom of the NFL in the first season without star J.J. Watt left the Texans as one of the league's worst teams.

### CAMP NEEDS

Now that Watson has been traded to Cleveland, the Texans are focused on developing Mills. Houston has committed to him as the starter for this season, but he'll need to show that he's made progress in camp after a subpar rookie season. Metcalf, a second-round pick, could help Mills in his second season, but must show that he's healthy after off-season knee surgery. The Texans expect Stingley, the third overall pick in the draft, to step in immediately to improve their secondary, which makes his work in camp particularly important.

### KEY CAMP COMPETITIONS

Houston has had the worst running game in the

NFL for the past two seasons but made some additions this offseason to attempt to improve it with Johnson gone. Mack is expected to be the starter, but Pierce, a fourth-round pick, could use a good camp to earn some carries behind him and veteran Rex Burkhead this season. Christian Kirksey and Kamu Grugier-Hill are two of the team's starting linebackers but performance in camp will determine the last spot. Christian Harris, a third-round pick, and offseason acquisition Maybin, are two of the top options for the job.

### EXPECTATIONS

Multiple high draft picks and several free agent additions should make the Texans better than they were last season. Smith, the team's former defensive coordinator, is committed to turning around the defense and believes the additions of Stingley and Pitre, a second-round pick, can transform a secondary that was terrible last year. If the rookies improve the defense and Mills takes a step forward in Year 2, Houston should win a few more games than last season, but it's unlikely that this young team will be good enough to contend for the playoffs.

# Ties to Texas, Big 12 bind coaching newcomers Dykes, McGuire

ARLINGTON, Texas (AP) — Two of the three new head coaches in the Big 12 aren't really new at all when it comes to the state of Texas, the conference and the traditional Dallas-area home of the league's football media days.

TCU's Sonny Dykes and Joey McGuire at Texas Tech have been there, done that.

Dykes is the son of late former Texas Tech coach Spike Dykes, was an assistant with the Red Raiders in the early 2000s and even spent a season on the staff of Gary Patterson five years before replacing the longtime Horned Frogs coach.

The 52-year-old has already been a head coach in his home state, having spent the past four seasons at SMU in Dallas, about 30 miles from the TCU campus. But that was the American Athletic Conference. This is the Big 12.

"Look, I love this league," Dykes said Thursday, the last of two media days on the field at AT&T Stadium, home of the Dallas Cowboys and site of the Big 12 championship game.

"I'm familiar with a lot of these coaches," Dykes said. "A lot of these guys, I've known them most of my life and most of their lives. I've been to games in these stadiums when I was a kid. That felt like home."

McGuire, a championship-winning high school coach south of Dallas in Cedar Hill, joined the Red Raiders after five years as an assistant at Big 12

rival Baylor.

He replaces Matt Wells, who was fired in the middle of his third season last year.

"The one thing I always say, and I believe this, it's not just a little slogan, but I'm a high school coach that gets to coach college football," McGuire said. "My DNA is a high school coach."

The difference is Dykes has left the state, with head-coaching stops at Louisiana Tech and California. After he was fired at Cal, Patterson hired him as an offensive analyst.

McGuire has barely left the Dallas area, where he was born, went to college (Texas-Arlington) and coached for 22 years before straying 100 miles south to Waco.

"I think the Texas high school coaches understand, what we say, we're going to do, that they can trust us to take care of their players," McGuire said. "Whenever you can walk into a high coach and the head coach knows, 'Hey, this guy is what he's all about, what he says, what he's going to do,' it makes a huge impact on those guys."

Spike Dykes got to see his son in charge of the sideline at Louisiana Tech and Cal, but died less than a year before Sonny Dykes was hired at SMU, which was one of Texas Tech's rivals in the Southwest Conference. TCU was another SWC foe, and son said dad always thought it was a good job.

"It's a little bittersweet," Sonny Dykes said. "I think he would have gotten a kick out of me being at SMU.

I know he's looking down and excited about this opportunity and certainly gets a kick out of it."

### RESETTING CYCLONES

Iowa State had its highest-ever preseason ranking at No. 7 last year before a 7-6 season that ended with a loss in the Cheez-It Bowl a year after the Cyclones lost to Oklahoma in the Big 12 championship game.

The Cyclones will try to bounce back from that disappointment, but will have to do it without quarterback Brock Purdy and running back Breece Hall, who had consecutive 1,700-yard seasons before bypassing his senior year and going early in the second round of the NFL draft.

"I think I said this a year ago, if we would have ever listened to what people said about Iowa State in the preseason hype, we would have never got our program off the ground," said coach Matt Campbell, who is going into his seventh season after consistent chatter over several years about him taking a higher-profile job.

Hunter Dekkers will get the first shot at replacing Purdy, a three-year starter, while the task of filling Hall's void will be considerably tougher.

"The ability to find greatness is the ability to overcome yourself," Campbell said. "We've really tried to find out where we need to continue to grow, why we've either taken steps back or taken steps forward, and how do we continue to push forward as a program."

### HEISMAN HOPEFUL

Texas running back Bijan Robinson was the most likely among the play-

ers at Big 12 media days to become a Heisman Trophy candidate.

So the junior knew the question was coming after he rushed for 1,127 yards, averaged 5.8 yards per carry and scored 11 touchdowns.

Robinson's name surfaced a year ago when he had five consecutive 100-yard games, particularly after career highs of 35 carries for 216 yards in a 32-27 victory at TCU.

The last two of those five games were the start of a six-game losing streak, and Robinson missed the final two games after dislocating his elbow in a 57-56 loss to Kansas.

"When everybody on the team is successful and we start winning games, then it's not just about me," Robinson said. "It's about everybody that's around me that's getting their awards, too. When we win games, everybody eats on the team. It is a distraction, but when we all eat, then we'll all succeed together."

### STILL TALKING HORNS DOWN

Once again, Big 12 coordinator of officials Greg Burks got a question about the "Horns Down" signal, this time on whether it was a dead issue. Burks didn't really say, except to try to lump the gesture in with all taunting situations by labeling it a judgment call.

"Let me be very clear with 'Horns Down.' I have no ownership on this symbol," Burks said as he flashed both the "up" and "down" version. "This symbol is the same as all other signals. It's when you do it, who you do it to and which manner you do it."
