# A Moment in History

# The Melba Hotel

The Melba Hotel, located at 813 W. Third St. Originally known as the Broadway Hotel, the E.D Carroll firm and Mrs. Steve seedy hotel was renamed Melba by 1968.

In 1928, another hotel showed up on Big Spring 's horizon. The Broadway Hotel was no comparison to the Settles, Crawford, and Douglass hotels, that were being completed at the same time however, lodging was always in demand.

The red brick building at 813 West Third was small with 11 guest rooms and two bathrooms and was only 25 ft wide by 84 ft deep. It was named for the Broadway of America Highway that ran through Third Street and Big A narrow stairway led guests

to a second-floor lobby and the bottom floor offered spaces for

two business. The first occupants were Gates Auto Supply and Lydick Roofing. The Broadway was built by the

Conocio was named as "matron"

or manager.

If there were any grand plans for this small hotel, they fell short immediately. Within two years, the hotel was under new management and by 1968 it had been renamed the Melba Hotel.

Rooms were rented daily or even hourly. Screen doors were added to each room. There was another set of stairs at the back of the building that had a red light above. This light would be turned on as a warning that the police were entering the establishment and a quick getaway was needed.

Ladies of the Evening usually arrived on the bus and were shuttled to the different hotels, including the Melba. They left after a few weeks and a new group would arrive. Big Spring had several of these "hourly" hotels and motels that included the Duncan and Wyoming.

The hotel was eventually closed in the 1980s and the building remains vacant.

# Alex Jones ordered to pay \$49.3M total over Sandy Hook lies

AUSTIN, Texas (AP) — A Texas jury on Friday ordered Infowars' Alex Jones to pay \$49.3 million in total damages to the parents of a first-grader killed in the 2012 Sandy Hook Elementary School massacre, which the conspiracy theorist falsely called a hoax orchestrated by the government in order to tighten

The amount is less than the \$150 million sought by Neil Heslin and Scarlett Lewis, whose 6-year-old son Jesse Lewis was among 19 children and six educators killed in the deadliest classroom shooting in U.S. history.

The trial is the first time Jones has been held financially liable for peddling lies about the 2012 attack in Newtown, Connecticut. Jurors at first awarded Heslin and Lewis \$4.1 million in compensatory dam-

ages, which Jones called a major victory. But in the final phase of the twoweek trial, the same Austin jury came back and tacked on an additional \$45.2 million in punitive damages. Punitive damages are meant to punish defendants for particularly egregious

conduct, beyond monetary compensation awarded to the individuals they hurt. A high punitive award is also seen as a chance for jurors to send a wider societal message and a way to deter others from the same abhorrent conduct Attorneys for the family had urged jurors to hand down a financial punish-

ment that would put Infowars out of business. "You have the ability to stop this man from ever doing it again," Wesley Ball,

an attorney for the parents, told the jury.

It's unclear how much money Jones and Infowars' parent company, Free Speech Systems, have. An economist hired by the plaintiffs testified that Jones and the company

are worth up to \$270 million, suggesting that Jones was still making money. But Jones testified that any award over \$2 million would "sink us." And Free Speech Systems filed for bankruptcy protection during the trial's first week. Jones still faces two other defamation lawsuits from Sandy Hook families in

Texas and Connecticut.

AUSTIN, Texas (AP) — Conspiracy theorist Alex Jones and his company Free Speech Systems are worth up to \$270 million, an economist testified Friday to a jury trying to determine if Jones should have to pay punitive damages to the family of a 6-year-old killed in the 2012 Sandy Hook Elementary School

The same jury ordered Jones to pay Neil Heslin and Scarlett Lewis \$4.1 million in compensation for defamation. Jurors began considering additional punitive damages Friday as a separate issue. The parents want to punish Jones for a decade of pushing false hoax claims that they say led to a decade of trauma and abuse from the Infowars host's followers. Bernard Pettingill, who was hired by the plaintiffs to study Jones' net worth,

said records show that Jones withdrew \$62 million for himself in 2021, when default judgments were issued in lawsuits against him. "That number represents, in my opinion, a value of a net worth," Pettingill

said. "He's got money put in a bank account somewhere." The money that flows into Jones' companies eventually funnels its way to him, said Pettingill, who added that he has testified in approximately 1,500

"He is a very successful man," Pettingill said, calling Jones a "maverick" and "revolutionary" for finding ways to monetize his online messaging.

While the \$4.1 million award Thursday was less than the \$150 million the parents sought, it marked the first time Jones has been held financially liable for repeatedly claiming that the deadliest school shooting in U.S. history was a hoax perpetrated to try to bring about tighter gun restrictions.

Mark Bankston, an attorney for Heslin and Lewis, whose 6-year-old son Jesse was among 20 children and six educators killed in the school attack in Newtown, Connecticut, insisted that the \$4.1 million compensation award wasn't a disappointment and warned that they would be trying to punish Jones in the next phase

"We aren't done yet," Bankston said Thursday. "After tomorrow, he's going to owe a whole lot more."

Another of the plaintiffs' attorneys, Wesley Ball, asked jurors in closing Friday to award an additional \$145.9 million, which would bring the total amount in damages to that \$150 million target.

"You are asked to punish Alex Jones," Ball said. "You are asked to deter Alex Jones from ever doing this awful thing again to another person or another family — to deter anyone who wants to step into his shoes."

"Send the message to those who desire to do the same: Speech is free. Lies, you pay for," he said.

But Jones' lawyers said their client has already learned his lesson, and asked for lenience. The jury's punishment should be less than \$300,000, attorney Andino Reynal said.

"You've already sent a message. A message for the first time to a talk show host, to all talk show hosts, that their standard of care has to change," Reynal said. Jones still faces two other defamation lawsuits

from Sandy Hook families in Texas and Connecticut that put his personal wealth and media empire in jeopardy. Jones — who was in the courtroom briefly Friday

but left before Pettingill's testimony — told jurors earlier this week that any award over \$2 million would "sink us." And a week ago, his company Free Speech Systems, which is Infowars' parent company, filed for federal bankruptcy protection. Lawyers for the family suing Jones contend that

Jones has tried to hide evidence of his true wealth and have sued him claiming he's tried to hide money in various shell companies.



Crunchy Cucumber Salad with Crushed **Peanuts** Serves 4

English or other unwaxed cucumbers, chopped into 1/4-inch dice (about 3 cups) medium green

serrano chile, minced (seed first if you prefer) cup peanuts, preferably raw, but toasted, unsalted ones will do

2 tablespoons lemon juice, or more if needed

1 teaspoon salt 1/2to 3/4 teaspoon sugar


1/8 teaspoon caytablespoon teaspoon mus-

Place the diced cucumbers in a medium bowl along with the chile. Using a coffee grinder or food processor, pulse the peanuts until they are reduced to a coarse powder. (You don't want big chunks of peanuts, nor do you want a fine powder; stop grinding somewhere in between!) Add the peanuts to the cucumbers along with the lemon juice, salt and sugar, and mix well. Taste and adjust the salt, sugar and lemon juice as needed. The salad should be slightly tart. Make the tadka: Place the cayenne in a little pile on top of the salad. Do not stir it in yet. Heat the oil in a small skillet or butter warmer over high heat. When it begins to smoke, add the mustard seeds, covering the pan with a lid or spatter screen. As soon as the seeds stop sputtering, pour the oil over the cayenne. Stir the dressing in and serve at room temperature or cold. TF228184

Today is Monday, Aug. 8, the 220th day of 2022. There are 145 days left in the year.

Today's Highlight in History:

On Aug. 8, 1974, President Richard Nixon, facing damaging new revelations in the Watergate scandal, announced he would resign the following day.

On this date:

In 1814, during the War of 1812, peace talks between the United States and Britain began in Ghent, Belgium.

In 1815, Napoleon Bonaparte set sail for St. Helena to spend the remainder of his days in exile.

In 1861, biologist William Bateson, founder of the science of genetics, was born in Whitby, Yorkshire, England.

In 1911, President
William Howard Taft
signed a measure raising the number of U.S.
representatives from
391 to 433, effective
with the next Congress,
with a proviso to add
two more when New
Mexico and Arizona
became states.

In 1942, during World War II, six Nazi saboteurs who were captured after landing in the U.S. were executed in Washington, D.C.; two others who cooperated with authorities were spared.

In 1945, President Harry S. Truman signed the U.S. instrument of ratification for the United Nations Charter. The Soviet Union declared war against Japan during World War II.

In 1953, the United States and South Korea initialed a mutual security pact.

In 1963, Britain's "Great Train Robbery" took place as thieves made off with 2.6 million pounds in banknotes.

In 1973, Vice President Spiro T. Agnew branded as "damned lies" reports he had taken kickbacks from government contracts in Maryland, and vowed not to resign ,Äî which he ended up doing.

In 1994, Israel and Jordan opened the first road link between the two once-warring countries.

In 2000, the wreckage of the Confederate submarine H.L. Hunley, which sank in 1864 after attacking the Union ship Housatonic, was recovered off the South Carolina coast and returned to port.

In 2009, Sonia Sotomayor was sworn in as the U.S. Supreme Court's first Hispanic and third female justice.

Ten years ago: Egyptian President Mohammed Morsi fired his intelligence chief for failing to act on an Israeli warning of an imminent attack days before militants stormed a border post in the Sinai Peninsula and killed 16 soldiers. Misty May-Treanor and Kerri Walsh Jennings of the United States became the first three-time gold medalists in Olympic beach volleyball history, beating Jennifer Kessy and April Ross in the all-American final.

Five years ago: President Donald Trump said continued North Korean threats aimed at the United States would cause the U.S. to respond with "fire and fury like the world has never seen." Venezuela's new constitutional assembly, created by embattled President Nicolas Maduro, took over the halls of the opposition-controlled congress and decreed itself to be superior to all other branches of government. Singer Glen Campbell died in Nashville, Tennessee, at the age of 81; he had announced in 2011 that he'd been diagnosed with Alzheimer's disease.

One year ago: Taliban fighters seized most of Kunduz city, the capital of a key northern Afghan province, the latest in a series of blows to government forces. The pandemic-delayed Tokyo Olympics officially came to an end; the closing ceremony was held in an empty stadium, though athletes were still able to gather on the field. Hall of Fame football coach Bobby Bowden, who built one of the most prolific college football programs in history at Florida State, died at his home in Tallahassee, Florida, at 91.



# Barr could help young Cowboys star Parsons' pursuit of sacks

OXNARD, Calif. (AP) — The signing of free agent linebacker Anthony Barr could nudge young star Micah Parsons closer to being primarily a pass rusher for the Dallas Cowboys.

The club also had depth in mind with the addition of Barr, a four-time Pro Bowler who spent his first eight seasons in Minnesota. Dallas had shown interest in him long before training camp in Cali-

Barr is starting his stint with the Cowboys on the physically unable to perform list, not for an injury but because the club is taking a conservative approach getting the 30-year-old ready for camp prac-

Parsons had 13 sacks on his way to winning NFL Defensive Rookie of the Year, tied for the thirdmost for a first-year player since sacks became an official statistic in 1982.

Because of injuries early last season, there were times Parsons played the majority of his snaps at defensive end, and the Cowboys usually had two

other linebackers on the field. The addition of Barr means the top three choices in the new mix, which includes Leighton Vander

Esch, are former first-round picks. "I think when you look at packages and how we feature Micah, I think it gives you another weapon, another excellent player on and off the ball," coach Mike McCarthy said. "I think when you get in and out of packages as you build your system for a 17game season, I know the defensive staff is real excited to have another piece."

Barr's career high for sacks is four from his rookie year with the Vikings in 2014, when he was the ninth overall pick. The 6-foot-5 Barr is more in the mold of Vander Esch (6-4) as a traditional lineback-

When Parsons lines up at defensive end, including in the three-point stance the Cowboys envision on occasion, Barr and Vander Esch could be paired on the second level behind him.

"I'm just trying to continue to help unlock his game and allow him to be the best player he can be," Barr said of Parsons. "Pretty amazing what he was able to accomplish. I think he can just continue to elevate and take it to the next level. I'm hoping to be a tool and resource to him and also to learn from him and learn from all the guys."

Barr was a steady presence during his first six seasons in Minnesota, including four straight trips to the Pro Bowl from 2015-18. A torn pectoral muscle sidelined him for the season in Week 2 in 2020. He then missed the first four games last year with a knee injury.

Because he went unsigned through the offseason, Barr's first practice at camp will be his first since the end of last season. He said there was never a specific timeline for finding a new team.

"Timing is everything," Barr said. "No rhyme or reason to it. It was just the right time for both parties. Hopefully, it's a good marriage."

Second-year player Jabril Cox was cleared for camp after tearing an anterior cruciate ligament in Week 8 against Minnesota last season, although he recently was given a couple of days off.

The Cowboys are high on rookie fifth-round pick Damone Clark, who fell in the draft because of spinal fusion surgery that could sideline him all of this season. The injuries to Cox and Clark are two more reasons the Cowboys had interest in Barr.

McCarthy remembers Barr from facing the Vikings as coach in Green Bay. And part of Barr's interest in Dallas came from senior defensive assistant George Edwards, who was Minnesota's de-

fensive coordinator for Barr's first six seasons. "We always had to be very, very conscious of the matchup that you had with him," McCarthy said. "We want to be multiple in our defensive packages and we want to continue to develop different rush plans. He's a great fit for us."

NOTES: The Cowboys are thin at RB in camp with Rico Dowdle and rookie Aaron Shampklin in COVID-19 protocols. They also lost their only fullback for at least a couple of weeks as Ryan Nall battles a shoulder injury.

# Column: NFL lets bad boy owners get off with slap on wrist

After Donald Sterling's racist ramblings were exposed to the world, the NBA moved quickly to banish him from the league.

Sure, the forced sale of the Los Angeles Clippers made Sterling even richer, but it sent a clear signal that such behavior would not be tolerated, even from the guys with the biggest checkbooks.

Then there's the NFL, which seems content to let its bad boy owners slide with nothing more than a slap on the wrist, no matter how egregious the of-

Tampering with some of the game's biggest names? Suggesting it would be a good idea to lose games inten-

No problem, says the league which likes to throw around the word "integrity" at every opportunity — except when it really matters.

In the eyes of Commissioner Roger Goodell, some mandatory vacation time, a fine that roughly amounts to loose change in the sofa, and surrendering a couple of draft picks should be enough to smooth things over.

That's exactly what Goodell imposed this week on Miami Dolphins owner Stephen Ross, whose conduct was so reckless that it wouldn't have been out of line to shove him out the door — or at least give him a gentle nudge.

Of course, in its version of the justbefore-the-weekend news dump, the NFL brilliantly unveiled the case against Ross — and it's quite a doozy while most fans and pundits were fixated on what's next for quarterback Deshaun Watson, who received a six-game suspension for multiple allegations of sexual misconduct during massages.

The NFL appealed, which could have sent the case to Goodell for harsher, more appropriate punishment, but he timidly handed it off to an outside arbiter.

The Watson case is bad enough. Ross' shenanigans were also worthy of outrage.

But Goodell would prefer we all just move along from a week of disturbing revelations and get to what's really important: a season that conveniently began Thursday night with the Hall of Fame exhibition game in Canton, Ohio.

Pay no attention to that man behind the curtain!

The great and powerful commish has spoken!!

By now, it should be crystal clear to everyone that Goodell couldn't care less about integrity as long as the league's coffers — and his own keep growing at a rate far ahead of surging inflation.

Sure, he'll swing into action when a net worth of \$8.2 billion player who hasn't been with his team. and a blip compared to

all season dares venture onto a casino app to place legal bets on NFL games. Never mind that the league has fully embraced sports gambling and has no problem cashing all the massive

checks it brings in. Calvin Ridley's wagering, which he readily admitted to with no suggestion that it impacted games, led to his suspen-

sion for at least the 2022 season and means the Atlanta Falcons receiver has no chance to receiving his \$11.1 million salary until he's reinstated.

Compare that with Ross

Goodell issued a harsh statement, singling out "violations of unprecedented scope and severity," but showed he didn't have the stomach to actually back up his words with decisive action.

Sure, the Dolphins will be hurt by the loss of a first-round pick next year and a third-round pick in 2024, but the remainder of the sanctions were laugh-

able. Ross was fined \$1.5 million, which is roughly 0.018% of his estimated the salary Ridley isn't receiving. Ross also was suspended from his team through Oct. 17, meaning he won't be around for the first six games of the regular season — at least 11 games fewer than Ridley's banishment.
