

Burglars gained entrance to the Del Mar Grill by smashing the glass of the front door with a brick and took about \$60 in change and some candy and cigars.

A Billups filling station on Highway 35 was entered the same night, and about \$12 to \$15 was taken.

Deputy Sheriff Sherman Mundine, while investigating both cases, arrested three other burglars and cleared up the March 20 burglary of the Star Package Store here.

An 18-year-old youth was arrested about 3 p.m. Monday afternoon in Austwell by Mundine and Deputy Slim Haynes, and two juveniles, 15 and 16, were arrested later in Rockport in connection with the latter theft.

In signed statements the three youths admitted attempting to enter the store, owned by Bob Naper, through a rear entrance, Mundine said. Failing this, they smashed the glass in the front door, he continued.

Naper reported loss of 27 bottles of liquor in the break-in, as well as a quantity of gum and cigarettes. Mundine said that a small amount of the liquor was recovered after the youths were arrested. He is continuing investigation of the Sunday thefts.


