

Frederic Langdon Booth, 89, a resident of Rockport for 19 years, died in Bayview Hospital at 5:45 p.m. Tuesday after a short illness. The son of Frank D. and Isabel Booth, he was born in Ripon, Wisconsin, on September 6, 1869, and in early life lived in St. Louis. where he was baptized at the Webster Grove Presbyterian church in 1883.

As a young man, he was an engineer with one of the companies that drove the subways of New York beneath the Hudson River. In later years, after he moved to Texas, he was with the Universal Carloading Corporation for many years, first at Waco and later at San Antonoi, before retiring at the age of 70.

Moving to Rockport, he took an active part in the affairs of the community, being respected for his experience, clear thinking, sound judgment and integrity.

During the war he managed the Surf Theater in the absence of its owner.

He was a Mason; a lifetime member of the Shrine, and belonged to the Karem Temple at Waco. He was confirmed as a member of St. Peter's Episcopal Church in Rockport on October 7. 19-3

He is survived by his wife, Helen Elizabeth, of Rockport; a daughter, Mrs. Joan Bonnell, of Fort Worth; a granddaughter and two grandsons.

Funeral services were held at Et. Peter's Episcopal Church in Rockport at 4 p.m. Wednesday with the Rev. Harry Carter officiating, and afterwards the body was transported to the Mission Burial Parlors in San Antonio for cremation.





In just 14 years, young William H. Wharton made a giant's mark on the pages of Texas history..as lawyer, pioneer, planter, soldier, statesman and patriot. Born in Virginia, in 1802, Wharton came to Texas in 1827, married Sarah Ann Groce, daughter of another pioneer, and established the beautiful and historic plantation, Eagle Island. As one of the colonist party demanding of Mexico separate statehood for Texas, Wharton opposed the conservative policies of Stephen F. Austin. The petition of 1832, ask-ing for statehood, was a document which has become a political classic Wharton was its author.

But when the territory was faced with the actual fight for freedom, Wharton and Austin forgot their enmities of earlier years in devotion to the cause to which both were dedicated. Wharton supported Austin in his campaign for presidency of the Republic. Sam Houston, the victor, then appointed Austin Secretary of State and Wharton the first Minister to the United States. Through the young Minister's diplomatic skill, the Republic won U. S. recognition on March 3, 1837. But only two years later Texas lost the distinguished services of William H. Wharton. The accidental discharge of his own pistol ended a brief but brilliant career in the cause of freedom.




