Red River County Court handles misdemeanor cases

Jack Herrington, Red River County Attorney, reported that Red River County Court which handles misdemeanor cases, was held Tuesday, February 15.

County Judge L.D. Williamson presided and nine people had their probations revoked.

Jahmar Young was sentenced to one year in the county jail, along with Brandon Nickerson, 90 days jail; Raymond Miller, Jr., 90 days jail; Veta L. Dilworth, nine months jail; Leslie L. Dever, nine months jail;

Stacy D. Coleman, 90 days jail; Sherry A. Haddock, 90 days jail; Less Mimmis, Jr., six months jail; and Don M. Gilbert, nine months jail.

Twenty other cases received probation, with a total of \$12,500 in fines and 2,100 hours of community service.

Several defendants did not appear for their court date. Herrington asked the court to revoke their bond and issue a warrant for their re-arrest. Judge Williamson issued that order.

\$316.7 million delivered in February tax rebates

Texas Comptroller Carole Keeton Rylander delivered \$316.7 million in monthly sales tax payments to 1,105 Texas cities and 119 counties, a 0.47 percent decrease compared to the \$318.2 million allocated to cities and counties in February, 1999. So far, sales tax rebates to cities and counties are up 6.6 percent compared to the first two months of 1999.

Local payments received include: Mt. Pleasant received \$326,199.87, a 9.11 percent decrease over last year's payment.

Talco received \$1,052.43; marking an 18.57 percent decrease. Bogata received \$8,116.34 for a 59.14 percent decrease.

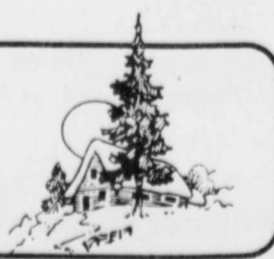

Chocolate Chess Pie-she had one of these made up and it looked delicious!

Angel Biscuits-this dough can be kept refrigerated for several days or frozen for future use.

Pound Cake-this recipe is great with early morning coffee or just anytime!

Pie Crust-this recipe can be made up and stored in an airtight container, unrefrigerated for several months. Take out desired amount, add water and you have a no-muss, no-fuss pie crust!

dies February 19

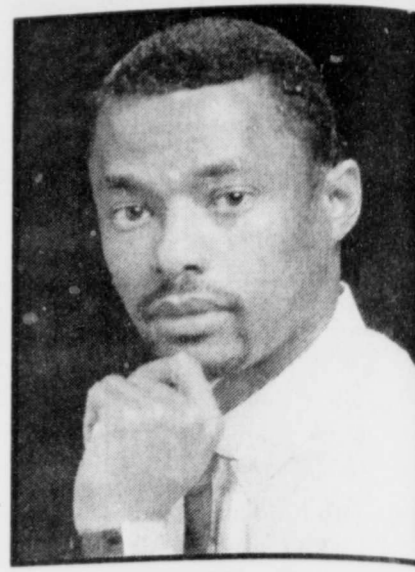
R.D. Cotton, age 74 of Commerce died February 19 in Presbyterian Hospital in Commerce.

Chocolate Pie

1 cup sugar
3 cups sweet milk
3 eggs-save whites
pinch salt
1 teaspoon vanilla
3 teaspoons cocoa
2 tablespoons flour
3 tablespoons oleo

Combine flour, cocoa, salt and sugar; mix well. Slowly beat in small amounts of milk and egg yolks and blend until smooth. Add vanilla and butter and blend until smooth. Pour into unbaked pie shell and bake at 350 degrees until center is set.

Sweet Potato Pie

2 cups sweet potatoes-boiled
1/2 cup butter
2 eggs
1 cup brown sugar
1/4 cup granulated sugar
1/4 teaspoon salt
1/2 teaspoon ginger
1/2 teaspoon cinnamon
1/2 teaspoon nutmeg
1/2 cup milk
unbaked pie shell

Combine potatoes, eggs and milk; mix well. Combine other ingredients and mix until smooth and creamy. Pour into unbaked pie shell and bake at 450 degrees for 10 minutes; reduce heat to 350 degrees and continue cooking until center is set, approximately 30-35 minutes.

Sweet Dough or Rolls

2 cups warm sweet milk
1/2 cup sugar
3 eggs-beaten
2 teaspoons salt
7 to 7-1/2 cups flour
2 cakes of yeast or packages
1 stick oleo

Combine milk, sugar and oleo to heat to lukewarm. Dissolve yeast in mixture and add beaten eggs. Sift flour and add to mixture; mix well. Cover and let rise. Push down and let rise again. Knead several times. Place three small balls of dough in each section of a muffin tin. Let rise again and bake at 400 degrees for 10-15 minutes.

Buttermilk Pie

3 eggs
1 cup sugar
2 tablespoons flour
1/2 cup melted margarine
1 cup buttermilk
1/2 teaspoon vanilla
1/2 teaspoon lemon flavoring
1 unbaked pie shell

Beat eggs slightly; add sugar and flour and margarine; mix well. Add buttermilk and flavorings. Pour into pie shell and bake at 325 degrees until custard is set and browned as desired.

Chocolate Chess Pie

2 large eggs-well beaten
1-1/2 cup sugar
3-1/2 tablespoons cocoa
1 teaspoon vanilla
1/2 can carnation milk
1 unbaked pie shell

Combine all ingredients and pour into pie shell and bake at 325 degrees for 45 minutes.

Angel Biscuits

4 cups flour
1/4 cup sugar
3 teaspoons baking powder

1 teaspoon soda
1 teaspoon salt
1/2 cup shortening
1 package dry yeast
2 teaspoons warm water
2 cups buttermilk

Combine flour, sugar, baking soda, soda and salt. Cut shortening. Soften yeast in water. Stir until dissolved. Mix with buttermilk and combine with dry ingredients. Roll out 1/4-inch thick and cut out and place on greased pan. Place in cold oven and turn on at 400 degrees and cook for 15 minutes or until brown. Biscuits will rise while oven heats.

Pound Cake

1 cup shortening
2 cups sugar
4 eggs
1 teaspoon vanilla
1 teaspoon orange extract
3 cups flour
3/4 teaspoon salt
1/2 teaspoon soda
1/2 teaspoon baking powder
1 cup buttermilk

Combine all ingredients in a large bowl and beat well., by hand or electric mixer.
Bake in a well greased and floured loaf or bundt pan at 350 degrees until brown.

Pie Crust

6 cups flour
1 teaspoon salt
2-1/4 cups vegetable shortening

Combine flour and salt and using pastry knife, cut in shortening; resulting in crumbs. When ready for use, combine 3 cups of mixture and 8 tablespoons cold water. Shape into dough and make pie shells.

Miss Thelma's love of people shines

Miss Thelma Warren loves the community of Deport. In fact, she has never lived more than eight miles from the downtown Deport Water tower in her 91 years! It doesn't take a long visit with her to know how much she loves this area, her family and her friends.

Thelma was born July 16, 1908 in the nearby community of Milton. Her parents were Carl and Alice King Ladd. She is the only girl and the oldest of four children. Two of her brothers, Ralph and Hoyle are both deceased. Brother Carlos lives in Deport.

She went to school through the sixth grade in the Martin Community School. Seventh grade through high school graduation in 1925 was spent in the Deport school system. After high school graduation Thelma went to Paris Junior College for two years, majoring in Elementary Education. She then began teaching in the Deport Elementary School. She continued working on her degree on weekends at PJC and during the summer months at East Texas State Teachers College in Commerce. The summer of 1937 she and two other teachers took classes at Columbia University in New York. They went with the Deport School Superintendent and his wife. The Superintendent was working on his doctorate. Thelma said "We got a lot of education by seeing the sights of New York. We went on a boat up the Hudson River to West Point. We saw the Rockettes, and several Broadway shows. Of course, we saw the statue of Liberty, Atlantic Ocean and Harlem. This was all very exciting to us country girls!"

Thelma was connected with the Deport Elementary School for 16 years either as a teacher or principal. She says "We believed 'spare the rod, spoil the child.' However, we were not abusive. We tried to teach the children to love and respect everyone. We often had programs, celebrating May Day, Thanksgiving, Christmas and other times. We had a cantata: Jack and the Bean Stalk. It was something the children always

seemed to enjoy, as well as their parents. Not only did the children and their families enjoy them, but we, the teachers, took great pride in the children's interest and efforts".

Thelma retired at the end of the school year of 1943. She had married Ben Warren at Christmas of 192, and was taking on a new role as the wife of a farmer, rancher and dairyman in the Fulbright community.

Mr. Ben had a daughter, Susie Lou, by his first wife, who had died. Susie Lou was married. Her husband was in Air Force Cadet Training. World War II was going on. Since they were being moved from air base to air base the couple brought their son, Jim, to Ben and Thelma when he was only two weeks old. Living conditions for new born babies were not good, so Jim Kunkel spent his formative years with Ben and Thelma during the war. Jim called them Papa and Momma, and to this day he still calls Thelma Momma. The lives in Houston with his family, and calls "momma" at least once a week.

After the war Jim became big brother to his sister, Valerie, who lives in Longview with her family. 'Back then his family lived in Clarksville. Every Friday, when he got out of school, Thelma was there to pick Jim up and he spent the weekend with the Warrens. One Friday, after a heavy rain, the creek was out and water was across the bridge. Thelma was late to Clarksville to fetch Jim. She told him why she was late and asked him what he would do if she was later some other time, or could not show up.

Jim's firm reply "I'll sit on the steps and wait for you, Momma."

Thelma says that some of her students grew up to be her best friends. Some of these friends and others made up a traveling group of seven. They took several fun trips together in a van. Thelma, Virginia Grant Kirkland, Reba Griffin Temple, Ruth Grant Murrell, Ina Sparks, Nina Sparks and Mavis Sowards take off to places such Branson, Mo.; Gatlinburg, Tenn. (they also have been to Pigeon Forge

and Dollywood). A favorite spot going and coming from Tennessee is the Casey Jones Motel, where they go through the Casey Jones Home, now a museum.

Thelma's grandparents, Henry Clay and Amy Rebecca King were from Jackson, and she wondered what it had been like in Jackson in their day. In addition to these trips they went to Beavers Bend, Oklahoma in April and October for many years.

Thelma is a long time member of the First United Methodist Church of Deport.

"I am surrounded with friends I grew up with and many that I taught. They play the piano, the organ, Direct the choir and are Sunday School teachers...it's home" she smiles.

Thelma says that "four classes of former Deport Students go together and have homecoming often, and they always include me. One year they had as their theme "This Is Your Life Miss Thelma". Some are now 80, but they come home and enjoy being together and remembering their cherished school days, their cherished school days, and the teachers and friends they love so much. On another occasion they presented me with a long white paddle that reads 'From All Your Students, We Love You Miss Thelma'. It decorates one of my walls and reminds me of them daily."

Miss Thelma, as she is affectionately known, has a lovely apartment in the Deport Housing Authority. She is happy and enjoys the company of friends daily. She and the other traveling members have lots of stories to share.

Thelma says "The greatest thing about living in the apartments is being reunited with my friend of 70 years, Ruth Grant Murrell. We went to high school together, attended college together and never lost contact over the years that Ruth lived in Lufkin. We don't see each other every day but we do talk several times a day on the phone."

Miss Thelma has lived a rich, full life and her multitude of friends and admirers testify to that.

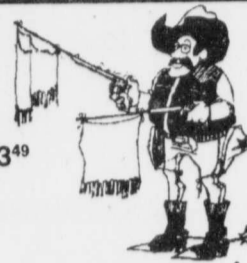

Campaign signs not allowed on right-of-way

As the election season moves into high gear, candidates and campaign workers are reminded to be careful where they place campaign signs.

Such signs are not allowed on state highway right of way, which is reserved for official traffic control signs. Campaign signs erected on highway right of way will be removed by the Texas Department of Transportation and the owner can be charged for removal costs.

In addition, a person placing an unauthorized sign in highway right

of way can be fined up to \$500 per sign.

Campaign signs may be placed on private property, with the landowner's permission if they meet certain restrictions. Signs must be made on lightweight material and be no larger than 50 square feet. They can be erected no sooner than 90 days before an election and must be removed 10 days after the election.

Signs within city limits may be subject to local ordinances.

Miss Texas 1999 will make Lamar/Red River county appearances



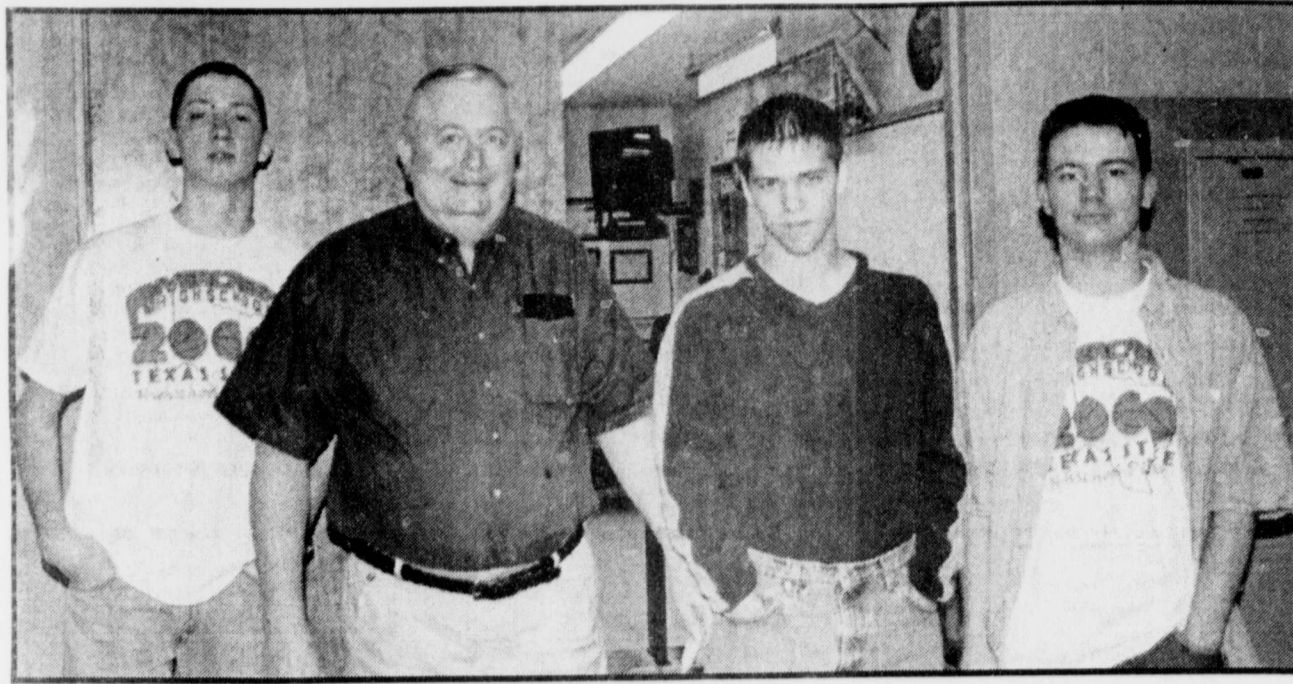
