Waxed what?

But I began thinking about waxed paper and how scarce it is now.

Exactly what year did bread begin to come in plastic sacks? I remember being still at home. My grandmother Jeffus would fuss and fuss because her arthritic fingers had trouble with the little, flat plastic clips. The twist ties made her much, much happier. Of course, the plastic bags gave her something else to save, along with plastic margarine tubs, rubber bands, string bows and ribbons from gifts and flower arrangements!

Before the bags bread came in waxed paper wrappers that made it impossible to keep bread moist, once that package wax open the bread was going to dry out...hence bread boxes, also an endangered species these days.

But it wasn't only bread that came that way, snack cakes, fried pies, boxes of tea bags, many things appeared wrapped in the waxy paper that was heat sealed shut.

Cracker Jacks, cough drop boxes, candy bars and more were sealed for freshness.

Now, mylar type packaging seals that freshness in a whole lot better. It is more challenging to get into though, isn't it?

Strangely, crackers still come in individual waxed paper packs inside a plain cardboard box. An occasional fried pie still is bundled up in waxed paper, but other than that there are very few evidences of the once-prevalent paper.

Waxed paper, in it's familiar blue colored box, can still be purchased at a grocery store, but plastic wrap and aluminum foil long ago took it's place for routine covering of food items.

It's seldom used now except for special cooking projects. Growing up, there was always a roll in the kitchen. Now there never is.

Do I mourn the loss of waxed paper? No, I don't. I like plastic bread sacks, mylar candy bar wrappers and the various other things that have improved the shelf life of food products. But, I did spare it a few moments thought. I'll bet you can think of other packaging that has faded away with time...glass milk bottles, perhaps?

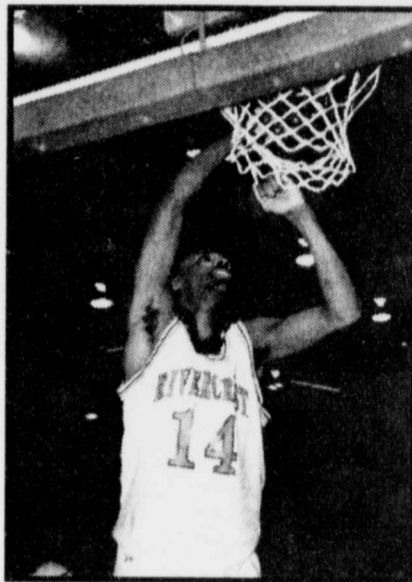

The Talco and Bogata Guaranty Banks will be closing their doors early on Friday, March 2, 2001.

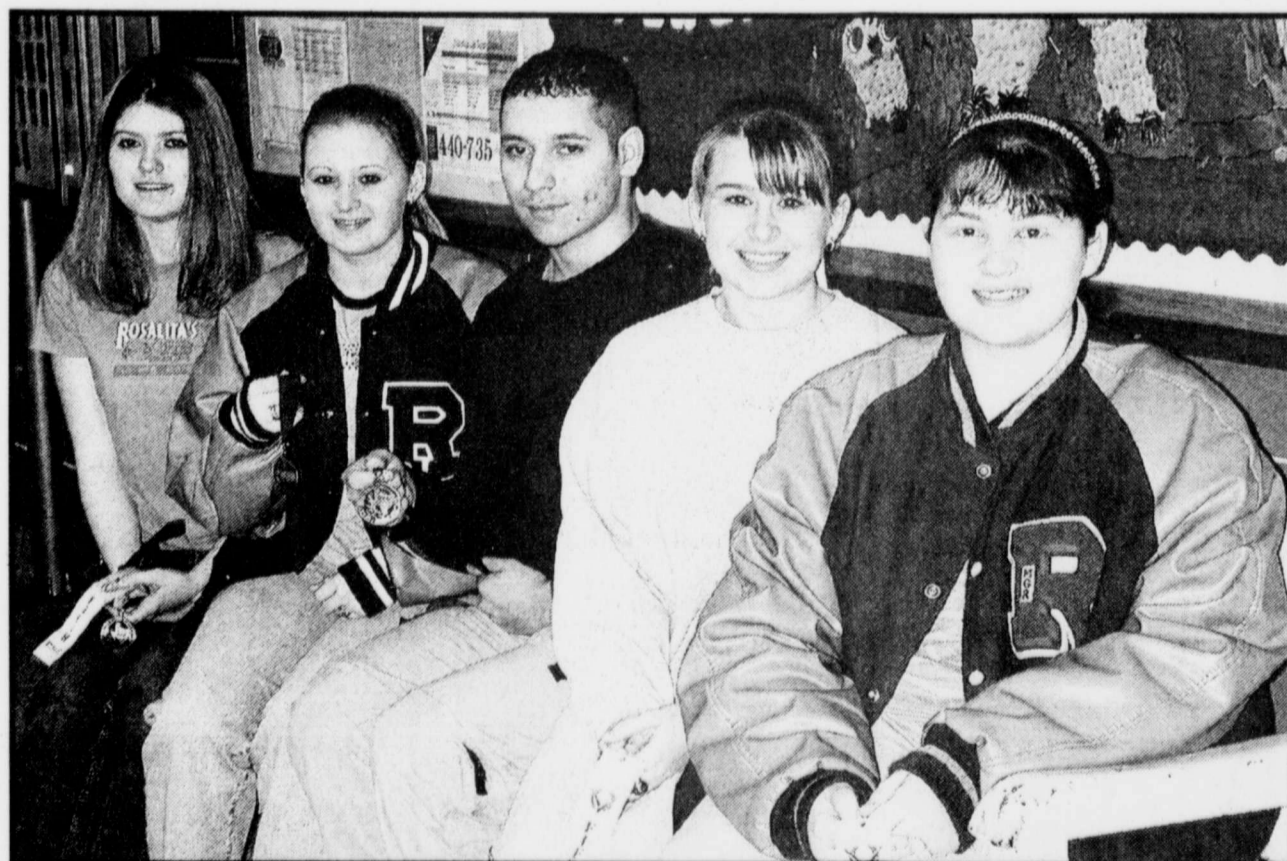
The banks which are normally open until 6:00 p.m. on Fridays will close at 5:00 p.m. March 2 in order for the employees to be able to attend the

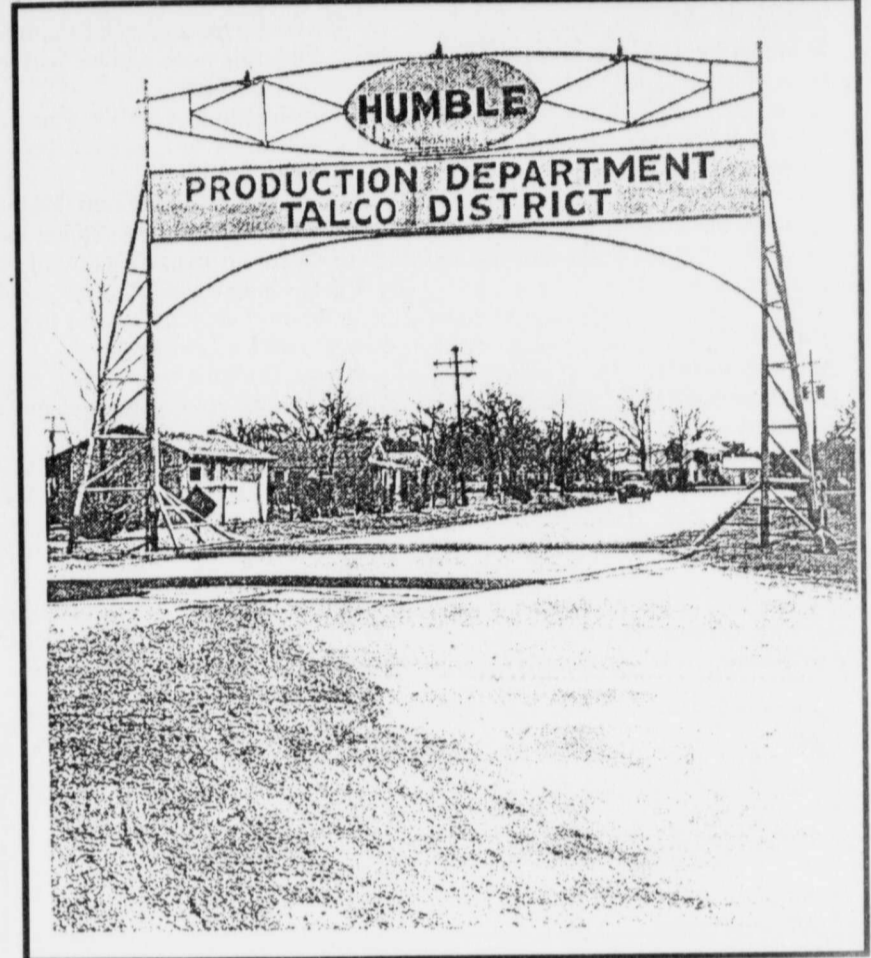

Seventy-Two years of service for the Lord

The Talco Church of Christ hosted Lectureship services last week and among the guest speakers was Perry Cotham who spoke on Sunday night.

Mr. Cotham was born January 5, 1912 in Murray, Kentucky and grew up on a farm. He began his preaching career in 1929 after being encouraged by an older cousin. He preached in his home area until 1934 when he earned a degree from Murray State University. Mr. Cotham was proud to say that a number of his childhood friends had also made preachers.

He moved to Shawnee, Oklahoma and on June 25, 1936 where he married Teresa Overby, a daughter of a preacher. In 1946 the couple moved to Paris, Tx. to work with the Lamar Avenue Church of Christ. They spent 6 years in service there. The couple had 2 sons and 1 daughter who gave them 5 grandchildren and 4 great grandchildren.

In 1972, Bro. Cotham directed full time effort to world evangelism. He has preached in all 50 states, Canada and all the continents except Antarctica, where by the way he has no plan to go. He has preached on most of the islands of the West Indies and in over 70 different nations.

When asked what are the largest changes he has seen over his years of preaching he said, "People's moral attitude has changed and the great change in home life". Bro. Cotham has taught in a preacher training school in Australia and currently teaches during the winter quarter at the Brown Trail School of Preaching in Ft. Worth, Texas. He has written 16 religious booklets and engaged in public religious debates, 3 of which are in print. Many of his writings have been translated into numerous languages.

Bro. Cotham has recently returned from a mission trip that took him to visit India, Nepal, Singapore, Malaysia and Thailand. In summary of the

trip he reported a total of 15,135 Bibles; 600 New Testaments; 300 portions of Scripture and 219 tribal song books bought and a total of 1,174 baptisms were performed in India. Three more baptisms were performed after the close in Singapore and eleven were baptized in Kakinda the following Sunday.

Although Bro. Cotham has no plans at this time for traveling overseas he does have many gospel meetings planned for the United States. He jokingly said if he had any leisure time he'd just write more. When asked why he has not retired, after a good chuckle, he said, "I love preaching just too much and will do it as long as I am able to do so". A fond childhood memory of Bro. Cotham's was going to church during and ice and snow storm. He remembers some neighbors coming by with a horse and buggy pulling a sled behind. His folks got in the buggy and he and the neighbors child got to ride in a box on the sled. What fun he remembers that ride to be. (As usual, children don't remember the cold like adults do, just the fun.)

Bro. Cotham considers Asia as a field of great opportunity today. He has bought thousands of Bibles for work in that area in native languages. There have been some 5,000 conversions during his visits to Asia thus far and he hopes to see God's work continue there.

Bro. Cotham recently celebrated his 89th birthday and has given of himself in the Lord's work 71 and working on 72 of those years. He has seen many changes in America and the entire world both for the good and bad but he will continue to work for the Lord as long as he is allowed.

The Talco Church of Christ is honored to have had Bro. Cotham speak and will work to help spread his message from the word of God.

Grandmother Gibb's Ranger Cookies

1 cup granulated sugar
1 cup brown sugar
1 cup shortening
2 eggs-beaten
2 cups flour
2 cups oatmeal
1/2 teaspoon baking powder
1 teaspoon soda
1/2 teaspoon salt
1 cup Post Toasties-crushed

Mix sugars and shortening; add eggs and vanilla. Then add dry ingredients. Mix well. Add cereal. Place on greased cookie sheet by teaspoonsful. Bake 10 minutes at 450 degrees.

Peach Filling for Fried Pies

2 gallons unpeeled peaches-cut up
6-8 cups sugar
2 cups vinegar

Mix and cook until thick or consistency of peach preserves. Pour into hot pint jars while boiling hot and seal. They may be placed into freezer containers and frozen. To make pies, simply make and cut pastry into 5-inch circles. Fill one side of circle with peaches and dot with butter. Moisten edges of dough with water and fold other half of dough over peaches. Seal edges of pie by pressing edges together with fork tines. Fry in hot shortening and turn once.

Pastry for Fried Pies

2 cups flour
1 teaspoon baking powder
1 teaspoon salt
1/2 cup margarine
1/2 cup + 2 tablespoons warm water

Combine flour, baking powder and salt. Cut in margarine and then add warm water. Cut into 5-inch circles.

Party Cheese Ball

2-8 ounce cream cheese
2 cups shredded cheddar
2 tablespoons mayonnaise
1 teaspoon black pepper
1 tablespoon Hidden Valley Ranch Dressing Mix
1 tablespoon mustard
1 bell pepper-chopped
4 green onions-chopped

Combine all ingredients and form into a ball. Sprinkle lightly with paprika.

Pecan Pie

3 eggs-slightly beaten
3/4 cups sugar
1/2 cup dark corn syrup

1/2 cup light corn syrup
1/4 teaspoon salt
2 tablespoons margarine-melted
1 teaspoon vanilla
1-1/2 cups pecans
9-inch deep dish pastry shell

Heat oven to 350 degrees. Spread pecans in pastry shell. Beat eggs, just until blended. Add sugar, syrups and salt. Melt margarine and let cool. Blend into syrup and sugar mixture. Add vanilla. Pour over pecans in pie shell. Bake 45-50 minutes.

Morning Glory Muffins

4 cups flour
2-1/2 cups sugar
4 teaspoons soda
4 teaspoons cinnamon
1 teaspoon salt
4 cups grated carrots
1 cup raisins
1 cup pecans-chopped
1 cup coconut
2 apples-peel, core & grate
6 eggs-slightly beaten
2 cups cooking oil
4 teaspoons vanilla

Into a large bowl, sift first five ingredients. Then stir next five ingredients. Combine last three ingredients and stir into flour mixture until just combined. Spoon batter into well-oiled muffin tins. Bake at 350 degrees for 15 minutes. Let cool 5 minutes and then turn out on rack to cool completely.

Cowboy Cookies

2-1/2 cups flour
1/2 teaspoon salt
1 teaspoon soda
1/2 teaspoon baking powder
1 cup shortening
1 cup sugar
1 cup brown sugar
2 eggs
1 teaspoon vanilla
1 cup oatmeal
1 cup chopped nuts
6 ounces chocolate chips
1 cup mini M&M's

Sift together flour, salt, baking soda and baking powder; set aside. Cream shortening, sugar, eggs and vanilla until fluffy. Add flour mixture. Mix well. Drop by spoonfuls onto greased cookie sheet. Bake at 350 degrees for 10-12 minutes.
