VETERANS CORNER

Two subcommittees (Disability Assistance and Memorial Affairs, and Oversight and Investigations) of the House Veterans' Affairs Committee (HVAC) recently held a joint oversight hearing examining VA's disability claims process for veterans afflicted with Gulf War Illness (GWI). VA's own data reveals that at least 80 percent of Gulf War Illness claims are denied. The data is specific to undiagnosed illnesses and chronic multi-symptom illnesses—both presumptive conditions. This data reveals apparent problems in VA's interpretation of the law with regard to claims processing. The

purpose of the hearing was to evaluate VA's disability claims process with respect to veterans suffering from Gulf War Illness. Don't let this deter you from filing a claim if you were there and experience these problems, come and talk to me. 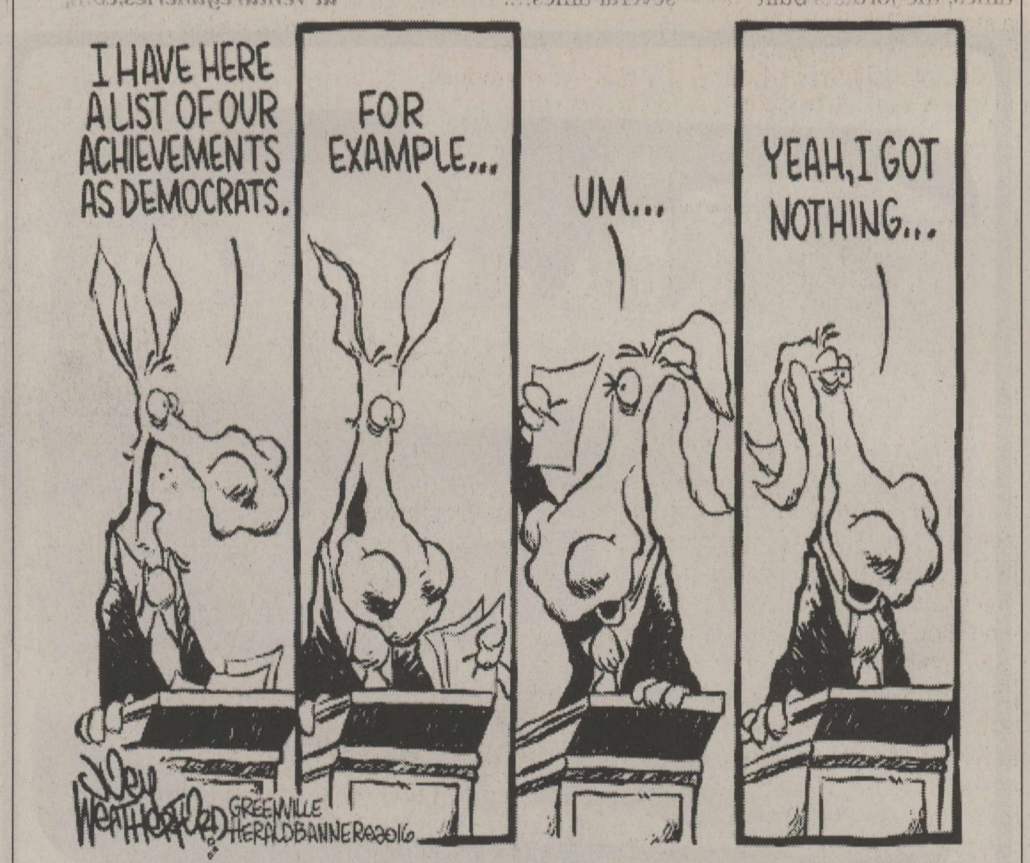
