Booster Club to sponsor tailgate parties at home games

Plains Booster Club, in their meeting Aug. 11, finalized plans to sponsor tailgate parties prior to each home football game. A different meal will be offered each night with parents of each class responsible for one game and all working together for the homecoming game.

Senior parents will serve barbecue-on-a-bun at the first home game, Sept. 2 against Seagraves. Junior parents will offer hot dogs prior to the Oct. 14 game with Anton. Sophomore parents are in charge of the Oct. 28 game with O'Donnell and will sell hot wings or drumsticks. Freshman parents will serve burritos at the Nov. 4 game with Smyer. All will help serve baked potatoes at the homecoming game Sept. 30 against Farwell.

Parents of each class are asked to rotate the responsibility of decorating cars with streamers each Friday morning. Freshman parents will have the first game. Boosters believe this will involve more people in support of the school athletics.

Announcement was made that the club made \$1,000 from the sale of hamburgers and breakfast burritos during the Friday and Saturday night rodeos. They also won \$40 for their second place winning float in the parade.

Sales of poster schedules topped last year with 750 posters expected to be in before the first football game. They will be distributed as soon as possible.

family and friends to wear. The first button ordered is \$4, additional buttons will be \$3 each.

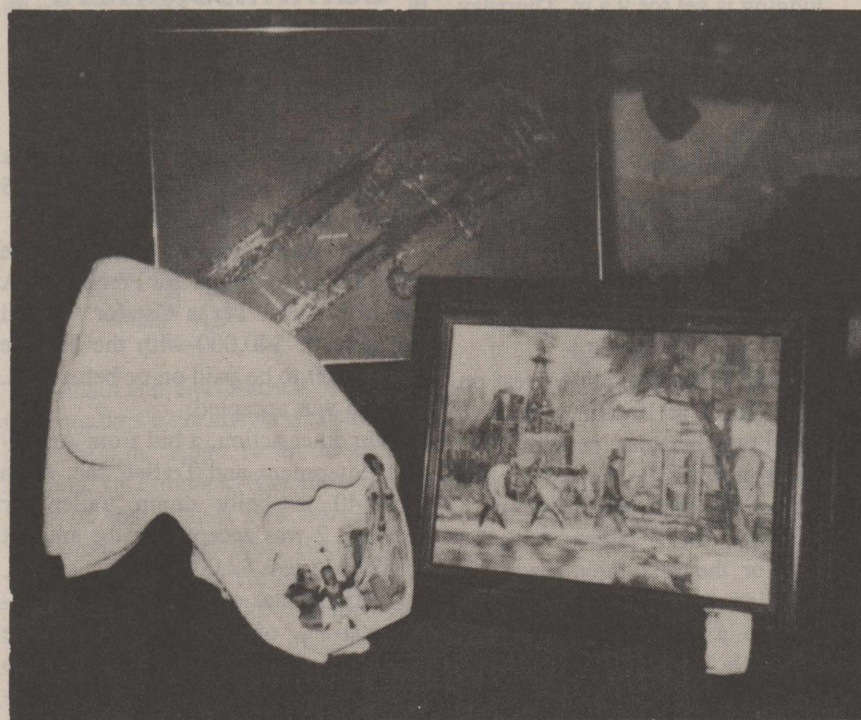

Entry deadlines nearing for South Plains Fair

A barn full of pigeons, poultry and rabbits is expected in the Poultry and Rabbit Barn during the eight days of the 77th Annual Panhandle-South Plains Fair, Sept. 24 - Oct. 1, reports Steve L. Lewis, fair manager.

Poultry and pigeon breeders will showcase their birds while competing for \$4,100 prize money during the Pigeon and Poultry Shows set for Saturday and Sunday, Sept. 24-25. Birds will be on display until Monday evening, Sept. 26, when they will be released, beginning at 9 p.m.

Pigeon and Poultry judging is scheduled for 9 a.m. Saturday, Sept. 24. Capon judging, open to regularly enrolled 4-H club members or students of a Vo-Ag Department, is set for Sunday, Sept. 25, at 9 a.m.

Exhibit birds will be accepted in the Poultry and Rabbit Barn after 6 p.m. Friday, Sept. 23, and must be cooped before judging begins at 9 a.m. Saturday.

Judge for the Pigeon Show is Billy McGwier of Livingston, TX. Judging poultry and capons is Warren Beal of Maiden, NC. Last year almost 1,200 birds were entered in these shows.

Rabbits will take center stage in the barn after 2 p.m. Tuesday, Sept. 27, and will be on display for the remainder of the fair.

Rabbit show competition is open to the world and more than \$2,500 in prize money will be awarded. The show is sanctioned by the American Rabbit Breeders Association, the Southwest Rabbit Association and 17 major breed associations. More than 1,500 rabbits were entered in the 1993 fair.

Judging is set for 9 a.m. Thursday, Sept. 29 and Tex Thomas of Marionville, Missouri will judge the show.

Rabbits will be received in the barn through the Broadway gate entrance at the following times: Tuesday, Sept. 27, between 2 and 6 p.m.; Wednesday, Sept. 28, between 8 a.m. and 6 p.m. or between 10 and 11 p.m. No Wednesday entries will be taken after 11 p.m.

A youth rabbit judging contest on Saturday, Oct. 1 at 10 a.m. is open to entrants in two divisions: persons 12 or under and persons 13-18. The contest will consist of rabbit placement and a written test. Cash prizes will be awarded for the first three places in each division and first place winners will receive a trophy. Contest entry must be made before 10 a.m. the day of competition.

Entry forms for poultry, pigeon and rabbit shows are available from the fair office and should be mailed to the following show officials: pigeon show superintendent James L. Welch, 4201 52nd Street, Lubbock, TX 79413; poultry show secretary Floyd Starkey, Rt. 1 Box 221A, Ralls, TX 79357; and rabbit show secretary Rosalie Berry, 513 E. Kent, Lubbock, TX 79403. Entry deadlines are Sept. 8 for rabbits; Sept. 16 for pigeons and Sept. 19 for poultry.

A \$1 fee should accompany each bird or animal entry. Capon entries must be approved by the students' county extension agent or vo-ag teacher.

Yoakum County Commissioners Court met in special session Aug. 15 with all members present.

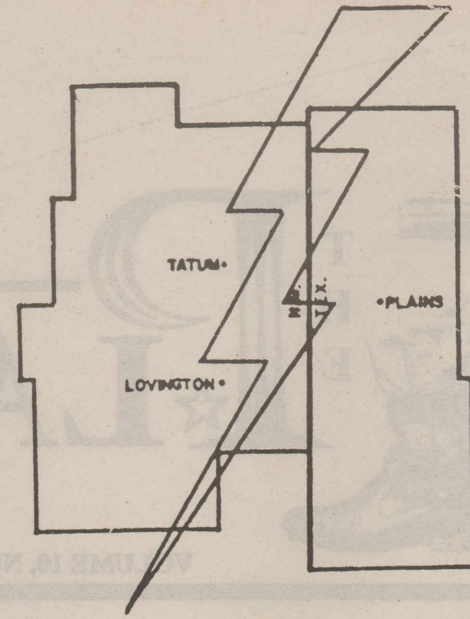
Bids were opened for the purchase of a new motorgrader for Precinct 1. A bid from West Texas Cat for a down payment of \$40,000 with the balance of \$33,160 to be paid on or before Jan. 1, 1995 was accepted.

In other action, a bid from American Equipment and Trailer, Inc. for a new 40 ft. belly dump trailer for Precinct 2 was accepted in the amount of \$22,618 less \$2,000 trade-in.

Fritzi Cates and Sheryl Cates, representatives of Women's Protective Services of Lubbock met with the court and presented statistics on services provided to Yoakum County victims. They requested additional funding for the program. A motion was approved to move \$1,000 from general fund/other department/contingency for Women's Protective Services.

A petition from TEXAS ALLTEL to lay, construct, operate and maintain communications cable under and across county roads was unanimously approved.

Disbursements and part time salaries were approved for payment.

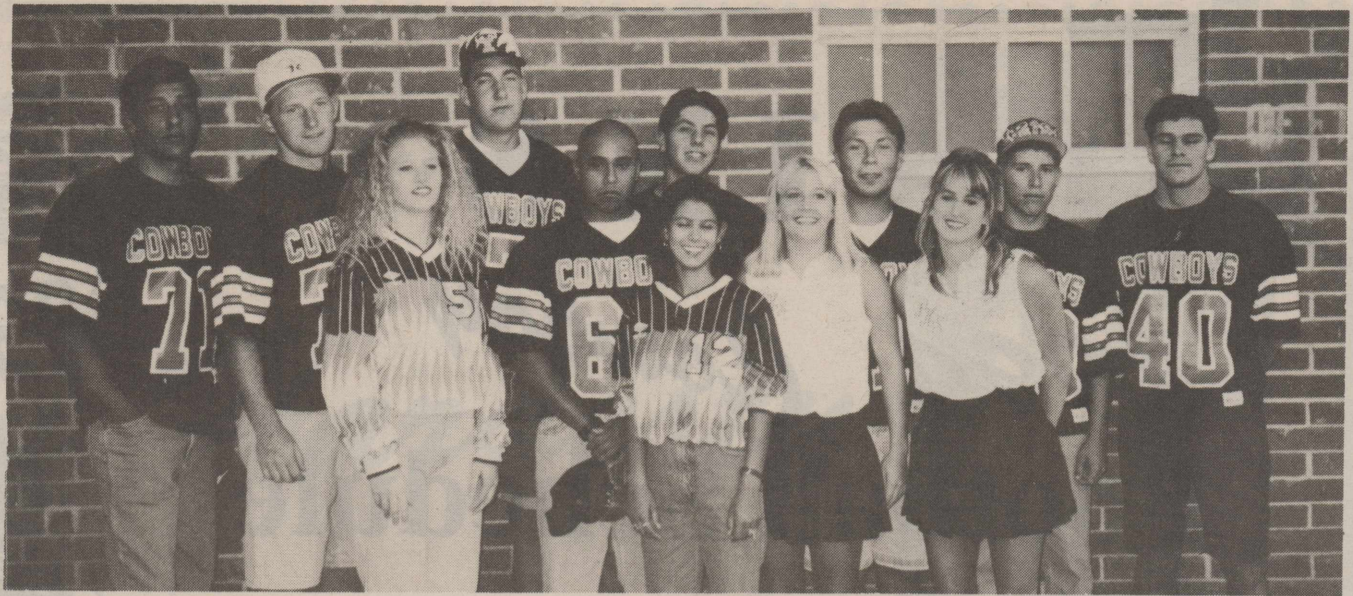

SPS announces new contract with Lea County Electric

Southwestern Public Service Company has entered into a long-term power supply agreement with Lea County Electric Cooperative in New Mexico, in which SPS will provide the cooperative's full requirements power into the next century. The agreement will be for 20 years and continues a relationship between the utilities which has existed since Lea County Electric was founded in 1949.

Lea County Electric purchased a portion of its power needs from SPS until 1983 when the cooperative discontinued its own generation and began purchasing all its power needs from SPS.

Lea County Electric Executive Vice President K.C. Martin noted that Lea County Electric has some of the lowest rates in the state of New Mexico. "The members of Lea County Electric have benefited from the purchase of all our power from SPS," Martin said. "This new contract will assure us of the ability to continue to receive reliable, low-cost power from SPS for the next two decades," he said.
