## **Counts Begins Fifth Term As State Representative**

AUSTIN - State Representative David Counts (D-Knox City) was officially sworn in for this fifth term as state representative for the 70th District during the opening ceremonies of the 74th Texas Legislature.

"I am excited about the possibilities for the new session," Counts said. "In previous sessions, we have always come in with a number of court mandates and deadlines to deal with. This time, we are going to have the opportunity to really explore in depth some of the issues facing Texas.

Counts noted education, welfare reform, crime, juvenile crime tort reform, and property rights as some of the key issues for the 74th legislature.

"Education has to be our top priority," Counts said. "The advances in techology and the opening world economies are changing our job markets daily and the only way our kids are going to be able to compete is with a top notch education. It is really encouraging to see how our schools are trying new and innovative ap-

proaches to reach out to the kids and help them succeed. I want them to have the freedom to continue to try different approaches and decide for themselves how they will administrate their schools." Counts also commented on the issue of juvenile crime. "There is a real movement to crack down on juvenile violence and crime," Counts stated. 





## **METER TAMPERING NOW A FELONY**

The State of Texas has recently adopted an amendment to the State Penal Code making meter tampering a third degree felony. A third degree felony comes with a punishment of confinement in the Texas Department of Corrections for a term of not more than 10 or less than 2 years. In addition to imprisonment, an individual adjudged guilty of a third degree felony may be punished by a fine not to exceed \$5,000. Before the amendment of the new law, it was a class A misdemeanor for meter tampering unless the loss of

service was more than \$200. Under the new law, any meter tampering regardless of the amount of loss is now a felony of the third degree.

Meter tampering consists of, but is not limited to:

(1) Diverting electricity from passing through a meter device.

(2) Preventing electric service from being correctly registered by a meter device.

(3) Unauthorized activation of electric service.

As a special note to our members, it will also be considered meter tampering if a meter is reset and electrical service is restored by anyone other than a Cooperative employee.

All Cooperative meters are sealed. This seal should not be cut or broken without special authorization. In cases where the seal must be cut for emergencies the Cooperative should be notified as soon as possible so that the meter can be resealed.





Do you have a child age one or older who doesn't have a Social Security number? Have you changed your name this year (through marriage, divorce, or any other reason)? Are you receiving Social Security Benefits and you've moved this year? Did you work this year while receiving Social Security benefits and earned more than the annual earnings limits?

If you answer yes to any of these questions, you should be talking to Social Security as soon as possible. If you are receiving benefits, failure to report these changes may affect the amount of your benefit or whether you receive them on time. If you are not receiving benefits, failure to report them may affect the amount of your future benefits.

#### **Check Social Security Numbers On Tax Returns**

The law requires you to list a Social Security number on your tax return for all dependents over age one. Also, for the first time, the IRS will be delaying returns that have incorrect Social Security numbers until they are corrected. So you should be sure you have a correct Social Security number for yourself and any dependents before you file your next tax return.

#### Report Name Changes To Social Security

If you changed your name this year (through marriage, divorce, or any other reason) and haven't made sure your new name is listed on your Social Security card and in Social Security's records, there may be problems posting your earning to Social Security's files. (This could reduce your future Social Security benefits.) Also, the Internal Revenue Service may have problems processing your tax return.

To get a replacement, you need an identifying document, such as a driver's license. To change the name on your card, you need documentation that shows both your old name and your new name. If you were born outside the United States, generally you also must show proof of U.S. citizenship or lawful alien status. Your replacement card will have the same number as your old card.

**Report New Address Changes To Social Security** 

N If you're receiving Social Security benefits and you've moved this year, make sure we have your new A DECEMBER OF address. (Sometimes people who have their checks sent directly to their bank forget to tell us about a change in their mailing address.)

W You must notify the post office and Social Security immediately if you change your mailing address.

In fact, failure to report a change of address is the leading cause of checks not arriving on time. Your S report should include your claim number, your old address, and the new address, including Zip code. Give the names of all family numbers who receive benefits or information at the new address.

You should report a new address even if you have direct deposit because important letters from Social Security are sent to your mailing address, even though your benefits go directly to a bank. Your benefits could be stopped temporarily id Social Security cannot locate you because you have not reported a change of address.

#### Report Excess Earnings To Social Security By April 17, 1995

If you received Social Security benefits, worked in 1994, and earned above the annual limit, you need to report your earnings to Social Security by April 17, 1995. The 1994 limits were \$8,040 for people under 65 and \$11,160 for people 65-69. If you were age 70 for the entire year, the earnings limits do not apply to you.

## **Texas Licenses To Have New Look In '95**

Texas driver licenses will have a new look beginning early in 1995. The new licenses will be more convenient for Texas' 15.6 million license and identification card holders and will provide more security features, according to the Texas Department of Public Safety.

"We're always looking for new ways to prevent criminals from using driver licenses for illegal purposes," said DPS Director Col. James R. Wilson. "The new licenses and identification cards will be much harder to forge or alter. A real bonus is that the same technology that makes the new licenses more secure will greatly reduce the time it takes to get the card into the hands of the owner."

The DPS will begin phasing in the new technology in January. New licenses will be available in all 243 towns and cities with driver license offices later in the year.

Current licenses need not be replaced. They will continue to be valid until their expiration date. Fees will remain the same.

The new license will have a look similar to a credit card, but will be easy to distinguish because of colorful images of the Texas flag

and Texas seal against a beige background. New digital imaging technology also will enhance the licensees' photographs.

"The new format will include a magnetic stripe, a bar code and a special laminate to maximize security," said Judy Sibert, DPS project manager for the digital image driver license system. "Licenses issued for Texans under the age of 21 will look different from regular licenses, making it easier for merchants to determine a customer's age."

The application and renewal procedures will change very little. Applicant's thumb prints will be taken using imaging equipment, eliminating the mess of ink. Photos will be taken with video cameras linked to computers, allowing technicians to better assure a good likeness of the applicant.

"A real benefit to licenses is that the new system will allow us to get the license in their hands in fewer than 10 days, instead of the current four to six weeks," Sibert said. "And as merchants adopt equipment capable of reading the magnetic stripe, these new cards will speed up check acceptance."

Sibert said another security feature will be a laminate embossed with the word "TEXAS" in lines on the front. The "TEXAS" will glow under ultraviolet light.

Drivers with good records will continue to be able to renew for a second four-year period without returning to a license office.

The last major change in licenses was made in 1968, when pictures were added and the use of paper licenses was discontinued except for temporary licenses, learners' permits and certain special needs licenses.

## **Reminder To Taxpayers JANUARY 31, 1995 IS THE LAST DAY TO PAY YOUR 1994 TAXES** AND AVOID THE ADDITIONAL PENALTY AND INTEREST CHARGES

## HOMESTEAD EXEMPTIONS

Homeowners are not required to file a homestead exemption annually. If you are already receiving the state mandated \$5,000 homestead exemption or additional over sixty-five \$10,000 exemption, you need not reapply for the taxing year of 1995. However, if you became 65 after January 1, 1994, and before January 1, 1995, you need to apply for the additional over 65, \$10,000 exemption. If you have changed your place of residency you need to apply for a new exemption. All homestead exemption applications must be filed with Chief Appraiser Stanton Brown, between the dates of January 1,1995 and May 1, 1995. These exemption forms are available at the Knox County Appraisal District Office, which is located in the Knox County Courthouse.

## AG-USE EXEMPTIONS

Annual applications for qualifying land for agriculture use is not required. If you have been receiving the AG-USE exemption on your land in prior years, you need not reapply for the exemption. If you have recently purchased a farm, you need to report this to the Chief Appraiser. AG-USE exemption forms are also available at the Appraisal District Office. Deadline for filing new exemptions are between January 1, 1995 and May 1, 1995.

## DISABLED VETERANS EXEMPTION

These exemptions need to be applied for annually. If you received your exemption on the 1994 tax roll, you will automatically receive it for the tax year of 1995. However, if your disability percentage has changed, you need to report the change to the Chief Appraiser. Deadline for filing new exemptions are between January 1, 1995 and May 1, 1995.

## RENDITIONS

Taxpayers are reminded that it is still their responsibility to render their property to the Chief Appraiser. These rendition forms are also available at the Appraisal District Office. Deadline for tax renditions is between January 1, 1995 and April 1, 1995.

## **CBI Students Learning Valuable Skills Through Involvement In Community**

Students in Knox and Haskell counties with special needs and challenges are being given the opportunity to gain skills in Community Based Instruction. The program is a cooperative effort of the two county school districts served by the Haskell-Knox Consortium.

This program is provided for students who receive special education to gain skills in the natural environment, providing experience for life after graduation. Local community members offer mostof these opportunities for students needing to utilize their skills. Students and their training schedules are coordinated with their individual education plan.

Training sites are chosen to meet the appropriate needs of each group of students. Students are not paid as they are obtaining training experience in the actual community setting, as well as gaining job skills.

A job coach (school personnel) will be present at each site to provide the students with independence on task.

Time on the job training site is usually 1 to 1 1/2 hours, two to three days a week, depending on the individual needs. Training sites can be churches, community buildings, school facilities or private businesses.

Students rotate among the job training sites every six weeks. The same site may be used each six weeks for a different group or individual. At any time an employer is dissatisfied with the program, they may relay this infor-




