

Youth Win At Fort Worth


Knox City and area youth did well during the Fort Worth Stock Show held last week.


Winners were:

Greyhounds Are District Champs









Here's To Your Health

By Dr. Shirley Barretto

Last week we looked at the new buzzword in health care called "Wellness", and one of its components - - exercise.

Wellness is more than just freedom from disease or illness. Wellness implies that the individual has chosen a life style that will promote good health, that will bring him or her to their full physical, emotional and mental potential.

As part of Knox County Hospital's commitment to bring a full scope of health care to the community, the Knox County Wellness Center has been set up to help individuals obtain the exercise you need. The Center, located on the second floor of the Knox County Hospital, was opened in November.

Those who join the Wellness Center will get an initial evaluation which consists of a test on a stationary bicycle. The staff at the hospital will combine the results of that test with information about the person's age, weight and blood pressure. This information will then be faxed to Abilene Regional, where it will be fed into a computer which will generate a custom-designed fitness program, tailored for each person.

The initial evaluation costs \$25. Following the evaluation, members will pay a flat fee of \$20 per month. The fee will include use of the equipment, and aerobics classes, which will begin in the next few weeks.

The Wellness Center utilizes the same equipment that was brought into the hospital for the Cardiac Rehabilitation Programanother new service which began last year. Both services are being offered at the Knox County Hospital. We have the treadmills, two exercise bikes, an ergometer, a weight machine, a rower and stair steppers. It's the same type of equipment that those who belong to health clubs in larger towns have.

Hours for the Wellness Center are 1:00 to 8:00 p.m., Monday, Wednesday and Friday; 8:00 a.m. to 8:00 p.m., Tuesday and Thursday and 8:00 a.m. to noon on Saturday.






