For Sept. State Sales Tax Rebate Rebate Down 22.97% From \$9449.90 A Year Ago

City Receives \$7,278.44 Check

(Austin, November 10, 1995) State Comptroller John Sharp today delivered \$197.6 million in monthly sales tax rebates to 1,075 Texas cities and 111 counties, including a check of \$7,278.44 to Knox City. The rebate to Knox City reflects a decrease of 22.97% from a check of \$9449.90 one year ago at this same time. Overall payments for the year to Knox City are \$93,614.04, up 14.51% from \$81,745.22 one year ago at this same time.

Texas cities received \$181.5 million, up 1.5 percent above payments at this same time one year ago. Counties received a total of 16 million in rebates, down 3.3% from their November 1995 rebates of \$16.6 Million.

This month's payments include taxes collected by monthly filers on September, 1995 sales and reported to the Comptroller in Oc-

same time. Munday received

\$11,460.39, up 9.86% from a payment of \$10,431.10 last year at this same time. Munday's yearly total now stands at \$75,281.17, down 1.65% from \$76,550.39 in 1994. Munday collects a 1.500% rate of sales tax, with Benjamin and Goree collecting a 1.000% sales tax. While Knox City just started collecting the new rate of 2% last month, those rebates at 2% will not be reflected until the December, 1995 check issued by State Comptroller John Sharp. Knox City will then receive a full 1% into the normal sales tax refund check, and a full 1% split into the two different accounts for Economic Development.

In Haskell County, Haskell received \$36,844.72, up 27.40% from a payment of \$28,918.64 in 1994. Haskell collects a 2.000% rate of sales tax. O'Brien received \$347.07 to increase their yearly total to \$2,177.68, up 15.84% from this time a year ago. Rochester received \$0, down 100% from a payment of \$1,216.15 last year. Their yearly total stands at \$6,961.48, down 6.79% from last year's total of \$7,469.37.

In Jones County, Stamford received a payment of \$50,486.61,

down 19.57% from a payment of \$62,777.75 in 1994. Stamford collects a 2.000% rate of sales tax.

In Baylor County, the city of Seymour received a payment of \$17,752.63, down 8.93% from a payment of \$19,494.87 in 1994.

In Foard County, Crowell received a payment of \$5,973.03, down 16.41% from a payment of \$7,146.22 in 1994. Crowell collects a 1.500% rate of sales tax.

In Dickens County, Dickens received a payment of \$0, down 100% from a payment of \$2,818.50 in 1994. Spur received a payment of \$3,780.15, down 41.85% from a 1994 payment of \$6,500.69 Dickens collects a 1.5% rate of sales tax, while Spur collects a 1% rate.

In Cottle County, Paducah received a payment of \$5,371.56, down 3.19% from a payment of \$5,549.01 in 1994. Paducah collects a 1% rate of sales tax.

# **County Passes 11 Amendments**

Knox County voters passed 11 of the 14 constitutional amendments in the November 7 elec-

Proposition 10 passed overwhelming across Texas abolishing the state treasurer's office, 187-93.

Voters tied 139-139 on proposition 2, to authorize lawmakers to exempt Masonic lodges and some other state charitable organizations from property taxes.

Defeated were proposition 9 to allow investment of money from the Texas Growth Fund in a business without the business's disclosure of investments in South Africa or Namibia, 122-162, and proposition 13, to give local governments the option to exempt shrimp and fishing boats from property taxes, 87-177.

Passing were proposition 1 (education bonds) 180-109; proposition 3 (agricultural loans) 181-107; proposition 4 (home refinancing) 158-121; proposition 5 (veterans' housing bonds) 173-

Also, proposition 6 (survivors' exemption) 217-63; proposition 7 (reduce collider bonds) 174-102; proposition 8 (constable offices) 184-79; proposition 11 (land appraisal) 169-110; proposition 12 (tax exempions) 185-97; proposition 14 (veterans' exemptions)159-104.





# Drunk Driving Leads To Prison Sentence For Man Involved In JoDee's Case

Jurors Find Defendent Guilty of Aggravated Assault With Deadly Weapon

(Editor's Note: The following article is a reprint from a recent issue of the Floyd County Hesperian-Beacon on the case involving the June 10, 1995, accident of Jo Dee Homstad of Knox City. We are using the article in its entirety.)

Thursday, October 19, after two days of witness testimonies, Floyd County jurors deliberated for 1 1/2 hours before deciding that Rudy Valadez, 35, of Floydada, was guilty of the 2nd degree felony of Aggravated Assault.

Jurors also found Valadez guilty of using a deadly weapon (his automobile) in the commission of the aggravated assault.

Charles Mais, the attorney for Valadez, requested sentencing be made by 110th District Court Judge Randy Hollums. After attorney's arguments, on Friday, October 20, Hollums sentenced Valadez to 18 years in prison and a \$10,000 fine.

The conviction of using a deadly weapon in the commission of the crime prevented Valadez from being eligible for probation. He must also serve a minimum of 1/4 of his sentence before he can be considered for parole. According to District Attorney Becky McPherson, a "deadly weapon is anything that can cause serious bodily injury or kill someone."

This conviction stems from an accident in Floyd County, June 10, 1995, at approximately 10:14

According to McPherson, Valadez was traveling west bound on FM 784. At the same time, three pickups were parked, one behind in the other, in the east bound lane of FM 784. The wheels

of the pickups were on the edge of the shoulder of the lane. Ten teenagers were visiting at the scene, four outside of the pickups and six inside pickups.

Witnesses testified that Valadez crossed the center stripe, struck the first pickup in the line, continued down the pickup, and then struck the second pickup, penning eighteen year old Jo Dee Homstad between the 2nd pickup and Valadez's vehicle.

The impact broke Homstad's right leg and tore all of the ligaments in her right knee. Her left leg was almost totally severed at the hip.

Dr. Seay, an orthopedic surgeon from Lubbock, testified that the car actually amputated the leg at the hip and he just finished the amputation at the hospital.

Because of the accident, Homstad of Knox City, was also blinded in her right eye and has undergone over 15 surgeries, including two brain surgeries. She is now in a wheelchair undergoing physical therapy. Medical bills are already over \$350,000 and are expected to go higher.

Todd Hinsley, 16, a passenger in the second pickup, suffered a broken nose as a result of the collision. Shane Derryberry, 17, escaped injury by jumping on the top of the tool box on the first pickup.

A DPS chemist testified at the trial that four hours after the accident, the blood alcohol concentration in Valadez was .17. Because of the time lapse the chemist told jurors that at the time of the accident the blood alcohol level would have been .25.

The legal intoxication limit is .10 blood alcohol concentration.

Medical records introduced at the trial also showed Valadez tested positive for cocaine.

During the punishment phase of the trial it was shown that Valadez had two previous DWI convictions. One of the convictions was out of Castro County in 1985 and the other was in Floyd County in 1993.

Adult Probation Officer James Williams testified that at the time of the accident, Valadez was on probation for the 1993 DWI conviction.

Williams testified that Valadez had been taken before the Judge on two separate occasions for drinking while he had been on probation.

Aspart of his probation Valadez was ordered to attend MHMR counseling and AA meetings. Williams testified that Valadez did not attend meetings regularly.

The maximum sentence for Aggravated Assault with a Deadly Weapon is 20 years and up to a \$10,000 fine.

McPherson asked Hollums to impose the maximum sentence saying the "life of JoDee and her family will never be the same. The defendant will be able to walk out at the end of his sentence but JoDee will never be able to walk out."

"The action of the defendant changed Jo Dee's life and that of her family forever," said McPherson. "Valadez may not have intended to hurt Jo Dee, but he did intentionally take that drink and get behind the wheel of his car knowing the consequences."

"Valadez has been given every chance to prove he is not danger-ous to the public but he has proven he is dangerous. The only way to

keep this from happening again is to give him the maximum 20 years," said McPherson.

Defense Attorney Mais asked for leniency and argued that Valadez was not "a hardened criminal and that he had never been convicted of a felony."

Mais also had friends and family testify on behalf of Valadez.

Besides the 18 year prison sentence and the \$10,000 fine, Judge Hollums also ordered Valadez to pay restitution.

# Graveside Rites Held Saturday For Annie Paul

Graveside services for former Knox City resident Annie Janie Paul of Irving were held Saturday afternoon, November 11, at two o'clock in the Knox City Cemetery with Rev. Demp Emerson officiating.

Mrs. Paul, 98, died Thursday, November 9, in Irving following a lengthy illness.

Born in Womack, Texas, Erath County on April 10, 1897, she was the last child of the E.S. McGuire family. She married W.H. (Bill) Paul in 1922. He preceded her in death. She was a member of the First Baptist Church for over 35 years serving as teacher, working in WMU and a dedicated faithful church member. At the time of her death, she was a member of First Baptist Church in Arlington where she lived until she moved to Irving in 1991.

She was preceded in death by a daughter, Velma McNellie; and sons, Glen and Grady Paul.

Survivors include three daughters, Ruby Coleman of Visalia, California, Dorothy Brown of Irving; and Margie Loher of Dallas; a son, Irvin Paul of Port Lavaca; 11 grandchildren and 20 greatgrandchildren.

# Police Issue Legality Of **Golf Carts On Streets**

By Dean Homstad Knox City Chief of Police

Recently, several questions have arisen in reference to the legality of the operation of golf carts upon public streets. This article will attempt to address some of these concerns.

If a golf cart is not going directly to or from a golf course, it is subject to Texas Registration Law and must be registered.

If a gold cart is operated upon an "Arterial Street", that is to say Texas 6 or Texas 222 in Knox City, it must be equipped with the orange triangular slow moving vehicle emblem displayed to the

Golf carts operated upon public streets after dark (defined as 30 minutes after sunset to 30 minutes before sunrise) must be equipped with lights as follows: at least one white light to the front visible for 1000 feet. Two red lamps to the rear visible for 100 feet or one red light visible for 1000 feet and two red reflectors visible for 600 feet.

Golf carts are not exempt from traffic laws having to do with the

safe and orderly movement of vehicles upon public roads. Operators of golf carts, when on public roads, have many of the same responsibilities and obligations as licensed drivers of motor ve-

Examples: They must stop at stop signs. They must stay on the right side of the road. They must signal for turns and lane changes. They are not exempt from rightof-way law. They are subject to the provisions of the reckless driving law.

There is not driver's license requirement for the operation of a golf cart on a public street since the cart is not defined as a motor

The term public street or road includes alleys.

Drivers of golf carts who are in violation of applicable traffic laws can be cited. Parents of minor children operating golf carts in violation of the law may be cited for permitting the violation. In addition, parents may be held civilly liable for damages and injuries which might occur in relation

to the negligent or criminal operation of a golf cart by their chil-
