Dudensing Sets School Record In Triple Jump

Grimsley Is First In 300 Meter Hurdles

David Dudensing set a new school record at the Knox City Relays in the triple jump with a leap of 44' 10".

The Knox City boys finished fifth in the meet with 54 points and the girls were also fifth with 24 points.

Overall totals for the boys were Munday first with 165, followed by Quanah with 155, Lueders-Avoca was third with 58, Crowell was fourth with 57 followed by KC in fifth, Spur was sixth with 34, Megargel was seventh with 14, Paint Creek was eighth with 11 and Munday's "B" team was ninth with nine.

In the girls' overall contest, Quanah was first with 189, Munday was second with 164, Spur was third with 142, Crowell was fourth with 30, Knox City was fifth with 24 and Paint Creek was sixth with five.


First Baptist Church Needs Input From Channel 17 Viewers

Judge Perdue Is Appointed




