Local business owners eye 1997 while keeping their fingers crossed

The economy of Knox City during 1996 proved to be far less than most expected, and business owners seem to be apprehensive when looking ahead to the new year of 1997. With most retail oriented businesses in town fighting discount stores and big city competition, Knox City could very well be on the verge of losing even more businesses if local economic conditions do not improve.

While not wanting to be quoted in the paper, some business owners who have been here for many years express the feeling that things couldn't be any worse. Others are more optimistic and are investing more into their businesses in an effort to catch the eye of customers.

Several new businesses have opened in the past few years, and several others have remodeled, moved to better locations, or expanded their stock to remain competitive.

While discount stores in the larger cities have taken some of the local business, shoppers are quick to point out that they will go where they get the best deal for their money. Shoppers are more mobile than ever before and are willing to travel longer distances to stretch their shopping dollar. Shoppers seem to be smarter than ever before, taking advantage of lower prices wherever they find them and avoiding businesses that have a reputation for excessive markup on merchandise. Those stores in Knox City that take less of a markup in order to keep their customer base are reporting success and seem optimistic, while others are moaning the blues and making grim forecasts about 1997. Local business owners are indeed going through a transition period as the new year arrives. While there is some doubt, one thing is certain: business can no longer be conducted as it has always been in the past. New ideas are needed to keep the shoppers

If your plans include traveling this New Year's Eve, then make plans that only allow a totally sober driver to be behind the wheel.


Mr. Smith, 72, died Wednesday, December 25, at 7:00 p.m. in an Abilene hospital following a lengthy illness.
