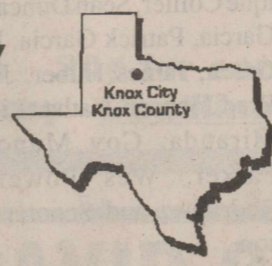

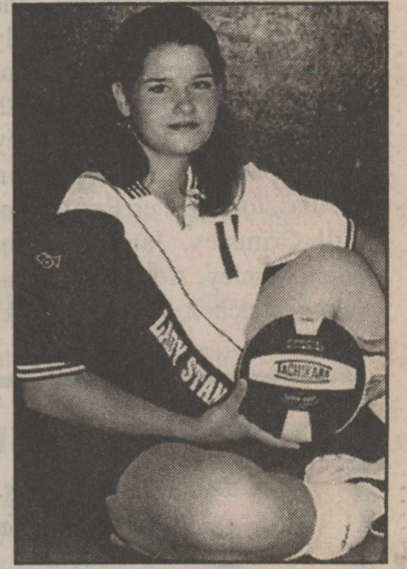

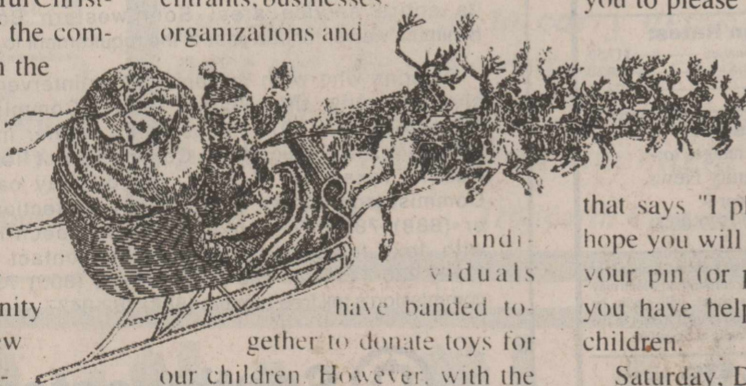
In the following news article turned in to *The Knox County News* by the Knox County Child Welfare Board, it is apparent that the group is anticipating another great Christmas for all the children of our community:

Most of us anticipate a time of family togetherness and gift giving to the ones we love. Unfortunately, not all families in Knox City, O'Brien and Benjamin are able to provide these gifts that

mean so much to children.

This year the Knox County Child Welfare Organization is faced with an unusual situation. In past years, Christmas Parade entrants, businesses, organizations and



individuals have banded together to donate toys for our children. However, with the closing of Perry's, and a concern for our older children (ages 9-15) not receiving age appropriate gifts, we faced an unusual problem this year.

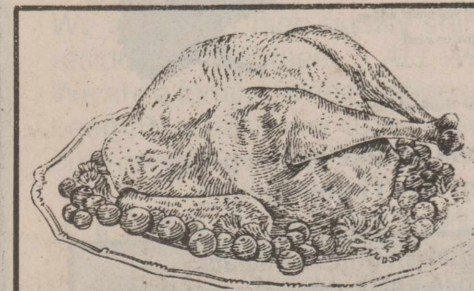
Thanks to all of you in Knox City and the surrounding area for many years of generous giving in the true spirit of Christmas. Please..... help again."

# Pecan show set for December 6

The 1997 Knox County Pecan Show has been scheduled for Saturday, December 6. Judging will be at the Texas A&M University Vegetable Research Station in Munday beginning at 8:30 a.m.  
Entries must be submitted by noon on Wednesday, December 3, to one of the following locations: Whittle and Paint Shop, Knox City; Knox County Extension Service office, Benjamin; or the TAMU Vegetable Research Station, Munday. There is no entry fee and no limits as to the number of entries submitted by an individual.  
All entries must have been raised on trees in Knox County. Each entry must include the exhibitor's name, complete mailing address and telephone number. An entry consists of forty (40) pecans of one variety grown on the same tree.  
This year, the judge will be Emory Boring III, Entomologist with the Texas Agricultural Extension Service in Vernon. Mr. Boring has judged many pecan shows here in Knox County and throughout West Texas.  
This year's pecan show is being sponsored by the Brazos Valley Young Farmers, the Knox County Horticulture Committee, and the Knox County Extension Service.  
For more information, call the Knox County Extension office at 454-2651. Educational programs conducted by the Texas Agricultural Extension Service serve people of all ages regardless of socioeconomic level, race, color, sex, religion, handicap or national origin. # Incentive program for Knox City High School students called 'LOCO'

Congratulations to the Volleyball team and coaches for a great season!

The football season is also over and, as they did last year, those young players got better as the year progressed and they continued to give a great effort from week to week. As those guys mature and grow, we're going to see that program become more competitive in a hurry.  
November has snuck up on us and the Holiday season and basketball season are here! Our Varsity boys and girls basketball teams will be playing this week in the Rule tournament. The girls play at 10:00 and the boys at 11:30 on Thursday morning.  
This is one of the busiest times of the year for our students and it is very easy for them to get so involved with all their other activities that they let their schoolwork slide. To help the kids keep this from happening, we've started a new incentive program for our High School students this six

weeks called LOCO. That stands for **lunch off-campus opportunity**. If a student meets the following criteria then they are allowed to leave campus for lunch on three Fridays the following six weeks. Students must have 100% attendance for the six weeks and be on the A or A/B Honor Roll or show a 10% overall gain in the academic areas on their report card. If they fulfill those requirements, and with parent permission, they will be issued a LOCO pass for lunch on the designated days. This will normally be every other Friday following the Wednesday that report cards go home. We hope that this program will encourage our kids to perform at the highest level of their abilities.  
As always, the faculty and staff are continually looking for ways to improve student performance and we encourage you contact us if you have any suggestions.  
We realize that education is a cooperative effort between the school, parents and the community and welcome your involvement in the education of our children.

**Straight Talk**

This week has been a hectic one here at the NEWS office as we have had to play 'catch-up' with a lot of work that was put off while Stacy's father, Buddy, was so sick before he passed away two weeks ago. Following Buddy's funeral, our welcome back to work was a large stack of work that we are just now beginning to finish up.

In the midst of everything that has been going on around here, we had political visit on Monday from Scott McLaughlin of Big Spring. Once again campaigning for the David Counts' seat in the Texas House of Representatives, McLaughlin was going around to all the small town newspapers to announce his race.

When he entered the NEWS office, he asked to speak to me, but I was gone so Stacy talked with him. Even though Stacy was introduced to him and his wife at the Chamber of Commerce Banquet during the last election and saw him at various other political functions during the campaign, he apparently did not remember Stacy, and did not hesitate to tell her so. Then to her shock and amazement, McLaughlin just seemed to ignore her comment and without even offering a consoling word about her loss, just kept badgering her before she finally got upset with him.

To make matters worse, there were other customers in the office at the time who also noticed (and commented about later) his rude and offensive manner.

Mr. McLaughlin, let me state things plain and simple for you right here in print so that there is no 'misunderstanding' or anything 'between the lines': After your very insensitive and abrasive conversation with Stacy, you will need to speak to me personally in the future. You may be a politician and running for a state level office, but that does not give you or anyone else an excuse to be rude and treat my wife in the manner that you did this past Monday.

As for getting your political advertising in this newspaper, you will be treated just like every other political candidate. Yes, we do personally support David Counts as our hometown State Representative, but David pays for his political advertisements just like any other political candidate. How we feel personally

about David does not interfere with doing advertising business with you or any other political candidate.

Should you choose to advertise in this newspaper, you will be treated as fairly as anyone else, providing you treat us with the same respect.

Believe me, Mr. McLaughlin, here's nothing that we would like better than to run stories about an election that focuses on the issues affecting our readers, not on campaign politics.

My advice to you Scott McLaughlin, would be to consider an apology to Stacy as your next words that you want to appear in this newspaper. That might give us and our readers a little better insight into your character than what you apparently displayed here on Monday. Again, let me state that we will treat you the same way you treat us. So, Scott McLaughlin, now it's up to you.

Mr. and Mrs. David Brown Sr. of Moran are parents of the bridegroom.

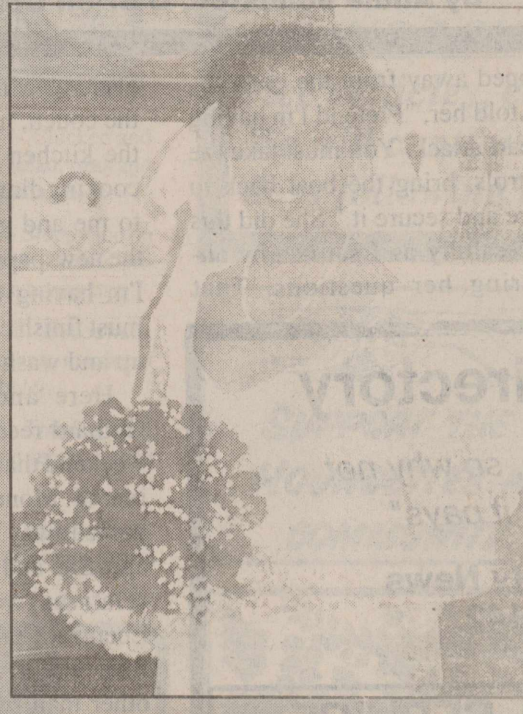
Attending the couple were the bride's sister, Ashley Harrison, as maid of honor; and Michael Stewart of Moran, best man.
