## Hospital Auxiliary Is Being Organized

Something new is being added to benefit the Knox County Hospital! Through the efforts of Director of Nurses Melba Pharr, a hospital auxiliary is in the process of being organized. For many years, men have given of their time and efforts to serving on hospital boards and foundations, so possibly the beginning of hospital auxiliaries may have been the outgrowth of the desire for a common family interest, Mrs. Pharr said. Mrs. Pharr explained that as the hospital and its services have grown, improving with more and better equipment and more and better know-how, there also developed a changing order of hospital-care programs. All of these things have made more work for highly trained professional personnel, and also increased the cost of the hospital operation, thus making it necessary for hospitals to expand their voluntary service programs. There are many groups of volunteers working in various hospitals, and in recent years, a tremendous growth has been witnessed in organized service groups such as the hospital auxiliary. The hospital auxiliary is organized with explicit approval of the hospital board and operates under the supervision of the administrator. It is an integral part of the hospital team. The service rendered by hospital auxiliary volunteers cannot be valued in dollars and cents. This service cannot be bought! The purpose of a hospital is to promote public welfare through development of better patient care for all the people. The purpose of a hospital auxiliary is to assist the hospital in the development of this better patient care by providing volunteer services, promoting better understanding between the hospital and the community, and assisting in financing. The auxiliary volunteer augments the work of the trained personnel so that the employee may have more time for the more technical

job for which he or she is trained, thus increasing the services to the hospital and broadening the services to the patient. The auxiliary volunteer does not replace any paid employee, Mrs. Pharr explained. The auxiliary member or volunteer can be the hospital's best public relations medium. Active, well informed auxiliary members can do much to further good public relations in the surrounding area by "telling the hospital story". The hospital auxiliary is a vital link between the hospital and communities. The hospital auxiliary can do much to augment the services to patients and staff through money making projects or other forms of fund raising. Many projects may not otherwise be available if dependent entirely upon the regular programs or budget of the hospital.

Mrs. Pharr emphasized that the hospital auxiliary will need support from all the surrounding communities. An organizational meeting is scheduled in the near future and all interested persons are encouraged to contact Mrs. Pharr at their earliest convenience. Auxiliary seminars will be available, Mrs. Pharr said, as well as assistance by an invited representative with auxiliary experience. The Texas Association of Hospital Auxiliaries works hand in hand with the Texas Hospital Association and auxiliary members participate in the THA conventions. To help kickoff the Knox County Hospital Auxiliary, a benefit show by the Grapevine Opry Road Show will be held Thursday, July 24, at 8:00 p.m. in the Munday High School Auditorium. ## Residents Urged To Observe City Rules

City officials are reminding residents of the requirements in disposing of their garbage. With the extremely hot weather, strictest compliance of the regulations become necessary, according to Faye Railsback, city secretary-manager. Garbage containers must be securely staked or put in racks with their lids secured

so that dogs cannot overturn or open containers and scatter garbage. Any household garbage subject to decomposition must be bagged before being put into the garbage containers. If any garbage should spill into the container, the container should be washed out and aired for sanitary reasons. Tree limbs must not exceed 10 feet in length and no limb or stump shall exceed 50 pounds.

## City Efforts Continuing On Drainage

The City of Knox City is continuing its efforts to improve drainage within the City Limits. Progress is being made in removing silt from the City's north drainage ditch, which should allow water to drain away more quickly with a minimum amount of water backing up in streets adjacent to Avenue B (Canal Street). Ditches on each side of Avenue K have been deepened and widened to prevent so much water from draining across yards and driveways in the immediate area, Mrs. Faye Railsback, city secretary-manager explained.

The City Council recently agreed to close the City's landfill site to all except Knox City residents. Effective July, the gate will be kept locked at all times, Mrs. Railsback said. Any Knox City resident wishing to haul his own limbs, tree trimmings, etc., will have to get direction and pick up a key at the City Hall. # NOTICE To Knox City Residents

Household garbage subject to decomposition must be bagged before being deposited in garbage containers. If any garbage should spill into the container, the container should be washed out and aired for sanitary reasons.

Every business house or household must have adequate garbage containers and they must be securely staked or put in racks and have their lids secured so that dogs cannot overturn or open containers and scatter garbage.

Tree limbs must not exceed 10 feet in length and no limb or stump shall exceed 50 pounds. Anyone hiring a contractor or other person to trim trees and shrubs must have the same removed at his own expense. Grass, leaves, and hedge trimmings must be bagged, boxed or in a regulation trash container marked "grass". In no case will more than one load, per residence, be hauled.

Items which will not be picked up include rocks, dirt, concrete, brick, tile, furniture, appliances, carpets and scrap building materials. Owners or contractors must dispose of these items at their own expense.

Dogs, cats or other dead animals shall not be placed in garbage containers. Upon notice, the City will provide pick-up service.

Residents may get directions to the landfill site and pick up key at City Hall. The old dump ground on the north side of the City has been closed permanently due to state requirements.
