

The multiple choice test battery has five parts including writing skills, social studies, science, reading skills, and mathematics. Three of the tests have an hour's time limit, while two, social studies and science, have a limitation of one and one half hours. Therefore, most examinees take six hours to complete the test

Persons eligible for testing must (1) be a resident of Texas or a member of the Armed Forces stationed in Texas and (2) be at least 17 years of age and officially withdrawn from school for one calendar year. Applicants who have attained their seventeenth birthday and will enter the Armed Forces may test immediately after withdrawing from school.

To receive a certificate of high school equivalency, the examinee must (1) complete the examination with a minimum standard score of 40 on each of the five tests or an average standard score of 45 on all five tests and (2) have attained at least their seventeenth birthday prior to date of testing and be out of school for one calendar year.

The GED Program provides a means for determining the educational level of adults who have not completed a formal high school education. A certificate of high school equivalency will be issued to adults who successfully complete the GED examination. This verifies that the holder has demonstrated a level of competence on the examination which is equivalent to that of a high school senior

#### **Taxpayers Should List Dependents**

A common error of taxpayers claiming head of household filing status is not listing the name of a qualifying dependent or child, and this can lead to a refund delay. To file as a head of

household, a taxpayer must be unmarried and provide more than half the cost of keeping up a home that is the main home for his or her dependent or child. An unmarried child who qualifies the taxpayers as head of household must live with the taxpayer but need not be his or her dependent. Other qualifying persons must be the taxpayer's dependents. They generally must live with the taxpayer. However, the taxpayer's dependent parents may qualify, even though they live elsewhere, if the taxpayer paid more than half the cost of keeping up their home and is eligible to claim one or both parents as depen-

Unmarried includes single, legally separated, divorced and widowed persons, the IRS said.

Without a child or qualifying dependent, unmarried taxpayers are not eligible to file as heads of household and if they do not qualify as surviving widows or widowers, they file under single status and use the corresponding tax table.





#### **City Sales Tax Rebates** On Increase

AUSTIN, Tex. -- State Comptroller Bob Bullock Wednesday said 960 Texas cities shared nearly \$100 million in city sales tax rebates in February.

Bullock said his office sent a total of \$91.5 million to cities levying the optional one percent city sales tax.

He said the January-February payments to cities this year is more than \$30 million higher than the same period last year

Knox City's check for the period was \$9,414.95 as compared to \$6,349.36 for the same period last year. The 1981 payments to date are \$12,716.21 reflecting a 45 % increase over 1980's \$8,761.45.

Munday's check for this period totaled \$6,362.13 as compared to \$2,825.41 for last year. Payments for 1981 to date are \$9,451.82, a 125% increase over last year's \$4,184.71.

Other amounts for this period include Benjamin with \$428.66; O'Brien \$364.49; Rochester \$1,197.05; Rule \$3,231.75; Haskell \$22,422.45; Stamford \$22,419.41.

The city sales tax is collected along with the state sales tax by merchants and businesses and rebated monthly to the cities in which it is collected by the Comptroller.
