A 27-year old Knox County farmer received the 1984 Texas Rural Heroism Award for saving the life of an electric co-op serviceman during

July, 1983 Ray Herring of Munday, brother of Mrs. James Albus and Mrs. David Albus, both of Knox City, received the heroism plaque Monday, March 19, during the annual Texas-Southwestern Safety Conference and Exposition held at the Hyatt Regency Hotel in Dallas.

The annual award is sponsored by the Texas Farm and Ranch Safety Council. Ben Bullard, associate director for the TFB Health & Safety Department, is council

Herring crawled up the scissor-like pole leading to the plastic bucket. Although he was unfamiliar with the gears, Herring managed to lower the bucket and pull Longan from it.

Herring and Karen Longan, the victim's wife, who had been riding with her husband that day, began to administer CPR to the unconscios Longan. They then took Longan some 20 miles to a hospital at Seymour.



Free Tax Help For **Last Minute Filers**
