ONOR Ceremonies slated today for naming EMS facilities in honor of Tomlinson, Cook

ynn County Healthcare System is honoring the memory of two local citizens who dedicated much of their time to helping to create and serve the Lynn County Emergency Management Services (EMS). On Thursday, Oct. 27, citizens are invited to attend dedication ceremonies at 5 p.m. for the naming of the LCHS EMS station as the Tomlinson EMS Station "Tom Base 1" and the its spacious educational center as the Barb Cook Learning Center. Family and friends of the two honorees will be on hand for the ceremony that will recognize the dedication and service of the two.

Billy Tomlinson ("Billy Tom") and his wife Jolene were among a handful of Tahoka and O'Donnell citizens who bravely took the first steps towards getting EMT certification and forming the first certified Lynn County Hospital EMS team in 1983.

Billy Tom, a local farmer, also served for many years as a director on the LCHD Board of Directors, and was passionate about providing the best possible healthcare to his community. He died in 2009.

Barbara "Barb" Cook was also an early member of the LCHD EMS, joining in the early years, and was a strong advocate of volunteer first-responder service to the community. She was a long-time volunteer with the EMS, serving for a span of 14 years.

"It is an honor to dedicate the new EMS Station and Learning Center to Billy Tom and Jolene Tomlinson and Barb Cook. This will commemorate the generosity and dedication each of them, demonstrated during the years they served and established the very first hospital-owned EMS service. All three were dedicated to Lynn County and passionate about helping others. Their dedication to service will long be remembered and this naming is a small thank you for their hard work and dedication," said Dr. Melanie Richburg, CEO of Lynn County Healthcare System.

charges of enticement of a child

An O'Donnell ISD employee has been arrested after being accused of communicating inappropriately with a 14-year-old female student. Nicholas Dominique Bueno, 27, was arrested last Wednesday on charges of enticement of a child, according to the Lynn County Sheriff's Office. He is also facing further federal charges of enticement and attempted enticement of a minor.

Bueno was immediately placed on administrative leave during the investigation.

On Tuesday this week, OISD Superintendent Dr. Cathy Palmer told *The News* that Mr. Bueno is no longer employed at O'Donnell ISD. He was a new hire this year as a head basketball coach.

The allegedly inappropriate contact started Sept. 23 and continued until Oct. 19. The Lynn County Sheriff's Office, the O'Donnell ISD Resource

Officer, and the OISD administration are all participating in the investigation. The incident has also been reported to Child Protective Services and the Texas Education Agency.

According to news sources, on October 18, 2022, the Lynn County Sheriff's Office informed the FBI about an investigation into an inappropriate relationship between a high school teacher in O'Donnell and a 14-year-old student. The student is referred to as Jane Doe in the complaint. The charges allegedly stem from sexually explicit text messages and sexually explicit videos sent by Bueno to the student.

On Oct. 19, 2022, Bueno was interviewed by a Special Agent with the Texas Department of Public Safety. During the interview, Bueno admitted he used a pre-paid phone to engage in sexually explicit conversations with Doe beginning on Sept. 23. Bueno admitted he requested Doe send him images of herself and admitted to sending a sexually explicit image and video of his genitals to the student, news sources reported.

"It was clear from the interview, and from Bueno's relationship with Doe, that he knew that she was a 14-year-old child and that he was discussing his intentions of engaging in sexual acts with Doe," the complaint shows.

The school superinteindent sent out a statement last Thursday to report the situation to OISD families.

"It is with a heavy heart that I am reporting this information to the families of students enrolled in O'Donnell ISD. After receiving information on Oct. 18, regarding an O'Donnell High School employee allegedly using electronic media to communicate inappropriately with a high school student, OISD contacted the Lynn County Sheriff's Office. OISD administrators and local law enforcement authorities began investigation immediately, and the OISD employee was placed on administrative leave pending the results of that investigation," Dr. Palmer stated.

The statement said that the safety and well-being of students remains the school district's highest priority. "O'Donnell ISD always provides counseling services for any of our students and encourages parents to contact the counselor if they have any concerns," Palmer stated.

Bueno was being held in the Lubbock County Detention Center on a federal hold.





"Billy Tom wasn't shy at all, he just jumped right in there and

did what he thought should be done," said Jolene with a laugh. "He had great people skills, and could talk to anybody," she added. In the early days, she said

the EMS did not have their own pagers or radios, but used their own phones. Eventually, the hospital provided radios to the EMS. There were so few people on the volunteer service, she says, that they were pretty much on call all the time.

"It was pretty much just scoop and go back then, we weren't certified to do IVs or anything like that," says Mrs. Tomlinson.

Their very first EMS run was a very difficult one.

"Our very first run was a SIDS baby, and that was so

very hard," Jolene remembers. "Afterwards, Billy Tom was sitting on the ambulance bumper in the hospital parking lot, and we were all pretty shook up. Dr. (Richard) Wright came out and had a talk with Billy. He told him he was going to have to find a way to get over it if he wanted to help people. And he was right," she recalled.

Billy Tom and Jolene served years as volunteers on the EMS, and were strong supporters of the organization.

Barb Cook began her volunteer service with the EMS as a driver, in 1983. After serving as a driver and helping with the ambulance runs, she was ready to take the certification training, and she earned her EMT certification in 1986.

"I am not sure why she started with the EMS," recalls Barb's daughter, Kathy (Cook) Long. "I know that Billy Tom and Jolene were trying to find people to volunteer. I remember that he pretty much challenged/dared her to give it a try, but that is all any of us really remember. She did love working on the ambulance service and helping people. Up until this point she had not had a job since before she married."

Barb was a dedicated volunteer, and passionate about helping people. After a few years, she took over as head of the EMS volunteer service.

"I don't remember what year she became the head of the EMS but she did this for several years add up, with an influx of people prior to her death," her daughter remembers.

Since 1983, the Lynn County EMS has grown into an exceptionally well-qualified emergency service here, and one upon which Lynn County residents strongly rely. There are many who have served the organization well throughout the years, but it took the determination and willingness of those first brave few who took the training and dedicated their services to this community for the organization to gain its momentum and carry on the tradition of service.

It is with great gratitude that county citizens should give thanks to all who have served, and continue to serve, on the. Lynn County EMS.

Salmonella outbreak, stomach bug illnesses cause alarming numbers of sick people here

An alarming number of people suffering with intestinal issues has been reported as seeking medical attention from Lynn County Healthcare ER and clinics during the past week, with at least 50 people being treated or admitted to Lynn County Healthcare facilities with symptoms of nausea/ vomiting, diarrhea, stomach cramps and other issues related to a possible stomach bug, or possibly salmonella infections.

When the cases started to of all ages identified with the same symptoms, healthcare workers here began testing for Salmonella infections. Test results have proven positive in at least 30 cases, according to Dr. Melanie Richburg, CEO of Lynn County Healthcare System.

Salmonella, or salmonellosis, is an infection with Salmonella bacteria that causes fever, diarrhea and other stomach (gastrointestinal) issues. It is the most common form of bacterial food poisoning in the U.S. Many kinds of food have caused salmonella outbreaks, including peanut butter, packaged meats, poultry/eggs, frozen food and

way to get salmonella is from a source. As of yet, no source food preparation.

It is contagious, and people get salmonella from can touching surfaces that animals and people who are infected with Salmonella bacteria may have touched.

"My best advice to people, is wash your hands, wash your hands, wash your hands!" says Dr. Richburg. "We've had more than 50 people, youth and adults of all ages, treated or admitted to our facilities during the past week. It is beginning to slow down this week, but this isn't normal [to have so many people presenting with the same symptoms]. We have not positively identified a source for a Salmonella infection," she added, noting that she has been reporting to the state Health Department on the issue.

"It is the state Health Department that has the authority to decide whether to issue a public alert in such cases," she said.

Healthcare staff have asked patients many questions about where or what they have eaten, but Dr. Richburg said that the incubation period for salmonella can be up to three days, which produce. The most common makes it harder to determine

undercooked food or improper has been found that relates to all cases seen, although once the initial cases came in the infection could have easily been spread

"It can easily be spread if the people who are infected do not properly wash their hands after going to the bathroom, especially in places like schools," said Dr. Richburg.

Bryant Sears, Lynn County Emergency Management Coordinator, told The News that because of the unprecedented number of illnesses reported he had done some investigating as to possible causes of a salmonella outbreak, including getting test results from the city water supply.

The city water supply is tested daily, but according to Dr. Richburg those tests include testing for e-coli bacteria but do not include testing for salmonella.

"All tests of the city water supply have come back within the proper levels, and despite some reports of possible sources of food contamination, nothing has been substantiated. I don't really have anything to report except to say that nothing has proven to be found," Sears said.



With cotton production down, some gins won't operate this season

ith much of Lynn County's cotton production lost to a severe drought this growing season, the outlook is bleak for the area gins that count on the cotton harvest for their operating seasons.

At least two area gins will not even start up operations this year, according to information from gin officials reached by The News staff.

Farmers Coop Association #1 in Tahoka and Wes-Tex Coop Gin in O'Donnell do not Tahoka will be working with plan to start up, with most of their regular customers unable to produce any cotton this

after him," said Torrey Price, Tahoka ISD Superintendent.

"Due to the extremely limited number of acres that survived the drought, it is in the best interest for us to team up and work together this year. Wells Farmers Coop Gin will gin the cotton and Farmers Coop Gin Tahoka will haul the cottonseed and bales," he explained.

New Home Coop Gin is currently operating, and reported their first bale was produced on Oct. 19 from Lynn County producer Gregg Armes.

Woolam Gin in O'Donnell will begin operating either sometime in November, or after the first freeze, according to gin officials.

Wells Coop Gin and Garlyn Coop Gin officials told The News that they plan to begin operations later as well.

Texas Star Gin, with operations in Wilson and Union, is currently custom ginning, but gin officials anticipate that some local harvest will be brought in, in late October.


