Congressman Emanuel Cleaver, II **Guest Speaker For 20th Anniversary** Of The Patterson Branch Library


During the 14th Annual African American History Month, the 20th Anniversary of the Bobbie Gean and T. J. Patterson Branch Library, 1836 Parkway Drive, will be celebrated on Saturday afternoon, February 27, 2016, beginning at 2:00 p. m.

Guest speaker will be Congressman Emanuel Cleaver, II, 14h Congressional District of Kansas City, Missouri. He was the guest speaker when the library opened on Saturday, December 5, 1995.

Cleaver is now serving his sixth term representing Missouri's Fifth Congressional District, the home district of President Harry Truman. He is a member of the exclusive House Financial Services Committee, the Ranking Member of the Subcommittee on Housing and Insurance, and also a Senior Whip of the Democratic Caucus

Having served for twelve years on the city council of Missouri's largest municipality, Kansas City, Cleaver was elected as the city's first African American Mayor in 1991.

During his eight year stint in the Office of the Mayor, Cleaver distinguished himself as an economic development activist and an unapologetic redevelopment craftsman. He and the City

Council brought a number of major corporations to the city, including TransAmerica, Harley Davidson, and Citi Corp. Cleaver also led the effort, after a forty year delay, to build the South Midtown Roadway. Upon

completion of this major thoroughfare, he proposed a new name: The Bruce R. Watkins Roadway. Additionally, his municipal stewardship includes the 18th and Vine Redevelopment, a



Todd Klein Announces Run for Mayor of Lubbock, Texas Recently

Todd Klein announced his candidacy for mayor of Lubbock on Monday morning, January 18, 2016, in a lot near East 24th Street and Martin Luther King Jr. Boulevard in Lubbock, across from the Lyons Chapel Baptist Church.

Rather than paying the \$100 filing fee like the other two candidates running for mayor so far, Klein chose instead to get the necessary number of signatures on a Petition for Candidacy to get his name on the municipal election ballot for May.

"It's who we are; we're grassroots people and we think this is keeping with that," Klein said. "It builds in that whole beautiful relationship, and I believe people should be as involved as possible. It's easy enough to say, 'If elected I want to involve the people as much as possible,' but I'd like to live it and practice it as a candidate as well.'

The filing fee is \$100.

City Secretary Becky Garza said the necessary amount of signatures for a candidate petition this year is 25.

The City Charter says the needed number of signatures is the greater of either 25 signatures or one-half of 1 percent of the total vote received for the

seat in the last election.

Garza said that, because current Mayor Glen Robertson went unchallenged last year, there were no votes cast to get the "one-half of 1 percent" number, so candidates just need to get 25.

Garza said candidates for the other seats (city council and municipal judge) also would need to get 25 signatures if they chose to submit a petition because that's greater than one-half of 1 percent of the voters the last time the seats were up for elec-

Klein also said spending \$100 for a filing fee wasn't something he wanted to do, saying he'd prefer to spend it elsewhere.

"One hundred dollars can be spent buying, you know, air time or placing an ad or print documents. You can kind of go through the list of things you can

ation Chris joined the United States Navy where he served our country for four years. After his


venture with the military, Chris moved to Dallas, Texas where he started a new career in Computer Business Management.



Flores is seeking the seat in Precinct 3, a position he has held


Flores has previously served 16 years on the Lubbock County

Pastor Cotton referred to the importance of educating children in the community. "My



Even before controversy, blacks cool to Oscars telecast

to," said Darnell Hunt, director of UCLA's Ralph J. Bunche Center for African American Studies. "When you have African-American nominees, they're usually excited about the prospect of them winning and they tune in in larger numbers."

That was certainly the case in 2005, when 5.3 million blacks watched the Oscars. That made up 12.2 percent of the show's audience that year. The Academy Awards hasn't made it up to that level since, hitting a low of 6.6 percent in 2011. According to the U.S. Census Bureau, blacks comprise 13.2 percent of the U.S. population. Blacks tend to watch more TV than other ethnic groups and in February 2015, when the last Academy Awards were broadcast, blacks made up on average 15 percent of the audience for prime-time shows, the Nielsen company said.

With diversity among Oscar nominees an issue last year, too, Nielsen said 3.3 million blacks watched the Oscars, down from 4.1 million in 2014. The annual BET awards, which honor cultural work popular in the black community, was watched by 5.5 million blacks last year. That's 89 percent of the show's total audience of 6.3 million.

Callie Crossley, a cultural commentator for WGBH-TV in Boston who has talked about the Oscars, said she initially questioned whether a boycott of black viewers would gain traction. But in talking with several friends about the issue, Crossley was taken aback at the amount of anger she heard.

The topic may not have blown up into a controversy had there been few award-worth performances by non-whites, although that would have been an issue for the film industry by itself. When the popular "Straight Outta Compton" and acting performances by Will Smith and Idris Elba all received pre-Oscars buzz, the lack of diversity was more obvious. Crossley said she was heartened that the Acad-



1. Your opponent has criticized you for voting for a salary increase during your first term, please explain why you voted in favor and why you felt that a salary increase was justified?


The Commissioner's Court did vote 4 to 1 to raise ALL Elected officials salaries. He fails to tell you that he gave himself a 23% raise. Why is he trying to take the stye out of my eye when he has a log in his? By Texas State statute, The Commissioners' Court can give or decline salaries for employees and all 26 Elected Officials in Lubbock County. Salary increases are an age -old issue. Past Commissioners have declined raises for Elected Officials 8 out of the last 12 years for fear of not getting re-elected! Sometimes Elected Officials have to make tough decisions and I took the stance to raise the salaries for competitive wages for all 26 Elected Officials in Lubbock County. I compared elected officials salaries to eight similar sized counties and we ranked #8. The increases were

for the following Elected Officials: Sheriff, Tax Assessor, County Clerk, District Clerk, JP's, etc. After the raise we are still #8.

2. Some state legislatures have state laws in place for setting elected county official's salaries. Would you be in favor of county commissioners salaries being set by the Texas state legislature as opposed to commissioners setting their own salaries?

Counties are extensions of the State and can only do things specifically authorized by the Texas Constitution and Statues. As I said before, we set salaries by Texas State statue. pear to hold a great deal of interest on a regular basis among black viewers. The Golden Globes, a boozy Hollywood party that honors movies and television, has had between 5.2 percent and 10.6 percent black viewership over the past decade. The high point came in 2007; between 2013 and 2015, the percentage has been just under 7 percent each year.

The Emmys have shown more consistency, staying roughly in the 6 to 7 percent range of black viewers over the past decade. Black viewership shot up to 14.3 percent last year when Viola Davis was named best actress for her role in "How to Get Away With Murder" and "Empire" was the most talkedabout new drama.

In seven of the past 10 years, the Oscars had a higher percentage of black viewership than either the Emmys or Golden Globes.

Despite some Academy Award celebrity defections and calls for a viewing boycott, "Chris Rock may generate some viewers," Hunt said. People will be curious to hear what he has to say about the topic. Another drawing card is the participation of Reginald Hudlin, producer of "Django Unchained," who is coproducing this year's Oscars cer-

"It's going to be tough," Crossley said. "They can't afford to lose viewership. The controversy will not end this month. It will keep going until next year."


