
ber 6th, but early registration is encouraged. Applications are being accepted now.

#### **West Nile Virus**


The City of Lubbock Health Department has confirmed the first human case of West Nile Virus in Lubbock for 2016. WNV is a disease of birds. Humans are exposed to the virus when they are bitten by mosquitoes that have fed on infected birds. The infected mosquitoes become the link (vector) that spreads the disease from birds to humans through a mosquito bite. WNV cannot be spread personto-person.

Symptoms of West Nile virus include headache, fever, muscle and joint aches, nausea and fatigue. People with West Nile fever typically recover on their own. entation, coma, tremors, convulsions, muscle weakness and paralysis. Up to 80 percent of people infected with the virus will have no symptoms.

There are no medications to treat or vaccines to prevent West Nile virus infection. People over 50 years old and those with other health issues are at a higher risk of becoming seriously ill. If people have symptoms and suspect West Nile virus infection, they should contact their healthcare provider.

While we are near the end of mosquito season it is important for individuals to continue to take steps to avoid mosquito bites. These include:

Wearing an EPA registered insect repellant

 Covering up with longsleeved shirts and long pants

• Keeping mosquitoes out of living areas by using air conditioning or intact window screens







Students, staff and community leaders gathered today at the Margaret Talkington School for Young Women Leaders (SWYL) to commemorate what would be the 101st birthday of school's namesake and two prestigious awards earned by the school and staff. Earlier in the week, Talkington Principal Berta Fogerson and Lubbock ISD Superintendent Berhl Robertson, Jr. were in Washington, D.C. as the Talkington School for Young Women Leaders was recognized as one of only 279 schools named a 2016 Blue Ribbon School by the U. 
