Eaustin, Texas -- In his 111 years on this planet, Richard Overton has seen a lot. The country's oldest veteran has met many presidents and celebrities, but the one place the United States Army veteran enjoys the most is his front porch.

Overton built his East Austin house in 1945, and it's now a struggle to stay inside. His current caretaker can no longer provide for him and Department of Veterans Affairs benefits do not cover around the clock at-home care. "When you're at the point where 24/7 care is needed... what's best for the veteran might not be the home," explains Patrick Hutchison, public affairs specialist for Central Texas Vet- a gofundme page to help raise erans Affairs Health Care Sys-

The VA does cover at-home care seven days a week, up to three hours a day. Veterans can also apply for compensation to help pay for in-home care. However, Overton's family isn't relying on the VA. They've turned to crowd-funding to keep their loved one where he loves to be.

"I'd hate to see him not have a smile on his face because he's smiling when we come over here. [Going to a nursing home] would take that smile away," says Volma Overton Jr., Richard's cousin. "This smile is America's treasure."

tem. "The caregiver is taxed at money to pay for his at-home care. Their original goal was \$50,000 and they have now raised more than \$58,000. The gofundme goal is now upped to \$100,000.

AARP research just released last month gives a snapshot of the strain caring for a parent or another loved one can have on families. It shows caregivers spend, on average, nearly 20 percent of their income on care-

More than 78 percent of caregivers face out-of-pocket costs that add up to \$6,954 per year. Household expenses are responsible for the largest share of that spending at 41 percent. Medical expenses account for a big chunk as well at 25 percent.







Commissioner John Wiley Price found 'not guilty'

Dallas, Texas -- Commissioner John Wiley Price was found not guilty of bribery and mail fraud charges Friday, while the jury failed to reach a verdict on other counts.

"We're of course very gratified at the finding by the jury of no bribery whatsoever, but we are not surprised," said Shirley Baccus-Lobel, an attorney for Price.

The FBI raided Price's house in June 2011, yet after just over five years, was not able to prove their case. Testimony in the trial began Feb. 27, and jurors began deliberating the case April 19.

Jurors told U.S. District Judge Barbara Lynn that further deliberations would not yield a verdict on tax-fraud charges against Price, so she dismissed the jury and ended the trial.

A conviction on all 11 charges against the longtime political leader and civic activist would have meant decades in prison.

Dapheny Fain, a top aide to Price and co-defendant, was acquitted of charges that included

During the trial, Price was portrayed as a hardworking public servant who helped his close friends in need, but also as a greedy and corrupt man who enriched himself by selling his vote

He was first elected to his po-

Federal officials accused him of taking almost \$1 million in bribes over a decade from a lobbyist to help her clients. They said he failed to report those bribes and other income in his

tax fillings.

Price's lawyers argued that money he received from Fain, his chief of staff, was repayment of loans he made to her to launch a business and not evidence of a scheme to avoid paying taxes.

Price took his place in the Commissioner's Court on Tuesday as meetings reconvened.

"Dallas County government is now able to proceed full throttle, and the Commissioners Court will be fully functioning with all commissioners. We know Commissioner Price will hit the ground running. For his constituents in District 3, he is still 'Our Man Downtown.' We wish the best to Commissioner John Wiley Price," Dallas County Democratic Party Chair Carol Donovan expressed in a statement to the media.



DeVos Booed at HBCU Graduation

Boos and jeers from graduating seniors greeted billionaire U.S. Education Secretary Betsy DeVos as she began her commencement address Wednesday, May 10, 2017, at Bethune-Cookman University.

The graduating class also

turned their backs in protest against someone they believe has insulted the Black community and Historically Black Colleges and Universities (HBCUs).

"One of the hallmarks of higher education and of democracy is the ability to converse with and learn from those with whom we disagree," DeVos told graduates of the historically Black university in Daytona Beach, Fla.

As boos toward the education secretary grew louder, the university's president, Edison Jackson, interrupted her speech with a warning to the approximately 300 graduating students.

"If this behavior continues, your degrees will be mailed to you," he said. "Choose which way you want to go."

Nevertheless, many students persisted.

Jackson invited DeVos to speak at the graduation ceremony. In an opinion piece for the Orlando Sentinel published May 3, the college president said he did not object to inviting a potentially controversial speaker.

"I am of the belief that it does not benefit our students to suppress voices that we disagree with, or to limit students to only those perspectives that are broadly sanctioned by a specific community," Jackson wrote.

Students, alumni and political activists sought to have DeVos' invitation withdrawn, saying they were offended by her earlier comments. In February, the education secretary, a proponent of school choice, sparked controversy when she said, in a now-recanted statement, that HBCUs were "pioneers" of educational choice.


"HBCUs are real pioneers when it comes to school choice,"

DeVos said. "They are living proof that when more options are provided to students, they are afforded greater access and greater quality. Their success has shown that more options help students flourish."

Supporters of HBCUs noted

that the institutions were founded because Black students couldn't enroll in predominantly white colleges in the South, even public institutions. African Americans had no choice but to create colleges and universities.




