Lady Raider Basketball Great Sheryl Swoopes will join the program as the Director of Player Development, Head Coach Candi Whitaker announced Wednesday afternoon, July 5, 2017.

"I am thrilled to welcome Sheryl back to Texas Tech as our program's Director of Player Development," Whitaker said. "She brings a wealth of experience playing at the highest level and will be an outstanding resource for our student-athletes. Sheryl's passion for our program and for impacting young players will be extremely beneficial for our continued growth. She is a fantastic addition to our staff."

In her role, Swoopes will focus on creating and implementing a plan to help develop each student-athlete personally, academically and athletically. She will work closely with various departments within Texas Tech Athletics, including academic services, sports performance, and sports medicine and will assist the coaching staff in breaking down film and preparation of game strategy. In addition, Swoopes will assist the Red Raider Club, Marsha Sharp Center for Student Athletes and Kirby Hocutt in community outreach and serve as the color analyst for televised games.

"I couldn't be more excited about joining Texas Tech and the Lady Raider program. I am very grateful to Coach Whitaker for giving me this opportunity and I am looking forward to working with the players and staff," Swoopes said. "My role as Director of Player Development gives me an opportunity to do what I love and help the players

Swoopes is the most decorated athlete in Texas Tech history. In just the last two years, she has been inducted into the Women's Basketball Hall of Fame and the Naismith Memorial Basketball Hall of Fame.

With her induction into the Basketball Hall of Fame last year, Swoopes became the first Texas Tech basketball player – men's or women's – to achieve this honor.

Along with the National Championship crown, Swoopes guided the Lady Raiders to the Southwest Conference regular season and tournament championships and the national championship crown her senior As a Lady Raider, Swoopes set 30 different women's basketball records, including four Final Four records, three NCAA tournament records, four NCAA championship game records and eight Texas Tech school records, including the single-game school record for points (53), which still stands. Her No. 22 jersey was retired on Feb. 19, 1994.

In 2003, Swoopes was inducted into the Texas Tech Hall of Fame for her outstanding career with the Lady Raiders.

Swoopes was one of the first players to sign a WNBA contract. She was a three-time WNBA MVP, two-time scoring champion, four-time WNBA champion, three-time defensive player of the year and six-time all-star. She also represented the United States numerous times, including the 1996, 2000 and 2004 Olympic Games.

A photo of a Klan supporter at a rally wearing a hairstyle culturally associated with Black people goes viral.

Social media users are abuzz about the irony of a photo of a Ku Klux Klan supporter at a rally in Charlottesville, Va., wearing dreadlocks — a hairstyle culturally associated with Black people, and a style for which Black people are often discriminated.

On Saturday, July 8, 2017, a few dozen members and supporters of the North Carolinabased Loyal White Knights of the KKK shouted "white power" at a rally to protest against a city council decision to remove a statue honoring Confederate General Robert E. Lee.

DeVanté Cunningham, a recent graduate from the University of Virginia, took the photo of a KKK supporter wearing dreadlocks and a shirt with several Klan symbols.

"Me and my friend were in total disbelief," Cunningham told BBC Trending. "We really couldn't believe we had just seen a Klansman with dreads. We're looking at the KKK here, and dreadlocks are basically a symbol of African culture. It was really weird to see."

The white supremacists at the protest brandished Confederate flags and signs with anti-Semitic messages, while hundreds of anti-KKK protesters waved signs denouncing racism. The

groups were separated from crowds by a ring of fencing and a heavy police presence

Later police fired tear gas canisters when some protesters refused orders to disperse. Twenty-three people were arconfirm their affiliations, according to Reuters.

Cunnighman said he attended the rally to show his opposition to KKK supporters.

"I was angry that they were coming to a place that I have called home for the past six years," he told BBC Trending. "So I knew that whatever counter protest was going to be happening, I needed to be there."

The photo of the unidentified man went viral on Twitter.

Social media users were confused as to why a supporter of the Klan, identified as a hate group by the Southern Poverty Law Center, would choose a hairstyle with a connection to Black culture.

Many summed it up as cultural appropriation. The term is used to describe when a marginalized culture's creations are used, borrowed and imitated by a privileged culture, many times for profit, without a true understanding or respect for its history and traditions.

In 2015, at age 16, actress Amandla Stenberg, who was in the film "The Hunger Games,"

posted a video on YouTube called "Don't Cash Crop on My Cornrows," discussing Black natural hair in mainstream culture and explaining her thoughts on cultural appropriation.

Though a white male KKK rested, but officials could not supporter seemingly appears comfortable wearing dreadlocks while promoting racist ideals, many Black men and women are still questioned by society when choosing to wear the hairstyle.

In the 2015 book "Twisted: My Dreadlock Chronicles," author Bert Ashe chronicles his journey to wearing dreadlocks. Ashe, an associate professor at the University of Richmond, wavered for 20 years before he decided to grow out his hair.

Black women have been marginalized for attempting to wear dreadlocks in the workplace. For example, Chastity Jones received a job offer from Catastrophe Management Solutions (CMS), an insurance claims processing center, in 2010. When Jones refused to get rid of her dreadlocks, the job offer was rescinded.

The U.S. Equal Employment Opportunity Commission filed a race discrimination lawsuit against CMS on behalf of Jones in 2013, stating, "Dreadlocks are a manner of wearing the hair that is physiologically and culturally associated with people of African descent."

White Maryland Student Indicted in **Black Army Officer's Murder**

(Reuters) — A grand jury indicted a white former University of Maryland student for murder on Thursday in the stabbing death of a Black U.S. Army officer that is still being investigating as a possible hate crime, authorities said.

Sean Urbanski, 22, of Severna Park, Md., who was a member of a racist Facebook group, was indicted for common-law murder over the on-campus death of Lt. Richard Collins III in May, said John Erzen, a spokesman for the Prince George's County state's attor-

"Right now, the investigation into the motive, including whether it was a hate crime, is still ongoing," Erzen said in a telephone interview.

The Federal Bureau of Investigation was helping police analyze Urbanski's digital devices. "We expect that to conclude in

He told Collins, who had been commissioned as a lieutenant a few days before, "Step left, step left if you know what's good for you."

When a puzzled Collins said, "No," Urbanski stabbed him in the chest. Collins, 23, died a few days before he was to graduate from Maryland's Bowie State University.

Police arrested Urbanski on the University of Maryland campus in a Washington suburb.

A police investigation showed that Urbanski was part of the Alt-Reich group on Facebook, where members post disparaging material about African Americans, Jews and others.

When he asks what agency she works for, she responds: "I'm the state attorney".

The officer immediately launches into an explanation for the stop, explaining that he ran the tags on her car and received no result.

Ms Ayala asked: "What was the tag run for?"

The officer then begins to stumble, saying: "Oh we run tags through all the time, whether it's a traffic light and that sort of stuff; That's how we figure out if cars are stolen and that sort of thing."

He added: "Also, the windows are really dark. I don't have a tint measure but that's another reason for the stop."

The State Attorney, visibly annoyed, asks for the officers' cards. Neither have them available, so they write their contact information on a piece of paper.

Orlando police department said that it "allows the running of tags for official business only, and this is done routinely on patrol".

"In regards to the video, which was released by the Orlando Police Department last month, the officers stated the tag did not come back as registered to any vehicle. As you can see in the video, the window tint was dark, and officers would not have been able to tell who, or how many people, were in the vehicle," a statement said.

No complaint has been filed over the stop, police said.

Ms Ayala, a career public defender, ran for state attorney on a platform of transparency and a promise to bridge gaps with communities of colour.

In a statement to The Independent, Ms Ayala said she has "violated no laws".

"The license plate, while confidential was and remains properly registered... The tint was in no way a violation of Florida law... Although the traffic stop appears to be consistent with Florida law," the statement said.

"My goal is to have a constructive and mutually respectful relationship between law enforcement and the community, Ms Ayala added. "I look forward to sitting down to have an open dialogue with the Chief of Orlando Police Department regarding how this incident impacts that goal".

Ms Ayala recently made headlines for refusing to pursue the death penalty in the murder trial of Markeith Loyd, who is accused of killing Orlando Police Lieutenant Debra Clayton and his pregnant ex-girlfriend, Sade Dixon.
