

Lubbock Branch of the NAACP Advises Lubbock ISD About Why They Are Working Hard To Hire A NewSuperintendent By Letter

The Lubbock Branch of the National Association for the Advancement of Colored People, NAACP, in a letter on Thursday, November 30, 2017, talked about the hiring of a new superintendent. The letter was signed by Annie White, president of the Lubbock Branch.

Here is a copy of the letter:


The members of the Lubbock NAACP #6198; as members of this community, parents of students, and taxpayers; are very concerned about the speed and lack of transparency in the hiring of a new school superintendent. We do understand the need for a smooth transition but are still concerned about the way you are conducting this process.

The fact that you posted the vacancy almost immediately and had the posting open for only the minimum amount required of ten days instead of increasing the length of this posting was alarming. The closed meeting that you had the day after the posting closed did not alleviate our fears. Second, it has been rumored that the Board had already decided who they wanted to hire, and that this person would not be well received by the taxpayers of this district is also of great concern. In a past administration, we had a superintendent that terrorized and dismantled our education system

especially for the minority and low-income students and we are worried that the improvements that have been made since that time will be reversed.

The public would like to know who you are considering and would like their opinions and suggestions be seriously heard. We would like to know that our educational system is in the hands of someone who will have the needs of ALL students and teachers as their priority and not their political or personal

He started as quarterback for the Coronado High School Mustangs when he was a Junior, throwing over 4,000 yards a season.







breakdown is 61% white, 17% Hispanic or Latino, and African-American 13%. Accordingly. and surprisingly, people of color are disproportionately killed by police in greater numbers than whites. Many are unarmed. What makes this more than mind-numbing is that no country bears the daily experience of a law officer killing a person of color more than America, the land of the free, home of the brave. Why is racism practiced in such a lethal fashion here?? Is it a personal bias? Is it a public health crisis? For people of color it sure is, and the old way of addressing it is long gone.

It is Time to get Real about Black Business

1992, that there was no sincere movement or interest in developing Black owned businesses. Even though Booker T. Washington wrote books about it there was no sincere movement to push forward the thought and reality of "BLACK BUSINESS". It was like the term was too rich for American society. That is silly. We used the Spanish pronunciation of Black, Negro, for decades, centuries in fact. It was that old stereo type that Black is bad and White is good. Angel's Food cake versus Devil's Food cake. It took the Black Power movement to settle the issue for most. But even today we have organizations with descriptions of "colored people", "urban", "minority" - which is a misnomer of the world's racial makeup.

That is why Kay and I proudly announced the formation of the National Black Chamber of Commerce®. The name was never reserved, and we immediately applied for patent rights to it. Since then groups like the National Minority Supplier Development Council and National Association of Minority Contractors considered us rivals or competition. How silly? They represent corporate America and provide cover for them in terms of Title VI of the Civil Rights Act (for example, no discrimination in business practices such as procurement). When they were started in the early 1980's, Black owned businesses were doing no more than 2% of procurement activity with white owned government suppliers. Today, after decades of public relations, media activity, conferences, and trade shows, they are doing no more than that same 2%. They try to "run" from that with

claims of the "Billion Dollar Round Table" and other jazzy implications of doing much more. In the end, we are still at that same 2% if that.

Strangely, the only rhetoric about Black business development has come from the Republican Party. I guess that should not be strange as it was the Republican Party that was cofounded by one of the greatest Black advocates of all times, Frederick Douglas. It was newly elected Black republicans that lobbied for the Homestead Land Grant program after the Civil War that allowed freed Blacks to apply for free land grants (160 acres each). My great grandfather, Cicero Alford, (freed slave) participated in that program along with his son, my grandfather Thomas Alford. Yes, it was under the aura of Republicans that Booker T. Washington, Frederick Douglas, Dr. Martin Luther King, Senior (Martin's father) and others fought for economic parity in our great country. Slavery, itself, would not have ended without President Abraham Lincoln, the first Republican president. The Ku Klux Klan, on the other hand, was populated with De-

You might say that when we broke out with the National Black Chamber of Commerce and demanded Black business participation here and there it kind of "shook up" the status quo. First, they laughed at us but when we started winning victories for increased Black business participation from United Air Lines, City of Indianapolis, State of Indiana, U.S. West telecom, etc. they tried to fight us. When they could not knock us off our game they started coming up with ruses.

The ruses did not work, and we have never changed our devotion for Black business develop-

It is our hope and prayer that we can regain some of the improvements that were made during the Bush Administration and then set back under the onslaught of the Obama Administration with its lying numbers, reports and fake news distributed by fake organizations plus other tricks rather than sincere efforts. Overall, we are still at around 2%.

Next week, Dec. 5th, at the Willard Hotel in Washington, DC we will participate in a summit for Black business developwithin the Administration via federal agencies. It is a Call to Action. Starting now through the next three years, I predict historical improvement with the reality of increased Black business development. As God as my witness, we are going to work like never to bus down the doors of deception, misrepresentation, fronting and Jim Crow denial. Jobs, new business, fair trade, capital formation, etc. will become realities and we will at last soar above that 2% level. Get ready for the hard work and big

2008 - 2016 were the worst years for Black economic development since the roll out of the Civil Rights programs such as Affirmative Action, Black Capitalism (Nixon), etc. It is time to snap out of it people! Let us again demand excellence and not accept excuses, corruption, fear, etc. in its place. The "stars" are aligning and the next "Renaissance" is about to take form. **ACCEPT NO IMITATIONS!!**

White House Bars One of Few Black Journalists From Attending Christmas Party



White House Bars One of Few Black Journalists From Attending Christmas Party

The White House failed to early! Finally, good news from invite a popular and combative black reporter to the annual holiday party because, the reporter said, officials in the Trump administration "don't like me."

American Urban Radio Networks Washington Bureau Chief April Ryan, one of the few minority female journalists credentialed to attend the White House daily press briefings, said it was no mistake that she had yet to receive an invitation for the yuletide event.

"I don't think I was overlooked," Ryan told The Washington Post. "I think they don't like me. For whatever reason, they have disdain for me."

Ryan, a CNN political analyst who has said journalists of color are considered the "opposition" to the Trump administration, said it was the first time in her career as a White House reporter she had been excluded from the guest list. Washington correspondents from mainstream media outlets and other publications covering the White House have all reportedly received their invitations. That said, CNN said it was boycotting the annual tradition "In light of the President's continued attacks on freedom of the press and CNN," the network told Politico.

The decision to abstain from the event was celebrated by White House Press Secretary Sarah Huckabee Sanders, who tweeted, "Christmas comes

@CNN."

Just days before, Sanders was thrown into a petty Twitter feud with Ryan after the journalist demanded she post another picture of a pie the press secretary baked for Thanksgiving, suggesting it may have been a stock photo. Sanders responded to the controversy, which quickly became known as #piegate, with a lighthearted olive branch for Ryan.

"Don't worry @AprilDRyan because I'm nice I'll bake one for you next week," she wrote, adding a wink and the hashtags #RealPie and #FakeNews. (For the record: Sanders has not

baked the pie.) Instead of a pie, it appeared the press secretary withdrew Ryan's name from a guest list where—presumably—other baked goods will be served.

The latest squabble was just one of many moments Ryan has become notorious for under Trump; refusing to be silenced, the reporter recently won the She Persisted award at the 2017 Women's Media Center Awards for holding the powerful accountable. Ryan serves as one of just a half-dozen or so black White House press correspondents, and has interviewed former Presidents Barack Obama, George W. Bush and Bill Clin-

Ex-Press Secretary Sean Spicer also squared off with Ryan, telling her to "stop shaking your head" during a tense exchange that began with the reporter asking how the Trump administration was planning on fixing its public image. Ryan's tension with Sanders began once she became a staple of the daily press briefings, when she repeatedly asked the former deputy press secretary why her boss was routinely absent. Earlier this month, Sanders said she was "starting to regret" calling on Ryan when she brought up the president's tweets from that

Obama Admnistration Travel Cost 114 Million, Trump's So Far Is \$10 Million

Former President Barack Obama's family travels cost the U.S. a total of \$114 million during his presidency, according to documents obtained by Judicial Watch, a conservative legal group. President Donald Trump has, so far, cost taxpayers \$10

Judicial Watch obtained the expense documents from the U.S. Air Force and the Secret Service through a Freedom of Information Act request, and two FOIA lawsuits. They represent the known totals so far, and there could be more Obama administration travel expenses re-

vealed in the future. Among the big-ticket trips were two family vacations during the weekend of February 14, 2014, that cost the Secret Service \$272,192. That weekend, former first lady Michelle Obama went on an annual trip to Aspen with her daughters and shut down its airport; the total

a golfing trip to Palm Springs and met with King Abdullah II of Jordan, which rang in at \$183,529.62.

CBS reported in September that President Trump's children and their families also took a yearly trip to Aspen, and spent over \$330,000 this March.

When she campaigned for Hillary Clinton in North Carolina, the former first lady racked up a bill of \$40,902.40.

Trump, though he has only been in office for nine months, is so far on track to come out ahead of the Obama administration's expense record. He, too, has had his fair share of trip

To celebrate his 100th day in office, Trump flew to a rally in as required by law.

Pennsylvania, costing \$156,618. Days later, he went to his golf club in Bedminster, New Jersey, which came out to \$224,765.80. In June, he flew again to Bedminster, racking up a \$199,332 bill. He also spent over \$1.1 million visiting the Mar-a-Lago resort in Florida.

"It shouldn't require federal lawsuits to...prod the Secret Service and Air Force to produce information about the costs of presidential travel—whether the travel is necessary or not, it's a massive amount of money," the organization's president, Tom Fitton, said in a statement. "We will continue to monitor this spending while taxpayers continue to pay the bills for presidential travel."

The new total was calculated by adding newly released documents to previous expense documents Judicial Watch had requested. Judicial Watch sued because the Air Force and Secret Service did not respond to its public records requests in time,


