Ernest Mims has been selected as the new head basketball coach at Coronado High School, announced today by the Lubbock ISD Athletics Department.


Coach Mims currently serves as head basketball coach at Winona High School in Winona ISD and has extensive experience as a head coach and assistant coach at the high school level.



MENTAL ILLNESS

For the last few days, the most tragic news available in the media has been of the unnecessary deaths in this country. It is my opinion that mental illness is sweeping this country and statisticians have no idea how bad and to what extent it exists in this country. Homestead Act of 1862 – Closest Thing to Reparations, Part III (FINAL)

As we stated in the previous two parts, American descendants of the vicious American Holocaust known better as Slavery gathered immense portions of land. The great Booker T. Washington would encourage freed slaves to work the land that they owned and invest profits from it and build an economic infrastructure to help empower ourselves after slavery. It appears that too few listened to his advice or admonition. Most freed slaves and their descendants who received these precious acres of land by way of the Homestead Act of 1862 and through means of inheritance were destined to lose the land.

Today, several members of Congress are trying to pass a resolution or law that would grant reparations to descendants of slaves. This is no big thing as it was first introduced in Congress back in 1989. They discuss it, kick it around and let the thought fade away eventually. Maybe it is too late for us. We had the opportunity to take advantage of the Homestead Act of 1862 and virtually blew the opportunity. We would get free land and then squander it or lose it through trickery or a soft form of land theft. Sometimes it may have been through worse tactics.

Take the case of another one of Harry's great grandfathers. Harry Watkins of Bellevue, Louisiana owned 225 acres of farmland. How he got it we do not know but in 1873 he used it as collateral for a loan of \$250. The loan agreement is in the records held at the local courthouse. The terms of the loan were this: He would agree to pay back the loan within two years or the land would revert to the lenders. The lenders were

two whites. For some reason, Great Grandfather Harry Watkins defaulted on the payment. When the due date arrived, he was nowhere to be found. In fact, Harry disappeared and so did our 225 acres. Not many of my family members talk about it. The story goes he got frustrated and left the family and the land.

We don't think so. Our fear is that Harry Watkins was murdered, and his bones are lying somewhere in Bossier Parrish, Louisiana. Why would he abandon his family and the 225 acres? One thing that is very interesting is the fact that Harry Watkins was totally illiterate. On the agreement the two white lenders signed as witnesses. Harry put his "X" in his signature block and the two whites claimed they were witnesses to his "X"

If we really believe we can overcome the negativate obstacles in our path, then we can. There's no doubt about it things have happened in other parts of Lubbock, but we don't need to quit doing what WE really know is right for us to do. Sure there are POSITIVE THINGS we really need but we

disappear. So, we total the amount of property that was once owned by two of Harry's great grandfathers and one of his grandfathers and we come up with 545 acres. What is left of that is 40 acres.

Fortunately, Harry and his cousins got together and decided to formally cut up the last 40 acres. Grandfather Thomas had eight children, so we turned the 40 acres into 8 lots of 5 acres each. We contracted an attorney and performed a "Voluntary Secession". That way we would be less vulnerable to adverse actions or trickery. 5 acres is less inviting to land thieves than 40 acres.

Down South, you must be vigilant to keep your property from being taken away. For example, there is a process known as "Adverse Possession". According to Wikipedia the definition of Adverse Possession is: "Adverse possession is a method of acquiring title to real property

Should We Panic over the Measles Outbreaks?

In general, it is not a good were removed before a hearing idea to panic about anything. The panic itself often causes more harm than the original

Crisis situations, real or contrived, lead to new intrusive laws that the public would never accept otherwise. We supposedly cherish freedom, but if we believe that the world will end if we don't act NOW, then we may clamor for the government to save us. Cynical politicians bent on increasing their power never let a crisis go to waste.

Something like the Green New Deal—the end of our comfortable, prosperous lifestyletakes a truly apocalyptic threat. But to eliminate our freedom to decline a medical treatment, the threat that "millions will die" of measles is evidently enough. Or if not millions (most older people had measles and recovered fully), a few especially vulnerable children, who can't be vaccinated themselves, might catch measles and die.

There are several hundred cases of measles nationwide, more than in 2014, and bills are being pushed through state legislatures to eliminate all but very narrow exemptions to the 60 shots now mandated for school

attendance. In New York City, people are receiving summonses based on Mayor Bill de Blasio's emergency order. Everybody, adult or child, who lives in four ZIP code areas must get an MMR shot or prove immunity, or face the prospect of a \$1,000 fine (\$2,000 if you don't appear as ordered). Your religious exemption is overridden. The threat of 6 months in prison and the prospect of forcible vaccination on a lawsuit brought by five mothers. The judge dismissed the case.

Health Commissioner Oxiris Barbot said that the purpose of the fines is not to punish but to encourage more people to proclaim the message that vaccines are safe and effective. Get it? If you say something to avoid a fine, that makes it true.

It's about the need for herd immunity, they say. We need a 95 percent vaccination rate for herd immunity to measles. With only 91 percent or so we are having outbreaks! If we could just vaccinate another 4 or 5 per-

Mayor De Blasio has a point about vaccinating everyone. Adults are getting measles because their shots have worn off. It is likely that we have survived for decades with a large part of the adult population vaccinated-but not immune. So where do the mandates stop?

Outbreaks have occurred in populations with a near-100 percent vaccination rate. Was it vaccine failure? Or was the vaccine not refrigerated properly? Or was a claimed outbreak real? One in Ann Arbor, Michigan, was called off when a special test, a reverse transcriptase polymerase chain reaction (RT-PCR) showed a vaccine-strain measles virus rather than a wild-strain measles virus. Some 5 percent of vaccinees may get an illness that looks like measles, but it is just a "vaccine reaction." Can they shed live virus? Yes. Should you keep your immunocompromised child away from recently vaccinated people? Just asking.

Like all medical treatments, vaccines are neither 100 percent effective, nor 100 percent safe. Read the FDA-required, FDAapproved package inserts. Arizona defeated a law that would have required making these available to parents in obtaining informed consent. (You can get them on the internet.) Vaccine Court has paid out about \$4 billion in damages—recently for two children with severe brain damage from encephalopathy (that's brain inflammation) after a fight lasting about 15 years. Just incidentally, they had an autism diagnosis also. Parents bring their severely injured children to hearings. You won't see these children on tv, only pictures of babies with measles. No "fear-mongering" allowed about "rare," possibly coincidental problems from vaccines.

There are trade-offs with vaccines: risks and benefits. But in the panic about measles, the right to give or withhold informed consent—fundamental in medical ethics as well as U.S. and international law—is being sacrificed. And so is free speech. The AMA wants to censor "antivaccine" information on social media. I happened on a factual article by investigative reporter Sharyl Attkisson, but was not able to retweet it because it had been removed.

The threat of infectious diseases is real and increasing. We need more robust public health measures, better vaccines, and improved public knowledge and awareness. Deploying vaccine police and shutting down debate will erode trust in health authorities and physicians, although more people may get their shots. But such heavy-handed measures will not defeat the enemymeasles and worse diseases.

Maxine Waters a model for many outspoken freshman Democrats

WASHINGTON (AP) — She's been called "Kerosene Maxine" and gaveled off the House floor for accusing Republican men of badgering women. She dismissed President Donald Trump and his allies as thugs and predicted his impeachment before he was sworn into office.

No one, Maxine Waters once observed, should be surprised by her. But after nearly three decades in Congress, the 80year-old California lawmaker is in an eye-opening role as the highest-ranking African American woman in the country. She's wielding the gavel of the bankregulating Financial Services Committee with the power to investigate Trump where some say it counts most: his business deal-

The role makes Waters a model for many, but notably for the outspoken freshmen Democrats who have drawn as much scrutiny — and as many threats - for what they've said as for the barriers they are breaking. Waters, known by some of them as "Auntie Maxine," has been there. And her unique ascent offers lessons in how to balance activism with work and pru-

"@RepMaxineWaters always tells it like it is like our favorite auntie," tweeted Michigan Rep. Rashida Tlaib, one of the first Muslim women in Congress. She, like Waters, called for Trump's impeachment, though

in more profane terms Waters has minced no words on her drive to see Trump formally charged by the House. She is leading one of six House committee investigations of Trump's specifically world, Deutsche Bank, the German asset management firm that has lent Trump's real estate organization millions of dollars over the years. She said earlier this year that the bank is cooperating with requests for documents. But Trump last week launched a legal fight to block the banks from doing so, opening a new front in his battle against Con-

Waters, the only woman and the only African American to hold that chairmanship, has offered instruction by example of how to survive as a "first" in the most diverse House in U.S. his-

"Her preparedness and her concentration on getting something done, and her ability to get along with us, allows her to get the policy done, too," said House Oversight and Reform Committee Elijah Cummings, D-Md., whose panel is also investigating Trump. "She can fire folks up, but she also does her homework. She also has a game plan in the end."

Tlaib and a dozen other Democratic freshmen on the panel had front row seats for what became a class in what House Speaker Nancy Pelosi calls "knowing your power." When Treasury Secretary Steven Mnuchin complained about how long Waters was questioning

him, she glared down from the

"This is a new way and it's a new day and it's a new chair and I have the gavel at this point," Waters said levelly.

Mnuchin suggested she drop the "gravel" and dismiss him. She did not. "Please do not instruct me as to how I'm to conduct this committee," she said. Mnuchin departed when Waters was ready. He promised to come back if called.

"She doesn't care who she might offend," said House Foreign Relations Committee Chairman Eliot Engel, D-N.Y., one of the other chairmen on the call who's served alongside Waters in the House since she arrived. "She cares more about the policy and getting from A to B."

R. Kelly Judgment Withdrawn After Lawyers Say He Can't Read

CHICAGO (AP) — R. Kelly spent much of Wednesday in court, with his lawyer explaining to one judge that the singer didn't respond to a lawsuit brought by one of his sexual abuse accusers because he is illiterate and with Kelly paying \$62,000 in back child support during a second hearing.

At the first hearing, Judge Moira Johnson vacated a default judgment she made against Kelly after the singer failed to respond to a lawsuit brought by one of the four women he's

charged with sexually abusing. Johnson reinstated the lawsuit after one of Kelly's attorneys explained that the singer was in jail when he was served with the lawsuit documents and that Kelly didn't respond because he can't read.

The second hearing, which pertained to child support, came weeks after the judge in that case ordered Kelly to jail after finding him in contempt of court for failing to pay \$161,000 in back child support to his ex-wife, who is the mother of his three chil-

Board was correctly decided. Any nominee who cannot fully endorse Brown is completely disqualified from the federal bench.

bought the land from my grandmother. We drove up to look at one day and found someone building a home on the property. My father went to court and the judge made the trespasser pay my father fair market value for the property. You just must be vigilant if you are Black and own property in America.

Too many Blacks have squandered their rights to land. We call it "Disrespectful Inheritance". There are more than a few cases of people living out West or up North and have little regard for family land. When a relative dies and the land is willed to them, they will quickly cash it in and ignore the possibility of investment or turning it over to their heirs. There are more than a few cases of a family member dying and leaving good property for their heirs. The heirs without evaluating the value will call a local realtor to sell the property immediately. In northwestern Louisiana it was not unpopular for an heir to fly in from Los Angeles; meet the realtor at the airport; sign the papers; receive the check and fly right back out to LA. Then he would go to the nearest Mercedes Benz dealership and instantly spend all of the money. What a waste!

In sum, we believe that we had our chance at reparations through the Homestead Act of 1962. No one in this nation is going to agree to reparations for descendants of slaves. Let's move on.





Kelly's attorney Lisa Damico told reporters after Wednesday's hearing, the Chicago Sun-Times reported. "All he wants to do is do right by his kids."

Kelly's bookings for performances began drying up following the airing of a television documentary "Surviving R. Kelly." That was weeks before his February arrest on charges accusing him of sexually abusing a woman and three girls over roughly a 10-year period starting in the late 1990s. But on Tuesday, one his attorneys told reporters that he was lining up performances for the Grammy award-winning R&B singer in Illinois and outside the state, and that he anticipated the judge approving requests to travel to make those appearances.

Kelly has pleaded not guilty to the sexual abuse charges and denied any wrongdoing.
