




"It was an outstanding day when this large number of people were in attendance," said B. J. Morrison.


All of these individuals are the newly elected officials at Jackson Elementary.





# In Cinque

#### THE EFFECTS OF ROE V. WADE TODAY

In the wake of finding children dead each week of this year in this country, due to parental neglect or individual insanity, it would appear that our various states would just leave ROE V. WADE alone. Lately, several states are passing laws to nullify Roe v. Wade and making the act of having an abortion criminal

On January 22, 1973, the case of Jane Roe, et al v. Henry Wade, District Attorney of Dallas County was decided by the Supreme Court of the United States. The decision held that:

The Due Process Clause of the Fourteenth Amendment to the U. S. Constitution provides a fundamental "right to privacy" that protects a pregnant woman's liberty to choose whether or not to have an abortion. This right is not absolute, and must be balanced against the government's interest in protecting prenatal life. Texas law making it a crime to assist a woman to get an abortion violated this right.

This right to abort a fetus was legal in the first trimester of pregnancy. During the second trimester, the government could require certain health regulations for an abortion and during the third trimester, abortions could be prohibited unless saving the life of the mother was necessary. This required the courts to evaluate state abortion laws. The case of Planned Parenthood v. Casey, in 1992 modified the findings of Roe v. Wade wherein a woman's right to abort was upheld if the fetus was nonviable, but defined the fact that a fetus' viability could occur as early as the 23rd or 24th weeks. This has become a political arena and the effects of the politics seem to be putting divisions in places where it should not occur, especially with the #ME TOO movement and men whom are guilty of causing unwanted pregnancies are making the laws that deny a woman the abortion of an unwanted child.

Aside from the race to change the laws, the Planned Parenthood organization is facing closings, burnings of offices, killing of doctors and nurses who perform abortions and at the same time, parents are killing their children at a young age which seems cruel and inhuman, when they could have had an abortion if they were not ready to be par-

Abortions occurred before Roe v. Wade which has saved some lives and it will continue if it is overturned. We need to get 'in cinque,' use common sense and support Planned Parenthood as it has made sexual life and birth healthier for this country.





## Kevin Durant had surgery to repair ruptured Achilles

TORONTO — Golden State Warriors star Kevin Durant walked onto the court an hour before tipoff of Game 5 against the Toronto Raptors on Monday

He was preparing to do his pregame workout ritual. It was the first time in over a month since sustaining a right calf injury in Game 5 of the Western Conference semifinals — that the 10-time All-Star worked out in a public setting.

Over the past two weeks, Durant fought valiantly to push up his return date. With his team down 3-1 in the NBA Finals, he wanted to give it a go and the team doctors subsequently cleared him. Going through this pregame warmup was the final step to returning to genuine game action.

This was a joyous time for him and the organization.

But on his way to the Warriors' basket, he was met with blaring boos. And then the antics ramped up when Durant began shooting midrange jumpers. On misses, the crowd camped around the lower bowl collectively started cheering. On makes, it collectively went silent as a way to irritate him.

"Damn, they're really f---ing with this man after what he's been through?" a Scotiabank Arena security official said. After approximately 15 minutes on the court, Durant retreated to the locker room as a series of boos showered down on him.

He had no reaction.

This was just the beginning of an ugly night, a night in which the Warriors staved off elimination with a 106-105 win in Game 5 of the NBA Finals to send the series back to Oakland but ended up paying a steep

Early in the contest after Durant picked up his first personal foul, chants of "KD sucks!" broke out, which baffled a few Raptors fans because this was a player capable of dramatically changing the course of the se-

But even before Game 5 came around, Durant had heard it all.

In the initial stages of his postseason absence, the narrative circulating was that the Warriors were a better team without him. Toward the middle of his time being sidelined, some took issue with him remaining in the locker room and not sitting on the bench with his team. In the latter stages of his rehab, the chatter shifted to the possibility that he was milking the injury to prove to the Warriors how desperately he was needed to win another championship.

Family, teammates and confidants routinely checked on Durant during his quest to rejoin his guys on the court. Each time, Durant explained that he was working to speed up the process but was still experiencing discomfort pushing off his right foot, league sources told Yahoo Sports.

Sources described Durant as being in agony because he was unable to help his teammates.

Warriors general manager Bob Myers was teary when he gave the news after Game 5 of the NBA Finals on Monday night. An MRI will be performed Tuesday to determine the severity, but Durant's season is clearly over and his recovery will likely take several months if the Achilles is indeed torn.

"He's one of the most misunderstood people," Myers said. "He's a good teammate, he's a good person, it's not fair. I'm lucky to know him. I don't have all the information on what really the extent of what it all means until we get a MRI, but the people that worked with him and cleared him are good people, they're good people."

push that Black Democrats made into districts that have been traditionally white strongholds in the suburbs.

Of the nine Black Democrats who won their first race this year, four are billed as majority makers - Democrats who won seats previously held by Republicans. A fifth won in a traditional swing seat outside Las Vegas that has gone back and forth for decades.

This group includes Colin Allred, a former National Football League player who ousted longtime Rep. Pete Sessions (R-Tex) in a suburban Dallas district where Democrats did not even field a candidate two years

In a special election last year, Democrats poured a record \$30 million into the suburbs north of Atlanta for Jon Ossoff, who was a 30-year-old former congressional staffer. He came up short, only to watch Lucy McBath, a gun control advocate whose son was killed in a shooting, run an under the radar race to victory over the same Republican.

For decades, the all-white leadership has taken CBC seats for granted, seeing them as heavily Democratic districts in urban strongholds that will remain in their corner no matter who holds them.


Now, leaders have to cater to these new CBC members to preserve their majority in two years."

## Chilling new details emerge in the attempted murder of David Ortiz

Six men are now in custody in the Dominican Republic tied to the attempted murder of baseball star David Ortiz, authorities announced Wednesday, saying it was a coordinated attack for which the men were allegedly

paid the equivalent of \$8,000. Jean Alain Rodríguez Sánchez, the Dominican Republic's chief prosecutor, spoke at a press briefing, indicating that authorities believe they have the alleged shooter in custody but are still pursuing one more suspect. They still haven't announced a motive for the attack

Ney Aldrin Bautista Almonte, the director of the Dominican National Police, presented the black handgun allegedly used to shoot Ortiz on Sunday night outside of a popular nightspot in Ortiz's hometown of Santo Domingo. It was the first time authorities confirmed publicly that the shooters were paid to target Ortiz.

Authorities say the attack on Ortiz was planned the night before. According to court documents obtained by The Boston Globe, the men believed to be part of the plot met again Sunday night with two cars and a motorcycle parked nearby.

Two men - including alleged shooter Ramón Martínez Perez, who goes by the name Rolfie and was named for the first time Wednesday — left on the motorcycle to attack Ortiz. The driver was 25-year-old Eddy Vladimir Feliz García, who lost control of the motorcycle, crashed and was detained and beaten by nearby citizens. Initial reports from the scene believed that García was the

The shooter escaped on foot, returned to the two vehicles and fled the scene. Witnesses were able to identify the cars and police tracked down Perez.

Among those in custody, according to The Globe, is Oliver Moisés Mirabal Acosta. Acosta, according to Dominican newspapers, was previously sentenced to prison time on an illegal gun charge and was accused of being part of four execution-style killings in 2013 that were tied to a local drug gang.

Ortiz, meanwhile, has been is in a Boston hospital, where his condition is improving, according to his family. His wife Tiffany Ortiz released the following statement Wednesday, June 12, 2019,

"David continues to recuperate today in the Intensive Care Unit at Massachusetts General Hospital under the direction of treating trauma surgeon Dr. David King.

"Yesterday and this morning, David was able to sit up as well as take some steps. His condition is guarded and he will remain in the ICU for the coming days, but he is making good progress towards recov-

"My family and I again want to thank everyone for their endless love and well wishes, and still ask for privacy while David continues to heal."






