

Former Lubbock Resident, Ms. Ethel Young, **Expresses The Goodness Of God!**

Centerville, Texas - Ms. Ethel Young, a former longtime resident of Lubbock, Texas, can tell you many stories she lived in her life in which God was the answer. You see, she recently celebrated her 95th birthday in the presence of her family and friends. This outstanding celebration took place on Tuesday, September 3, 2019 in Madisonville, Texas.

She resided in Lubbock for many years and was a faithful member of the Bethel African Methodist Episcopal Church. She made many positive contributions to her church in many ways. She was always seen meetings in the community. walking throughout her community making things happen.

She will tell you how she misses Lubbock, Texas. At this time, she sends her hellos to her church members and friends.

Ethel is the sister of Simon Young and Mary Cofield, both of Centerville, Texas. She is also a sister of the late sisters: Katie Rollison and Emma Rayford, both of Lubbock, Texas; and Helen Young Jones of Dallas,

views - and mania. She moved home for a while, returned to school and then left, saying she had a friend she was able to stay with. Bennett now believes that during this period Devan was houseless and engaging in sex work to survive. She and her husband provided some material support, keeping her phone on and telling her she could always come home to shower or eat.

Bennett and her husband had encouraged their daughter to see a therapist, but Devan seemed resistant and closed off in therapeutic settings until she "hit bottom" one day, calling her mother to say she was staying with a man nearby who she was afraid would hurt her, and had herself pulled a knife on him. Devan later said she was probably entirely safe and experiencing

paranoid delusions. Bennett picked her up and brought her home, and Devan began regularly engaging in therapy and taking medications to stabilize her mood.

Gradually, her life began to stabilize. At the time she died, Devan lived in her own apartment and was working for a company that transcribes phone calls for the hearing impaired. A few days after her birthday, she had made plans with a friend to meet for coffee. When she didn't show, the friend contacted Devan's building manager and then her parents, triggering a series of frantic phone exchanges that eventually led to Devan's building manager's assistant calling Bennett to say "the coroner's office would be in touch."

'It's OK to Struggle'

Gabriel Lavaly lived in Sacramento until he was 13, when his family moved to the Portland area.

His school in Sacramento was diverse: he estimates about half the students were White and half were people of color. The White student population included students from a variety of immigrant groups. As a biracial student - Layaly's mother is White and his father was Black - he fit in.

Then his father became ill, and Lavaly's life was disrupted. He and his sister left school for six months to care for him. When his dad died from complications of dialysis in 2010, when Lavaly was 15, Lavaly lost his connection to his identity.

"He was my connection to the Black community here. When he got sick, I kind of lost that," Lavaly said.

Lavaly struggled to fit in at his new school, which had fewer students of color, and where students would ask him intrusive questions about his background and where they would ask if they could touch his hair.

"I was really angry. I didn't really talk. I found it hard to open up to people. I pretty much just kept it to myself. I pretty much just shut down," he said.

Lavaly, 25, now works as an outreach assistant for target populations for Lines for Life, a Portland-based nonprofit that runs crisis hotlines and other programs for mental health and substance abuse outreach. He studied community development at Portland State University, but began to consider a career in mental health after he graduated.

He didn't begin to address his own issues with mental health, which included suicidal thoughts, until college, when he met other Black students through PSU's ACCESS program, which is under the umbrella of student services.

"[The other students] were very open in talking about how they would struggle or they had depression. I never really told a lot of people that I was struggling. They were just so open about it in an educational, but also kind of a friendly way, that I was just like, 'OK, I can share my story too," Lavaly said.

Oregon ranks 15th in per capita deaths by suicide nationwide, and has had a higher rate of suicides than the U.S. generally for more than 30 years, according to the Oregon Health Authority. In Oregon, African Americans are less likely to die by suicide than the general population. But a 2018 article in JAMA Pediatrics showed an increase in suicides by Black elementary school-aged children between the years of 2001 and

"I didn't really hear anybody in my family or in my community talk about suicide, and I thought Black people just don't talk about suicide," said Dolores Bennett. "What I've learned is that White people don't talk about it either. It's hard to talk about."

But Bennett believes that talking openly is the only way to

Her daughter, Devan Elyse Bennett, died two years ago in August. She would have turned 30 last month. Bennett and her husband, Austin, both born and raised in Chicago, moved to Portland three years ago after "one too many blizzards" made them decide to retire in a milder

Devan was smart and funny and sensitive, a gifted writer and musician who self-published a book of poems and for a period played violin in the Chicago subway for money.

"Middle school was when we knew something was a little off," Bennett said. She struggled to make friends, was a "bully magnet" in high school and initially balked at the idea of leaving home for college. Three-and-ahalf years into her course of study at Knox College in Galesburg, Illinois, she left college and returned to Chicago to live with a man she had met through school, but who wasn't a stu-

After leaving school Devan began showing signs of severe anxiety, including agoraphobia she rarely left her apartment and had panic attacks in job inter-



FRAUD AND SCAMS

Every day we are confronted more and more by fraud and scams possibly occurring in our lives. Just answering the telephone is the most current fear as the Robo callers become more and more persistent each day. They have gotten wise regarding not having a caller ID and have begun to clone telephones in your calling area or using names of some organization which you probably never heard of and which probably does not exist. They are bold enough to use the names of government agencies such as the IRS and Social Security Administration to get you off guard and potentially vulnerable to their schemes, especially if you are an elderly person.

They have access to the names and addresses of potential social security and/or Medicare recipients. Here lately, my mother, deceased some twentythree years now, has been receiving more mail from insurance companies and entities with supplies for the elderly than I have been receiving. Mail for her sister of the same nature also comes regularly. She has only been deceased for five years. They even attempt to thrash out the names of relatives living or dead whom they feel are potential marks. At this stage of the game, it is not just the callers with no caller ID, but also those with the weird IDs on the telephone or internet. Some are im-

As hard as I try, I ended up involved in a scam taking a survey from Amazon regarding the last item I had purchased online. It was two months later when I discovered that I, according to a company called WATCH US, had signed up to purchase a luxury bag at the cost of \$98.89 per month. I had agreed to take the survey and accept a purse for shipping cost only as a reward, planning to give it away as a gift later. It was no luxury item and I have since contacted them to cancel any agreement whether I made it or not and refund my credit for merchandise which I do not want either. I have since decided NOT to take any surveys, online or in the mail so as not to repeat that mistake.

One telephone scam wherein it is attempted to get you to sign up for something which you do not want is one where the caller asks you how are you doing and if you can hear them. They want you to say "Yes." They record your answer and you are giving them permission to sign you up for whatever they plan to secure in your name. Be careful about whom you tell that you can hear them. Best yet, refuse to talk if you answer the telephone. Most callers will hang up. That does not mean that they will not call again; most do. There is one other alternative. You an insult them and maybe the timid will not call back. Get 'in cinque' and be very careful about dealings with online and telephone conversations and surveys.

Not All Private Prisons are the Same

At the National Black Chamber of Commerce, we change lives through our Project Rebound program, designed to place at-risk applicants into meaningful jobs where they can contribute to society. I am pleased to report that we recently visited another place that changes lives for the better, a most unexpected place: a detention center. Two of them, actu-

When you turn on the news today, it seems everybody is bashing private prisons. They cause mass incarceration and cage children at the border, the saying goes, and take poor care of those in their custody.

Since I have a background in Corrections and have been in a dozen prisons, I decided to see for myself. My wife, Kay and I were recently part of a group that visited the Broward Transitional Center in Pompano Beach, Fl., and the South Bay Correctional and Rehabilitation Facility in South Bay, Fl. Both are managed by the GEO Group, a corrections firm that has had its share of negative headlines. My conclusion: the progressive and media narrative is wrong. Both facilities help people improve their lives in ways that are inspirational – and go far beyond what any state prison would do.

In the first place, neither Broward nor South Bay seem like the stereotypical image of a prison. The Broward facility which GEO runs under contract for U.S. Immigration and Customs Enforcement - is more like a college dorm. Detainees from 43 countries mill about in their clean, air-conditioned, bunk bed-style rooms (equipped with flat-screen TVs) or in the yard, where they enjoy an artificial turf soccer field; weightlifting



Kamala Harris Proposes Loaning Government Funds to 'Disadvantaged' Marijuana Business Owners



Senator Kamala Harris

Senator Kamala Harris (D., owned and controlled by so-Calif.) plans to make government loans available to "economically and disadvantaged" Americans seeking to launch marijuana businesses, she revealed as part of a broader criminal justice plan released Monday, September 16, 2019.

Harris, who has been criticized by progressives over her record as a prosecutor, calls for a restorative justice approach to marijuana legalization that would direct the resulting economic benefits to the communities that she argues have been most harmed by the war on drugs. As part of this approach, Harris would direct federal funds to states and local governments that would then provide presumably low-interest marijuana business loans to individuals deemed "disadvantaged."

"Provides states and localities with funds to make loans to assist small businesses in the marijuana industry that are cially and economically disadvantaged individuals," criminal justice plan reads.

Harris would fund these loans through a "sales tax on marijuana and marijuana products."

Harris now supports legislation that would legalize marijuana at the federal level and retroactively expunge the records of those convicted on marijuana-related charges, but her support for legalization represents a departure from the stance she maintained as a prosecutor and as a freshman law-

In her six years as California attorney general, Harris jailed 1,974 people on marijuana-related charges. As recently as 2014, Harris laughed when asked about the Republican California attorney general's support for legalization and, in 2010, she opposed a California measure that would have legalized recreational marijuana in

Harris also faced paternal backlash after she insinuated during a radio interview that she hailed from a family of marijuana users.

"Half my family's from Jamaica. Are you kidding me?" Harris said when asked if she smoked marijuana in her youth.

Harris's father responded by accusing his daughter of shaming the family.

"My dear departed grandmothers (whose extraordinary legacy I described in a recent essay on this website), as well as my deceased parents, must be turning in their grave right now to see their family's name, reputation and proud Jamaican identity being connected, in any way, jokingly or not with the fraudulent stereotype of a pot-smoking joy seeker and in the pursuit of identity politics," he wrote.

Of the top-tier Democratic presidential aspirants, former vice president Joe Biden is the only one who has not yet endorsed federal legalization.

Kevin Durant says he'll 'never be attached' to Oklahoma City again

Brooklyn Nets star Kevin Durant doesn't have plans to return to Oklahoma City when his career is over. Durant said he'll "never be attached to that city again" during a wide-ranging interview with J.R. Moehringer of the Wall Street Journal.

That was far from the only contentious thing Durant said during the interview. The 30year-old also discussed hating the NBA and his exit from the Golden State Warriors.

Durant's harshest comments, however, were reserved for his former city. Durant - who spent eight seasons with the Oklahoma City Thunder — said he has no desire to return to the city any time soon after the way he was treated when he left to join the Warriors.


"I'll never be attached to that city again because of that," Durant says. "I eventually wanted to come back to that city and be part of that community and organization, but I don't trust nobody there. That s--- must have been fake, what they was doing. The organization, the GM, I ain't talked to none of those people, even had a nice exchange with those people, since I left."

Durant cited fans spray painting "For Sale" signs at his house and burning his jersey as reasons he felt betrayed by Thunder fans. He also described the atmosphere as "venomous" when he returned to Oklahoma City for the first time as a visiting player."

In the piece, Durant also talks about how much he despises the

"Some days I hate the circus of the NBA," he says. "Some days I hate that the players let the NBA business, the fame that comes with the business, alter their minds about the game. Sometimes I don't like being around the executives and politics that come with it. I hate that."

He also discussed his departure from the Warriors, saying he always felt different there because he wasn't drafted there and didn't resurrect his career

there. Durant also questioned the team's strategy in the playoffs, saying the Warriors' motion offense didn't work after the first two rounds. Durant said the team would have to mix in individual play, and he wanted the opportunity to hone those skills more often.

It's unclear when he'll get that chance for the Nets. Durant is currently rehabbing from a torn Achilles. He's expected to

miss 9-12 months due to the in-

Until then, Durant will keep pushing himself so he can get back on the court as soon as possible. If all goes well, Durant could be back in time to join the Nets when they travel to Oklahoma City to take on the Thunder in April.

Thunder fans should have quite the reaction to that, especially after Durant's comments.

Pro Football Hall of Famer Lynn Swann has resigned as athletic director at his alma mater, USC, in a move that could affect the football coaching world at both the college and NFL levels.

USC President Carol Folt praised Swann in a statement, saying, "He will forever be a valued member of the Trojan family."

That statement aside, Swann's tenure has been heavily criticized. The USC athletic department was involved in the college admissions bribery scandal, and Swann has taken heat for his decision to stick with head coach Clay Helton after last year's 5-7 record. A new athletic director is highly likely to want his or her own coach, and Helton will need to have a very good season this year to keep his job. So far he's 2-0 and USC is ranked No. 24.

Whatever happens with the USC football program will have an impact on the NFL. The USC job would be attractive to NFL coaches, and USC and NFL teams are always in competition for coaches, including this year, when USC hired Kliff Kingsbury, who was former head coach at Texas Tech University in Lubbock, Texas, as its offensive coordinator, and Swann attempted to prevent Kingsbury from interviewing for NFL jobs. Kingsbury ultimately resigned from USC and became the Cardinals' head coach.

After an All-American career at USC, Swann was a first-round draft pick and three-time Pro Bowler with the Steelers, the Super Bowl X MVP, and a member of the Pro Football Hall of Fame class of 2001.

More news reveals that The common alternate name for the University of Southern California (31) is the University of Spoiled Children, a putdown that was coined long before Lori Loughlin bribed her daughter's way into school. 
