



Lubbock National Bank celebrates opening of East Lubbock branch



The ribbon cutting to celebrate the grand opening of the new Lubbock National Bank inside United Supermarkets at 2630 Parkway Drive was held on Thursday, September 24, 2020 from 12:00 pm-12:30 pm.

Lubbock National Bank, along with community partners, celebrated the opening of their newest branch on Thursday.

The full service LNB branch is located inside the United Supermarkets store at 2360 Parkway Drive. Up until several weeks ago when LNB had a soft opening, residents living east of

interstate 27 in the city of Lubbock had been without a nearby bank since July 17, 2019, more than a year ago, when Wells Fargo abruptly closed their branch location inside United.

LNB market president Eddie Schulz remembers watching the news when the branch closed. He remembers residents saying the community needs a bank, and shortly after that Shulz says LNB began planning to fill that community need.

On Thursday, Schulz said he hopes the arrival of the bank will play a role in the ongoing

revitalization of East Lubbock neighborhoods.

"Part of my career started in East Lubbock many years ago," Shulz said. "Its people were more than generous to me and it is my pleasure to become a part of this community again ... We value the opportunity to help people and businesses succeed."


Along with celebrating the branch opening with a ribbon cutting, LNB also presented a \$10,000 check to Guadalupe-Parkway Sommerville Centers.

The Parkway branch is LNB's first bank branch inside a




Above: LNB's \$10,000 Donation to Pkwy-Guad-Som. Center







"PANDEMIC VOTING"

November 3, is roughly seven (7) weeks away and from the moment there was talk of voting by mail, I have received e-mails almost daily to contact federal officers, Congressmen and women and the President to alleviate the hardships on the United States Postal Service.

It appears that the President of the United States, along with some of his big party campaign donors feel that if voters are permitted to mail in their ballots because of the pandemic, that he will lose votes and not be reelected. Consequently, mail has been slowed down tremendously by removing machines from the post offices which could sort over 30,000 pieces of mail in a very short period of time. Besides that, many outside mailboxes have been removed, causing mailers to have to find a place to post their mail which may not be as convenient as before. In addition, to removing sorting machines and mailboxes, friends of the President have been installed in high positions in the post office hierarchy and experienced heads of departments have been moved, creating pandemonium in the post office.

Until 1971, the United States Post Office was a cabinet entity of the U.S. Government. It was one of the few departments specified in the U.S. CONSTITU-TION. The establishments of roads mentioned in The CON-STITUTION were for the purpose of expediting the mail. The Pony Express needed roads to take the mail from one place to another in fair time. In 1971, during the Nixon administration, the Post Office was made into an independent agency under the executive branch of government and called the U.S. Postal Service, rather than department. The Postmaster General is no longer a cabinet member. The current

Postmaster General was not appointed by the President but yet he has far reaching influence as to the person who now holds that position and whom had little knowledge of what he is supposed to do. His employment has a great influence on the slow-down of the services and the need for financial input into the services. Party politics are at play and the American people are not just suffering from the pandemic brought on by the Coronavirus but the plague existing at the U.S. Post Office.

I do not foresee any immediate miracle for better postal services, but I can imagine that every soul, able or disable, get 'in cinque' and find a way to the voting polls on November 3 and vote. This time, I am being par-

5 Fitness Startups Seizing **New Opportunities During** COVID-19

Fitness applications and marketplace platforms can be a forcing function for productivity today, and after the crisis ends.

In 2016, I launched an on-demand fitness platform, NamaStay. NamaStay was a two-sided marketplace connecting users with certified yoga instructors. At the time, the market opportunity for yoga instruction was \$3.7 billion and \$3.3 billion for personal instruction. I assumed that people aren't practicing yoga and improving their health because they can't get to a studio. Also, a majority of yoga teachers surveyed work parttime, which meant they had flexible schedules higher-earning power. After testing the assumptions, I realized

Customers loved the marketplace. Additionally, they received expert training from the comfort of their own home.

· There wasn't liquidity of supply. Yoga teachers weren't compelled to travel around the city to give instruction. They liked the prospect of making more money, but going to each class cut into their free time.

Both sides of the marketplace ultimately wanted a solution that gives them their time back. Four years ago, consumers and trainers weren't forced to digitize their workout routines. Today, COVID-19 is an accelerant for innovation. The coronavirus out-



Big Ten Will Play Football in 2020, Reversing Decision

Leaders of Big Ten universities have faced pressure from coaches, players, parents and fans since announcing on Aug. 11 that the conference would not

compete until 2021. The Big Ten Conference, one of the wealthiest and most powerful leagues in college sports, had been besieged for weeks to reverse its policy not to play football this fall because of the coronavirus pandemic. But as recently as last week, many of the university leaders behind the league's most consequential decisions were skeptical of altering their approach.

Then came a new series of conversations with the league's medical advisers, who had kept deliberating even after they led the conference's presidents and chancellors to conclude overwhelmingly last month that the pandemic made it too risky to play until at least 2021. By Wednesday morning, the league's 14 universities, including athletic powerhouses like Michigan, Ohio State and Penn

State, had unanimously agreed ders to surrender. But some top to try to play football as soon as Oct. 23, but without fans in the stadiums. The turnabout fed debate over whether political interference and the allure of enormous broadcast contracts not to mention the envy-inducing sight of other college and professional sports leagues filling the airwaves with their own game had led the university lea-

players welcomed the decision, and Big Ten leaders insisted that they had reconsidered because of, not in spite of, medical advice. some Big Ten players, including Justin Fields, the Ohio State quarterback, urged the conference to find a way to play.





Justice Ruth Bader Ginsburg Dies at Age 87



Supreme Court Justice Ruth Badar-Ginsburg

(CNN) Supreme Court Justice Ruth Bader Ginsburg died on Friday, September 18th due to complications of metastatic pancreas cancer, the court announced. She was 87.

Ginsburg was appointed in 1993 by President Bill Clinton and in recent years served as the most senior member of the court's liberal wing, consistently delivering progressive votes on the most divisive social issues of the day, including abortion rights, same-sex marriage, voting rights, immigration, health care and affirmative action.

Her death -- less than seven weeks before Election Day -opens up a political fight over the future of the court. Addressing the liberal justice's death, Senate Majority Leader Mitch McConnell said Friday evening, "President Trump's nominee will receive a vote on the floor of the United States Senate."

But Ginsburg told her granddaughter she wanted her replacement to be appointed by the next president, NPR reported. "My most fervent wish is that I will not be replaced until a new president is installed," she dictated to granddaughter Clara Spera days

"She led an amazing life. What else can you say?" President Donald Trump said Friday evening upon hearing about her death. "She was an amazing woman whether you agree or not she was an amazing woman who led an amazing life.

Democratic presidential nominee Joe Biden praised Ginsburg as a "giant in the legal profession" and a "beloved figure," saying in brief on-camera remarks Friday evening that people "should focus on the loss of the justice and her enduring legacy."

"But there is no doubt, let me be clear that the voters should pick the president and the president should pick the justice for the Senate to consider," he added, saying that was the position of Republicans who refused to vote on then-President Barack Obama's nominee in 2016.

Ginsburg developed a rock star status and was dubbed the "Notorious R.B.G." In speaking events across the country before liberal audiences, she was greeted with standing ovations as she spoke about her view of the law, her famed exercise routine and her often fiery dissents.

"Our Nation has lost a jurist

of historic stature," said Chief Justice John Roberts. "We at the Supreme Court have lost a cherished colleague. Today we mourn, but with confidence that future generations will remember Ruth Bader Ginsburg as we knew her -- a tireless and resolute champion of justice."

Ginsburg, who died on the eve of the Jewish new year, was surrounded by her family at her home in Washington, DC, the court said. A private interment service will be held at Arlington National Cemetery.

Ginsburg had suffered from five bouts of cancer, most recently a recurrence in early 2020 when a biopsy revealed lesions on her liver. She had said that chemotherapy was yielding "positive results" and that she was able to maintain an active daily routine.

"I have often said I would remain a member of the Court as long as I can do the job full steam," she said in a statement in July 2020. "I remain fully able to

In 2011, by contrast, President Barack Obama singled out Ginsburg at a White House ceremony. "She's one of my favorites," he said, "I've got a soft spot for Justice Ginsburg."





First, Zuerlein placed a perfect onside kick that America's Team recovered after the Cowboys scored on a nine-play drive ended by a Prescott rushing touchdown.




Do las Cowboys wide receiver Amari Cooper (19) makes an oustanding 58 yard catch.

here for the long haul, and this branch is a testament to that," Ware said on Thursday. "We can't wait for the future."







By utilizing the Booker T. Washington Garden, we are able to physically show youth what healthy relationships look like and how a community can come together to build a lasting

Guadalupe-Parkway Sommerville Centers youth participated every Wednesday at the garden to learn about the relationships the plants had with their environment and discussed the similarities to our own relationships. The youth learned what community can achieve when we come together and support one another.

While speaking to the youth about community it was vital to begin with the history of the E. In our past we see our failures, our victories and our defeats. The past allows the people of the present and future to learn without having to endure. We can see how others coped, we can see how others survived and persevered during hard times.

The past gives us courage and protects us. It is startling youth do not know who the parks in their neighborhood are named after or even who their neighborhood is named after. If we do not know and recognize our past, we are doomed to repeat the same mistakes other generations have made. It is important for us as a community to teach our community's history correctly.

The youth participants received a crash course in the history of East Lubbock and disco-

vered the impact individuals had on their community and the struggles folks went through to get them to where they are.

The Booker T. Washington Community Garden is in the shadow of the Chatman Community Health Clinic. Youth learned the building was once the Chatman Medical and Surgical Hospital, the first hospital for African Americans in Lubbock. All of the youth had been to Mae Simmons Pool and Mae Simmons Park but did not know why Ms. Simmons was important to their community history. At the garden they learned she was the first African American female principal in Lubbock and how she was a strict disciplinarian who expected positive results from her students. They also learned her house was directly behind the garden.

Ms. Jessica Tullar Caroom with South Plains Hunger Solutions showed the youth where their food comes how to plant fruits and vegetables such as sweet potatoes and cantaloupe. Using the compost bins in the garden she taught youth how to make compost and how it is valuable to your garden.

The highlight of the summer was the Kids Farmers Market sponsored by South Plains Hunger Solutions. Ms. Jessica brought community partners and volunteers from around Lubbock to hold a farmers market for the youth. Each young person received five fake dollars and were able to choose produce and flowers to take home with them. This was such an enlightening event. Youth who had not ever been given the opportunity to choose healthy food for themselves were able to select cucumbers, carrots, tomatoes, arranged flowers and more. They also left with information on double up food bucks through the Lone Star Card.

We would like to thank Ms. Shirley Green at the Roots Historical Arts Council for allowing us access to the garden. We also thank our devoted volunteers, Ms. Shonta Fockler. Mr. Donnie Danford Jr., Ms. Danielle Demetria at East Lubbock Art House, and the Davis Family for giving their time to the garden. This fall we are asking for community members to join us as we cultivate community at Booker T. Washington Community Garden, 2201 Cedar Ave. Lubbock, Texas 79404.
