Stratford City Council met in regular session, Thursday January 25, 1990 at 7:30 p.m. with Mayor Doug Reese presiding and the following Council Members present: Wanda Riffe, Claude Harlow, R.J. Hill, Wayne Merrill and Ronnie Pickens. City Attorney, Kyle Lewis, was also present.

Minutes of the last meeting were read and approved as read.

Passing Ordinance # 271 that will prohibit keeping livestock inside the City

XIT Cellular Is Coming--It's Worth Waiting For

XIT Rural Telephone Cooperative, Inc. announced that it will be providing cellular service as XIT CELLULAR.

XIT Cellular's service area will include Dallam, Hartley, Sherman, Moore and Oldham Counties of the West Texas Panhandle, otherwise known as Rural Service Area 1 (RSA-1).

The construction permit was issued by the Federal Communications Commission (FCC) in Washington, D.C. on January 16, 1990. Cell site construction will begin as soon as possible in the Dalhart and Dumas areas. Tentative plans are to implement this service the last of May, 1990. Additional plans are to add cell sites in Stratford and Adrian on 1-40 west of Amarillo. These plans are pending FCC approval.

If a person is interested in obtaining mobile phone service, he should give serious consideration to the type of service he will be getting. He should take into account the limitations that traditional mobile service places upon him: * Limited access by only a few subscribers * Limited number of available channels. Possible distorted voice transmission * Interrupted service because of poor range capabilities * Outdated equipment and service.

On the other hand, cellular radio offers the latest in technology. How does it work? The cities and rural service areas are divided into smaller geographic areas called CELLS. The number and size of the cells required by each service area depends on the demand for service, the number of square miles of coverage and the terrain. In metropolitan areas low powered transmitters are placed in the center of each of the cells. By using this type of transmitter, the coverage area remains small and the frequencies can be re-used more often. This makes it possible for more subscribers to have access to the service. In the rural areas, these transmitters will be more high powered and will serve larger goegraphic areas. Availability for access by subscribers is accommodated by adding channels to each cell. This can be accomplished in rural areas where the demand for channel frequencies is much

Another important advantage is that the coverage area of the cells overlap with other cells. With conventional mobile radio, as the user moves away from the base station transmitter, the signal quality deteriorates

until eventually the call will be dropped. With cellular radio, when a call is in progress and a vehicle moves from one cell to another, the conversation is routed from one cell site antenna to the next--and so on. This is referred to as "Call Handoff" and is accomplished without interrupting the call.

Eventually, cellular service will be provided nationwide. this will be accomplished when all the rural service areas have their cells "up and running" and have provided the necessary links to the metropolitan cells. Such features as "Follow Me Roaming" and "Call Delivery" will allow calls to be forwarded to the cellular user no matter where he is traveling.

So, why is cellular service worth waiting for ? Cellular service offers everything that traditional mobile service can't: * Access to virtually an unlimited number of Subscribers * Greater number of available and re-usable channels * Clear voice transmission * Uninterrupted service from cell to cell * More privacy * Direct Dial long distance service * Advanced technology [Follow Me Roaming - Call Delivery].

The mobile phone service that are now being offered in this area are not "true cellular" services. In addition, the equipment being offered is not "truecellular" equipment. Some of this equipment may be in the same frequency spectrum as cellular equipment, but it has certain limitations.

Seminar Held At Mary Allen

Clements To Serve As District Judge

This article taken from the Dalhart Texan, Thurs. Jan. 25, 1990.

Gov. Bill Clements on Wednesday Jan. 24 appointed Ronald Eugene (Ron) Enns of Dalhart as judge of the 69th State District Court. The jurisdiction includes Dallam, Hartley, Moore and Sherman Counties.

Enns was appointed by Clements to fill the unexpired term of Judge Bill Sheehan of Dumas who is retiring on March 31. The position for the 69th District Judge will be on the March 13 primary ballot and on the ballot in the General Election on November 6.

On the March 13 ballot there are two Democrats, David G. Lewis and Louis Dubuque both of Dumas. Enns is on the Republican ballot and will face the Democratic winner on the March 13 primary in

November. Enns is unopposed on the March 13 ballot.

Enns was notified by the Governor's office of the appointment. Enns said he was very pleased with the appointment. He said "I feel good about Dallam, Hartley and Sherman Counties but need to get better acquainted in Moore county and this appointment will give me a good chance to do that."

He said he is looking forward to the challenge of serving as judge.

He will take over as District Judge on April 1 and will hold the appointed office until December 31. He and the other two candidates for the office were interviewed about three weeks ago in Austin by an Attorney in the Governor's office. One other Dumas attorney applied for the appointment who is not a candidate for the office.

An ordinance prohibiting the keeping of livestock, swine, fowl, domestic and barnyard animals within the corporate limits of the City of Stratford; providing, however, for a permit to keep livestock if there is no adverse effect to the citizens of Stratford; providing for a Grandfather Clause; providing for a penalty, repealing Ordinance No. 150 and declaring the effective date.

WHEREAS, the City of Stratford has been advised of and received complaints concerning the keeping of livestock and other farm animals within the city limits; and

WHEREAS, the City of Stratford is vitally interested in providing all of its citizens with the freedom from odor, dust and noise sometimes occuring from keeping of livestock and other farm animals within the city limits; and

WHEREAS, it is in the public interest and welfare to prohibit or regulate the keeping of livestock and other farm animals within the City of Stratford;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF STRATFORD, TEXAS:

SECTION 1. Except as provided below, it shall be unlawful for any person, firm or corporation to keep or maintain any livestock, swine, fowl, or domestic or barnyard animal, except common pets, within the corporate limits of the city of Stratford, Texas.

SECTION 2. Any person, firm or corporation desiring to keep or maintain livestock, swine, fowl, or domestic or barnyard animals within the corporate limits of the City of Stratford may seek a permit from the City Council of the City of Stratford. Each permit sought must be coupled with the written consent of at least one adult resident of each residence within a 200 foot radius of the place where such livestock will be

SECTION 3. The City Council of the City of Stratford, upon application, coupled with the necessary signatures, may allow and issue a permit allowing the animals specified above to be kept within the Stratford city limits if it determines there will be no adverse effect to any citizen within the City.

SECTION 4. It shall be rebuttably presumed that there will be no adverse effect to any citizen within the City if the consent of at least one adult resident of each residence within the radius specified above is obtained and furnished with the application for the permit.

SECTION 5. ordinance shall not apply to any person, firm or corporation keeping or maintaining any livestock, fowl, or domestic or barnyard animal within the corporate limits of the City of Stratford, Texas, on the effective date of this ordinance. However, should any such person, firm or corporation cease from keeping or maintaining any livestock, swine, fowl, or domestic or barnyard animal after the effective date of this ordinance, such person, firm, or corporation shall then be required to furnish the necessary application and signatures described above before any livestock, swine, fowl, or domestic or barnyard animal may again. be kept or maintained on the premises

SECTION 6. Even after a permit has been validly issued, upon an objection to the keeping of any of the animals specified above within the city limits, the City Council may, upon a determination that any holder of a valid permit is adversely affecting the health or welfare of the citizens of the City, require rectification of the adverse effect within a time specified

by the Council or the permit shall be revoked.

SECTION 7. Any person who shall violate any of the provisions of this ordinance shall be fined not to exceed \$2,000.00 upon conviction thereof.

SECTION 8. Upon passage of this ordinance ORDINANCE number 150 is hereby repealed as of this ordinance's effective date.

SECTION 9. To provide ample time to the residents of the City of Stratford to receive notice of the implementation of this ordinance, this ordinance shall become effective on March 1, 1990.
