

One Mans Vision Became A Reality

Four years ago Judge Bill Sheehan attended a Judicial conference in Corpus Christi Texas & returned to his 69th district with a vision. He had learned of a program designed to help children through court procedureshumanely and expeditiously. The Judge was anxious to implement this type of plan within his district. His vision became reality as he worked with community leaders to create the first, and to date, the only rural CASA program of 366 nationwide organizations. CASA stands for Court Appointed Special Advocate and is a plan providing trained community volunters to serve as advocates for children whose home placement is being decided by a court. These young people have usually been removed from their natural homes and placed in. foster homes. The CASA volunteer fills a gap in our Judical system by giving support to a frightened child and providing additional information to the court.

The stress of day to day living is difficult for some parents to handle. All too trequency their frustrations are vented upon their children. Neglect and or abuse verbal, physical or

sexual-often result. Child abuse is a complex problem in our society today-in Rural america as well as in our cities. Judge Sheehan was familiar with the complexities of child abuse problems and was also concerned that courtroom decisions were being made with inadequate information and without total regard for the best interests of the child. CASA 69, Inc. was created from the Judge's concern for abused children and encompasses his Judicial District of Dallam, Hartley, Moore and Sherman Counties. It is a non-profit organization that operates on private contributions, funding from its four county commissioners courts and State and Federal grants. Since its inception in 1985, it has served 92 children. CASA is officed in the Dallam courthouse and has a part-time director, Stacey Urbanczyk, who helps recruit, train, and supervise the volunteers. There are 21 active volunteers at this time and 14 who recently completed training.

appointed to a court case by the presiding Judge. The role of these unpaid workers is many-sided: To assess progress through interviews with the child, natural parents, foster parents and all concerned parties; to keep abreast of developing problems: To attend court proceedings dealing with the case; to submit an assessment and recommendation to the court concerning permanent home placement for the child; to help the child through a frightening and confusing ordeal by explaining the court process to the youth and interpreting the young person's needs and interests to the court. Case workers, foster parents attorneys and judges may change over time, but the CASA volunteer remains a constant for the youth throughout the duration of his or her stay in the court





FmHA Housing Money Targeted To Counties That Need It Most

Temple, 2-7-1990, Rural Housing funds are being targeted to 100 counties in 38 states across the nation that need it the most, including Colorado, Frio, Maverick, Presidio, and Zavala, according to J. Lynn Futch, State Director for the Farmers Home Adminsitration (FMHA).

FmHA, rural credit service of the U.S. Department of Agriculture, regularly funnels millions of dollars annually in housing funds into the small towns and rural areas of Texas.

"Our efforts to provide safe, decent, and adequate housing for rural residents have been successful, and yet, some areas are still desperately in need of housing assistance," Futch said.

"We have identified counties that need additional FmHA housing assistance and we are starting a demonstration program to target an additional \$840,000 for multi-family housing and \$1,436,000 for single family housing to them," he said. The counties involved are still fully eligible for the regular single family and multi-family allocations of housing funds the state receives.

Counties were identified as eligible for the program on the basis of a high percentage of very-low income households and substandard housing. After analysis of the volume of FmHA loan and grant making in fiscal years 1986-1988, counties identified as both "needy" and "underserved" by FmHA housing programs were selected for the program. Applicants for assistance

Farmstead Windbreaks

By Mary Wilder, SCS

Planting trees and shrubs to form a windbreak around your home can add beauty and protection to your farmstead. As a bonus, a well-planned windbreak can lower your utility bills by as much as 30%.

When planning a farmstead windbreak, location is first consideration. Prevailing winds in Sherman County originate from the southwest. A windbreak planted on the south and west side of your farmstead would break most winter winds. In the summer, the shade provided by your fully grown windbreak can lower the temperature around the windbreak area by 25 degrees.

There are some things to keep in mind in planning a windbreak. First locate your trees no closer than 100 ft. from driveways and buildings. Also, avoid creating blind corners by planting 20 ft. or more from the main road. And third, avoid placing your trees under power or telephone lines.



Abandoned Wells

By Bill Mires

The Sherman County Soil and Water Conservation District and the North Plains Water Conservation District are working together in an effort to locate and cover any abandoned wells within the district.

Every owner or operator of any land within the North Plains Water District, upon which is located any open or uncovered well is, and shall be, required to close or cap the same permanently with a covering capable of sustaining weight of not less than 400 lbs. except when said well is in actual use by owner or operator; and no such owner or operator shall permit or allow any open or uncovered well to exist in violation of this requirement.

The above law was written and passed by the 57th Legislature of the State of Texas in 1961

Due to the CRP program. many wells will not be in use for the next 10 years and have had the pumps pulled and are setting open.

These abandoned wells could present a potentially dangerous situation to small children, also small animals may find there way into these holes. This could have effect on the water quality in that area.

If you have or know of this situation you should take care of it as soon as possible.


