lower tax rates in the Panhandle. The State Legislature is currently looking at a state tax rate average between .85 and .95 cents per \$100 value. Stratford has a tax rate of .73 cents which is well below the state average. In many of the bills introduced the local school districts tax rate must be at or near the state average or they will lose some of the state funds allocated.

Governor Clements has stated that he is against raising any taxes at the state level. If taxes are not raised at the state level, then those school districts that are considered wealthier than others will receive less state money. This state money will be allocated to poorer school districts. In other words, if taxes are not increased at the state level, they will be increased on the local level. This is what happened in the last Legislative Session last year. Stratford I.S.D. received less money from the state

and had to raise local taxes. It looks like any bill that may be passed in the Special Legislative Session on education will cost the taxpayers in Stratford I.S.D. several cents in our local tax rate. For instance if the state money is reduced to Stratford I.S.D. by

Cyndy James, a volunteer on our local ambulance service, has recently received certification as an EMT-Intermediate from the Texas Department of Health. This comes as Cyndy completed a 4-month course which upgrades her basic EMT skills to include advanced airway & IV therapy. Cyndy was one of 20 students in the special skills class that was sponsored by Memorial Hospital In Dumas under the auspices of Frank Phillips College. The course consisted of 136 hours of didactic, 112 hours of clinical time in areas such as respiratory, therapy, ICU, emergency room, obstetrics and the operating room and an additional 56 hours on an advanced life support ambulance. Students were required to take a written exam and show competency in both basic and advanced skills at the intermediate level.


Paul O. Dixon







### Wheeler Wins Certificate



When the flag dropped at the Feb. 24, 1990 matinee performance of the 1990 Houston Livestock Show and Rodeo, the scramble was on, as 28 4-H students and 14 unruly calves covered the 2,75 acre Astrodome arena with excitement.

Colby Wheeler from Stratford, Texas won an \$800 calf certificate by catching, haltering and maneuvering one of the elusive calves into the winner's circle. The certificate, sponsored by Price Washer, will enable the youngster to purchase a registered beef or dairy

During the next year, Colby will raise the calf under the supervision of his county extension agent or agriculture science teacher. He will send monthly progress reports to the calf certificate sponsor and to the Show. Also required are accurate monetary records, a journal including photographs and a 500 word essay covering the year's experi-

The culmination of the year-long project will be when Colby returns to Houston to show the heifer at a special competition during the 1991 Houston

Livestock Show and Rodeo.

"Those students fortunate enough to receive one of these certificates should seize the opportunity and make the most of it," said John Smallwood, chairman of the all-volunteer Calf Scramble Committee. "Maxmum effort is required--effort that just starts in the Rodeo arena," he added.

The calf scramble program awards 302 calf certificates each year. Since the first scramble was held in 1942 more than 11,000 calves have been purchased at a price of more than \$2 million.

The Houston Livestock Show and Rodeo, which runs through March 4, is the largest of its kind in the world. The Show includes a rodeo, top notch entertainment, the world's largest livestock show and a world famous horse show.






