## Loses Thumb To Mower

Leslie Todd Richburg, small son of Mr. and Mrs. Gene Richburg, was rushed to Plainview Hospital and Clinic Tuesday, May 2, for surgery on his hand after getting it caught in the belt of a mower his father was working on. Todd's fingers were shattered in the mishap, and he lost the end of his thumb at the first joint. The accident occurred around 6:30 at the Richburg home.

## McLain Is Winner

E. I. McLain, incumbent commissioner, Precinct 1, won the run-off race for the post.

McLain received 261 votes in Saturday's balloting, while his opponent, John Rice, pulled in only 161 votes.

In other voting, Castro County Democrats turned out 468 strong to vote for incumbent Joe Pool for U. S. Representative At-Large. Pool won 316 Castro County votes to Robert Baker's 152.

## Hart High School Principal Resigns

Mr. and Mrs. Malcolm Atwood have accepted teaching positions in the Tulia Public Schools.

Atwood will be teaching distributive education, while his wife will be teaching in the second grade.

Atwood, Hart High School principal, has been teaching for 11 years, 4 of which have been in Hart schools. He graduated from Texas Tech with a Bachelor of Business Administration degree in 1951 and a Master of Arts degree in education in 1960.

Atwood had college majors in business education and administrative education. His college minors were commercial teaching, physical education and mathematics.

Mrs. Atwood, a first-grade teacher in the Hart schools, has been teaching for 10 years now. Before coming to Hart, she—as did her husband—taught in schools at Tahoka, Henrietta, Idalou and Rio Vista.

She graduated from Mary Hardin-Baylor College in Belton. Her college majors were elementary education, English

and business; she minored in science. Also, she has now completed much of the required work for a masters degree from West Texas State University.

The Atwoods have three children—two sons and a daughter. Martin is the oldest child at 11, Richard, 10, falls in the middle and Jana, 5, is the youngest.

## Fire Destroys Farm Garage

The combined garage and hired-hands living quarters on the Howie H. Parker farm caught fire and burned about noon Monday.

Firemen arrived shortly after the blaze was reported.

In addition to the damage to the building, the fire completely destroyed a new freezer full of deer meat, a divan, some clothing and a new riding lawn mower.

## First Wheat In At Hart

The first load of wheat from the Hart area was received Monday at Hart Grain.

The first load—14,280 lbs. of grain—was brought in and harvested by Harry Young off of Mrs. I. C. Sharp's farm, 12

miles northeast of Hart.

The wheat tested at 60 lb to the bushel, with a moisture content of 9.20 per cent.

Payment for the load was \$1.50 per bushel—and a \$100 bonus for the first load.

**STATE CONVENTION**--State Democratic party leaders here have completed advance preparations for a June 16 Texas party convention which could turn into a donnybrook or go off smooth as silk.

Action will take place at Houston's big coliseum and the swank Shamrock Hilton Hotel, convention headquarters.

Delegates and alternate delegates who will cast the 2,834 authorized votes (some counties are sending up to 15 times their authorized strength) will be quartered in 27 hotels scattered all over Houston.

Big job is selecting delegates to the August national presidential nominating convention in

Atlantic City and picking Texas national Democratic committee representatives.

Big argument is whether the convention will go on record as favoring the as-yet-unwritten national Democratic platform.

Gov. John Connally, who claims a two-thirds to three-fourths margin of control, prefers that delegates remain silent on the liberal national program. He wants to write his own state party platform at the September State convention along moderate-to-conservative lines.

Sen. Ralph Yarborough and State AFL-CIO President Hank Brown argue the convention not only should pledge its support to President Johnson (there is no argument about that) but to his liberal program as well.

Some 26 per cent of the convention's seats are in contest. Austin Attorney Will D. Davis, chairman of a State Dem-

ocratic Executive Committee sub-panel on credentials, has instructed heads of 14 rival delegations from seven counties to sent him advance written briefing on their positions.

**HIGHWAY IMPROVEMENT PLAN**--State Highway Commission authorized a \$166,000,000 improvement program to get more safety and less congestion on 2,067 miles of primary and state highways.

Of the amount authorized, \$151,000,000 is earmarked for construction, and \$15,000,000 for right-of-way. About 65 per cent of the cost is expected to come from state gasoline tax revenue and license fees and the rest from federal grants in aid.

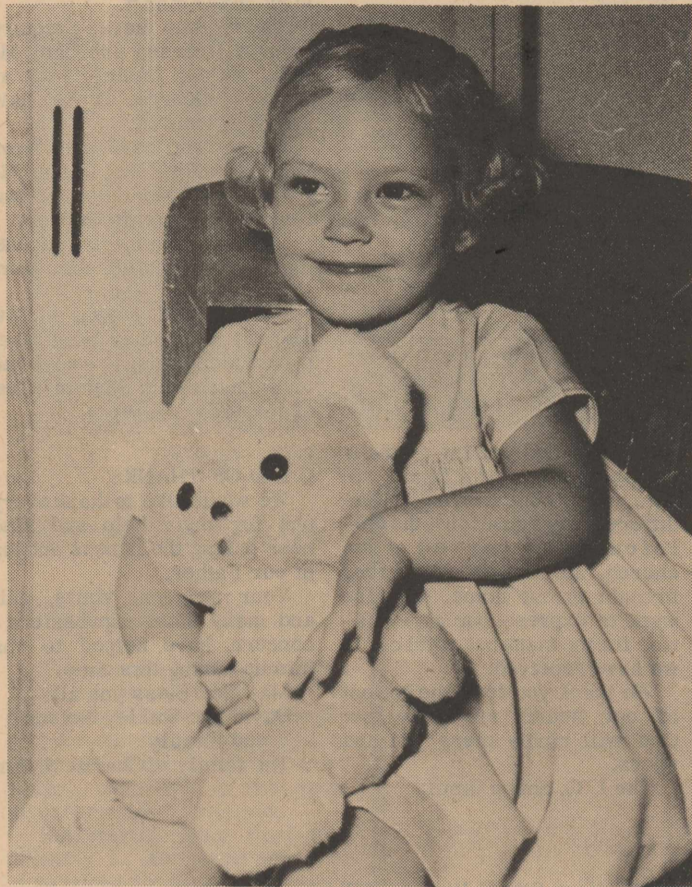

**LEGAL NOTICE**

**ORDINANCE NO. 22**

AN ORDINANCE REGULATING THE TAPPING OF SEWER LINES; PROVIDING FOR PERMITS TO TAP SEWER LINES; AND PROVIDING FOR FEE FOR SUCH PERMITS AND FIXING THE PENALTY FOR THE VIOLATION OF THE PROVISIONS OF THIS ORDINANCE

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF HART, TEXAS:

SECTION I. It shall be unlawful for any person to tap any sewer line of the City of Hart, Texas, except as herein provided.

SECTION II. Before any person, firm or corporation shall be permitted to tap any of the sewer lines of the City of Hart, Texas, said person, firm or corporation shall make application to the City Secretary of the City of Hart, Texas, for a permit to tap said sewer line, stating the purpose for which such tap is to be made and the location of such proposed tap.

SECTION III. The City of Hart, Texas, shall make a charge of \$5.00 for issuing each permit.

SECTION IV. Permits to tap the sewer lines of the City of Hart shall be granted only to persons, firms or corporations approved by the City of Hart and no sewer line shall be tapped by any person, firm or corporation not so approved.

SECTION V. Any person, firm or corporation who violates, refuses or fails to comply with any of the provisions of the Ordinance, shall be guilty of a misdemeanor and upon conviction shall be punished by a fine in any sum not exceeding \$100.00.

SECTION VI. The fact that there is no adequate ordinance regulating the tapping of sewer facilities in the City of Hart, Texas, and because the City Commission considers the passage of this Ordinance necessary to protect the health, welfare and safety of the City of Hart, Texas, and its inhabitants, properly provide for the orderly installation of sewer taps within the City of Hart, Texas, it is hereby declared to be an emergency measure demanding that the rule requiring that ordinances be read at three several meetings be suspended and such rule is hereby suspended and this ordinance shall become effective upon its passage, approval and publication.

Passed and approved, this the 27th day of May, A.D., 1964.

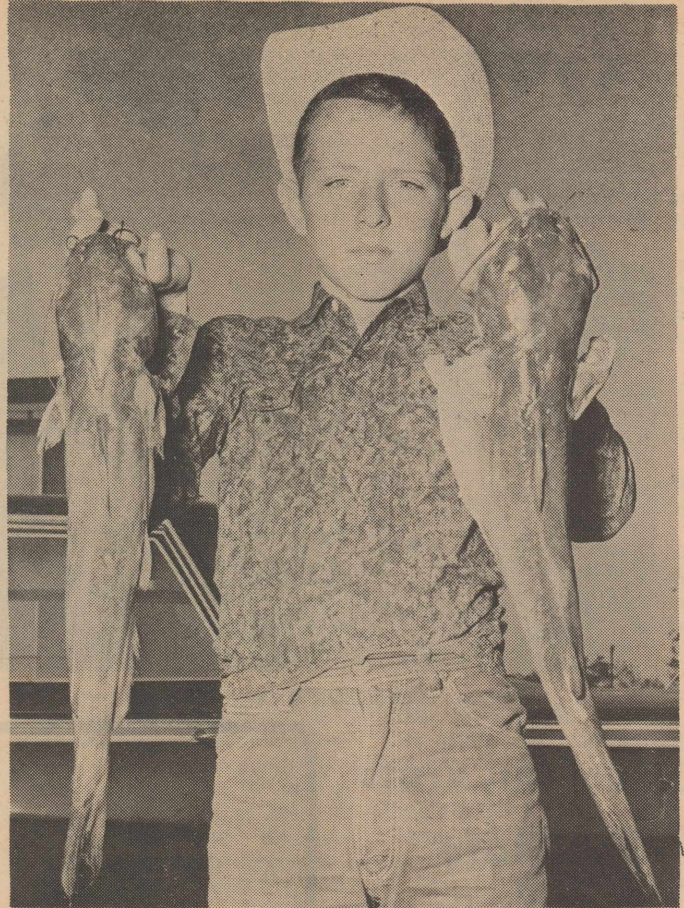
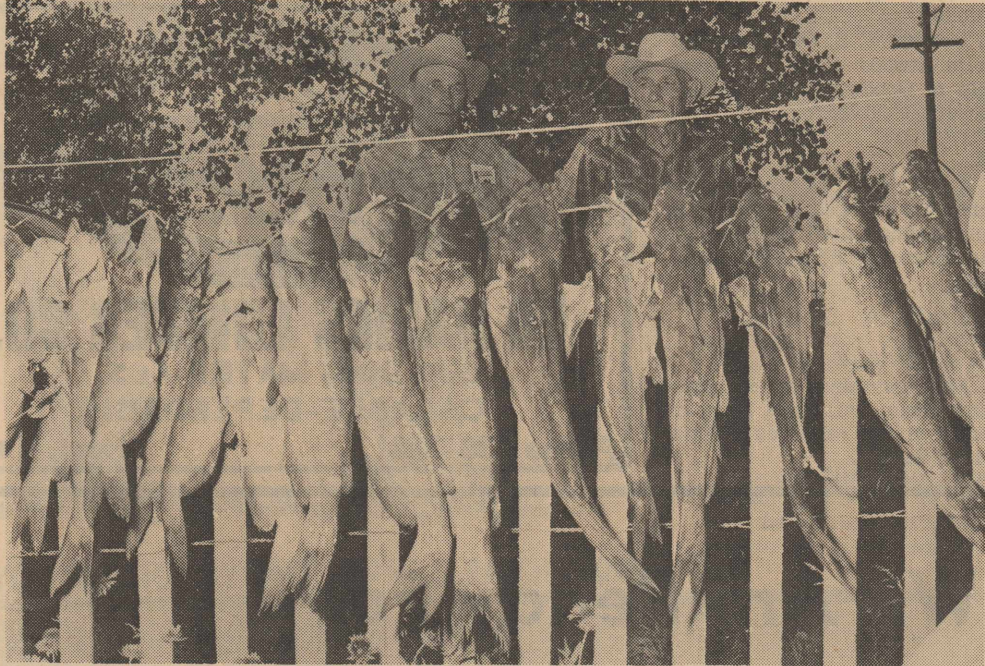

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF HART, TEXAS:

SECTION I: It shall be unlawful for any person, firm or corporation to install, maintain, own or operate additional storage and handling facilities for anhydrous ammonia within the corporate limits of the City of Hart, Texas.

SECTION II: No building permit shall be issued for the erection, construction or equipping of such a storage or handling facility for anhydrous ammonia by the City of Hart, Texas.

SECTION III: The invalidity of any section, sub-section, paragraph, sentence, clause, phrase, word or words of this ordinance shall not invalidate any other part of this ordinance. It is the intent of the City Commission in enacting this ordinance that the provisions hereof are separable and no provision hereof shall become inoperative or fail by reason of the invalidity of any other provision.

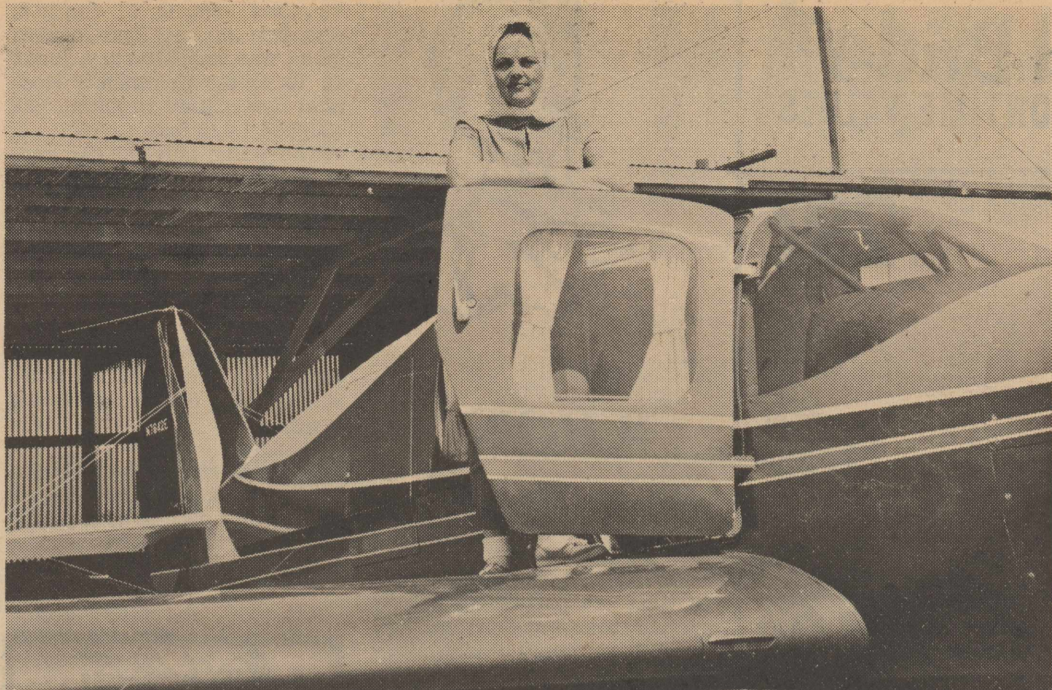
SECTION IV: Any person, firm or corporation violating any of the terms or provisions of this ordinance shall be guilty of a misdemeanor and upon conviction thereof shall be fined in a sum not exceeding \$100.00. Each day that any person, firm or corporation shall continue to violate, or fail to comply with, a provision of this ordinance shall be a separate offense.

SECTION V: That by reason of the fact that the City Commission considered the passage of this ordinance necessary to protect the health, welfare and safety of the residents of the City of Hart, Texas, it is hereby declared to be an emergency measure, demanding that the rule requiring ordinances to be read at more than one meeting of the City Commission be suspended, and that this ordinance take effect immediately from and after its passage, and it is so ordained.

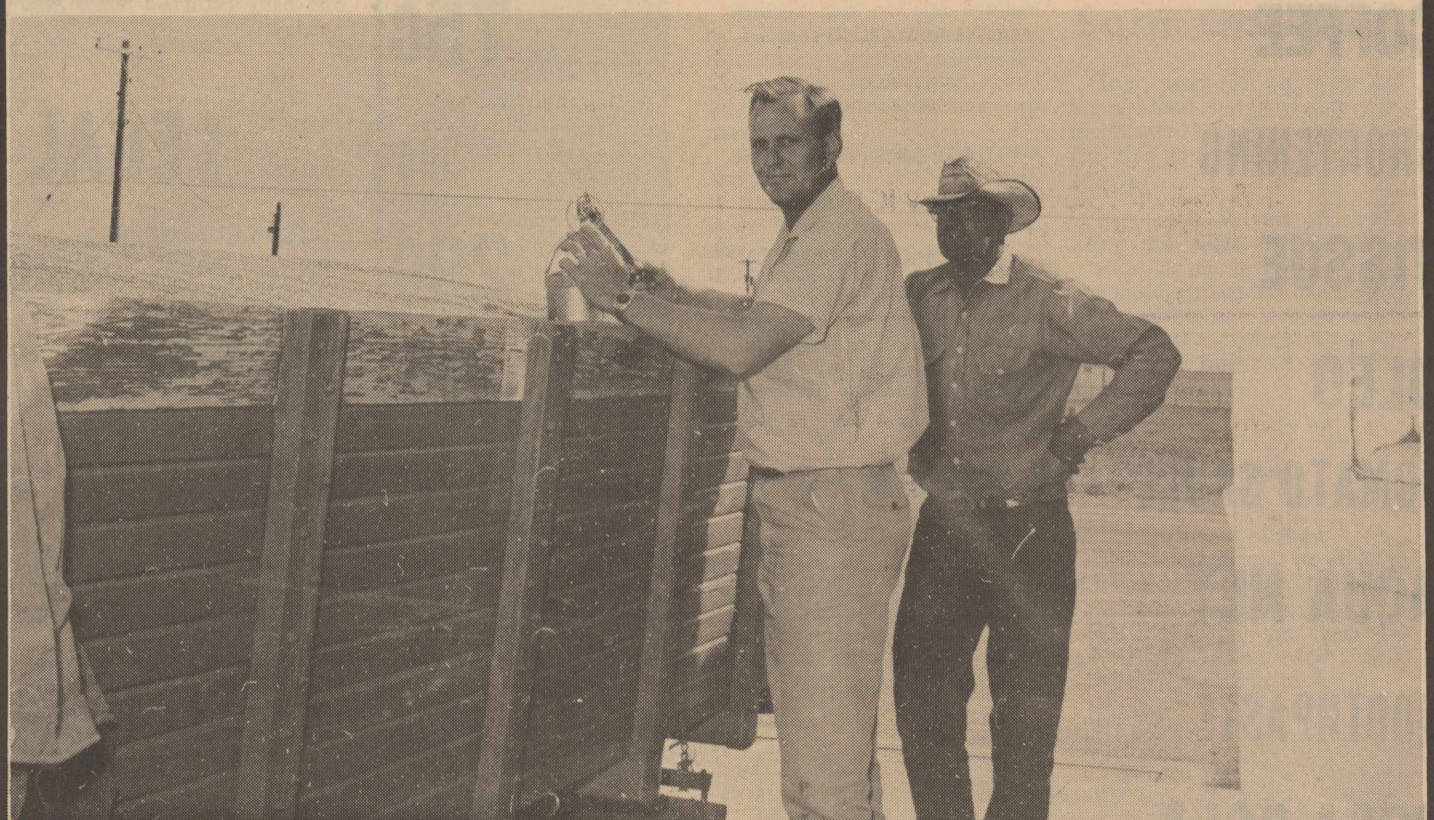

## LEGAL NOTICE

### ORDINANCE NO. 21

AN ORDINANCE REGULATING STORAGE, DISPOSAL AND REMOVAL OF GARBAGE AND TRASH, PRESCRIBING CHARGES TO BE COLLECTED FOR REMOVAL, AND PROVIDING A PENALTY FOR VIOLATION.

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF HART, TEXAS:

**SECTION I:** It shall be unlawful for any person, firm or corporation to sweep, throw or deposit any garbage, trash, dirt, concrete, rocks, stagnant water or dead animals into, upon or along any drain, gutter, alley, sidewalk, street or vacant lot or upon any public or private premises within the corporate limits of the City of Hart, Texas, or to permit such garbage or trash to remain within the corporate limits of the City of Hart, Texas.

**SECTION II.** It shall be the duty of every person, firm or corporation owning, managing or operating, leasing or renting any premises or any other place where trash and/or garbage accumulates to provide a suitable garbage can which shall be placed at a point accessible to garbage and trash collection vehicles.

**SECTION III.** The City of Hart, Texas, shall collect, or cause to be collected the trash and/or garbage within the corporate limits of the City of Hart at regular intervals, and the monthly charge for such service shall be the sum of \$2.00, to be collected in like manner as the water and sewer charges.

**SECTION IV.** Waste from building operations, or resulting from salvage or general cleanup of property will not be removed by the City, but shall be removed by the building contractor or owner at his own expense.

**SECTION V.** Any person, firm or corporation who violates, refuses or fails to comply with any of the provisions of the Ordinance, shall be guilty of a misdemeanor and upon conviction shall be punished by a fine in any sum not exceeding \$100.00.

**SECTION VI.** The invalidity of any section, sub-section, paragraph, sentence, clause, phrase, word or words of this ordinance shall not invalidate any other part of this ordinance. It is the intent of the City Commission in enacting this ordinance that the provisions hereof are separable and no provision hereof shall become inoperative or fail by reason of the invalidity of any other provision.
