## New Church Dedication Here Sunday

Dedication for the New St. John's Catholic Church here is set Sunday at 11 a. m.

The church is located at Seventh Street and Ave. D.

Open house will be held at the church all day Sunday with the public invited to both the dedication service and the open house.

Bishop Lawrence De Falco of the Amarillo Diocese will dedicate the new church.

Pastor of the local church, a mission of the Immaculate Conception Church in Dimmitt, is Reverend Raphael Chen. The Rev. Chen has been pastor of the churches for the past five years.

An example of modern liturgical architecture and economical construction, the new church has a seating capacity of 250 and room for future expansion.

There are two large class rooms and a nursery that are not included in the church proper.

Building of the mission church was made possible from the funds of local parishioners and a grant of \$10,000 from the Extension Society of the Catholic Church of Chicago, Ill.

An enchilada or roast beef dinner, prepared and sponsored by the ladies of the church, will be served to the public Sunday at the Hart School cafeteria. Serving will start at 12 noon, following the church dedication.

Proceeds from the dinner will be used for new pews for the church.

Adult tickets sell for \$1.25 and children under 12, for 75 cents.

Tickets may be obtained from C. O. Burt or may be purchased at the dinner.

## Requirements On Wheat Told

Wheat growers who participate in the 1967 wheat program will be eligible for domestic marketing certificates for about the same amount of wheat as in 1966 but the percentage of allotted acres is less because of the increased allotment according to Charley E. Hill, secretary of the Castro County Agricultural Stabilization and Conservation Committee.

The percentage is 35 compared with 45 in 1966.

The expected domestic food use for 1967 is 520 million bushels. Hill explained that the law requires domestic certificates to be issued for no more than the expected domestic food use. The 520 million bushels is 35 percent of the projected production of the 68.2 million acre national allotment.

In the 1966 program, the 45 percent of the farm projected yield for which program co-operators earned certificates was estimated to equal 500 million bushels. Thus co-operators in the 1967 program will be eligible on 20 million more bushels.

Domestic certificates, which are issued to help maintain farm income, will be valued in the 1967 program at the difference between the national average loan rate of \$1.25 and parity next July 1. The certificates are valued at \$1.32 in the 1966 program.

"The Federal Supporting Program." will be the topic of the program.

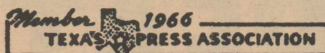

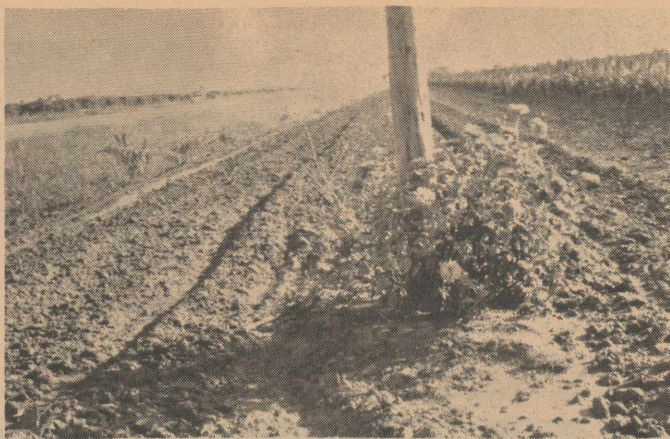

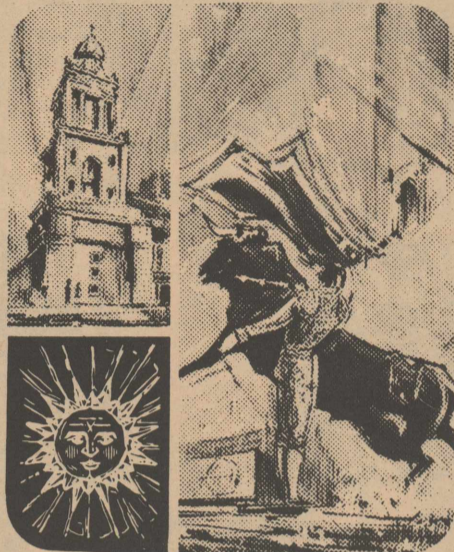

# KITCHEN KORNER

Of all things to do, I locked myself out of the office on Tuesday afternoon for over two and a half hours. So if you tried to call me I sincerely apologize for not being there.

Thanks, all of you who thought of me and visited me in the hospital and thanks to Hattie Mae, Jean and all the sweet nurses at the hospital for the care, kindness and patience. They made my stay there so much more pleasant.

Since the weather is so much for baking and nominding having the oven going especially on these cool mornings, try these for a taste treat.

## COCONUT CHOCOLATE BARS

Makes about 12 bars  
Preheat oven to 350 degrees  
Sift together and set aside:

- 1 1/4 c. sifted regular flour
- 1 t. baking soda
- 1 t. sugar

Work with a spoon until soft:  
1/2 c. butter or margarine

Add and beat until light:  
1 egg yolk  
Add dry ingredients alternately with:

- 2 T. water

Spoon into greased 9 inch square baking pan. Press dough gently in bottom of pan. Bake at 350 degrees for 10 minutes. Remove from oven. Sprinkle evenly with:

- 1 package (6 oz.) semi-sweet chocolate pieces

Return to oven and bake 1-2 minutes, or until pieces are softened. Remove from oven. Spread pieces evenly.

Combine in a bowl and mix thoroughly:

- 2 eggs, beaten
- 3/4 c. sugar
- 6 T. melted butter or margarine
- 2 c. flaked coconut
- 1 t. vanilla.

Spread coconut mixture over chocolate. Bake at 350 degrees for 30 minutes, until done. Cut into bars.

## CHERRY-PINEAPPLE DELIGHT

Makes 12 squares  
Preheat oven to 350 degrees  
Drain, reserving syrups:

- 1 can (1 lb.) tart red pitted cherries, in extra heavy syrup
- 1 can (1 lb. 4 1/2 oz.) crushed pineapple

Place syrups in a saucepan. Add:

- 1 1/2 c. sugar
- 1/3 c. quick cooking tapioca
- 1 t. vanilla
- 1 t. red food coloring

Mix well. Cook over low heat, stirring constantly, until thickened. Remove from heat. Add fruits. Set aside to cool.

Combine in a bowl:

- 2 c. sifted regular flour
- 1 c. firmly packed brown sugar
- 1 c. uncooked rolled oats
- 1 c. crushed corn flakes
- 1 t. baking soda
- 1/4 t. salt

Mix well. Add: 1 c. melted butter or margarine.

Mix well. Press half of the crumb mixture onto bottom of an ungreased 11x7x1 1/2 inch pan. Spread with fruit filling. Top with remaining crumbs. Bake at 350 degrees for 30-35 minutes, or until done. Serve warm or cold.

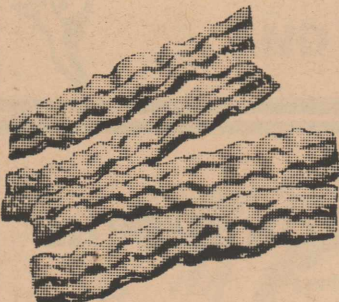

# HORNS LOCK

Relying on a fine defensive effort, the Hart Longhorns battled the Turkey Turks to an 8 - 8 deadlock there last Friday night, to bring their season record to 1-1-1.

The Longhorns, taking advantage of a blocked punt, drew first blood but the Turks, behind a fine running game, tied the score late in the first half.

Turkey, taking the opening kickoff at their own 30, immediately got a drive started.

Fullback Claud Robison carried the first three downs for Turkey, picking up 15 yards to the Turkey 45. A five-yard off sides penalty set the Turks back to their own 40 for a first and 15. Two tries by the turks set the ball on the 47 but on third, Robison fumbled and the Longhorns recovered on the Turkey 45.

The Longhorns, their offense sputtering as it did all night, could not move and three tries later had lost four yards and were back to the Turkey 49.

George Ed Bennett booted the ball down to the 10 where David Majors was waiting. Trying to pick up his blockers, Majors dropped back to his own two where he was slammed to the turf by end Larry Parker.

The Turks, gaining only six yards in three tries, were forced to go into punt formation on fourth at their own eight. Alton Setliff's punt from his own end zone was blocked by Larry Parker and recovered by the Longhorns at the Turkey 5.

Fullback Tommy Gonzales moved the ball one yard to the four on first. On second down, Gonzales again got the ball and scooted four yards to bring the score to 6-0.

The extra point attempt, a pass from Gary Rambo to Larry Parker, was good and the Horns led 8 to 0.

After the kick off, the Turks were unable to move the ball and punted out to the Hart 33.

The Horns, helped by a 15 yard penalty, moved the ball out to their own 49 before being forced to punt. George

Ed Bennett's punt rolled out of bounds at the Turk's 7.

Again the Longhorn defense went to work and forced the Turks to punt from their 8. Alton Setliff's punt rolled dead on the Hart 45.

On first down a Gary Rambo pass was picked off by Alton Setliff at the Turkey 45.

The Turks were unable to gain against the Longhorns and, on fourth, Alton Setliff booted the ball to the Hart 20.

Gary Rambo brought the ball back 14 yards to set the Longhorns on their 34.

Three tries by the offense failed to gain the yardage for a first and the Horns were forced to punt again. Bennett's boot carried to the Turk's 20, where it was gathered in by Alton Setliff and returned to the Turkey 31.

Two tries by Claud Robison moved the ball out to the 40 but an off-sides penalty against the Turks moved the ball back to the 35.

John King then punched the ball out to the 45 for another first down.

On first John King was held to a one-yard gain but Claud Robison moved to the Hart 45 for another first down.

A 15 yard penalty against the Horns moved the ball to the 30.

In three tries Harvey Case moved to the 19 for another Turkey first down.

Claud Robison carried to the 14 but John King was thrown back to the 15 on second.

On third, King carried to the nine but a 15 yard penalty set the Turks back to the 24.

With third down, and 15 the Turks went to the air but W. A. Hawkins intercepted on the five and made nine yards to the 14.

Only two plays later, the Turks again had the ball, recovering a Longhorn fumble at the 14.

Claud Robison moved the ball to the seven on first and John King picked up the final seven yards to make the score 8-6. The extra point try by
