## ORIENT NEWS

Messrs. R. D. Corne and J. W. Davis returned from their trip to Sweetwater Tuesday, and reports the railroad situation as being very encouraging. They found that seventy-nine men are employed in the steel laying; that one week ago 12 miles of track had been put down, the bad weather having greatly retarded the work. That when they were there a bridge was being constructed across one of the small streams on the line, and more steel was expected every day. They were informed by Mr. McCandley that Mr. Stillwell had officially announced that the track would be in readiness to run trains over it from Sweetwater to Kansas City by the end of this year, and that he felt sure that the statement would be verified. Mr. McCandley, also, told them that the work would be pushed right along and steps will be made at any of the towns between here and Sweetwater, as some people seem to fear, until Knox City is reached. Knox City will be a terminus until the bridge across the Brazos can be constructed, and possibly until the cut beyond Benjamin is finished, which will probably require thirty or forty days. As the company has given out the positive statement that the road is to be finished between Sweetwater and Kansas City this year, it is very probable that trains will be running to Knox City by early summer, and that Knox county farmers can depend on the Orient to haul their wheat, oats, and cotton to market this year.

Upon the above the Editor comments thus: From all reports and indications the building of the Orient is a certainty several miles of track north of Sweetwater are completed, with plenty of material on the ground to build to Knox City a distance of 90 miles. Something like 100 men are at work and it is reported that the track-laying crew will reach McCandley some time next week. Knox Co. News.

The Quannah Tribune Chief of Mch. 26 comes out in flaming headlines announcing the certainty of the building of a \$40,000 Irrigation Dam across Wanderers creek, about 5 miles S. E. from Quannah. The dam will be three-fourths of a mile in length and the water above it will cover more than 1,000 acres, and will receive the water drained from over 50 sections of land. The promoters of this enterprise are Cecil A. Lyon, J. S. Rice and W. M. Rice. We congratulate you, Bro. Koch, your county is exceedingly fortunate in securing such an enterprise, for with the building of dams to store and utilize the storm water, Hardeman county will receive a new impetus, and the advancement not only in agricultural pursuits, but in other lines also, will be phenomenal. It will give her an increased citizenship with an assurance of profitable employment, and a competent living.

What can be said of Hardeman in this respect may also be said of Foard. It has rich valleys on Wichita and Pease rivers, and Beaver, Mule and Goot Creeks that by proper systems of irrigation will give employment and support to 100 times the present population. Let us agitate.

The Legislature of Colorado, knowing that Alva Adams was the lawfully elected Governor of that state, but not being quite willing to put themselves on record as the perpetrators of a crime they have since committed they were willing to declare the election a nullity and give the office to the Lieutenant Gov., but the Supreme Court decided that they could only pass upon the contest between Adams and Peabody, whereupon the committee of 27 members, 18 republicans and 9 Democrats, proceeded to the investigation, and by rejecting the vote of 104 election precincts in Denver and 29 precincts in other counties, found a majority of 2870 votes for Peabody.

On joint ballot it was found that it would be impossible for Peabody to secure enough votes to seat him, there being 32 republicans opposed to him, believing that Adams was lawfully elected Governor, but willing to let him down gently, they agreed that if he would resign and leave the governorship in the hands of J. F. McDonald, Lieutenant Governor, who is also a republican, they would seat him. Peabody not only consented, but wrote out his resignation and placed it in the hands of his friend, W. S. Boynton, where it remained until Gov. Peabody had served one day when it was filed with the Secretary of State. Thus the law making power of that State has attributed itself to the man who was the choice of the people by a plurality of 9925 votes has been unseated without a proper investigation of fraudulent ballots cast in any other locality than in and around Denver. This taken altogether is a shameful proceeding, and will be alike humiliating to both republicans and democrats who favor fair play and an honest deal.

The latest dispatches from the seat of war indicates no new activity. The Russian army is slowly retreating and the Japs are following at a convenient distance, showing no disposition to press the attack for the present. Both armies seems to have reached the limit of human endurance during the two weeks of constant fighting in front of Mukden. And until they recuperate and close up their broken ranks, no general engagement is expected. In the meantime, not only the contestants in the terrible war, but the eyes of the world are anxiously watching for something that looks like an amicable settlement and ending of the conflict. And it is given out, even by Russian newspapers at St. Petersburg, that there is some possibility of peace, and it would be well for their diplomats to look ahead for that event.

### Then and Now.

In times by gone there was a pious old gentleman living at the cross-roads in nearly every community who claimed that God had sent him to preach to the people, and that he had put the words he wanted said in his mouth, and any elucation or preparation was unnecessary. The Hon. J. G. Witherspoon on last Monday introduced a bill in the Legislature to change the name of Foard County to "Ford."

The News regrets that Mr. Witherspoon has sought to make this change. We can see no good that would result from it. It was organized with the name as it is. Its land titles have gone on the records for the last 14 years, and in the courts and in all other business transactions, it has gone down as "Foard." The fact is, Foard is right. The county was named for Judge John S. Foard, a very distinguished jurist, who lived at Columbus, Texas. It has been claimed by some people, and there is perhaps where Mr. Witherspoon's mistake lies, that the intention of the Legislature was to name the County for Col. Rip Ford, a celebrated Indian fighter, but we feel sure that such was not the case. This question was agitated in a small way in the 28th Legislature, but when the facts were known, there was no more contention for the change.

We think the people of Foard County are satisfied with the name, at least we have heard no complaints. And if Mr. Witherspoon has ever consulted any considerable number of Foard County people in regard to the matter, or even any one person, we have not heard of it. It is true Foard County is in Mr. Witherspoon's district, but he is not a citizen of Foard County, and we think that it is a matter of justice to the people of this county that they should be consulted about a matter that concerns them only, and that too when the other counties would take no benefit by the change.
