WPA CANDIDATES RALLY SCHEDULED HERE FRIDAY NIGHT

High School Auditorium Is Chosen; Public Urged To Attend

County and district candidates will be here Friday evening of this week for their first scheduled speaking rally for this place, according to the program as worked out several weeks ago when they all met at Tahoka.

Since the last rally there have been a few changes in the official outlook for the county, and all voters are urged to be at the high school auditorium at 8:30 tomorrow evening to hear all the discussion and make their plans about voting.

We are told that E. B. Speck, candidate for Congress on the Townsend ticket, will either be here in person or will have a representative, and that Congressman Mahon will also have a speaker for the occasion. We regret that we have no further information along these lines. We also understand that two or three, or more of the candidates for representative will either be here or will have mess to present their plans.

While scores of our folks have already heard most of the candidates make their talks, there are still many who have not done so, and this is an opportunity which should not be passed up. Be at the school building Friday evening and cheer your candidate; he may need your moral support when he gets up to make a speech.

Work Is Begun On New Home School Building

Construction was started last week on a combination auditorium and gymnasium for the New Home school on the north part of the county, according to P. W. Goad, who was here Saturday in the interests of his campaign for reelection to the office of county judge. This contract was let several weeks ago to Moss Construction Co. of Lubbock. Mr. Goad reports that the work is being retarded to a great measure by lack of skilled labor.

This project will cost approximately \$15,000. We were told of this sum, around \$9,000 comes from a PWA grant or loan, and the New Home district recently voted bonds in the amount of \$7,000 to complete the financing of the job. When this work is completed, New Home will have one of the best school buildings in the county.

First Baptist Church Announces August Revival

O. H. Mansell authorizes us to announce that the annual summer revival will open at the First Baptist church on Sunday, August 2, with Rev. Homer T. Crimm in charge of the preaching. Music will be directed by local people.

All services during the two weeks, and there will be morning and evening services daily, will be held under the tabernacle for the sake of comfort of the congregation. There will be plenty of comfortable seats, adequate arrangements are being made for the best music, and everyone is cordially invited to come and take part. All the singers from the other churches and from our neighboring communities have a special invitation to come to the choir and assist with the music.

The evangelist is well known to O'Donnell people, having addressed special congregations on several previous occasions. He is, by the way, a cousin of the nationally-known evangelist B. B. Crippin and is considered by many people to be almost as great in this field of work as is his famous cousin.

Lynn County Without A County Judge

With the resignation of Judge W. E. Smith to accept the office of postmaster at Tahoka at the death of Coleman Wells last week, Lynn county was without a judge for the first time since its organization in 1903.

Mr. Wells died suddenly at his home on June 24, and Congressman George Mahon submitted Judge Smith's name to the postoffice department, or to the proper authorities, by wire, immediately after receiving the news. Notification of his appointment was published by the Associated Press wires Thursday last week, though Judge Smith had been notified personally some time to take office Tuesday.

He tendered his resignation to the county commissioners' court immediately after receiving his appointment, and the court accepted the resignation, but adjourned without appointing anyone to finish out his term of office as judge. Waldo McLaughlin, local commissioner, said this week that it has been tentatively decided that an appointment will not be made until after the Democratic primary on July 25.

Judge Smith's name will appear on the ballots, which had already been printed, but he will not be a candidate in fact. This leaves the field clear for P. W. Goad of New Home, who has already made the acquaintance of scores of O'Donnell people.

While Judge Smith had more friends here than most anyone, and while it is undoubted that he will make a most efficient and agreeable postmaster, we have heard considerable discussion over this appointment, many Lynn county folks being of the opinion that it would have been the courteous and fitting thing for Mrs. Wells to be appointed to finish out her husband's term. We do not know whether this is customary in civil service, but it would have been nice, an act which would have made many friends for those in authority.

J. M. Noble, Jr., Receives Appointment As Postmaster

Official notification was received last Friday from the post office department that J. M. Noble, Jr. has been appointed postmaster for this place, succeeding Hal Singleton for a number of years. At present he is manager of the Lynn County Motor Company, Ford dealers, having held this position some six or seven years. Previous to that he was connected with the old bank here and was also bookkeeper for the Ford shop. He is a World War veteran, and has been active in affairs of the Legion post here.

Mr. Singleton's retirement, the date for which has not yet been named, will mark the end of more than thirty years of government service. He began civil service work as a young man at Gilmer, going from there to Jefferson. He received his first appointment from President McKinley in the year 1900 and has served under every administration since that time. He has served the residents of this section since 1920 and has spared no effort nor thought to best meet the needs of the territory.

While he has not announced his plans for the future, he and Mrs. Singleton have a lovely, comfortable home just at the edge of town where they have been adding fruit trees, grape vines and chicken houses for the past several years, so it is supposed that they will live quietly there with their hobbies and enjoy their children and grand children as they grow up around them.

\$7,000 Available Soon For Waterworks Project; To Use Thirty Men

Mayor B. M. Haynes received official notification Friday that O'Donnell's application for a WPA grant for the purpose of building added water facilities had been approved in the Big Spring office, and is now in the state office at San Antonio, with every indication that favorable reports will be received from there within the next week.

The notice stated that this application has gone on marked as "Emergency Measure" and that more than likely it will not be necessary for it to go into the Washington office. In this case we may expect to have definite news within the next few days. If it is necessary for the application to go into Washington, it will be somewhat longer, but there seems to be no reasonable doubt but that these funds will be available to the city by the first of August at the latest.

The application was for approximately \$7,000, being a little less than that round figure. This money is to be used, states the application, for the purpose of drilling two new wells on the C. H. Doak farm west of town, installing three pumps, one for the test well which was drilled several months ago, and the other two for the two new wells, to construct canals by which this water may be brought into town, and finally to lower some of the present water mains below brook level and construct a concrete cover for the big storage reservoir.

Just how long all this will take no one knows as yet. However, the application calls for the employment of thirty men from the relief rolls, fifteen working in each of two crews. We understand that the present wage schedule places a minimum of 30c per hour for labor of this kind, and that all the digging, etc. is to be done by hand and shovels. In other words, we are to have some hand work on our water system. An 8-hour day, 5-day week is also specified, we are informed.

This is some of the most welcome news which has been received in O'Donnell in many months. Recently, it was necessary for the city council to order all the water for any purpose, be stopped, and the city water was to be cut off every summer, to the laws, shrubs, and trees. It is to be done by city use, it will appear, and to the benefit of the city than any other which could be worked out.

Index readers will recall that Doak has given the land for the asking no return other than water. It was a good deal that a test was drilled last fall on his farm so three miles west of town. Persons we felt like calling out the fire and staging a parade and demonstration. Mayor Hames took the news, and we are jubilantly looking forward to publishing the fact that the grant has been approved all up and down the line before another month rolls around.

We feel that the city council deserves no little commendation for this move.
