

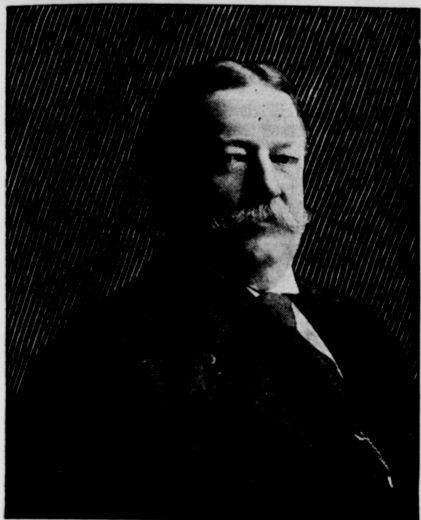

The Independent Movement

The election of last Tuesday has given some idea of the independent vote of the north end of the county. We may safely infer that there are over 100 voters within the corporate limits of the town of Artesia who will vote their sentiments irrespective of political organizations and the recent conduct of the democratic leaders will certainly increase the number. Outside the town there is a greater proportion of independent voters than within and it will not take many to give a majority for a ticket that is composed of good men advocating issues that has some real merit.

This weeks issue of the News contains a call for a meeting that has for its object the appointing of a central committee to take charge of the campaign. The meeting will be held in Artesia Tuesday, April 28. Those south of town can come up on the freight in the morning and return on the evening passenger.

This movement has for its object the abatement of the heavy taxes which are year by year becoming more burdensome to the people of Eddy county. Equality of assessment will receive proper attention and the fair distribution of public improvements will be advocated.

FIGHT AT LAS VEGAS

Rival Factions Engage in Free for all Fight--Sheriff Forced to Disarm Delegates

Las Vegas, N. M., April 7—A big free-for-all fight, in which blood was shed and many black eyes and broken heads received, took place yesterday afternoon at the city convention of the Republicans in West Las Vegas. The fight was the culmination of the bitter feeling that has existed for some time between the members of the faction, headed by Secundo Romero, the present mayor, and Dr. M. F. Desmarias and his supporters, Desmarias being a candidate for the nomination for mayor. The trouble came when the Romero faction succeeded in naming a chairman for the meeting and the Desmarias contingent attempted to hold a rump convention.

Sheriff Cleofes Romero, at the beginning of the meeting took his place on the platform. "I am not a delegate to this convention," said the sheriff, calmly drawing a big Colt's six shooter, "but I am an officer of the law and I know my duty. Come up and deposit your guns."

There was a threatening murmur through the crowd. The sheriff deliberately leveled his

long-barreled gun at the hall full of men and ordered: "Come up and be searched, every one of you!" This time the demand was complied with and one by one the delegates were searched. A motley collection of knives and guns were piled upon the platform when the ceremony was over.

The convention that followed broke all records in New Mexico for bitterness and violence. Speeches of the most incendiary nature were made. After the Romero faction had captured the chairmen, the Desmarias men leaped to their feet and rushing with jeers and curses to one side of the hall, attempted to hold a rump convention.

They were finally ejected from the hall, fighting every inch of the way. Then they hurriedly wrote out their own ticket and ran helter skelter for the clerk's office, hoping to file it and have it made of official record. Getting wind of this the Romero men met them at the clerk's counter and a bloody fight ensued, during which the so-called regular ticket was torn to shreds. Both sides then nominated tickets which are being voted on today. Had it not been for the forethought and nerve of the sheriff in disarming the convention there might have been something worse than bloody noses, as the excitement reached a furious pitch.

THE CITY ELECTION.

Everything Democratic. Attempt to Disfranchise Nearly One Half the Voters. Bluff that Didn't Bluff

Artesia city election took place Tuesday and resulted in a complete victory for the democratic ticket. The weather was pleasant most of the day and the heaviest vote in the history of the town was polled. During the voting hours, everything was quiet and orderly and while both sides worked hard and brought out every voter possible there was little that was objectionable in the efforts put forth.

There were 228 ballots cast three of which were rejected leaving the legal number 225. The results were as follows:

Highsmith and Creath were on both tickets.

There was some dissatisfaction in the morning over the appointment of the judges. Two of those appointed by the council having been nominated on the ticket could not serve as judges and the usual custom is for the remaining member or members to appoint. In this case however it was found that Albert Blake and C. L. Heath had been appointed to fill the places. This matter was passed over and the election proceeded without anything until the time of counting out the ballots.

After a few ballots had been counted Mr. Blake took one from the box and carefully examined in a manner to indicate that he was surprised to find one such in the box notwithstanding that all the ballots voted directed to them by the members of that body. After some deliberation he pronounced the ballot illegal and passed it to Mr. Heath who did likewise. He passed it to Harry W. Hamilton who pronounced it legal giving as his reason that the ballots were prepared under the directions of the District Attorney and as such had been furnished to the voters of Artesia all day by the board.

During the conversation which followed both Blake and Heath admitted that they knew oath to faithfully perform their duty as judges which certainly did not include the placing before the innocent voter an illegal ballot. They were also informed that if they had knowingly placed illegal ballots in the hands of the voters that they were subject to prosecution under the fraudulent ballot laws of the Territory. They were further informed that the supporters of the Citizens ticket insisted upon a square deal and demanded that the ballots be counted and were there to see that they were counted. Mr. Blake looked over the men who were present and concluded that it was the proper thing to count the ballots.

It will be remembered that this Albert Blake is the same enterprising individual who through misrepresentation (were this a democratic paper we would discourteously say lying) obtained possession of the petitions for the creation of Artesia county and for a time delayed action in that direction. He is a member of the board of directors of the Artesia Advocate.

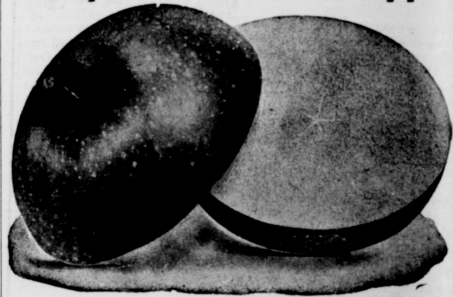

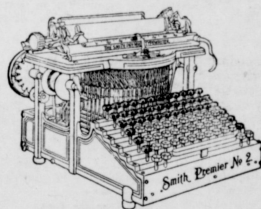
