Judge Jimmy Ross Resigns County Office

Jimmy Ross, of Quitaque, resigned, effective immediately, his elected position as

Briscoe County Judge at a special called Commissioners Court meeting Thursday,

September 28, 1989.

Ross, who was first appointed as County Judge by county commissioners in 1987 to fill the unexpired term of

Judge Fred Mercer and later elected by a majority vote last year, was under fire from a

group of concerned taxpayers because of the recent filing of a proposed budget and tax increase.

An overcrowded courtroom was once again the scene at the Briscoe County Courthouse as county governmental officials faced a decision of whether or not to roll back taxes and/or re-entry the 1990 budgetary process as requested

by a group of taxpayers known as Briscoe County Taxpayers Association of Concerned Citizens (BCTACT).

Approximately 75 citizens were present at the 4 o'clock meeting. BCTACT's attorney, William Warnick was on hand to once again explain his client's position and intent.

L. B. Garvin presided over the 10 minute meeting, offering the resignation of Ross at the onset of the proceeding. Ross was not

present at the meeting.

The commissioners did vote unanimously to re-open the 1990 budget process. A decision on the possible tax rollback (or increase) was not on the agenda, therefore, no vote was taken on that matter.

The Briscoe County Commissioners Court will hold their regular scheduled meeting Monday, September 9,

1989, at the County Courthouse. The agenda has not been prepared at press time. It is not known if the commissioners will appoint a replacement for Ross at that time. Commissioner Garvin will preside over the court until a replacement is named.

In a press release to the media dated September 28, 1989, Ross stated "I have had the honor of serving the people of Briscoe County as judge for the past two years. During that

time, we have examined the need for a more diverse economy and have taken some initial steps to make Briscoe County an even better place to live. There is still work to be done.

I have submitted my resignation as county judge effective immediately. I do so to pursue other interest and to spend more time with my

family, which has moved from Briscoe County because of health reasons.

I hope my successor will continue to work with the task

force which has been formed to attract tourists and sports people to the county. Only in diversification will Briscoe County grow and prosper."

Silverton Slips By Valley JV

The 4th quarter saw our defense play tough nose football stopping Silverton twice deep in our territory. The last defensive stop was inside our 10 yard line. On the first, a fumbled pitch and a tackle on our running back led to a safety which resulted in a victory for Silverton, 15-14.

I was pleased with the effort of our kids. They all played as hard as they could the whole game. We made some mistakes but we also made some great plays. We are going to work hard this week to get back on the winning track for the game against McLean Thursday night.

Patriots Beat Out The Warriors 30-24 Defense Passes Tests

The Valley Patriots avenged their record to 2-2 Friday night with a hard fought 30-24 win over the Miami Warriors.

After a scoreless first quarter Miami broke the ice with a 41 yard touchdown run. The kick was blocked and Miami had a 6-0 lead. Valley's Clay Edwards put the Patriots on the board with a 34 yard run. Chad Isbell kicked the extra point to give Valley the lead. Miami was able to get on the board again with a

38 yard run to regain the lead. The point after attempt failed making the score 8-12, Miami.

Edwards got into the scoring again; this time he threw to Bubba Clardy for a 42 yard touchdown. Isbell's kick was good to make the score 16-12 Valley. In the second half, Valley started off a 65 yard touchdown run by Edwards. The kick was wide to make the score 22-12. Miami, however, was not ready to quit as they bounced

back with a 12 yard interception which was returned for a touchdown. The score was 22-18 to begin the 4th quarter.

Miami took the ball down field to score on a 38 yard run with 3:18 on the clock. Valley then took the ball and drove down the field into scoring position. Jon Pigg made a great catch to keep the drive alive. With a 22 yard run by Edwards, Valley was in good position with 50 seconds on the clock. Clardy followed Kirk Garner over the goal line to keep Valley in the lead, 28-24. Isbell kick made it 30-24.

On the kick-off a hard hit caused the ball to come out and land in a warrior's hand while he was running full speed around end. Only a game saving tackle by Bubba Clardy kept him out. From the five yard line and with 31 seconds left in the game, Valley's defense held tough. Bengie Hughes, Jon Pigg, Jason Little, Warren Merrell, Bubba Clardy and Cory Pointer came together to hold the Warriors out of the end zone.

The boys showed a lot of class in coming back after they took the lead. But they showed a lot more class in holding them at the end. We were happy to get out of Miami with a win. But would liked to had a better game offensively. Our defense did a good job this week.

Extension Award To Be Given

Nominations are now being accepted for the fifth annual Cotton Extension Education Award. Any outstanding county, state or federal Extension worker or team whose educational activities contribute significantly to progress in the U. S. cotton industry may be nominated by October 13. The recipient will receive \$10,000, and another \$5,000 will be presented to support the recipient's Extension educational activities. The award is made possible by a grant to The Cotton Foundation from Hoechst-Roussel Agri-Vet's Agricultural Chemical Group. Staff support for the award is provided by the National Cotton Council. SOCIAL SECURITY NEWS & NOTES

If you are between the ages of 62 and 64, each dollar you earn above \$6,480, will reduce your Social Security benefits by 50 cents. If you're between 65 and 69, each dollar you earn above \$8,800 reduces your benefits by 50 cents. In addition, these earnings are subject to Federal income tax, FICA tax, and applicable state and local income taxes.



Many economic experts, as well as legislators, think the Social Security earnings test is not only unfair, but also unwise, because greater participation in the work force by older workers will improve productivity and expand the tax base. A number of bills have been introduced in Congress in 1989 which would eliminate the Social Security earnings test entirely, or eliminate it for those between the ages of 65 and 69, reports the American Society of Pension Actuaries.

The Social Security earnings test hurts less-well-off individuals much more severely than it does the wealthy. Dividends, interest, gains from sale of securities, and other so-called unearned income do not reduce Social Security benefits. Wages above the threshold amount do result in a reduction.
