## One vehicle accident kills one, injures one

A one vehicle accident on Brown Road claimed the life of Spearman youth Paul Trooper Tuesday afternoon.

According to Trooper Edward Longoria of the Texas Department of Public Safety, Trooper was a passenger in a Toyota pickup driven by another Spearman youth, Clay Scribner. The vehicle was westbound on Brown Road when Scribner lost control of the vehicle, skidding sideways into the ditch on the south side of the road. The passenger side door struck a utility pole as the truck skidded.

Trooper reported that the Spearman fire department rescue unit was summoned to pry Trooper from the wreckage of the pickup. He was taken to the Hansford Hospital emergency room.

According to charge nurse Mary Allen, Trooper was in critical condition with severe head injuries and

internal injuries to his chest and abdomen.

According to Trooper Longoria, Trooper was being transported to Amarillo by Spearman EMS when his condition worsened, requiring the ambulance to stop at the Borger hospital where he died shortly after 3 p.m. Tuesday afternoon.

Longoria said the Scribner youth was admitted to Hansford Hospital and treated for a broken right arm and other minor injuries. According to Allen he was stable and still hospitalized at 4 p.m. Tuesday.

Trooper Longoria said the vehicle was not traveling at an excessive rate of speed. He said the Scribner youth stated he swerved to miss something in the road and "just lost control" of the vehicle. Longoria added that neither of the youths was wearing a seat belt.

## Gruver house fire results in damages

Seventeen members of the Gruver Volunteer Fire Department worked for two hours to put out a ceiling fire at the Don Dillow residence, 215 Richardson Street in Gruver, at 7:30 p.m. Monday.

According to Fire Chief Sam Gruver, the fire was started by an electrical short at a junction box leading to the air conditioner unit, located just under the roof line on the back of the house. He said the fire quickly spread into the attic of the house, resulting in extensive damage to the rafters and ceiling above the master bedroom and kitchen of the Dillow residence.

Chief Gruver, who lives across the street, was the first person to call the fire department when he smelled smoke and went to investigate. He reported seeing smoke pouring from the Dillow

residence and called in to report the emergency.

He went to the Dillow residence, where he found Mrs. Dillow spraying a small blaze in the back corner of the master bedroom with a fire extinguisher. He said these were the only flames visible at that time.

Because of the danger of smoke inhalation and asphyxiation, he ordered Mrs. Dillow out of the house and waited for the rest of the fire department to arrive. According to Gruver, the response time was four minutes.

By pulling down ceiling tiles, firefighters found the insulation and rafters above the bedroom and kitchen were on fire. Gruver said it took approximately 20 minutes to put out the flames. The rest of the time was spent checking for hot embers and making sure they would not flare up later.

# County communities combine efforts

Tom Dortch of the Morse Lions Club said, during a phone interview on Monday, that the Morse garbage dump will be permanently closed on Tuesday, June 19.

Morse's garbage will be hauled to the Spearman municipal landfill by the City of Gruver as soon as the Morse community can purchase 25 garbage dumpsters.

According to Dortch, an EPA official contacted the owner of the dump several weeks ago and informed him that the dump was in violation of EPA standards. The of-

ficial stated that further dumping would have to stop and the area would have to be cleaned up, or the owner would face fines totaling \$1000 per day.

Dortch said the owner sought members of the Lions Club for help in getting the dumping stopped and organizing the clean-up of the area. According to Dortch the owner contacted the Lions Club because of the lack of a formal governmental body in the Morse community.

Dortch stated the Lions Club agreed to organize and plan the

closing of the dump, the clean-up, and finding an alternative method for disposing of the Morse garbage. The club appointed a four-man committee to tackle the problem. Committee members are Bob Womble, Morse Lions Club president; Tom Dortch; Frank Lewis; and Dwight Gillispie.

During a community meeting held Thursday, June 14 at the school cafeteria, the committee outlined and sought approval for its plan. According to Dortch, the plan was approved by Morse residents

with only one dissenting vote. After the dump is closed on June 19, both Hutchinson and Hansford Counties will contribute men and equipment to gather waste material deposited at the dump and cover it with earth.

Morse's solid waste will then be hauled by the City of Gruver to the Spearman landfill. The City of Gruver agreed to haul the garbage provided it is collected in dumpsters. Dortch said the committee had originally stated at the meeting that the 25 needed dumpsters could be purchased used, for less than

\$200. The committee has since found out that those dumpsters are no longer available, and that dumpsters will have to be purchased new at a cost of \$260 each. Dortch says the dumpsters will be delivered in about three weeks.

According to Dortch, the Lions Club advanced the funds to purchase the dumpsters with the hope that the residents of Morse will reimburse the club by purchasing the dumpsters at a rate of one for every three families. For those who cannot afford this cost the Club will bear half the cost, with the other

half coming from the Hansford County Court.

The total cost for each family to buy a dumpster will be \$86.89. Additional monthly cost for garbage disposal, according to Dortch, will be about \$19 per family. From that monthly cost, \$15 will go to Gruver for transporting the garbage and an estimated four dollars is to go to Spearman for use of its landfill.

Dortch said response to the plan has been very encouraging. Residents present at Thursday's meeting decided to call for another meeting in July to discuss incorporation of the Morse community.

# Gruver Chamber of Commerce plans celebration

The Gruver Chamber of Commerce Board of Directors met at Gruver City Hall at 7:30 p.m. Monday to finalize plans for the Gruver 4th of July celebration and to pass a resolution to continue its "Adopt a Highway" project.

According to A.J. Ratliff, organizing the 4th of July celebration is a joint project of the Chamber of Commerce and Alpha Mu Psi sorority. The chamber is overseeing the events and the fireworks, while the sorority is organizing the games. Ratliff reports that other groups handling some of the events are Gruver

State Bank, the parade; Lions Club, the barbecue; and the Gruver Ministerial Alliance, the evening music before the fireworks.

According to a schedule of events released by the chamber board, the celebration will start at 10 a.m. with a parade down Main Street. According to Sandy Spivey, parade coordinator, there were 40 parade entries as of Tuesday afternoon.

According to the schedule, games begin after the parade. There will be games for all ages taking place in the park and along Broadway, starting with a bicycle race along Broadway. Starting

point for the race is the park.

At 11:30 a.m. in the center of the park, there will be a turtle race and a three-legged race. The turtle race is for both boys and girls. The three-legged race is open to all comers, kindergarten through adult.

At noon the Lions Club begins serving barbecue. According to Ratliff 1,000 pounds of meat have been ordered to feed the expected crowd. They will be set up at the southeast corner of the park.

1 p.m. marks the opening of the city pool, the start of the boot scramble, the sponge toss and the watermelon seed contest. The last

three events will be held in the center of the park.

Following at 2 p.m. in the center of the park a stickhorse race and a spoon race will start. The stickhorse race is for 1 to 6 year olds, and the spoon race is for 5th grade to adult competitors.

According to the schedule five events will go on all day. Bingo is open to everyone and will be taking place on the south side of the park. Everyone can participate in the water polo competition that will be held on Broadway. The dunking board will be open to everyone on the south tennis courts. Horseshoes

and washer-pitch games will be held on the east side of the park.

Five year olds and under can dig for copper at the "copper mine," located on the west side of the park.

Ratliff reported that competitors who work up a thirst or a hunger during the games can seek relief at the eight food and drink booths sponsored by local clubs and organizations.

Starting at 10 a.m. at the park gazebo, there will be continuous music and entertainment provided by the "Moon Man" from Guymon, Okla. He will continue to entertain until the last event in the park is

completed, at approximately 4 p.m.

The celebration will continue at 9 p.m. at the Gruver High School football field. Ratliff stated the Gruver Ministerial Alliance has planned a musical program, and a skydiving display will be provided by Rick Yanke. Finally, he said, the city has ordered a fireworks show which will be set off by Robert Blount to end the celebration.

# Russell disliked, but part of, history

William Lee (Bill) Russell, 93 years young, is part of Texas Panhandle history but he admits with a wry smile that history was the subject he liked least during his schoolboy days at the turn of the century.

"History was the one subject I hated and I told my dad I didn't want to study it...that maybe I just ought to quit school and do something else. But he said no!" the Hansford Manor resident says with a chuckle.

Bill's favorite class in school was math. "I loved anything that had to do with math and I was nearly perfect in it," he recalls. To this day, according to Hansford Manor Director of Nurses Carol Hergert, Bill can add a column of figures in his head or by longhand faster than she can punch them in a calculator. After he began his country school

days in Hammon, Okla., Bill and his family moved to Ochiltree, the original county seat of today's Ochiltree County, in 1906. His father opened a general store there in a 25 by 80 frame building.

Bill was one of ten Russell children and vividly recalls hanging around the family store as a child. "We had all the candy and Cracker Jacks a person could want," he says gleefully. A box of Cracker Jacks cost a nickel in those days, he says.

Although naturally left-handed, Bill's first teachers took his pencil out of his left hand, put it in his right hand and tied the left hand behind him to make him right-handed. In spite of this treatment, he is left-handed at everything except writing to this day. "I did all the sports, like baseball, left-handed," he explains.

Another memory that he shares is of the time he and his brother were watching a work crew grade a county road near home. One of the laborers threw down the smoldering stub of a cigar as he moved on down the road. "We picked up that stub of cigar and started smoking it. And sick! So sick - we got so sick we didn't know if we were going to live or die!" he remembers. He has never smoked since that time, he is quick to point out.

Bill joined the U.S. Navy to avoid being drafted into the Army as World War I wound down in the late teens of the twentieth century. "I

would have been the last man drafted for the war if I hadn't volunteered for the Navy instead," he affirms.

After spending seven months in Seattle, Washington with the Navy, Bill returned to the Texas Panhandle to work in a Liberal, Kansas grocery store. It was here that he met his future wife, Lemmie.

"I loved ... math ..."

"I went with a friend of Lemmie's a few times," he recalls, "but the very first time I saw Lemmie I thought 'I've got to have her!'" Bill says Lemmie was as beautiful on the inside as on the outside: "Just a doll!"

"She wasn't convinced that she needed me for a husband at first," he adds. "But I just grew on her, I guess." The Russells lacked only 18 days of being married 67 years before Lemmie's death a few years ago.

Bill and Lemmie had three children, Doris Jean, Margerie Helen and Bill. The young couple ran the general store in Ochiltree, but when the Sante Fe Railroad came through the area, they decided to move it to the new town of Spearman in Hansford County.

A steam engine pulled the wooden store building from Ochiltree to Spearman. As Bill remembers it, that chore cost \$500

and took three days to complete. While they waited for the building to arrive, Bill and his family camped out on the store's future site. When the store was first set up in Spearman, near today's Golden Spread Senior Citizen Center, the town boasted a population of 125 people.

The W.L. Russell Store was later established in the building which today houses Cates Men and Boys on Main Street. Bill says the store grew as the town grew, although making it through the Dust Bowl days was a struggle. After 1937, he comments, there were seven or eight very prosperous years for farmers, which spelled an end to years of debt for business owners in the town.

In 1950, Bill retired from the store and his son took it over. Later, it was sold and became Chamber's Dry Good and Groceries.

Bill moved into the Hansford Manor four years ago and remains a very viable part of this community. A member of the First Baptist Church, he attributes his good health and longevity to "trying to live a Christian life."

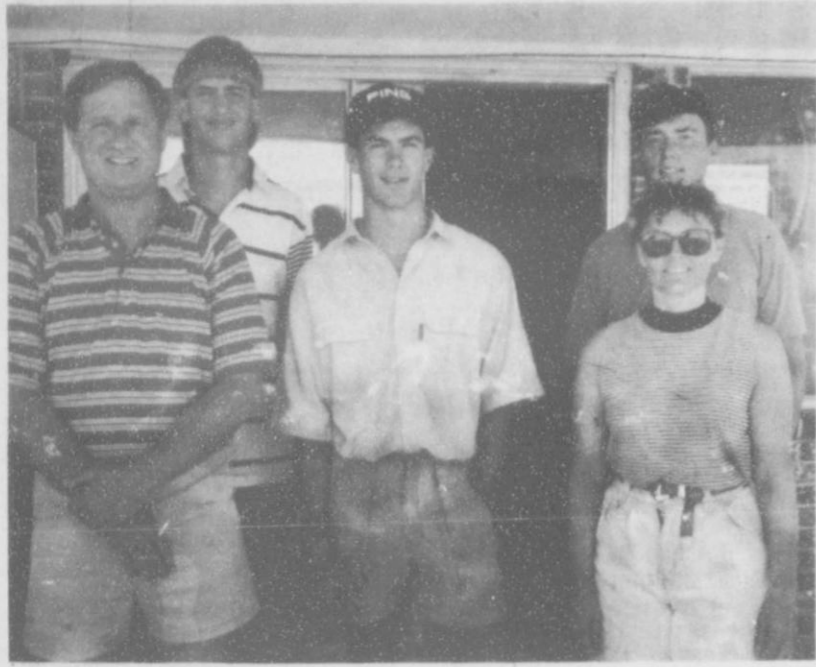

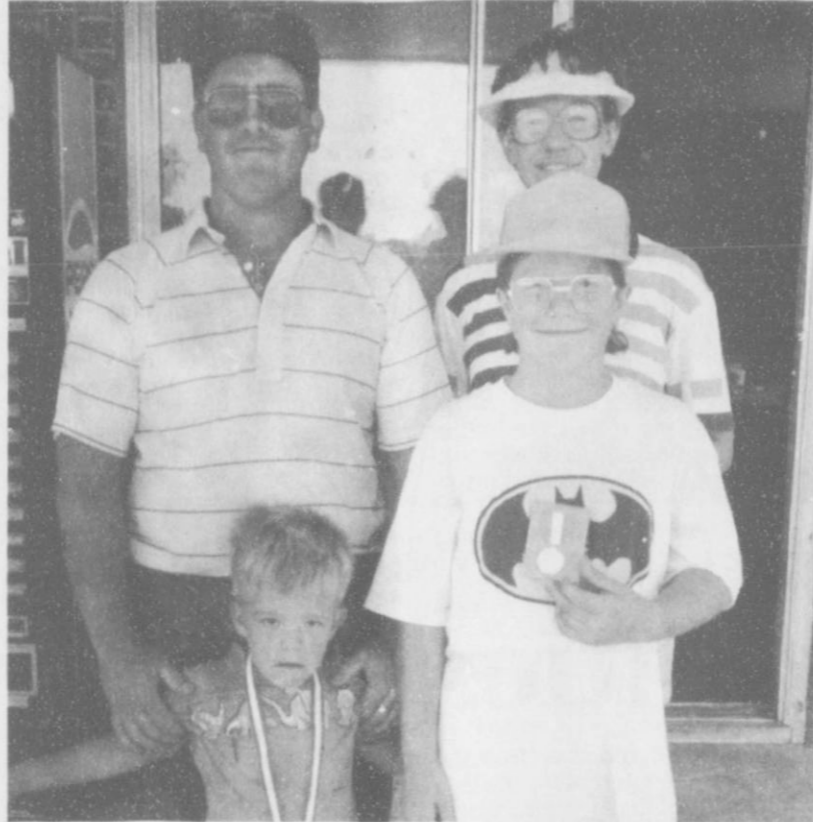

## Gibbs takes part in African crusade

Russ Gibbs, pastor of First Baptist Church, Spearman, returned home Friday from a 15 day evangelistic crusade and safari in Kenya, East Africa.

Gibbs participated in a Church-to-Church Crusade sponsored by International Crusades in Dallas in the area of Kambu, approximately halfway between Nairobi and Mombassa. The purpose of the crusade was to place Americans in local African churches and conduct preaching services and door-to-door visitations.

Twenty-two Americans participated including Tom Rasor, Kathy Gillispie and Brian Gillispie of Gruver. During the crusade Gibbs reports he slept in a tent, ate "unidentified" African food, and walked for miles every day through thick bush country.

Gibbs reports, "It was a tremendous, once-in-a-lifetime experience. The people were wonderful. They treated me with every consideration and were so thankful and appreciative of my work with them."

"It is exciting to be in a country where the preaching of the Gospel is unhindered and freely accepted. I had open access to preach in the schools, in the markets, stop people at work...everywhere we stopped, people were willing to learn more about God and how they could experience a personal relationship with Him. I wish people in America were as open and responsive to the Gospel as Kenyans are," he continued.

Following the crusade, a few of the Americans spent the next three days on photographic safari in the Tsavo West and Amboseli National Parks. Gibbs commented, "It was an awesome sight - unspoiled nature and wild animals in their natural environment."

A slide show of the trip and detailed information regarding the crusade, the culture and lifestyle of the people, and the animals of Africa will be presented this Sunday, June 24, at 7:00 p.m. at First Baptist Church, 123 Fernice, Spearman. The public is welcome to attend, said Gibbs.

## Doctor interviews in Hansford County

James W. Kindrick, M.D., accompanied by his wife Linda, visited Hansford County on Saturday and Sunday, June 16 and 17 and was interviewed by Hansford Hospital Administrator Al LaRoche, several hospital board members, and Dr. Laurence Behney.

Dr. Kindrick, who completed a year of residency training earlier this month in Odessa, is a Cincinnati, Ohio native. He completed his undergraduate degree at the University of Cincinnati in 1980 and went on to earn his M.D. at Wright State Medical School in Dayton, Ohio in 1984.

Upon completion of an internship at Wilford Hall Air Force Hospital at Lackland Air Force Base in San Antonio, Kindrick was employed for three years by the United States Air Force as a physician at Dyess Air Force Base in Abilene.

The Kindricks have spent the past year in Odessa, where Dr. Kindrick took a year of residency training through the Texas Tech family medicine program and Mrs. Kindrick worked for the Texas State Department of Human Services.

While visiting Hansford County Dr. and Mrs. Kindrick were interviewed by hospital board President Alton Ellsworth and board members Rosalee Butt and John Trindle. The couple was given a tour of the hospital and clinics, Hansford Manor, Gruver, the Palo Duro Dam, and other points of interest by LaRoche.

On Sunday, Dr. and Mrs. Kindrick attended church at First Presbyterian in Spearman and then joined Dr. and Mrs. Laurence Behney for dinner. Sunday afternoon, the two doctors met in Dr. Behney's clinic and Mrs. Kindrick went on a real estate tour.

LaRoche said Hansford Hospital is currently seeking to recruit two full-time physicians, preferably a family doctor and a surgeon. He said he expects to hear from Dr. Kindrick in the next week regarding the possibility of Kindrick's establishing a practice in Hansford County. Dr. Kindrick expects to interview in Trinity, Texas later this week, LaRoche said, at which time he will make a decision about where to locate his practice.

## Yesterday's Children sponsor event

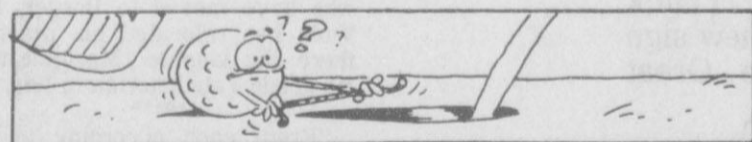

## Letter To The Editor

Dear Editor,

I hesitated to write this letter, because I always try to take the attitude that there are two sides to any issue, and why add fuel to a fire already out of control (pun intended), but in the end, I couldn't resist the opportunity to state my opinion on this controversial issue, and so here goes...

The U.S. Supreme Court decided this week that the flag protection law is unconstitutional. I join Warren Burger, Rush Limbaugh, and Joe Garagiola in applauding this decision. I especially admired former Chief Justice Burger, who said, while standing next to our First Lady, that he would not wrap himself in the American flag, because he might get burned. What a sense of humor!

Now honestly, was it that long ago that most of us applauded the Chinese students in Los Angeles and other parts of the USA for burning their country's flag, after the Tiananmen Square debacle? Have we simply forgotten, or is it maybe that we have a genuine double-standard? Surely, it must be different for a Chinese student to burn a Chinese flag than for an American to burn "Old Glory!" ## Bank honored

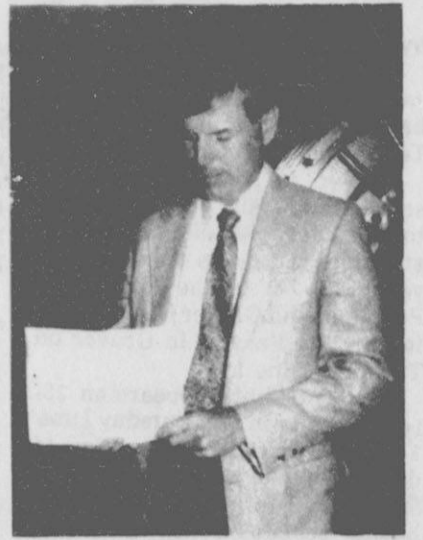
Jim Shirley, president of the First State Bank of Spearman, received notice last week that the bank had been chosen to receive honors from two national banking publications.

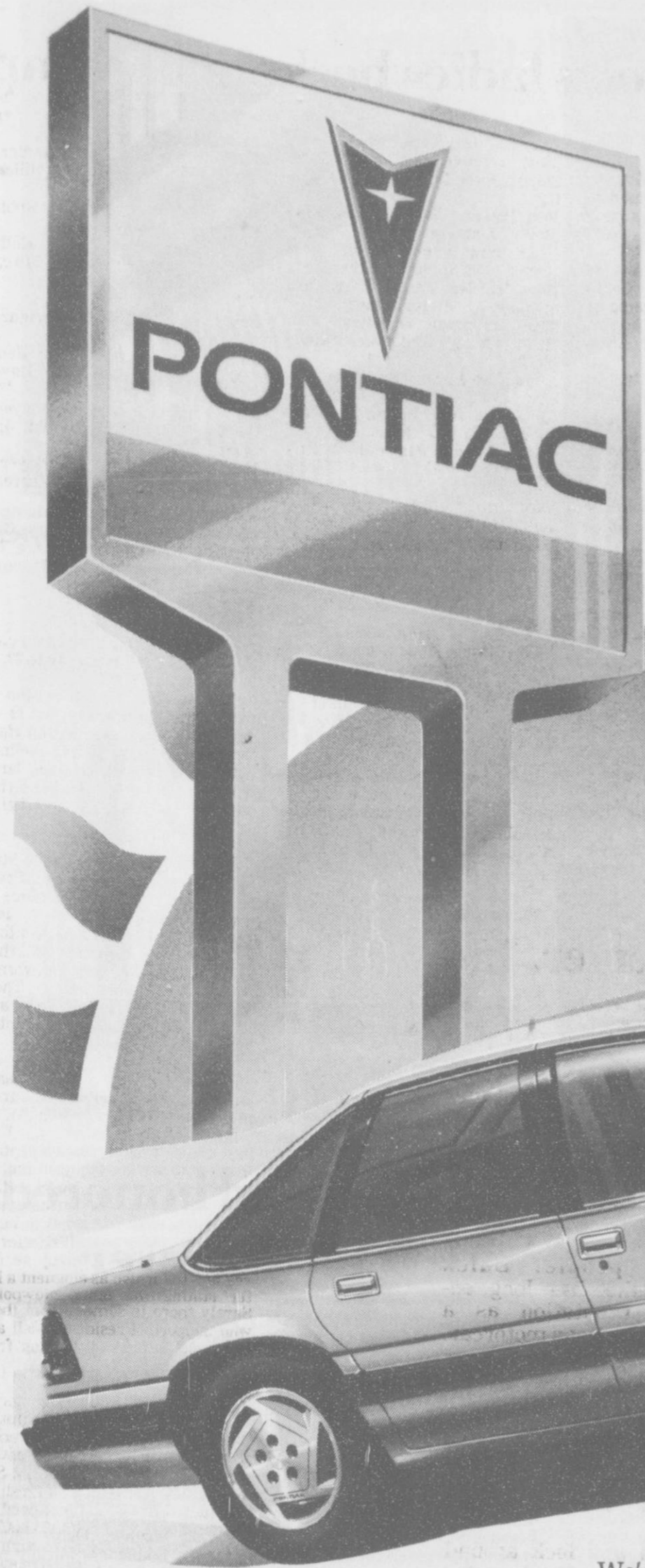

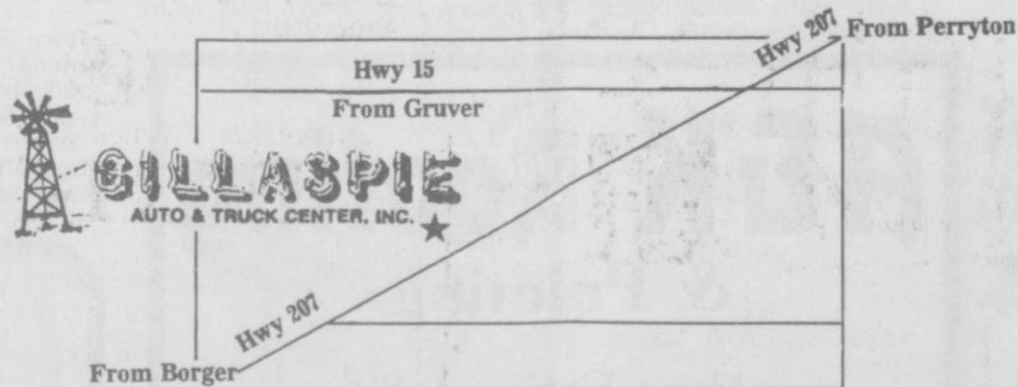

Shanna Hagler from Lubbock has been the guest of Brian Gillispie in the home of his parents.

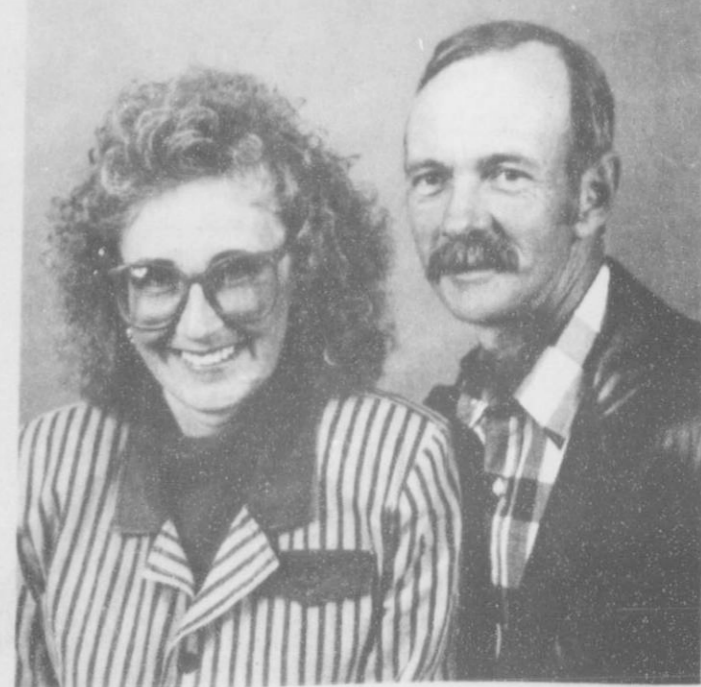

Motorists should use extra caution when driving in residential areas, remembering that we have longer hours of daylight. Always look out for children darting in and out from behind parked cars. Never assume that a child will see you. Slow down and honk your horn to get their attention, if needed.

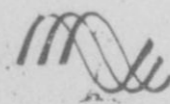

# Sheriff's office gives 1989, 1979 stats

Hansford County Sheriff R.L. McFarlin has released a report of the activities of the Sheriff's office for the calendar year 1989. Figures released include the number of persons arrested, charged and jailed in Hansford County Jail.  
The sheriff reports that last year one person was jailed for bond forfeiture, two persons were jailed for contempt of court and 69 were booked in for theft by check. There were five fugitives jailed, and five persons jailed for forgery. One person was arrested for theft of service, and five for probation violation and one for auto theft.

total of \$10,280 in fees.  
In addition, the sheriff's department reported a grand total of \$101,839 worth of property was stolen in Hansford County during 1989. However, \$63,023 worth of property was recovered during the year by department personnel.

For comparison purposes, Sheriff McFarlin has also provided figures for the calendar year 1979.  
Ten years ago there were two persons arrested and jailed on charges of bond forfeiture. "Hot check" writers have apparently diminished, as 138 persons were charged with theft by check 10 years ago. Fugitives in 1979 totaled 10, and four persons were charged with forgery. Four persons were jailed for probation violation and only one was jailed for D.W.I., but eight were charged with public intoxication.

Three "sleepers" were housed in the county jail in 1979 and four persons spent time in the county jail charged with possession of controlled substance. There were 21 persons booked in and charged with burglary, 12 persons charged with theft, seven illegal aliens and 10 persons charged with possession of marijuana.

Four people were jailed on assault charges, one jailed for disorderly conduct and three jailed for shoplifting. One person was charged with interference of child custody and two were charged with rape.

The total number of persons booked into the county jail in 1979 was 218.

# Slover attends workshop

Kelly Slover, teacher of agricultural sciences at Spearman High School, completed a two-day inservice education workshop held at Texas A&M University on June 11-12, 1990. Over 40 teachers from all areas of the state attended the program improvement workshop conducted by Dr. Gary Briers of the Department of Agricultural Education and Mr. Larry Ermis of Instructional Materials Service.  
The workshop provided information for conducting the Introduction to World Agriculture course in the school's agriscience department. Innovative ideas for implementing and improving activities related to the basic curriculum and essential elements highlighted the workshop.

each April at Texas A&M University for students enrolled in the course.

Southwestern Bell Telephone Company has instituted a Class Action Lawsuit seeking judicial approval of a settlement reached in Docket No. 7297, an inquiry of General Counsel of the Public Utility Commission of Texas into possible overcharges which occurred between September, 1976, and February, 1987, due to rounding practices, on bills of intrastate WATS/800 customers sent by Southwestern Bell and other telephone companies which concur in Southwestern Bell's tariff. The suit is styled "Southwestern Bell Telephone Company, Plaintiff, vs. MCI Telecommunications Corporation, A Member of the Class of Texas Intrastate WATS and 800 Service Customers Who Paid Overtime Charges From September 1976 Through February 1987, Defendant," and identified as Cause No. 471,460 in the 126th Judicial District Court of Travis County, Texas.

Pursuant to the settlement, while not admitting liability, Southwestern Bell, the other local exchange telephone companies in Texas, and AT&T Communications of the Southwest, Inc. have agreed to pay refunds to those WATS/800 customers who paid overtime charges attributable to the rounding practices for intrastate WATS/800 services at any time between September, 1976, and February, 1987. The refunds will be based upon either the actual or estimated amount of overtime charges attributable to such rounding practices. An exact refund will be determined for customers able to produce copies of their WATS/800 service bills. For customers who do not have copies of their WATS/800 service bills to establish actual overtime charges paid, an average refund of \$4.53 to \$5.95 per WATS/800 service line per month will be applied. All claims will be subject to verification. The refunds will also include interest at the rate of 7.80% per annum.

### Claim Forms And Additional Information

Those customers who think they may be entitled to a refund or who desire more information must call 1-800-782-3026, 8:30 a.m. - 4:30 p.m., Monday through Friday, or write to WATS Refund Pool Administrator, One Bell Plaza, Room 670, P.O. Box 650376, Dallas, Texas 75265-0376, to request a WATS Refund Information Package. The WATS Refund Information Package will contain further information regarding the lawsuit and eligibility for a refund, a description of documentation required to support a customer's claim for refund, and a refund claim form to be filled out and submitted requesting a refund. REQUESTING A WATS REFUND INFORMATION PACKAGE DOES NOT OBLIGATE YOU IN ANY WAY.

All claims for a refund must be received by the Refund Pool Administrator by Friday, October 5, 1990, and all rejections of the settlement (that is, requests for exclusion from the class action lawsuit) must be received by the Court by Wednesday, September 5, 1990. Only those who respond by filing a claim or by filing a rejection of the settlement, as explained in the WATS Refund Information Package, will receive notice of future developments in this proceeding.

# Minding Your Own Business

While attending the Texas Conference on Small Business last month in Dallas, I had the opportunity to hear Car Sewell of Sewell Village Cadillac explain the secret of his success. His candid remarks about customer service were well received by the audience of entrepreneurs and certainly bear repeating in this column.

I first read about Carl Sewell in Tom Peters' book, *A Passion for Excellence*. Since he took over in 1968, his agency has grown from the smallest dealership in Dallas to one of the largest in the world. Sewell Village is ranked as the No. 1 Cadillac agency worldwide in the area of customer service and has a service department that generates more revenue than any other Cadillac shop. Not surprisingly, Sewell was the first automobile dealer ever asked to speak to the Board of Directors at General Motors.

Sewell told the audience of over 1,000 that a plan for providing quality customer service is easy to conceive but difficult to execute. He explained that many businesses don't get past the stage of talking about customer service. "They pay lip service to taking care of the customer but aren't really willing to pay the price to make it happen," he said. Sewell paid the price and soon began to reap the benefits.

### Listen to Your Customers

The first action taken by the Sewell Village staff was to find out what was important to their customers. They talked to customers, took surveys, held focus groups and, above all, listened. They listened to minor complaints and major problems and, each time, sought a solution.

Customers pointed out that,

while their cars were very comfortable to sit in, the chairs in the waiting area were not. Sewell responded by replacing the cheap chairs with units of quality and comfort that he smilingly calls "Cadillac chairs."

Customers also had negative comments about the restrooms. As a result, the facilities were enlarged, remodeled with modern fixtures and lighting, and are now kept spotlessly clean.

Another complaint was that service shop was not open during convenient hours. The shop is now open on Saturdays and until 8:00 p.m. each evening.

Sewell discovered what his customers wanted and provided it. He realized that a commitment to taking care of the customer has to start at the top of every company. If the commitment doesn't trickle down to every employee, it simply doesn't work.

### Measure Performance

Sewell pointed out that statistics are kept in every area of sports, such as batting averages, pass completions, completed field goals, assists, etc. However, his dealership had very little performance information, so he began to keep records on all employees. How often was a problem solved on the first try?

How often was the automobile repaired in the time promised to the customer and at the price quoted in the estimate? Individual performance measurements paid big dividends.

As the mechanics began to see their service records posted for all to observe, some interesting things happened. Customer problems began to be solved on the first try. Repeat visits for the same repair were cut drastically. Service managers began to push for meeting both time and dollar estimates. More profitable work

was flowing through the shop.

Sewell believes that you should never stop raising your customer service standards. One of his highest-paid mechanics has seven consecutive months of zero defects in his work. That means, for seven months in a row, no automobile has been returned for the same repair.

A final point made by Sewell is that you can always learn from the best. While developing his customer service plan, he visited stores such as McDonalds, Stew Leonards and Nordstroms. The result was truly "Cadillac service."

## Back To Small Town Traditions

GRAMMAR AND SCHOOL FINANCE

It was the last senior English class of the year. Mrs. Sims, our English teacher, a white haired, short, heavy set woman, put down her book and picked up a sheet of paper from her desk. Looking at the class she said, "Seniors, I realize that tomorrow is 'Senior Day' and all of you are expecting to be out of school one day before the underclassmen. However, there are some of you who have not passed the grammar usage test. You all know that it is my rule that no senior passes this class until he/she has passed the test."

"Oh great!" I thought to myself "Is she going to hold us to that stupid rule?"

"The following students will report to me tomorrow. You will take the test until you can pass it."

Mrs. Sims began reading the list. Sure enough my name was on it. Grammar had always been a mystery to me. It seemed that for every rule there was an exception and you could bet your bottom dollar there were plenty of exceptions to be found in Mrs. Sims' test.

This was just not fair. I had passing grades in senior English even without the passing grammar test grade. I'm one of the captains of the football team, a class leader, and cool man on campus. How dare her to lay this humiliation on me. I've got strings I can pull and people in high places that will help me with Mrs. Sims.

First on my list are my parents. Mother will be outraged. Lookout, Mrs. Sims, when Mom gets a hold of you! Then there is Dad. He is good friends with the principal, Mr. Miller. He can swing some weight. A request from him and Mr. Miller will bring Mrs. Sims to the office and straighten her out! Nothing to worry about. I'll be out dragging "Main" with the rest of the seniors tomorrow.

When I got home Mother was in the kitchen mixing something. I threw my books on the couch and went to the kitchen.

"How does it feel to be through with high school classes forever?" she asked.

"Wish I were," I grumbled. "What's the matter?" she asked quizzically.

I related the situation with Mrs. Sims and told her how unfair I thought it was. "She ought to be turned in to Mr. Miller!" I said very angrily.

Mother turned around, looked at me and said very firmly, "Sit down. I've got something to say and I want you to listen carefully."

"Hey! What is this!" I thought. "I'm the one being 'messed around' and she's winding up to give me a lecture!"

I took a seat behind the blue formica breakfast table where I had received many sermons from my Mother. She had a large stirring spoon in her hand and it served as an extension to her index finger. She always shook it at me when she talked. It was the way she punctuated the sentences in her speeches.

"Whether Mrs. Sims has been fair to you or not is not my major concern. My major concern is that you know English grammar. If Mrs. Sims has to keep you all summer to teach you grammar then so be it. You will be in Mrs. Sims' classroom tomorrow for as long as she wants to work with you. You've had twelve years to understand grammar and you've piddled around. Don't tell me you can't get it! When the test was passed out, I could not believe my eyes! It was the same test Mrs. Sims had given me when I was a senior. It was on the same 5x7 paper, by the same company. I made 95% on the test.

Mrs. Sims had done me a favor. My parents had done me a favor. All I had done was give them a bad time.

School finance is a real issue this year. I am convinced that education will not get better until a lot more money is made available to local school districts. However, more money is not enough. Teachers like Mrs. Sims will be needed. Teachers who are willing to take the abuse of students like me, who have the courage to risk ridicule of parents, bosses, board members, or whoever to do what is necessary to get their students to accomplish what they are capable of achieving.

It will take parents with insight to work with and understand what teachers are trying to do. Learning must once again become the priority for the student, parent, and teacher. Let us quit playing "divide and conquer" games. Parents and teacher must be allies, not enemies. Let's let our children know that their education is important to us. Not just by what we say, but by what we do. Require them to get to bed at a decent hour. Provide a good study environment at home. Take interest in their school work by asking questions, requiring them to produce report cards, keeping in contact with their teachers, and voting for good board members. All of this doesn't cost a dime!
