

#### AN EXPLANATION.

At a meeting of the City Council last Monday night THE BRAND was designated as their official paper and given the job of printing all ordinances, etc., at the rate of 50c per hundred words, a bid 20 per cent higher than that made by the Searchlight.—Searchlight.

Our contemporary should give further explanation as to why it was not awarded the contract, which, if we understood the proposition, was to be given to the lowest bidder, provided it was published in the issue succeeding the acceptance of the bid. The Searchlight management had the same opportunity to prepare for the executing of the contract as had THE BRAND, and it was the fault of no one, except the Searchlight management, that said paper was not prepared to accept and fulfill the contract. In the Searchlight's bid it was stated that it would be a "physical impossibility to receive the copy now ready at this hour of the week and issue it this week, therefore, we add that we can publish a part this week and the remainder next, or by advising us of your decisision at once we will get everything else out of the way and issue the entire bulk next week." In the opinion of the City Council it was imperative that the ordinances be published that week so that they might become in force at once, as there had been too much unavoidable delay already, therefore THE BRAND's bid was accepted, provided that the said ordinances be published in its issue of May 1, 1903. Inasmuch as the Searchlight is issued one day later than is THE BRAND it will be readily seen that the Searchlight had more time than did THE BRAND in which to fulfill the contract. ### TITLE XX. Occupation Tax.

#### Chapter I.

Art. 365. An ordinance providing for the levy and collection of license tax and occupation tax and repealing all ordinances and parts of ordinances in conflict herewith and providing a penalty for failure to procure occupation license.

Be it ordained by the City Council of the city of Hereford, Texas, that:

#### LICENSE.

Sec. 1. There shall be levied on and collected from every person, firm, company or association of persons pursuing any of the following named occupations an annual occupation tax, except when herein otherwise provided, on every such occupation or separate establish-

ment as follows: Sec. 2. From every merchant whose annual purchases amount to less than two thousand dollars the sum of one dollar and fifty cents. From every merchant whose annual purchases amount to two thousand dollars, or less than five thousand dollars, the sum of three dollars shall be levied and collected. From every merchant whose annual purchases amount to five thousand, or less than ten thousand dollars, the sum of six dollars shall be levied and collected. From every merchant whose annual purchases amount to ten thousand, or less than fifteen thousand dollars, the sum of ten dollars shall be levied and collected. From every merchant whose annual purchases amount to fifteen thousand, or less than twenty-five thousand dollars, the sum of twelve dollars and fifty cents shall be levied and collected. From every merchant whose annual purchases amount to twenty-five thousand dollars, or less than fifty thousand dollars, thirty dollars shall be levied and collected. From every merchant whose annual purchases amount to fifty thousand or less than one hundred and fifty thousand dollars, sixty-two dollars and fifty cents shall be levied and collected. From every merchant whose annual purchases amount to one hundred and fifty thousand dollars, or less than two hundred and fifty thousand dollars, seventy-five dollars shall be levied and collected. From every merchant whose annual purchases amount to two hundred and fifty thousand, or less than five hundred thousand dollars, one hundred dollars shall be levied and collected. Every person, firm, corporation, or association of persons, desiring to sell goods, wares or merchandise within the city of Hereford, Texas, shall, before persuing such occupation, pay the tax and take out a license to persue the occupation of a merchant of the class to which he properly belongs, according to his annual purchases, as provided by law, and shall file with the tax collector an affidavit of the amount of his annual purchases for the past year, if previously engaged in such business, or part of the year if engaged in such business less than a year, and also of the estimated amount of his annual purchases for the ensuing year. Said affidavit

shall be filed and preserved by the

tax collector as a part of the rec-

ords of his office.

A merchant in the meaning of this article is any person, firm or association of persons engaged in buying and selling lumber and shingles, goods, wares, and merchandise of any kind whatever.

#### BANKRUPT STOCKS.

From every merchant who may move from place to place and offer for sale bankrupt stocks of goods or advertising fire sales or water and fire damaged stocks for sale, for a limited period of time, there shall be collected in advance fifty dollars per month, for the first month or less than a month during which said business is carried on in the city of Hereford, and for each additional month that such sales are continued in said city said merchant shall pay an additional sum of ten dollars. Provided, that where they remain for six months in one place, in addition to the fifty dollars charged for the first month they shall pay an additional sum of five dollars per month. Provided, further, that if they remain in said city for twelve months they shall be required to pay in addition to the fifty dollars for the first month the sum fixed in the preceding section according to class and amount of goods sold in one year.

#### MEDICINE TRAVELING SALESMEN.

Sec. 3. From every traveling person selling patent or other medicines there shall be levied and collected an occupation tax of fifty dollars, and no traveling person shall sell until such tax is paid. Provided, that this tax shall not apply to commercial travelers, drummers or salesmen making sales or soliciting trade for merchants engaged in the sale of drugs and medicines by wholesale.

#### FORTUNE TELLER, ETC.

Sec. 4. From every fortune teller the sum of five dollars shall be levied and collected. From every clairvoyant or mesmerist who plies his or her vocation for money, the sum of five dollars shall be levied and collected.

#### MONEY BROKERS.

Sec. 5. From every person, firm or association of persons engaged in having or discounting paper, or engaged in business as money brokers or bankers, or dealers in stocks, securities or bills of exchange, or in buying or selling bonds, state, county or city warrants, or other claims against the state, the sum of twenty-five dollars shall be levied and collected in advance.

#### PHOTOGRAPHERS.

Sec. 6. From every operator or owner of any daguerreian, photograph or other like gallery by whatever name called, the sum of five dollars shall be levied and collected.

#### AUCTIONEERS.

Sec. 7. From every auctioneer the sum of five dollars shall be levied and collected.

#### COMMISSION MERCHANTS.

Sec. 8. From every person, firm or association of persons, selling on commission, the sum of five dollars shall be levied and collected.

#### LAND AGENT.

Sec. 9. From every land agent there shall be levied and collected an annual tax of two dollars and fifty cents. The term land agent shall be construed to mean any person, firm or association of persons performing for compensation the following services: Purchasing or selling real estate for others, purchasing or selling land certificates for others. But this term, land agent, shall not be construed so as to levy a tax upon an attorney in addition to the one hereinafter levied.

#### LAWYERS.

Sec. 10. From every person practicing law, and from every conveyancer drawing deeds or other legal instruments for pay, the sum of two dollars and fifty cents shall be levied and collected.

#### PHYSICIANS.

Sec. 11. From every physician, occulist or medical or other specialist of any kind, traveling from place to place in the practice of his profession an annual tax of twenty-five dollars; from every dentist two dollars and fifty cents.

#### PHYSICIANS AND VETERINARIANS.

Sec. 12. From every local practicing physician, surgeon, veterinary surgeon or any medical or sugical specialist, an annual tax of two dollars and fifty cents.

#### KNIFE RACKS.

Sec. 13. From every person or firm keeping a knife, cane or doll rack, or any other device upon which rings are pitched, or at which balls are pitched, or at which balls are thrown, an annual tax of twelve dollars and fifty cents.

#### BILLIARDS.

Sec. 14. From every billiard or pool table, or anything of the kind used for profit, the sum of two hundred and fifty dollars shall be levied and collected annually in advance, and any such table used in connection with any drinking saloon or any other place of business where intoxicating liquors, cigars or other things of value are sold or given away, or upon which money or other things of value is paid shall be regarded as used for profit.

#### TEN PIN ALLEY.

Sec. 15. From every nine or ten pin alley, or other alley used for profit, by whatever name called, constructed or operated upon the principle of a bowling alley and upon which balls, rings or other devices. are used as substitutes thereof are rolled, without regard to the number of pins used, or whether pins are used or not, or whether the balls, rings or other devices are rolled by hand, or with cue, or with any other device, the sum of two hundred and fifty dollars shall be levied and collected in advance. Any such alley used in connection with any drinking saloon or any drug store, where intoxicating liquors are sold or given away, or upon which money or anything of value is paid shall be regarded as used for profit.

#### HOBBY HORSE.

Sec. 16. From all persons keeping or using for profit any hobby horse, flying jenny or device of that character, with or without name, the sum of seven dollars and fitty cents shall be levied and collected annually in advance.

#### PEDDLER.

Sec. 17. From every foot peddler the sum of ten dollars, from every peddler with one horse or one ox the sum of twenty-five dollars, with two horses or two oxen forty dollars; provided that any blind, deaf or dumb or any wounded person who has lost a hand or a foot, shall not be required to pay any tax for peddling provided that such person shall not be exempt from such peddlers occupation tax if employed in peddling for any other person or persons. Provided, further, that nothing herein contained shall be so construed as to include vendors of poultry, vegetables or other country produce exclusively, fruit and fruit trees exclusively, if raised by the vendor or his family.

#### THEATERS.

Sec. 18. From every theatre or dramatic representation, for which pay for admission is demanded or received, two dollars and fifty cents per day for every day they perform; provided that this tax shall not be collected where the performances are exhibited in regularly recognized opera houses or theatres, but in lieu of said tax the manager of said opera houses or theaters shall pay an annual occupation tax of twelve dollars and fifty cents.

#### CIRCUS.

Sec. 19. From every circus where equestrian or acrobatic feats and performances are exhibited, for which pay for admission is demanded or received, for each performance or exhibition where a fee of one dollar is charged, one hundred and twenty-five dollars. For each performance or exhibition where an admission fee of seventy-five cents is charged, one hundred dollars. For each performance or exhibition where fifty cents is charged, fifty dollars. For each performance or exhibition where twentyfive cents or less is charged, twentyfive dollars. Provided, that where there is a combination or circus and menagerie, or circus and other exhibition, the highest tax fixed by this section for any division or department of the combination shall be collected; provided, further, that every show or exhibition which advertises itself as a circus or menagerie, or a combination of circus and menagerie, shall be held and construed to be a circus and menagerie, or a circus or menagerie, whether it be such or not.

#### MUSEUM.

Sec. 20. From every menagerie, wax-work museum, side show or exhibition, whether connected with a circus or not, where a separate fee for admission is demanded or received, five dollars for every performance or exhibition in which fees for admission are received.

#### ACROBATIC FEATS.

Sec. 21. For every exhibition where acrobatic feats are performed and an admission fee charged for profit, not connected with a circus or theater, five dollars for each performance.

#### SLEIGHT OF HAND.

Sec. 22. From every sleight of hand performance or exhibition of legerdemain, not connected with a theater or circus, twelve dollars and fifty cents.

#### DOG AND BULL FIGHT.

Sec. 23. From every person bringing off a fight between dogs and bulls, or between bears and dogs, or between bulls and other animals, or between dogs and dogs, two hundred and fifty dollars for each performance.

COCK PIT.

Sec. 24. From every cock pit when kept for profit or upon which any money or anything of value is bet or paid, twenty-five dollars.

#### MENAGERIE.

Sec. 25. From every menagerie, wax-works or exhibition of any kind where a separate fee for admission is demanded or received, five dollars for every day on which fees for such admission are received; provided, that exhibitions organized for the promotion of art, science, charity or benevolence, shall be exempt from taxation; provided further, that persons who form a museum composed entirely of the products of Texas, shall have the right to exhibit the same for a fee without paying any tax.

#### CONCERT.

Sec. 26. From every concert where a fee for admission is demanded or received, one dollar; provided, that entertainments when given by the citizens for charitable purposes, or for the support or aid of literary or cemetery associations are exempt.

#### LIVERY STABLE.

Sec. 27. From every livery or feed stable, fifteen cents for each stall and fifteen cents for each hack, buggy or other vehicle, and from every hack, buggy, dray, wagon or other vehicle, let for hire, not connected with a livery, feed, or sale stable, one dollar.

#### WAGON YARD.

Sec. 28. From every wagon yard used for profit an annual tax of two dollars and fifty cents.

#### INSURANCE ADJUSTER.

Sec. 29. From every person acting as a general adjuster of losses, or agent of life, fire, marine and ac cident insurance companies, who may transact business as such in the city, an annual occupation tax of twenty-five dollars. By "general agent," as used in this article, is meant any person or firm representative of any insurance company in this state, or who may exercise a general supervision over the business of such insurance company in this state, or over the local agency thereof in this state or and subdivision thereof; provided that when such a general agent acts as a local agent, he shall pay an additional tax as herein after provided.

#### INSURANCE AGENT.

Sec. 30. From each and every person or firm acting as local agent of life, fire, marine and accidental insurance companies, who may transact any business as such in this city. an annual occupation tax of two dollars and fifty cents. By "local agent" as used in this article, is meant any person or firm who may solicit, contract for or receive premiums for insurance in this city for any insurance company or companies who may deliver contracts or policies of insurance, including railway agents and employes who may solicit or receive premiums for accident insurance in this city.

#### INSURANCE AGENT—LIFE.

Sec. 31. From each and every person or firm acting as local agent of industrial life insurance companies who may transact any business as such, in this city, an annual tax of one dollar. By "industrial life insurance," as used in this article, is

meant insurance, adapted to the wants and necessities of the wage earners in that the policies are small and the premiums collected weekly at the home of the insured, the maximum policy of insurance written for any one person being one thousand dollars.

#### PAWN BROKER.

Sec. 32. From every pawn broker an annual tax of seventy-five dollars.

#### WOOL BUYERS.

Sec. 33. From every wool buyer, or buyer of hides an annual tax of five dollars; provided, that a merchant who pays an occupation tax as herein prescribed shall not be considered a wool or hide buyer.

#### SEWING MACHINE AGENTS.

Sec. 34. From every person, agency or association of persons dealing in sewing machines an annual tax of seven dollars and fifty cents to this city; provided, that a merchant who pays an occupation tax as required by this article, shall not be required to pay this special tax to sell sewing machines when sold in his place of business.

#### PEDDLERS FOR VEHICLES.

Sec. 35. From every person or firm who peddles out clocks, cooking stoves or ranges, waggons, buggies, carriages, surreys and other similar vehicles, washing machines and churns, an annual tax of one hundred and twenty-five dollars to this city; provided, that a merchant who pays an occupation tax required by this article shall not be required to pay this special tax for selling the articles named in this section when sold in his place of business.

#### GAS COMPANY.

Sec. 36. From each gas company manufacturing gas in this city an annual tax of seventeen dollars and fifty cents.

#### ELECTRIC LIGHT.

Sec. 37. From each electric light company operating an electric light plant in this city an annual tax of seventeen dollars and fifty cents.

#### WATER WORKS.

Sec. 38. From every water works company operating a water works plant in this city an annual tax of seventeen dollars and fifty cents.

#### SKATING RINK.

Sec. 39. From each and every person, owner or keeper of any skating rink used for profit an annual tax of twelve dollars and fifty cents.

#### LAUNDRY.

Sec. 40. From each owner and keeper of every steam laundry an annual tax of five dollars.

#### ICE DEALER.

Sec. 41. From each person or corporation who are wholesale dealers, selling imported or home made ice to the trade to be sold again an annual tax of twenty-five dollars.

#### RACE TRACK.

Sec. 42. From every owner or manager of every race track one mile or more in length, used for profit, fifty dollars; from each owner or manager of every race track one-half mile or less in length, twenty-five dollars per annum; provided, that this shall not apply to race tracks owned by private individuals and used only for training purposes, or in connection with agricultural fairs and expositions.

#### - STREET CAR.

Sec. 43. From every street car company in this city one dollar per mile of track owned by said company or corporation.

#### PHONOGRAPHS.

Sec. 44. From each owner or manager of every phonographic, electric battery, graphaphone or other like machines or instruments where a fee is charged, an annual tax of twelve dollars and fifty cents, provided, that when an electric battery is used by a regularly authorized physician on a patient no tax shall be charged.

#### KINETOSCOPE.

Sec. 45. From each owner or keeper of every kinetoscope, or cinetograph or similar machine or instrument used for profit which shows the life like motions of persons or animals, an annual occupation tax of twelve dollars and fifty cents.

#### PANORAMA.

Sec. 46. From each owner, manager or keeper of every panorama or view-show, used for profit, exhibiting in a wagon, room, tent, or elsewhere, an annual occupation tax of five dollars. A panorama or view-show in the meaning of this section is a show exhibiting pictures, statuary or other works of art which are viewed through stereoscopic or magnifying lenses.

#### TENTED AMUSEMENTS.

Sec. 47. From each owner, manager or keeper of every show or company of persons giving exhibitions of music, songs, recitations, sleight of hand, gymnastic, dancing or other kind of performance in a tent, house or elsewhere which said exhibitions are used for profit by sale of medicines, electric belts or other articles of value, whether charge is made only for seats or not, an annual occupation tax of twenty-five dollars; provided that this tax shall not be assessed when these performances are given inside the grounds of any state or county fair during the time that said state or county fair is giving its annual exhibition.

#### CIGARETTE DEALER.

Sec. 48. From all dealers in cigarettes in this city the sum of five dollars per annum, provided, that this tax shall be in addition to the occupation tax levied on merchants and any other tax levied under the law, and, provided, further that each dealer shall be required to procure an annual license from the city assessor and collector of taxes which shall describe the house and locality where the dealer proposes to sell cigarettes.

#### GIFT ENTERPRISE.

Sec. 49. From every person operating or managing a gift enterprise for profit a license tax of five dollars per day shall be paid.

#### VEGETABLE WAGON.

Sec. 50. From every person running a vegetable wagon a tax of five dollars; provided, that this shall not apply to merchants who are regularly licensed as such nor to persons who sell the products of their farms.

#### BEEF WAGON.

Sec. 51. From every person peddling beef, pork or mutton a tax of twenty-five dollars.

#### STREET SHOW.

Sec. 52. From every person conducting a street show or exhibition a tax of two dollars and fifty cents per

day shall be levied and collected in advance.

#### BOOK AGENTS.

Sec. 53. From every person canvassing within the city limits as a book agent a license tax of three dollars per month shall be levied and collected in advance.

#### RESTAURANT.

Sec. 54. From every person keeping for profit any restaurant, lunch counter, short order house, or eating house a tax of seven dollars and fifty cents.

#### ICE CREAM PARLOR.

Sect 55. From every person keeping an ice cream parlor a tax of five dollars.

#### SODA FOUNTAIN.

Sec. 56. From every person keeping a soda fountain or fountain or stand where soda water, lemonade or other drinks are sold a tax of five dollars.

#### PIANO TUNER.

Sec. 57. From every person following the profession of piano tuner a tax of five dollars shall be levied and collected.

#### BAKERY.

Sec. 58. From every person keeping or running a bakery a tax of five dollars shall be levied and collected.

#### BILL POSTER.

Sec. 59. From every person persuing the business of bill poster a tax of five dollars shall be levied and collected.

#### BICYCLE STAND.

Sec. 60. From every person keeping a bicycle stand, stall or place where bicycles are kept or rented or let to others for profit, a tax of fifty cents on each and every bicycle so kept.

#### BOARDING HOUSE.

Sec. 61. From every person keeping a hotel, lodging house or public boarding house for profit, a tax of twenty-five cents per annum for each room so kept.

#### BEER DEPOT.

Sec. 62. From every person keeping any beer depot, storage room or storage agency for which a license tax of two hundred and fifty dollars per annum shall be levied and collected.

#### HACKS.

Sec. 63. From every person keeping or running any hack, omnibus, carriage or other vehicle for hire an annual tax of five dollars.

#### DRAYS.

Sec. 64. From every person running a dray, cart or wagon for carrying freight and baggage for hire a license tax of seven dollars and fifty cents per annum.

#### EXPRESS WAGON.

Sec. 65. From every person keeping or running any job or express wagon kept for carrying and delivering for hire any express, baggage, merchandise or other light articles a license tax of three dollars per annum.

#### LIGHTNING RODS.

Sec. 66. From every person, firm or association of persons dealing in lightning rods an annual tax of eighteen dollars, and upon every person canvassing for the sale of lightning rods an annual tax of

fifty dollars to this city for canvassing done in this city.

TELEPHONE.

Sec. 67. From every telephone company operating a telephone system in this city an annual tax of five dollars.

EXCEPTIONS TO THIS ARTICLE.

Sec. 68. Nothing contained in this article shall be so construed to prevent any person, firm or corporation who has paid an occupation tax for any particular year as a merchant for said city of Hereford from soliciting trade within the corporate limits of said city at any time during such year, nor shall the levy or collection of any occupation tax on any occupation or business as herein provided be held or construed to exempt from punishment any person who shall violate any provisions of the penal code of the state of Texas or any of the criminal ordinances of this city.

Sec. 69. And be it further ordained by the City Council of the city of Hereford. That all license or occupation taxes shall be collected by the City Marshal, and shall be paid to that officer by each and every person, firm or association of persons owing such license or occupation tax, before engaging in or persuing any trade, profession, business, calling, avocation or occupation subject to a tax by the ordinances of this city. And if any person shall engage in or persue any profession, business or calling which is by any ordinance of this city subject to a license tax or occupation tax without first having paid such tax and procured a receipt therefor, he shall be deemed guilty of a misdemeanor and upon conviction shall be fined in any sum not more than ten dollars for each day such violation of said ordinance may continue.

Sec. 70. The conviction of any person, firm or association of persons for persuing such business or occupation without payment of the tax and the payment of the fine and cost, shall not exempt such person, firm or association of persons from the payment of the license tax or occupation tax due; but this city may by civil suit in any court having jurisdiction enforce the collection thereof. This ordinance shall repeal all ordinances and parts of ordinances in conflict herewith and shall be in force and take effect from and after its passage and publication.

#### CHAPTER 2.

#### Who to Issue License.

Art. 266. All licenses shall be issued by the Mayor, under the seal of the city, and assessed and collected by the City Assessor and Collector and shall be in the following form :

Which said form shall be bound in a book with duplicate sheets attached thereto, showing the number of the license, the date of its issuance, to whom issued, for what purpose issued, the amount paid for same, for what period such license is issued, stating the date and termination of same, which stub shall be filled out by the Mayor at the time such license is issued.

#### TITLE XXI. Hog Law.

#### CHAPTER 1. Hogs Not Allowed to Run at Large.

Art. 267. All hogs are hereby prohibited to run at large within the corporate limits of this city, and for the purpose of carrying this ordinance into effect a public pound is hereby established wherein all such animals herein described which may hereafter be found running at large within the corporate limits of this city shall be placed, kept and confined until the same shall have been released or sold as herein after provided.

#### CHAPTER 2. Public Pound Keepers-Their Duties, Advertisement and Sale.

Art. 268. The City Marshal and policemen of the city of Hereford are hereby declared to be the public pound keepers of the city. It shall be their duty to take up all such animals mentioned in the preceding article running at large within the corporate limits of the city and impound the same in the public pound, and they shall immediately advertise the same under the following directions: When the said hog or hogs are taken up and impounded the pound keeper shall advertise same for three days, exclusive of the day of advertising and the day of sale; when such time shall have expired the pound keeper shall sell same at public outcry as herein provided; if said animal has not been redeemed or released as provided by this ordinance. the said pound keeper shall sell said animal for cash to the highest and best bidder at the time and placedesignated in his advertisement of such sale. Such sale shall be at the public pound.

#### CHAPTER 3. City Marshal to Provide Pound.

Art. 269. Such public pound shall be a suitable place for caring for such animals, and shall be any place provided by the City Marshal for such purposes within the limits of the

#### CHAPTER 4. Posting Written Notices in Three Public Places.

Art. 270. The aforesaid advertisement shall be by posting written notices of the time and place of such sales of such animals in three public places in the city, one of which shall be at the court house of Deaf Smith County, Texas, and two at some other places in the city. Such notices shall describe the animals so impounded, giving as near as practicable the costs and expenses incurred and to be incurred in case of

#### CHAPTER 5. Fees Deducted for Impounding.

Art. 271. When any such animals are sold the pound keeper making the sale shall deduct the fees for impounding, keeping, advertising and selling the same, and pay the surplus, if any, to the owner on proof of ownership; if no owner be found within the time allowed for redeeming, the surplus money remaining shall be paid into the city treasury.

#### CHAPTER 6. Compensation of Pound Keeper.

Art. 272. The pound keeper shall receive as his compensation for taking up and impounding, keeping, advertising and selling such animals the following fees, to-wit: / For taking up and impounding any hog or hogs, the sum of one dollar per head. For feeding and watering such hog or hogs, five cents per/head for each meal, allowing only two meals per day. For advertising such hog or hogs fifty cents per head. For selling such hog or hogs, ten per cent of the amount remaining after deducting all other fees and expenses.

#### CHAPTER 7. Owner May Redeem-When and How.

Art. 273. The owner of any such animals mentioned in the preceding article may redeem the same at any time before the sale of the same by paying to the pound keeper the fees incurred.

#### CHAPTER 8. After Sale - When Owner May Redeem.

Art. 274. The owner of any hog or hogs may redeem the same at any time within five days from the date of sale by paying to the purchaser thereof the amount of the purchase money paid by the purchaser for such animal, with ten per cent additional.

#### More Ordinances Passed and Other Business Transacted.

On Wednesday morning the City Council held another meeting for the purpose of passing some needed ordinances and for the transacting of other business which was to come before it.

Those present besides the Mayor were Aldermen Fuller, Loveless, Aten and Ricketts. D. E. Weaver was appointed city scavenger, and his bond was placed at \$500.

At the previous meeting F. L. Vanderburgh was appointed city secretary and treasurer, but on account of finding that the duties of the office would take too much of his time, failed to qualify, and requested that another be appointed in his place.

The committee appointed to confer with the county officials in regard to a joint dumping ground reported that the county had purchased a parcel of land for that purpose and it was moved and carried that the city buy enough additional ground adjoining to make twenty acres. This land is situated on the Western Union section beyond the stock pens.

Mayor Davis then appointed the following standing committees:

Claims and accounts, finance and revenue or ways and means—Ira Aten, L. W. Ricketts and A. J. Lipscomb; fire department, lights and waterworks—S. Loveless, A. J. Lipscomb and F. B. Fuller; police and public health—L. W. Ricketts, Ira Aten and S. Loveless; streets, alleys and public grounds—F. B. Fuller, Ira Aten and A. J. Lipscomb; miscellaneous—A. J. Lipscomb, S. Loveless and F. B. Fuller.
