



#### Two Petitions.

Two petitions, one from Dimmitt and the other from Hereford, were forwarded this week to the postoffice authorities at Washington requesting that the starting point of the Hereford-Dimmitt mail route be changed from Hereford to Dimmitt. This change is a good one, and should have been made long ago. At present mail for Dimmitt does not arrive at Dimmitt until the day following its arrival here, and mail from Dimmitt to the outside world does not leave Hereford until the following day after its arrival here. The change would also be beneficial to Hereford people patronizing the stage who have business at the Castro county seat, as at present the stage does not remain long enough at Dimmitt to permit of any business transaction in the meantime. Inasmuch as both Dimmitt and Hereford citizens favor the change we see no rason why it should not be made, in which event the stage would leave Dimmitt in the morning and Hereford in the afternoon.

#### Castro County Elections.

W. A. Tate, the popular Castro county commissioner and proprietor of Castro county's only hotel, was in town this week and informed us that his county went dry by a large majority in the local option election held June 2. In the special school tax election held June 6 the the tax of 20 cents on the \$100 valuation was carried by the handsome majority of 24 to 9. Castro county citizens can be depended upon to vote right in an election calculated to upbuild their county, and THE BRAND congratulates them upon the the results of their last two elections. Mr. Tate stated that the school tax election would have carried almost unanimously but for the fact that a few in some manner obtained the impression that the proposed tax would be 20 cents on the dollar.

#### Leg Broken.

The little son of Mrs. Straight of Shawnee, Okla., who are visiting at the home of the latter's parents, Mr. and Mrs. M. F. Barber in Castro county, had the misfortune on Monday to fall from the surrey, in which they were riding, the rear wheel passing over the little fellow's left leg, breaking it below the knee. He was brought to Hereford, where Drs. Gough, through the use of the X-ray machine, located and reduced the fracture and made the patient as easy as possible. The accident was a most unfurtunate one for the boy, aside from the suffering which will have to be endured, as he was anticipating a most pleasant vacation with his grandparents in the country, but, alas, his pleasure has been turned to pain.

#### General Stock News

J. D. Thompson last week purchased 202 head of two-year-old steers at private terms from F. G. Hendricks, which he will place on feed on his North Draw ranch.

We have heard of no sales so far this week, caused probably by the inability of the buyers to obtain cars for shipping purposes.

There are but three or four small bunches of cattle in the Hereford neighborhood that are on sale on the open market.

This country was treated to a continuous rain during the past week, which puts a fine season in the ground for our stock farmers. It has also relieved the stock water situation somewhat, as most of the lakes have more or less water in them. It is said, however that there is more water in the lakes around Dimmitt than those near Hereford. One hard rain now, however, would fill the lakes to overflowing and from present indications we are liable to get it at any time.

THE BRAND would thank our cattlemen friends to give us for publication any news which will be of interest to the stockmen of the country. We try to keep in touch with the different deals, but there are doubtless many transactions of interest that we hear nothing about and it is these items that we wish to publish.

Visiting cattlemen are invited to make THE BRAND office their head-quarters while in town. We have the West Texas Stockman, Fort Worth Daily Live Stock Reporter and Weekly Citizen and other live-stock papers on our exchange table, which you are welcome to peruse.

The Fort Worth Livestock market is doing a land office business now on account of the closing down of the Kansas City, St. Louis and other stock yards by reason of the severe floods.

The shipment of cattle from the Texas ranges to those in the northern part of this state has been very heavy during the past week and within the past few days between two and three hundred carloads of these range cattle have passed through this city on the Montana Central railroad from Texas bound for the Milk river ranges. Shipments of cattle to this state are constantly increasing and two train loads of over 2,000 head passed through here today.—Great Falls (Mont.) Leader.



#### INCORPORATION DISSOLVED.

At the corporation annulment election held last Saturday the vote stood 84 for annulment and 41 against. There was some doubt expressed as to whether a majority or two-thirds vote was necessary to annul the incorporation, but Saturday's vote puts all questions of that nature in the shade. We have no comment to make on the result of the election and while being as strongly in favor of incorporation as ever, we feel that the majority of the citizens ought to rule, and we abide by their decision and will continue to work as hard as ever for the upbuilding of Hereford and surrounding country and trust that every other citizen of the town, whether favoring or opposing corporation, will do the same.

THE muddy condition of our streets forcibly calls attention to the great need of suitable side and cross walks on our streets, especially on the main thoroughfares.

Our citizens should not lose sight of the fact that an addition to the Hereford High School is an absolute necessity and should be prepared to donate liberally when the building committee calls.

Now that the incorporation question is settled for the time being let unity in the upbuilding of the town once mere prevail. Our citizens have the progressiveness, push and energy to accomplish anything undertaken, but without a unanimity of purpose on the part of our citizens the first three virtues are of no value. It requires an all-pull-together spirit to keep a town on the progressive list.

We understand that the members of the Board of Trade held no meeting on Tuesday night on account of the inclement weather, at least we take it that that was the cause of the non-attendance. The Brand editor was out of town, but had he been here, would have attended, rain or shine. We would suggest that the president of the Board call a special meeting soon, as there are many things of importance to the town's growth which should be done, and as we have no incorporation now the existence and work of the

Board of Trade is now more necessary than ever. It is to this organization that the town will now have to look for its upbuilding and if every public spirited citizen of the town will become a member great good can be accomplished.

#### CRIMINALS CAPTURED.

Deputy Sheriff W. G. Ross Compelled to Kill One.

Last week Wednesday while prospecting for coal in New Mexico, T. A. Cox, Rat Jowell and J. W. Hanna were held up by Benton Howell and Claude Williams, who had been extended the hospitalities of the formers' camp during the previous night, and who claimed to reside at Carney, Okla., and Chanute, Kansas, respectively. On account of the meagerness of the reported holdup up to the time of going to press, we stated in last week's issue that Mr. Cox only had been held up, which was a mistake. After gathering up the armament of the camp and capturing two of Mr. Cox's horses, the desperados prepared to decamp, when a railroad contractor rode up on a fine roan horse. He was immediately held up with the rest of the boys and compelled to relinquish the possession of his horse, a valuable gold watch and one dollar in money, that being all the money he had with him, except a quarter, which the worthy pair generously gave back. Howell claimed that he had killed a man and that he had to have the horses in order to make his escape, and took Mr. Jowell's address, promising to notify him of the whereabouts of the horses after he and his companions were through with them.

They then took an easterly course and as soon as possible the victims of their desperation notified nearby ranchmen, who organized a posse and started in pursuit. Upon reaching the Escarbada division of the XIT ranch, telephonic notification was sent to Sheriff Inmon, who at once deputized T. R. Reagan to accompany Deputy Sheriff Ross to enter in the chase for the criminals, who took the evening train for Bovina. Upon arriving there they could find no trace of the robbers and Mr. Reagan boarded a passing train and went to Texico, N. M., leaving Mr. Ross to follow across the country.

At Texico Mr. Reagan was informed that two horsemen had been seen traveling south toward the DZ ranch. He at once obtained horses and in company with L. B. Blair scoured that section of the country returning late Saturday evening.

Meanwhile Sheriff Ross had obtained a horse and buggy at Bovina

drove to Texico, arriving there Friday morning. He had been there but a few minutes (less than half an hour) when he saw two horsemen, on the east side of the track, traveling toward the state line gate. Mr. Ross immediately started to intercept them and upon Howell's dismounting to open the gate called to them to hold up, he having recognized Mr. Cox's horse. Howell asked him what he wanted and Mr. Ross said, "I want you." "You can't get me," replied Howell, at the same time reaching for his rifle, or rather the rifle he had taken from Rat Jowell. Mr. Ross half turned and waved his hand to the Texico citizens, as much as to signal them that he had found the parties sought. He had no sooner turned than he felt a burning sensation in his thigh. Wheeling quickly he fired three shots with a 30-30 in rapid succession, Howell pitching forward at the third shot, but not until after he had made two more unsuccessful attempts to kill Sheriff Ross. His companion, being mounted, spurred his horse into a run as soon as the firing commenced, whereupon Ed Harwell, armed with a rifle, and A. Ragsdale, armed with a revolver, commenced raining bullets in a proximity too close for comfort, they not shooting to kill or maim him, as he had not attempted to do any shooting, their only object being to head him off and prevent his possible escape. As soon as Williams was out of range of the bullets he stopped his horse and threw up his hands, thereby indicating that he was willing to surrender. Upon examination it was found that the effective bullet had entered Howell's left arm, passing through his lungs, cutting the spine and lodged in his right shoulder, completely paralyzing his body. He was carried to the hotel, where Drs. Miller and Ferguson made him as easy as possible until death relieved him from sufferingabout an hour after the snooting.

Mr. Ross' wound was slight and looked as if a hot iron had been applied sideways to his thigh, the bullet striking the ground and glanced up and passed through the store building of Blankinship & Woodcock, being found under the safe.

After Williams' death Ed Harwell was dispatched to Bovina to wire the sheriff and county attorney at Portales to come to Texico.

Upon their arrival on the evening train Justice of the Peace A. Ragsdale empanelled a jury of inquest, consisting of J. C. Dyer, Alex Shipley, John Boss, J. L. Quinn, H. R. Meyers and M. O. Meeks, who found that the deceased came to his death by a gun short wound at the hands of Deputy Sheriff W. G. Ross of Hereford, Texas, while in the act of resisting arrest by an officer of the law, said jury completely exonerating Sheriff Ross from any blame in the matter, holding that he had bravely and conscientiously done his duty as an officer, giving the deceased every opportunity to surrender, not having fired or offered to fire until shot at and hit by the criminal resisting arrest. The dead man was buried in the Texico cemetery.

The following post mortem examination was made by Drs. Miller and Ferguson, after which the young criminal who surrendered was taken to Portales to await the action of the courts:

Post mortem made this day at about 1:10 o'clock p. m., on the body of Benton Howell by Drs. Miller and Ferguson.

We find that the deceased came to his death by a gun-shot-wound, the bullet entering about the center of the deltoid muscle and outer aspect of left shoulder, ranging downard and forward, fracturing the left scapula, passing from there to the spine, fracturing the 5th cervical vertebra, also severing the front half of the spinal cord and lodging under right clavicle. The bullet also in its course pierced the apex of left lung. Hemorrhage, shock and paralysis was the immediate cause of death. Death took place at about 10:45 o'clock.

Howell, who was a man of large statue, was about 30 years of age and claimed to have served three terms in the penitentiary and who has a sister living at Bayfield, Mo., and an aged father living at Carney, Okla., while Williams is about 17 years of age and claims Chanute, Kansas, as his home.

The horses, guns, watch, etc.,. which the desperados had forcibly taken from those who had previously befriended them, were left at Texico, subject to the order of their respective owners. Everything was recovered except Mr. Cox's revolver, which the robbers claimed to have lost in their flight to escape. The horses, however, are in bad shape from hard riding and wire cuts. Young Williams made the statement that at the outset he had endeavored to part company with Howell, but was immediately "covered" with a rifle and given to understand that he had got to remain with him (Howell) until their final escape, capture or death. Howell also informed him that he did not intend to be captured alive, as he had rather be dead than to return to a life of imprisonment. If this was Howell's determination it is evident that strategy alone would have to have been resorted to in order to effect his capture without bloodshed.


Too much praise cannot be bestowed upon Deputy Sheriff Ross for his bravery and coolness in his efforts to capture the criminals without bloodshed, even going so far as to jeopardize his own life in order to give the thieves an opportunity to make a peaceable surrender, and it is with pleasure that we note that the railroad contractor had expressed his determination to pay a \$250 reward for the capture of the thieves and the recovery of his horse, which reward Mr. Ross will undoubtedly receive in due time. That none of the pursuers received. serious injury at the hands of the desperados is also another matter of congratulation by all interested.

#### Reports Fearful Mortality.

J. D. Earnest was in the city last week from the old MK ranch, of which he is now the owner. He reports much of the country north of Big Springs badly in need of rain. Mr. Earnest expressed himself as glad to get back to this country from the plains, on account of his wife's health, which was very bad while he lived in Deaf Smith county. Speaking of losses on the plains as a result of the February storm, Mr. Earnest gave it as his opinion that 500,000 head of cattle had died in the Panhandle country this spring. He said 100,000 hides had been shipped from the town of Hereford alone since the storm. He said further, that not many of the ranchmen of that section were making any effort to restock their pastures at this time.—West Texas Stockman.

Upon reading the above, to say we were surprised that a man should make such a gross mistatement, without any grounds whatever for a foundation, is putting it mild. We were also surprised to see such papers as the Dallas News and West Texas Stockman publish such an item of news (?) without first having investigated as to the truth of the statement, as the editors of these papers could not help but know that the circulation of such an article would give this section of the country a hard reputation to intending investors. THE BRAND editor interviewed Station Agent J. S.

Jones, who, at our request, went over the records of hide shipments since December 1, 1902, and found that there had been 34,165 pounds of hides shipped from Hereford. All were in bundles with the exception of 206 loose hides, which weighed 3000 pounds. This would give an average of about 14 pounds to the hide, but to give good measure we averaged the hides at 12 pounds each, which would show that there were but 2803 hides shipped from this point during the winter, as against Mr. Earnest's statement of 100,000. These 2803 hides were picked up in this and adjoining counties tributary to Hereford as a shipping point.

While it is true that many of the stockmen of the Panhandle country (including Mr. Earnest) lost heavily, it is also true that those who had native cattle (Mr. Earnest's cattle were brought here from the southern country and were in poor shape to go through a hard winter without feed, which he did not have) and who were prepared to feed them from their last year's forage crop, lost very few cattle, many of them not having lost an animal. As for restocking their pastures, there are none of our stock farmers but what have all the stock their pastures will carry, as their losses of cattle are no heavier than what they expect to lose each winter from one cause or another.

This is a true statement of affairs here and we trust that the News and Stockman will give the true facts as wide circulation as they did the gross mistatements.
